I talked to Special Agent [redacted] in Las Vegas on November 14, 1946 who said that SIEGEL and VIRGINIA HILL had not yet arrived in Las Vegas but were expected that day. Since they would be driving, moving all SIEGEL's personal effects, it was probable that they had been delayed by the heavy rains. b7c

Portions of [redacted] Memo for SAC MURPHY in San Diego of November 7th were discussed with [redacted] with the idea in mind that it would be of benefit to him. b2 b7c b7D

[redacted] said that they already know but that he is not in Las Vegas. [redacted]

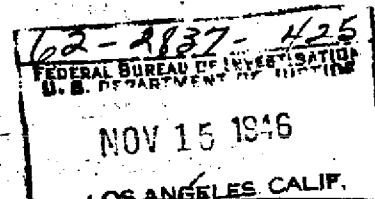
The case was referred to the Bureau and the Department and investigation was authorized. However, Phoenix did not make much of an investigation, but presented the case to the U.S. Attorney, who said that [redacted] was already well known to his office; that his predecessor had tried to get [redacted] on several occasions, but had failed each time to win a prosecution. He, therefore, thought it was useless to try again and declined prosecution. [redacted]

With respect [redacted] he still denies that he knows any of these people in the narcotic racket, but said that if he could see photographs of some of these people [redacted] he might be able to identify them. It is possible that he is holding back this information. If we have photographs of these people we should locate them and loan them [redacted] for display to the informant. *checked*

The new wire service is due in Las Vegas any minute now. [redacted] b7D

No technicals have been requested by the Salt Lake City Office as yet, but on November 14, 1946 [redacted] acting in charge, was to telephone Mr. ROSEN about this matter. b7c

Ship and 14 Aboard Believed Lost as Wreckage Sighted

Lending credence to fears that the 150-foot San Pedro motorship Pacifica foundered, probably with the loss of her crew of 14, off the Central America coast, the Coast Guard yesterday received reports that wreckage presumed to be from the long overdue vessel had been sighted. The motorship Notre Dame reported sighting, 100 miles south of Acapulco and 140 miles west of where a drifting lifeboat and two bodies were picked up last Sunday, a 20-by-25-foot section of decking, a 20-by-25-foot pilot house, and timbers of the kind carried by the Pacifica on deck when she left Guatemala Nov. 12 for San Pedro.

Capt. Kenneth G. MacLean, commander of the craft, had written to his wife here that he feared trouble from "bad ones" in the crew, and from the deck-load of lumber which made the vessel top-heavy.

Prisoner Key
Figure in Case

NEW YORK, Dec. 19.—The District Attorney's office late today identified Dave Krakauer, an alleged racketeer reputedly tied in at one time with the Dutch Schultz mob, as the mysterious "Pete" sought in the Alvin J. Paris gambling "fix" investigation.

Police said that Krakauer has a record involving arson, counterfeiting, burglary and Sullivan Law violation, an dthat as a gambler had been associated with such big time operators as Arnold Rothstein. He now is being sought for questioning.

The District Attorney's office also disclosed that it is investigating reports that an attempt was made to "fix" a prize fight last Friday night at Madison Square Garden. In this match, Charles Fusari, a welterweight, won aTKO over Chuck Taylor.

Fusari started as a heavy favorite but the betting odds sank to even money then jumped back up to 8-5. A flood of rumors also spread through the Garden before the main event got under way. One change of officials also was made at the last minute.

In another development of the hectic day, Treasury agents tried unsuccessfully to get into the office of the Jay Manufacturing Co., the firm for which Paris said he was employed.

The mysterious "Pete," in a tapped wire conversation, was said to have won \$10,000 on the fight last Friday night.

In still another development, counsel for William Staybach, president of the Lee Manufacturing Co. of Tenafly, N. J., announced that he would appear voluntarily at the District Attorney's office for questioning. His firm did business with the Jay Co., but the attorney said he "has nothing to hide."

Meanwhile, a second man was held by police in the case. The man, Jerome Zarowitz, 23, was described by Assistant District Attorney George F. Monaghan as an employee of "a combination of gamblers and bookmakers."

WASHINGTON, Dec. 19.—Representative Ed Hebert of Louisiana declared today Congress should drive "chiselers and fixers" away from pro and amateur sports by making bribery of athletes a federal offense.

He told a reporter he will introduce bills to do this just as soon as Congress convenes Jan. 3—"and don't think the penalties won't be tough."

Referring to charges that gamblers approached two New York backfield men before the Giants-Bears playoff for the National Professional Football League title last Sunday, Hebert said:

"This thing has got to stop. And the time to get this through is before the shock wears off."

One of his proposed bills will apply to the District of Columbia, the other to the rest of the nation. They will be patterned after the New York State Anti-bribery law.

BATON ROUGE, La., Dec. 19.—J. Walter Morris, president of the Class D Evangeline League predicted today that at least six players in the circuit were through with baseball after allegedly precipitating a gambling scandal which he said "will rock the baseball world."

Morris said that "more than six" players have been involved on charges of "throwing games, betting against their own clubs and being in collusion with gamblers." He refused to name the players or their clubs.

Grid inquiry turns to odds on prize fight

NEW YORK, Dec. 20. (UPI)—The district attorney's office, trying to blow the lid off the big town's sports gambling, today sought to determine whether a syndicate had manipulated the odds on last Friday night's Madison Square Garden fight in addition to trying to fix the Giant-Bears championship football game.

Sources close to Dist. Atty. Frank S. Hogan said that a close study was being made of the way the odds bounced up and down during the few days before the welter-weight fight between Charley Fusari of Irvington, N. J., and Charley Taylor of Coalport, Pa.

The investigation centered on a man known as "Pete," mentioned in telephone conversations on a tapped wire to Alvin J. Paris, 28-year-old would-be playboy accused of trying to bribe two Giants players to throw the National Football League championship game.

The trial of Paris, who was denied bail despite the attempts of a powerful legal battery to get him out of a Tombs jail cell, was scheduled to begin today in General Sessions Court here.

In their search for "Pete," police were checking on David Krakauer, a Bronx gambler with a police record dating back 26 years and including convictions for arson and counterfeiting. Krakauer was said to be in a New York hospital.

The cast of characters in the great football fix grew more bizarre by the moment. It already included five of young Paris' closest relatives, all with police records of one sort or another; a parade of Broadway party girls who allegedly were used to entertain professional football players; a high-powered criminal lawyer, Caesar B. F. Barra; and the most fabulous characters of all, the anonymous big-money gamblers of the syndicate for which Paris allegedly was a front.

Internal Revenue agents stepped into the case in New Jersey, where the gambling syndicate supposedly has its headquarters. They were looking for income tax evasions, a favorite government device for nailing high-flying criminals who manage to evade local convictions.

The investigation was spiced yesterday by questioning of various Broadway cuties whose names turned up in a little black address book found in the apartment of young Paris.

He was said to have entertained frequently, and detectives wanted to determine whether he supplied party girls for football players in order to win their friendship and confidence.

The telephone conversation which linked Paris and "Pete" to the Fusari-Taylor fight was reported by the district attorney's office to have gone like this:

Paris: "You are my partner and I'm looking to protect the office."

Pete: "He claims you are trying to throw the market around."

Paris: "What's he yelping about? He won \$10,000 on the fight last night."

The talk took place the morning after the Garden bout. Early in the week Fusari was a 2½-to-1 favorite. The odds dipped to even money, and went back up to 8 to 5 by ring time. Fusari won by a technical knockout.

Black Hand Gang Said Organized On A National Basis

NEW YORK (AP).—A new Mafia or black hand gang has been organized on a national basis and since the war has spread a trail of murder and wholesale drug peddling across the country from New York to California, Col. Garland H. Williams, district supervisor for the federal narcotics bureau, disclosed today.

Williams said the black hand activities were uncovered by the smashing of two huge New York dope rings and the arrest of six east Harlem gangsters on information reaped from the investigation of the murder of a Republican political worker in the home district of Rep. Vito Marcantonio.

He said that the new Mafia is the 1946 version of the original Unione Sicilano, the black hand of Sicily.

COVER ENTIRE U. S.

"The American born sons of the old Mafia," Williams said, "cover almost the entire United States, particularly the Florida New York, New Jersey, Kansas, Nevada and California areas, working in gambling and narcotics."

"They sneer at the outworn methods of the old Mafia. Where the older black handers worked with bombs, the young Mafia rely on 'connections,' bribery and political corruption."

He said "numerous murders" on the Pacific coast and slayings in other sections of the country had been traced to the Mafia.

Williams cited one murder in Chicago "where Carl Caramuse was on his way to church with his family when he was killed by a shotgun blast from a passing car."

SLAYING TRIAL WITNESS MEETS GANG DEATH

L. A. Cleaner War Figure Taken
for Ride, Dumped in Ravine

(Photo on Page Three)

Maurice Malter, 54, whose sensational evidence in a 1939 "cleaners and dyers" war murder trial here sent five men to life imprisonment, yesterday was found slain in true gangland fashion near San Mateo.

Sprawled in a ravine two miles east of Oak Cove Park where he had been dumped after being "taken for a ride," he had been shot twice in the head and twice in the chest with a .38 caliber automatic pistol.

Formerly engaged in the cleaning business and a key figure in Los Angeles' murderous acid-and-bomb-throwing cleaners and dyers battle in 1931, of late he had operated a radio parts store at 1170 South La Brea avenue here.

MADE TRIP—

Identified through an airline receipt found in his pocket which gave his address as 5230 West Olympic boulevard, Wilshire, Station Detective Robert Swan learned from the slain man's widow that on Saturday he flew to Oakland to purchase radio parts.

Callously dragged from an automobile and tossed over a barbed wire fence, the body—~~and~~ no doubt that Malter had been taken for a ride by his enemies," Sheriff McGrath said.

On April 27, 1939, after Malter gained immunity and subsequent freedom from a murder charge by turning state's evidence and testifying against six other defendants, five of the six were sentenced to life imprisonment for the slaying of John Stockman, watchman in an east-side cleaning shop, who was shot and killed December 16, 1931, seven years before, during the cleaners and dyers war.

TESTIFIED—

Malter testified concerning the pistol used to slay the watchman and told the court that Ed Rollins, one of those found guilty, had threatened:

"If you ever tell police what you know about that gun—you'll have a bullet put through your head."

Those sentenced to life imprisonment were Ed Rollins, Chicago hoodlum; Ed Freedman and Frank Fisher, ex-convicts; and Robert Cowan and George Gartler, wholesale cleaning plant proprietors who, according to Malter's testimony, hired the first three in an effort to monopolize through terror the cleaning and dyeing industry here.

Freedman, who was serving a term for the jewel robbery of Actress Mae West when convicted on the murder charge, is still in San Quentin. The others have been paroled. Fisher is serving a six months' sentence on a narcotics charge in the county jail here.

Angeleno Shot to Death in Bay Area Mystery

SAN MATEO, Dec. 15. (AP)—The body of a well-dressed, middle-aged man who apparently had arrived in San Francisco from Los Angeles by air Saturday was found today in a ravine off the Crystal Springs Road four miles west of San Mateo.

The victim had been shot three times through the chest and once in the head.

Among the papers found on the body, authorities reported was a Western Airlines coupon issued to an S. Malter, showing arrival at the San Francisco airport from Los Angeles at 2:4 p.m. Saturday, and a return ticket for the plane leaving at 7:45 p.m. the same evening.

A racing form and a garage ticket issued to M. Malter, 532 W. Olympic Blvd., Los Angeles also were found. The racing form carried the penciled notation "had CTC to win in seventh."

The horse See-Tee-See won one of the twin \$10,000 feature races at the closing program of the Bay Meadows track here Saturday.

One police theory was that the victim had flown to the track to see the race and had won heavily and then had been slain for his winnings. There was no wallet on the body and only 93 cents in change, police said.

Murder Victim Believed to Be Local Merchant

Maurice Malter, 53, of 532 W. Olympic Blvd., tentatively identified by San Mateo County authorities as the victim of roadside slaying there yesterday, has been part owner of an electric appliance store at 117 S. La Brea Ave. the last several years, police here said.

Police said Mrs. Malter told them he had flown to San Francisco Saturday to buy electric supplies for the shop. The Malters have two grown children. Police said the son, Albert, took a plane to San Francisco last night to identify the body.

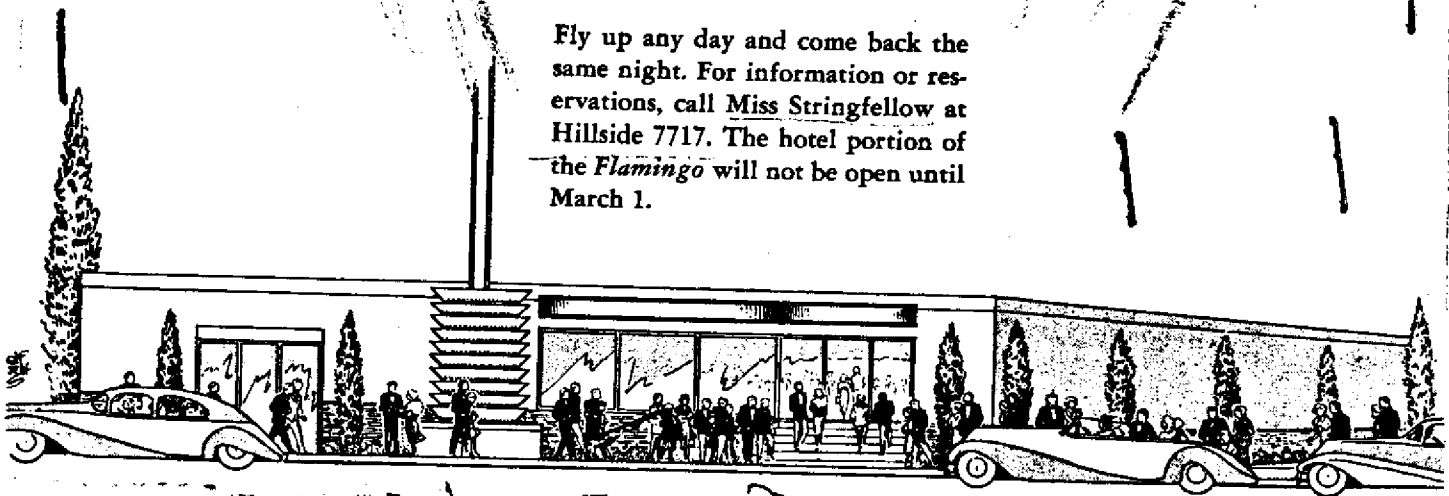
