On June 21, 1947, [REDACTED] telephoned to see if the FBI was interested in this case and was advised we are not. He said that he had been on the case since early in the morning. b7c

It was learned that SIEGEL had flown in early on the morning of June 20, 1947 from Las Vegas with [REDACTED]

[REDACTED] SIEGEL was to keep an appointment with his attorney JOE ROSS.

[REDACTED] was at the VIRGINIA HILL home and said that seven cartridge cases had been found outside the window. These cases were about 2" long and about .30 caliber in size. The bullets were copper jacketed and it looked like a carbine rifle had been used.

SIEGEL was four feet from the window and 14 feet from the place where the gun was rested. There is a lattice work between the HILL house and the neighbor's driveway. The killer rested his gun in one of the openings of the lattice. Nine shots were fired; only two bullets entered SIEGEL's body, both through the head. One bullet came out through an eye and a portion of the eyelid was found ten feet from him. There were five holes in the wall about as big as a dollar. Other bullets hit objects in the room.

The couch on which SIEGEL and [REDACTED] were sitting was at right angles to the window with its back in line with the right side of the window looking in. [REDACTED] was next to the window with his left arm resting along the back of the couch. SIEGEL was at the far end of the couch, leaning over a little and reading a paper. Apparently, the first two bullets just singed [REDACTED] coat on his left arm. The killer almost had to shoot around the corner and obviously was a good shot. b7c

On 6-23-47, [REDACTED] of the News stated that [REDACTED] were recently released from prison in Derby, Kansas and in jail one of them is said to have remarked that he had a big job to do on the West Coast and it was felt by [REDACTED] that they might have some connection with the SIEGEL case. b7c

On June 23rd, [REDACTED] for the District Attorney's Office, telephonically requested that if we received any information that might be of assistance in connection with this case, to please advise him of it at once. He was assured that we would be pleased to do so, if anything were learned. It was pointed out that we were not making any investigation of the case.

On June 24th, [REDACTED] of the Examiner stated he thought I would be interested in knowing the following: VIRGINIA HILL was the girl friend of JOE ADONIS of New York and she came out here to see Hollywood and SIEGEL was told to take care of her, and the money she has been throwing around was SIEGEL's. Furthermore, for some reason, she threatened to commit suicide in Las Vegas very recently and SIEGEL personally took her to the hospital. I questioned [REDACTED] a bit about this and he said his representative in Vegas had checked this and this was accurate information.

He also pointed out that [REDACTED] who was formerly a partner in the Flamingo, has ducked out and is also in Paris, as is VIRGINIA HILL.

[REDACTED] is now getting away from the narcotic angle for the motive and states he believes it is because of one of the two following reasons - mistreatment of VIRGINIA HILL or, (2) a fight over the racing news service. He stated he learned that SIEGEL had the bookie concession in [REDACTED] place in Las Vegas.

Siegel's Death Cheated FBI of Seizing Him as Dope King, Agent Reveals

LOS ANGELES—Gangland murder victim Benjamin (Bugsy) Siegel today was identified by federal narcotics agents as one of the world's biggest dope ring operators.

Narcotics agent W. J. Craig disclosed Siegel was shot to death Friday night just as he was about to be arrested for dope activities. Siegel's Hollywood playboy front in which he hobnobbed with film celebrities and was photographed with stars like his pal, George Raft, was just a means of covering up his participating in an international narcotics ring, Craig said.

"We have a heavy file on Siegel," the narcotics agent said, "and we were just about to close

in on him when he was slain."

"Siegel participated in big international narcotics deals," he added.

Reports from other sources said the fact that narcotics agents knew of Siegel's connection with the international ring probably led to his death to keep him from revealing the workings of the ring.

The west coast section of the ring, with headquarters here, was on the verge of being

cracked open by the federal agents. It was reported that the machine-gunning to death of Police Chief Juan Meneses of Mexico last Sunday night was due to his investigating narcotics smuggling across the Mexican border.

Siegel's part in the ring was reported to have been learned from Frank Orbe, 57, a prisoner in the Tijuana, Mexico, jail on a murder conviction.

The disclosure of Siegel's narcotics connections came as his friend, film star Raft, agreed to supply any information he had on the activities of the gangland leader.

Later that night, SIEGEL flew to Los Angeles and, according to the informant, arrived in Los Angeles about 2 a.m., June 20, 1947. The only business reported so far for SWIFTY MORGAN is that of a traveling tie salesman.

Data on Siegel to Be Pooled

Groping for a lead in the slaying of Ben (Bugsy) Siegel last June 20, local law enforcement officials will meet at 10 a. m. tomorrow to pool information.

The meeting was suggested by Walter Lentz, chief special agent for Attorney General Fred N. Howser.

It will discuss infiltration of known hoodlums from Detroit, Chicago and New York.

By pooling information, Chief Deputy District Attorney Ernest Roll said he hoped to turn up a clue for the motive behind Bugsy's slaying. Roll is heading the inquiry into the gangster's slaying.

Others attending the meeting will be Beverly Hills Police Chief C. H. Anderson, District Attorney William E. Simpson, Sheriff Eugene Biscailuz, Assistant District Attorney John Barnes, Chief Investigator H. Leo Stanley, and Undersheriff A. C. Jewell.

Simpson also has detailed an investigator to visit Eastern cities to look over operation of criminal syndicates and check on movements of known racketeers.

To date, Roll has admitted that there is no evidence pointing to identity of the gunman who killed Siegel as he sat reading a newspaper in the Beverly Hills home of Virginia Hill, wealthy divorcee.

Hotel in Hollywood investigated as headquarters of Bugsy dope ring

A prominent Hollywood hotel today was reportedly under investigation by federal narcotics agents as headquarters of a million dollar dope ring operating here and in Mexico.

The narcotics syndicate is said to have been captained by Bugsy Siegel, slain gangster.

Narcotics agents, acting on a tip that eastern mobsters from Detroit and Chicago recently have made Hollywood their headquarters, announced they expect "fast developments" in smashing the illicit trade.

The disclosure came shortly after Mexico City police officials linked Siegel to the international narcotics gang identified as the "Million Dollar Ring," said to be the largest in the world.

A Mexican official said Bugsy's murder a week ago may have been the result of a fight within the ring.

Siegel's ring controlled most of the drug traffic between Mexico and California, said Ignacio Mancilla Vaga, assistant chief of the Judicial Police of the Federal District and territories.

Efforts of Charles (Lucky) Luciano, deported gangster, to gain control of the giant ring were disclosed by Mancilla. He said Luciano unsuccessfully tried to make a deal with Mexican poppy growers.

American dope smugglers have for years been flying narcotics into isolated airfields in the state, Mancilla said. Fast launches also have been used in a manner reminiscent of prohibition days.

Leaders of the Mexican Dope Ring in Mexico were named by Mancilla as Juan Hernandez, Juan Vazquez, Juan Jose Smith, and Juan Williams. Mancilla said these men were active in the Hollywood dope ring.

for exchange of information on movements of known gangsters in this country.

Data for the mobster information bureau will be gathered by a special agent assigned by H. Leo Stanley, chief of the Bureau of Investigation. The agent will be sent to visit large eastern cities in the inquiry, Simpson said.

District attorney's men yesterday sought more details of Siegel's connections and personal life by questioning his ex-wife and the kid brother of Virginia Hill, in whose home Bugsy was slain last Friday night.

Tearfully, Mrs. Esther Siegel, dressed in black, said that Bugsy's "business activities" kept him away from home so much that they finally decided on a divorce. She added further details about his business connections which were withheld by investigators.

Charles Hill, 20, who was in his sister's home the night Bugsy was slain, said that the gangster and Virginia Hill were "in love" and added that she made an attempt to take her own life in Las Vegas after a spat with Bugsy.

Miss Hill had a way of always having ready cash on hand, her brother said, but he didn't know where the money came from.

Once she handed him \$5000 in cash to buy a 1941 Cadillac, said, and added that Bugsy footed the bill for a \$1000 champagne party in Hollywood given by his sister.

Other ramifications of Siegel's past and operations of the giant dope ring with which he was assertedly connected were being investigated by state narcotics agents.

Chief Special Agent Walter H. Lentz revealed the Department of Justice is interested in the case by calling a special meeting of law enforcement officials for 10 a. m. Tuesday.

SIEGEL CALLED DOPE RING BOSS

Mexico Authorities Say Bugsy
Supplied Hollywood, East

Mexican authorities yesterday said Ben (Bugsy) Siegel, slain gangster chieftain, was boss of a million-dollar narcotics syndicate supplying Hollywood and Eastern markets.

By airplane, speedboat and automobile, the ring smuggled opium and its by-products into the United States for several years, according to the former assistant chief of federal police in Mexico City.

Another Mexican source said Siegel had an auto with a secret compartment behind the front seat which would hold 300 cans of opium.

Ignacio Mancilla Vega said Siegel's murder in a Beverly Hills mansion June 20 may have been the result of a fight inside the syndicate.

NEW THEORY—

His opinion differed slightly from that of American narcotics agents, who blame the Mafia (Black Hand) narcotics ring of Charles (Lucky) Luciano for the killing.

Mancilla said the Luciano mob tried to get control of the Mexican narcotics traffic more than a year ago but failed to make deals with Chinese poppy growers in Mexico.

Luciano, deported to Italy, slipped back into the United States and came to Brownsville, Tex., for the deal, Mancilla said.

The news from Mexico City followed the Examiner's disclosure last Sunday that Francisco (Frankie the Gooch) Coker, murder convict in Texas, supplied Siegel in narcotics.

Coker said Siegel paid him \$50,000 to look for him and then checks for \$1000 each on a Los Angeles bank, which he said was a front for the mob.

On this date at 11:30 AM an unknown man who refused to give his name called and asked to talk with a Special agent whose name he believed to be [REDACTED]. When he was advised there was no agent here by that name, he asked the writer's name, and then submitted the following information:

An individual by the name of [REDACTED] (ph) with alias of [REDACTED] who owns the American Music Co., at Tucson, Arizona, and is "king" of the juke box machine business there, and also operates the narcotic traffic between Nogales, Mexico and U.S. was connected with Siegel, and had trouble with him. He stated that Cassioneri knew all facts surrounding demise of Siegel.

Informant again called at 12:15 PM this date and advised that [REDACTED] he had learned had a big argument with Siegel on narcotic traffic. He also stated that others tied up with the Siegel mob included [REDACTED]

[REDACTED] of the same city; that the last two named are now serving time in Federal Prison on narcotic raps. Informant requested that the writer meet him clandestinely this day, but he when advised that would be unable to leave office before 4:30 stated that to forget it at the present, and he would get in touch with the writer later.

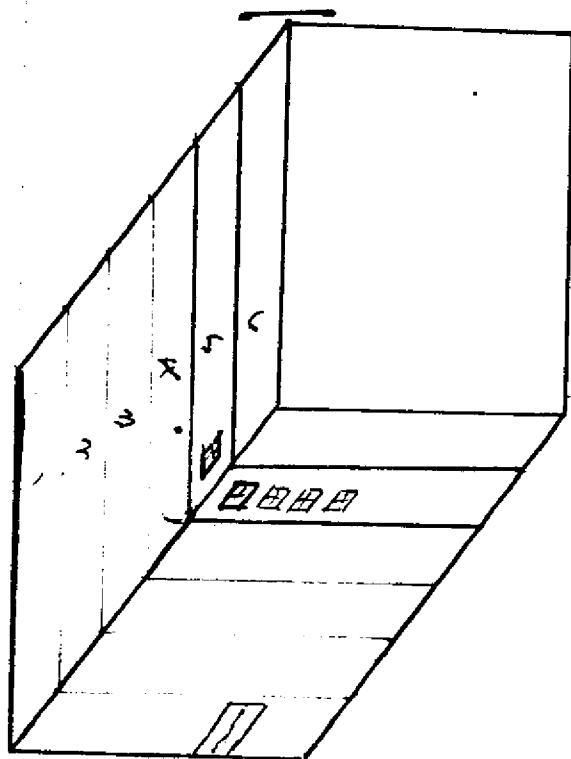

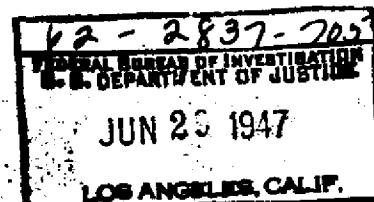

Heiress' Broken Romance With Slain Siegel Disclosed

Brother of Girl Tells of New Car and Sister's Plans

Virginia Hill, Alabama heiress, and Benjamin (Bugsie) Siegel were "romantically inclined," but the romance went awry before the gangster was slain last week in the heiress' Beverly Hills mansion.

This was disclosed yesterday by Charles Hill, 21, brother of Miss Hill, when he was questioned in the District Attorney's office by Chief-Dep. S. Ernest Roll and Chief Investigator H. Leo Stanley.

The youth, with Miss Hill's secretary, Jerri Mason, and Al Smiley, Hollywood sports figure and friend of Siegel, was in the Moorish residence at 810 N. Linden Drive at the time of the slaying.

Romance Disclosed

He said that his sister, now in Paris, and Siegel had been romantically inclined and that when Miss Hill lay unconscious in a Las Vegas hospital after taking sleeping tablets in Siegel's Flamingo Club, Siegel told him that he wanted to marry Virginia, according to Roll.

"And I am sure my sister was also in love with him," he was quoted by Roll as saying.

But the romance faded. Hill said his sister and Siegel had concluded that both were "too nervous" to get along and had agreed to split up. She had planned some time before to go to Paris. At first Siegel was against the trip but, after the agreement to part, advised her to go ahead. In their "split-up" there was no violence, the brother said.

Then Virginia returned to her Beverly Hills home which she had rented from Juan Romero, an importer, and made the arrangements to go abroad. Hill said he and Miss Mason were left to pack up and travel to Miss Hill's home in Miami, Fla., in Miss Hill's new automobile.

New Car Deal

Asked about this new car, Hill said that his sister had purchased it a month ago and paid \$6400 for it, according to Roll.

Stanley asked him if Siegel had put up the money for the car or the rental of the Linden Dr. dwelling which Romero has already told the police he rented to Miss Hill for \$500-a month.

"I don't know whether he put up any money for anything," he replied, according to Stanley. "He was there at the time we got the car but my sister gave me the money in cash to pay for it and I went and got it from a used-car place."

He added that he knew Siegel was in the habit of giving money away to a lot of people but that he had little exact knowledge of his sister's finances.

Asked About Visit

When asked about the reason for Siegel's last visit to the Hill residence, Hill said he understood that Siegel had come over from Las Vegas to get his clothing from a guest bedroom and that he had also planned to meet his daughters from New York and take them on a two-month trip to Canada.

In one point of the interrogation Hill was asked by Roll if he knew whether his sister had been well acquainted with J. Adams, a New York gambler. Hill replied that his sister had introduced him to Adams in New York about three years ago.

At the conclusion of the questioning Roll declared, "At least we have some evidence that Miss Hill did not get all her wealth because she was an Alabama heiress as it has been rumored."

Earlier, Dist. Atty. Simpson turned to the sportsman's divorced wife for help.

Investigators Kemp Nivern and Chick Ebbets Jr. brought Mrs. Esther Siegel and her attorney, Irving Hill, to Simpson's office for an hour's questioning.

Wife Nervous

Mrs. Siegel appeared in a conservative black dress with white trimmings, a black coat and black knit gloves. She is a blond with blue eyes and a florid complexion. She was nervous on the day after the funeral.

She said: "We were schoolyard sweethearts in New York City. About 20 years ago, while he was in the garage business there, we were married."

She talked freely with Simpson, Asst. Dist. Atty. John Barnes, Roll and Stanley.

There was no mention of Siegel's background as a tough slugger from Hell's Kitchen.

Divorced in Reno

Instead his ex-wife called him a "fine husband" and "thoughtful father." The only trouble was that he had so much business away from home that she decided there was no use staying married.

She divorced him last Aug. in Reno and got a substantial

property settlement and alimony. What was this "business" that kept him away so often?

She didn't recall any particular.

What were his relations with Virginia Hill?

Mrs. Siegel answered: "I never knew or heard about Virginia Hill until I saw her name in the papers after the murder."

Mrs. Siegel told how she telephoned from New York to Las Vegas on the fatal day and her call was completed to Siegel in Beverly Hills. They arranged for her to come here with their children, Millicent, 16, and Barbara, 11, so Siegel might see his daughters.

The nervous divorcee-widow walked from the District Attorney's office. She left an ash tray filled with lipstick-smeared cigarette stubs.

Hunt Turns East

Meanwhile Simpson ordered a top-notch investigator sent to the East for a thorough canvass of Benjamin (Bugsie) Siegel's gangland connections.

Police here began search for a racketeer who reputedly was badly beaten three weeks ago in a battle at Siegel's Flamingo Club in Las Vegas, Nev.

Underworld sources hinted that this racketeer is in a hospital. His wounds presumably are camouflaged on records as "gout." The Flamingo row was one in which Siegel was apportioned western control of book-making.

Simpson's men continued studying the files of Murder, Inc., and began a thorough search through Federal narcotic records here.

Walter H. Lenz, chief special agent of the State Attorney General's office, scheduled a meeting

for 10 a.m. next Tuesday to discuss the Siegel killing and other gang and racket activities.

Simpson, Roli, Barnes and Stanley will represent the District Attorney's office at this conference. Lenz also invited Sheriff Eugene W. Biscailuz and Undersheriff A. C. Jewell.

Two Beverly Hills detectives flew to New York yesterday with extradition papers for Albert Greenberg, suspected of robbing Mrs. Samuel Genis on April 2 in her apartment at 9543 Charleville Blvd., Beverly Hills.

When arrested in New York the day before the Siegel killing, Greenberg said he had been in Siegel's Flamingo Club at Las Vegas from March 30 to April 5 and that Siegel would vouch for this statement. He denied the \$114,000 Genis robbery.

Mrs. Siegel Tells of Romance and Life with "Bugsy" Fails to Shed Light on Dark Trails of Slain Ex-Husband

They were bashful, giggling sweethearts in school on the east side of New York . . .

The boy left school and bought a garage, continuing a timid courtship of the girl he loved . . .

Then they got married.

That was 20 years ago. Today the boy—Benjamin "Bugsy" Siegel, the rubbed-out gangland czar—was in his grave, dead from underworld bullets, and the tear-stained girl tremulously told the authorities of her life with "Bugsy."

Auburn-haired Mrs. Esther Siegel, 38, who divorced the slain gangster last August, submitted voluntarily to questioning by District Attorney William E. Simpson in a private conference at Simpson's offices here.

MYSTERIES UNSOLVED

But Mrs. Siegel's answers dashed Simpson's hopes to penetrate through shadowy mysteries cloaking "Bugsy's" past life and associates.

She disclaimed any knowledge of Siegel's associates in the limbo of the half-world . . . she knew of no one who wished to do him harm . . . she knew nothing of his gangland pursuits and intrigues.

"Bugsy," she told District Attorney Simpson, was "a good husband, a good father to our two daughters, and a splendid man."

"I divorced him in Reno last year only because I was so tired of being lonely," she commented, nervously puffing on a cigaret. "He was so rarely at home."

As far as she knew, Mrs. Siegel said, "Bugsy" had no enemies.

"I never heard of a single soul who didn't love him," she tearfully exclaimed. "Even after the divorce we remained on the best of terms. In fact, I talked to him over the phone the day he was killed. We discussed a trip our daughters were making to Los Angeles from the east."

Mrs. Siegel said she never had heard of Virginia Hill, wealthy heiress in whose Beverly Hills home Siegel was killed, before she read accounts of the murder in the newspapers.

Shown two gold keys found in Siegel's possession after the shooting, Mrs. Siegel exclaimed:

"I gave one of them—the blank one—to him on his birthday. I've never seen the other one." (The other key to which she referred opened the front door to Miss Hill's mansion.)

Shortly before the conference got underway, Simpson issued a statement in which he said:

"I have today instructed Chief Investigator Leo Stanley to assign one of his men to go to a number of large eastern cities to obtain all information concerning the associates and activities of Benjamin Siegel."

"Instantly Stanley will arrange for the establishment of a permanent unit for the exchange of information between eastern cities and Los Angeles county concerning the movement of known mobsters. When the arrangements are made, all information received will be available to all law-enforcing agencies."

Acting on instructions of Attorney General Fred N. Howser, who has moved into the Siegel case, Walter H. Lentz, chief special agent of the State Department of Justice, today revealed a highly important meeting scheduled for next Tuesday to discuss gangster activities in California.

Lentz said he had requested Sheriff Eugene W. Biscailuz, Undersheriff A. C. Jewell, District Attorney Simpson and one of Simpson's assistants to meet in the attorney general's office at 10 a. m. Tuesday.

"I intend to inquire into all forms of vice and gambling and the persons responsible," he said. "I shall seek the cooperation of the telephone companies in determining the names and locations of telephones that are being used for unlawful purposes."

Meantime, Siegel, confidant of film colony luminaries and ruler of a vast underworld empire, had gone to his grave alone and almost un mourned.

The body, hermetically sealed in an ornate \$5000 casket, was entombed in a crypt at Beth Olam Cemetery late yesterday from the mortuary where members of his family held a simple, five-minute service for him. None of the six mourners at the rites witnessed the burial.

At the same time, Attorney General Howser, in announcing that his office would enter the investigation of Siegel's slaying, said that he and Governor Cullen were not only concerned with "who killed Siegel, but more particularly with the cause."

District attorney's investigators and sheriff's officers speculated on a theory that a Chicago racketeer, whom they have identified, paid two gunsmen to rub out "Bugsy" because of jealousy over Miss Hill.

Paris police were cabled to get statement there from the thrice-married, red-haired divorcee, who had left for Europe a week before the shooting.

Local authorities want to know what her relations with Siegel were, why he was carrying a gold key to her home at 810 North Linden drive, Beverly Hills, and why she went to Paris.

It was also disclosed that two women and two men, one of them carrying a .38 automatic, were picked up by Santa Monica police for questioning about the Siegel slaying.

They were Mary Mabelle Moron, 25; Ruth Haffmone Shook, 30; Anthony Cambiano, 26, and Joe M. Masinia, all of Kansas City.

Agents of the F. B. I., expressing interest in the quartet under arrest, went to Santa Monica to join Santa Monica police and the district attorney's office in questioning them.

Lieut. Charles Horn, of Santa Monica police, said both men had been questioned about their whereabouts the night "Bugsy" was rubbed out.

The district attorney's office announced Charles Hill, youthful brother of Virginia Hill, would be questioned late today.

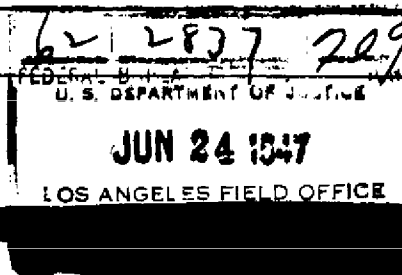

CHECK KEY

ROME, July 1.—(AP)—Charles (Lucky) Luciano, one-time New York vice overlord, said today that he still was "king" of all racketeers and sarcastically agreed to "take the rap" for the gangland killing of Benjamin (Bugsy) Siegel.

Luciano arrived in Rome, en route from Sicily to Papri, without fanfare. He stopped at the fashionable Savois Hotel, donned a light sports shirt and gabardine slacks and jeered at reporters throughout a 20-minute interview.

"Anything you want to know, just ask me," he said. "Sure I did it. Sure I had Siegel rubbed out."

"So they say I gave it to Siegel, huh? Why not? I'm king of them all—all the rackets. I'm king of vice, king of dope, Public Enemy No. 1, anything you want to pin on me. I did it."

Luciano refused to say how he knew Siegel had been mowed down by a gunman in Beverly Hills, Calif. No accounts of the slaying have appeared in the Italian press.

Asked about United States newspaper reports that he had ordered Siegel's death from Havana because Siegel refused to turn over receipts of the Las Vegas, Nev., resort to the "Sicilian Union committee," Luciano said:

"So it was in the American press, huh? Well, what're you

asking me for, then? If American papers says it's true, it's true. Whatever American papers say is true. Now, if that makes anybody happy, they're welcome to it."

He said he was touring Italy "like a private citizen. They ain't got anything on me here. They never did have and they're not going to, either."

And about an American report that he, Siegel and Frank Costello were organizing an international dope ring?

"Sure, sure. I don't know about Costello and Siegel, but I am, all right. What do you think I'm here for, my health? Sure, my territory's to be Europe and the Middle East—Russia, too, if I can get in there."

"Anything more they say I did? No snatchings, no baby killings, no ax murders, no clubbing old women to death? If they need anybody for them, send them to me. I'll take the rap for them all. I always do."

Luciano said he planned to return to Sicily in August for "nice long rest. Taking raps wear you out after awhile."

Howser aide investigates Bugsy rubout

Mystery of who killed Bugsy Siegel was needed a pretty poor second today to the much more absorbing question of why the dapper overlord of the underworld was rubbed out June 20.

Walter C. Lentz, chief special agent for Atty. Gen. Fred N. Howser, who has taken an academic interest in the Siegel saga, said:

"We are not interested so much in who killed Siegel, but in the cause of it. It is apparent there is a lot of money floating around and somebody is getting it."

Lentz made his statement as he went into a huddle with law enforcement officers here to try to revivify the flagging chase for Bugsy's killer.

The conference was called by Lentz on orders of Howser who before he departed for Washington ordered an investigation into the bookmaking, race wires, narcotics, gambling and prostitution fields.

At the end of the two-hour parlay, Lentz said, "This is the first in a series of meetings with county officials of the 58 counties in the state. We have discussed these problems and are in the fullest spirit of cooperation."

"A lot of hoodlums and gangsters from the East have selected California as a soft spot, partially because of crowded conditions here and the shortage of law enforcement officers," said Lentz.

"This is more than a mere county matter—it reaches beyond the state."

Lentz said he plans to call a similar meeting in San Francisco "very soon" to offer the services of the attorney general in cleaning up that city.

Attending the conference were Sheriff Eugene S. Biscailuz, Undersheriff A. C. Jewell, Dist. Atty. William E. Simpson, Chief Dep. Dist. Atty. Ernest Roll, Asst. Dist. Atty. John Barnes, H. C. Stanley, chief of the sheriff's bureau of investigation, and Everett P. Davis, captain of detectives in the sheriff's office.

While all this was going on, a mild stir was created by Herbert L. Michel, 346 N. Vermont Ave., North Hollywood, who found on the sidewalk in Temple St. in the shadow of the Hall of Justice a glittering gold key resembling those affected by Bugsy.

Inscribed on the key were the initials "B. S.," which induced Michel to take it to the sheriff's office.

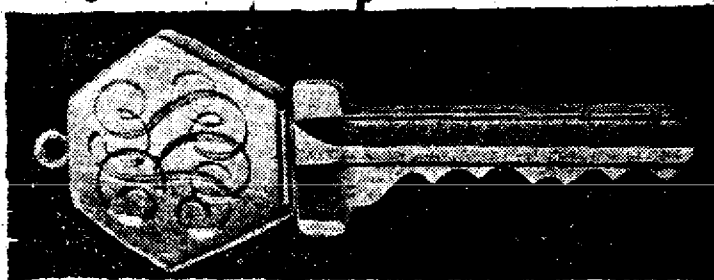

...we will pay particular attention to the bookie wire service and bookmakers because we feel they are at the root of gangster activities in the state. Declared Walter H. Lentz, chief special investigator of the attorney general's office, who called the meeting.

At the same time, President Miguel Aleman ordered a clamp-down on illicit drug traffic in Mexico, following disclosure that the slain underworld czar headed an international narcotics ring running dope from Mexico to the United States.

"LUCKY" LUCIANO

District Attorney William E. Simpson also announced that he has appointed investigator Thomas O. Slack to check Siegel's mobster activities in the east.

The meeting at Lentz's office was attended by Beverly Hills and Los Angeles police department representatives, the sheriff's office, district attorney's office and some federal agencies.

Meanwhile, in Rome, Charles "Lucky" Luciano jeeringly claimed he was willing to "take the rap" for any crime committed in the United States, including the Siegel rubout.

SARCASTIC

The former New York racket boss, who was deported to Italy, told reporters in a sarcastic interview:

Benjamin ("Bugsy") Siegel was a hood with class. His home outside Beverly Hills was a tourist showpiece. He dined with Barbara Hutton, went yachting with Countess Dorothy di Frasso.

Bugsy was born 42 years ago in New York's dingy Lower East Side. He got his start as night watchman for a gang of beer runners. Petulant as a small boy he went "bughouse" when crossed, but he was cunning, and he earned the respect of New York City's top crooks. When he hooked up with Meyer Lansky, New York ranked him as one of the "Big Six." He beat raps for rape, carrying concealed weapons, possessing narcotics, and murder. In 1933, Murder, Inc. was branching out. Bugsy, a member, set up western headquarters in Hollywood.

Businessman. Bugsy went right to work. He moved in on the gambling at Redondo Beach, took a cut of the profits at the Agua Caliente race track, muscled in on the numbers racket, cut himself a slice of the offshore gambling fleet and the Culver City dog track.

In 1939, Big Greeny Greenberg [a former associate of Bugsy] was found dead. Police arrested Bugsy. In jail, Bugsy lived fine, arranged for meals of steak and pheasant, and had liquor served in his cell to entertain his women visitors. And things took care of themselves. Two State's witnesses suddenly died: the case against Bugsy died with them.

The war years were good to him. He cornered the \$500,000-a-day California bookie business, set up a "milk run" smuggling Mexican heroin into California. In 1946 he opened the swanky \$6,000,000 Flamingo Club in Las Vegas. He made the acquaintance of sultry, dark-haired Virginia Hill, 30, who was famed for parties that dazzled even Hollywood. The story was that thrice-married Virginia had a Brooklyn patron, a gang overlord

who paid her handsomely to stay out of New York. Bugsy moved his shoes and suits over to Virginia's house.

But lately things had begun to go sour. The Flamingo lost money. From New York headquarters, the boys arrived to talk to Bugsy. A couple of hoods were cut down in the old '20s gangland style. Competition was increasing. The underworld was migrating eagerly into Southern California.

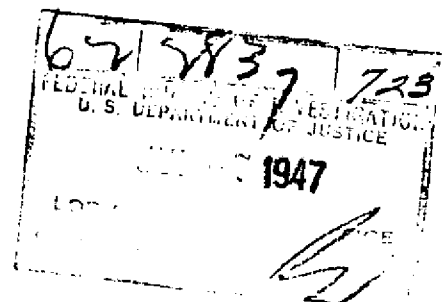
One day last week Bugsy returned to Beverly Hills from Las Vegas. He went to Virginia's house with his side-kick, Al Smiley. Virginia wasn't there; she had gone to Paris. Bugsy settled onto the sofa and glanced at the next morning's papers.

Outside, someone pushed a .30 caliber carbine through a rose trellis, drew a careful bead, put two shots into Bugsy's head, two into his body. A shot that went wild lodged in an oil painting of a nude woman, holding a wine glass.

SIEGEL HINTED \$1,500,000 IN DEBT BEFORE MURDER

Benjamin (Bugsie) Siegel's debts just a week before his murder in Beverly Hills 12 days ago may have totaled a staggering \$1,500,000.

That was disclosed last night by Chief Dist. Atty. Investigator H. Leo Stanley on the basis of information given him by an unidentified friend of the slain gambler.

Simultaneously, two checks signed by Siegel and totaling \$150,000—both of which bounced—were disclosed by the Attorney General's staff.

no way linked to the murder and has not been questioned by any of the Attorney General's staff.

But disclosures made yesterday indicated that Siegel's financial troubles ran into the seven-digit class—and that the \$150,000 debt represented only a fraction of his money difficulties. Chief Special Agent Walter Lentz of Atty. Gen. Howser's office declared:

"We believe these are not the only checks on which Siegel stopped payment. We think his purpose in paying to

June 16, four days before Siegel was murdered in Beverly Hills. They were drawn on the Las Vegas office of the Bank of Nevada.

Notations on them showed, respectively, the payment stopping and the nonpayment because of insufficient funds. In each case the Del E. Webb Construction Co. protested.

One for \$50,000 was returned because of insufficient funds. The racketeer had stopped payment on the \$100,000 check.

Both had been made out to Del E. Webb, wealthy Phoenix contractor who built Siegel's Flamingo Club in Las Vegas, according to the Attorney General's office.

Reached at Vancouver, B.C., where he flew yesterday, Webb was quoted in a dispatch as expressing surprise at news of the checks. He said he knows nothing of the checks and asserted that he certainly would have known about them had they been given to him as head of the construction company.

Webb said he expects to go to Victoria, B.C., today and will continue to Portland, Or., tomorrow.

One of three owners of the New York Yankees, Webb is in

That corroborated Stanley's report that the racketeer had told a friend one week before his death that he had to raise "\$1,500,000 — or hide out somewhere." Then Siegel said, according to Stanley's informant, "But I wouldn't know where to hide."

The murdered gambler at that time averred he had a 30-day deadline for acquiring the huge sum. He told Stanley's informant that he had "borrowed up to the hilt" from all his friends, and that "no bank would lend another dime on the Flamingo" because, despite its luxuriousness, it was a comparatively small establishment.

Of the two checks which were returned in San Francisco after going through the Bay City clearinghouse, the \$50,000 paper is dated May 6.

involves the entire West. "It is not so much who was killed but what is behind it," he explained.

"Gambling, narcotic smuggling, bookmaking, prostitution and other forms of crime are here."

Lentz intends to hold similar meetings with officials of all other California counties.

Only possible new hint to the murder was a gold key found on the sidewalk beside the Small Claims Court on Temple St. in the Civic Center. It resembles two gold keys found in Siegel's pockets and bears the sportsman's initials. The finder, Herbert L. Michel, 346 N. Vermont Ave., handed it to the Sheriff's bureau of investigation.

Chief Investigator H. Leo Stanley of the District Attorney's office and his aides questioned Siegel's dentist, barber and other associates. They offered no definite clue to the killer.

Chief Special Agent Walter Lentz of the Attorney General's office prepared to go to San Francisco to question Stanley Cohen, racing news publisher.

Lentz said Cohen heads the Continental Press Service in Northern California.

Miss Hill's Brother Explodes
Legend of 'Alabama Heiress'

Efforts to find Gangster Bugsy Siegel's slayer bogged down again yesterday.

Investigators said they still were checking his strained financial condition as the "most likely" reason for his murder by gunfire in the Beverly Hills residence of playgirl Virginia Hill on June 20.

Beverly Hills police questioned Virginia's older brother, John Mack Hill, 28, U. S. Marine and an expert rifleman, but he gave them little information other than Miss Hill is not an "Alabama heiress."

NO HEIRESS—

"That stuff about my sister is a lot of bunk," he said. "We came from Alabama, but from a family of very ordinary, middle-class people."

His testimony caused police to speculate on the source of Virginia's wealth and to wonder if, as some persons have said, she was more closely associated with the underworld than at first believed.

"Virginia and I never saw much of each other in recent years," said Hill. "I didn't approve of the way she lived."

Another brother, Charles, however, was in the house at the time Bugsy was killed.

There were reports that a second safety deposit box exists, probably in Beverly Hills. Authorities, however, have been unable to locate it.

Tell Siegel 'Touch' on Geo. Raft

Claim 'Bugsy' Asked
Actor for Loan
Of \$100,000

The name of George Raft, slick-haired portrayer of screen gangster roles, cropped up again today in the investigation of the tangled financial affairs of Benjamin "Bugsy" Siegel, slain ganglord.

Close on the heels of a disclosure by state investigators that Siegel may have paid a staggering \$1,500,000 debt with his life, District Attorney William E. Simpson said he had learned that "Bugsy" had recently approached Raft and other Hollywood film figures for loans of \$100,000 or more.

The actor, however, promptly denied that Siegel had attempted to borrow money from him, and said he had last seen the gambling czar March 6 at the opening of Siegel's Flamingo Hotel in Las Vegas, Nev.

NEEDED \$1,500,000

Simpson said he had reports that "Bugsy" had declared:

"I feel like burying my head in the sand. My pride is badly hurt. I got my friends and myself into this Flamingo thing for \$4,500,000 and it's driving me nuts.

"I need \$1,500,000 and I need it within 30 days."

The district attorney also said that investigators were checking on all phone calls to and from the Flamingo between June 18 and June 21 in an effort to locate whoever Siegel might have talked to from Las Vegas before he came to Beverly Hills last June 20 and met his death.

The theory that Siegel may have been rubbed out because of bad debts was based on the revelation that two of his checks for a total of \$150,000 "bounced" just before his murder.

"We believe these are not the only checks on which Siegel stopped payment," declared Walter H. Lentz, chief special investigator for the attorney general's office. "We think his primary purpose in coming to Los Angeles on the day of his slaying was to raise money to cover his bad checks."

Investigators also learned that "Bugsy" had confided to a friend a week before his death:

"I need \$1,500,000 within 30 days. The bank won't lend it to me and my friends have helped all they can. If I don't get it, I'll have to hide out."

CHECKS STOPPED

The two checks, for \$100,000 and \$50,000, were made out to the Del E. Webb Construction Co., the firm which completed Siegel's gaudy \$5,000,000 Flamingo gambling casino in Las Vegas, Nev.

Both were signed "Ben Siegel" and were drawn against the operating account of the Flamingo on the Las Vegas office of the Bank of Nevada. The hundred grand check, dated May 6, was returned marked "payment stopped." The other check, dated June 16, was returned for "insufficient funds."

Investigators declared that while no suspicion was attached to Webb, wealthy Phoenix con-

tractor and part owner of the New York Yankees baseball club, the checks indicated that Siegel was broke and "may have welched on some other people not so nice."

Webb, visiting Yankee farm clubs in Vancouver, B. C., denied he ever saw the checks.

"As far as I know the company doesn't have the checks," he said. "I did not receive them and I know nothing about them."

Since the drafts were not made out to Webb personally, he may not have seen them, investigator pointed out.

However, a close associate of Webb told newsmen that the contractor's investment was protected by liens on the Flamingo.

One of the theories about Siegel's rubout was that the underworld czar tried to raise money by boosting the rates for his racing news service. Bookies may have found it easier to kill him than to pay off.

The bad check find, a "top

secret" in the attorney general's offices, leaked out through the San Francisco Police Department. It had come through the Bay City clearing house, which took photostatic copies before returning them.

At a meeting with District Attorney William E. Simpson, Sheriff Eugene Biscailuz and other law enforcement officers, Lentz said the Siegel slaying shows that Los Angeles is rated as a "soft spot"

State tells of finding safe— deposit box used by Siegel

Atty. Chancery Cotts, of the state inheritance tax division, said today he has found a safety deposit box used by Bugsy Siegel, and the box has been opened by County Treasurer H. L. Byram.

Federal narcotic agents are said to be curious about the contents and about the existence of a second deposit box, possibly in Beverly Hills.

Had check operations by Bugsy Siegel put him \$1,500,000 in the hole and probably led him to seek solvency by borrowing from high-power friends in Hollywood the day of his death, law officers said today.

Raft was quoted as saying by the investigators.

Raft's publicist, a man with a passion for anonymity, subsequently volunteered a statement in an attempt to set the record right for his client.

"Mr. Raft has been questioned by the Beverly Hills police, the Los Angeles police, the FBI and the district attorney's office," he said.

"He admitted being a childhood friend of Mr. Siegel's on Tenth Ave. in Hell's Kitchen in New York.

"But the way Mr. Raft feels about the whole thing now is that Mr. Siegel is a closed chapter in his life. Mr. Raft is an actor, not a mobster," he said.

"There is a difference," he added thoughtfully.

names were expected to bob up in the rolling background of the late

Investigators from the office of Dist. Atty. William E. Simpson, checking into the story that Bugsy came here to try to borrow the money to cover his checks, ran again into the name of George Raft.

Raft, who is always as cool as a cucumber when he talks to the cops in the movies, got pretty excited when he was asked about it and denied the story violently.

"I haven't seen Siegel since the opening of the Flamingo Club,"

Bugsy as Simpson revealed he had in his possession records of all phone calls made from the Flamingo Club from June 18 through June 21, the day after Bugsy's death.

Simpson said his men are carefully checking the list of calls to narrow down legwork on the ones they consider important.

Information that Bugsy bounced two checks totaling \$150,000 before gangland bullets brought him to an untimely end on June 20 leaked out of the state's investigation into the slaying.

And tied in with this disclosure was a new picture of the gangland overlord painted by an unidentified friend—that the notorious Bugsy died a pauper while trying to patch the crumbling walls of his empire.

Bugsy, said Chief Dist. Atty. Investigator H. Leo Stanley, may have been as much as \$1,500,000 "in" on the basis of this new information.

Siegel had said a week before his death that he "had to raise \$1,500,000—or hide out somewhere," the informant told Stanley. But, the friend added, Bugsy "didn't know where to hide."

Besides that, the friend continued, Siegel thought he had 30 days to raise the cash. "But maybe someone considered some of those notes came due the night of June 20," Stanley theorized.

The bank drafts, signed by Siegel, were made payable to the Webb Construction Co., which built Bugsy's fabulous Flamingo Club in Las Vegas, Nev.

But Webb, millionaire contractor-sportsman, who owns a sizable slice of the New York Yankees' baseball empire, denied in Vancouver, B. C., last night that he had ever received the two checks.

"As far as I know," Webb told reporters, "the company doesn't have the checks."

Since the drafts were not made out to Webb personally, however, investigators pointed out that he may not have seen them.

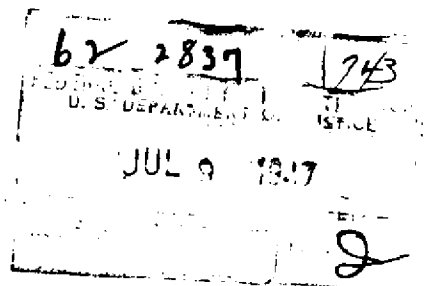
A group of creditors who built the Flamingo have claims totaling \$1,100,000 against the corporation, it was learned. Webb was described as the biggest creditor.

Investigators made it plain that no suspicion of complicity in Siegel's death was being directed at Webb.

There are lots of other questions, however, which the state wants answered about those rubber checks, according to Walter Lentz, chief investigator for the California attorney-general.

"We have reason to believe more of these checks are out," said Lentz as he prepared to leave for San Francisco today to press the investigation.

Siegel pals flee rumored death threats

Two confidantes of the late Bugsy Siegel—his red-headed girl friend and the man who sat beside him the night he was killed—were mysteriously missing today as the gangland word went out that they are marked for death.

An ocean and a continent apart, neither Virginia Hill nor Allen Smiley could be located to be warned by the reports.

In Los Angeles, central homicide squadmen reported an anonymous caller had tipped them that two triggermen had been assigned to eliminate Smiley, the tall, gray-haired friend of Bugsy who was injured in the shoulder by one of the bullets which Siegel caught last June 20.

Pals of Smiley indicated he was not around.

"Just say he's out of town," they said.

In Paris, where Virginia had gone a week before Siegel was slain in her Beverly Hills home, police reported she had checked out of her hotel and disappeared.

The report came after Beverly Hills Chief of Police Clinton H. Anderson said he had heard via the underground of the underworld that two gunmen, too, had been dispatched to Europe to kill her.

Police pointed out the strong possibility that both of Bugsy's friends knew from their own sources that they needed a change of climate for their health.

Both had clammed up under questioning, neither throwing any light on the identity of Bugsy's assassin.

The big "X" however, has been placed behind the names of the divorcee and Smiley because they know too much, the tipsters said. Chief Anderson said he immediately dispatched a cable to the prefecture of police in Paris, telling of the situation, and followed it with an air mail letter.

The other two occupants of Miss Hill's Beverly Hills home the night Bugsy was slain there got themselves married yesterday in Las Vegas, Nev. 30 days after the murder of the gang lord.

Charles Hill, 21, brother of Miss Hill, and Gerri Mason, 24, secretary to Virginia, were married and left for Florida where Miss Hill has ordered her home to be reopened.

Attorneys for the Nevada Projects Corp., which owns Bugsy's Flamingo Club, said a deal for sale of the gambling resort is imminent.

About 20 offers to purchase the club, which is making a lot of money or losing a lot, depending on which faction says it, have been received.

The lawyer said Bugsy owned 25 or 30 per cent of the club and controlled it with a couple

Quits Paris Hotel In Gang Threat

Virginia Hill, wealthy divorcee in whose Beverly Hills home Gangster Benjamin "Bugsy" Siegel was rubbed out, has checked out of her hotel in Paris and disappeared following disclosure that she too was marked for a gangland target, dispatches from Paris revealed today.

Word that two gunmen were on their way from the United States to slay the former friend of Siegel's was relayed to French police by Police Chief C. H. Anderson of Beverly Hills.

Chief Anderson said he received the information through "underworld sources," but declined any further comment.

Miss Hill has repeatedly denied all knowledge of the mystery surrounding Siegel's death. She had left for Paris a week before the killing.

Meanwhile, Charles Hill, 21, her brother, and Miss Jerri Mason, 24, her secretary, left for Florida today on a honeymoon following their marriage in Las Vegas last night. The pair was upstairs in Miss Hill's house on the night of the Siegel murder.

In Las Vegas, stockholders of Siegel's ornate \$5,000,000 gambling casino Flamingo held a secret meeting after which Attorney Louis Wiener said he has received "many offers" from persons wishing to buy or lease the club.

Wiener, who represents both Siegel's estate and the Nevada Projects Corp., owners of the Flamingo, said the stockholders have not yet decided what to do with the casino and hotel.

Siegel Murder Clue Seen in Race Wire War

Benjamin (Bugsie) Siegel may have met death as the result of a tug-of-war between rival racing wire interests in the San Francisco Bay area, Chief Atty. Gen. Investigator Walter Lentz said here yesterday on his arrival from a clue search in the northern city.

Lentz confirmed reports that Siegel, who was murdered in Beverly Hills last June 20, issued a virtual ultimatum to users of race track wire reports only 10 days before his slaying. The racketeer, according to information given Lentz by a "reliable" underworld tipster, told the Bay area betting interests that they must take his service — "or else."

San Francisco Inquiry

Although Lentz interviewed in San Francisco the head of the rival wire service, with little positive results, the State's investigator declared that he still isn't convinced "my information isn't true."

Lentz said, "I have good reason to believe that Siegel talked to several people in San Francisco 10 days before he was killed, and instructed them to subscribe to his service." Maybe Lentz agreed, somebody objected to the ex-gangster's technique.

Another Denies It

Another San Franciscan supposedly contacted by Siegel, the operator of a chain of cigar stores, denied knowledge of the racketeer's asserted "or else" ultimatum, Lentz said. This interview also left Lentz unshaken in his latest lead on the Siegel murder.

Of "eight possible motives," ranging from love to dope peddling, the probability that Siegel was slain in such a race track wire service row is the "hottest," Lentz declared. He said he had also learned that Siegel sought to channel his racing "news" across San Francisco Bay into Contra Costa County.

Meantime Beverly Hills Police Chief C. H. Anderson, who earlier notified Paris authorities of a rumored assassination attempt against Miss Virginia Hill, Siegel's onetime girl friend, said he has received no acknowledgment of his air-mailed warning. He added that he has heard that the mysteriously wealthy divorcee had left her Paris hotel.

Allen Smiley Missing

Also among the temporarily missing was Allen Smiley, Siegel's intimate chum who sat beside him the night he was murdered in Miss Hill's mansion.

Smiley, too, has been "marked" for death, according to information received by Chief Anderson from an unidentified source.

The Beverly Hills police official said he personally isn't concerned with reports that Siegel's murder may have originated in a bookmaker-tipster dispute.

"We don't have any bookies here in Beverly Hills," he said. "Our investigation is proceeding along other lines."

Virginia Hill, Bugsy Siegel's former girl friend, checked out of her Paris hotel last July 3 and has not been heard from since.

That was the news reaching here yesterday from the French capital.

It came as Paris police were trying to find the thrice-married playgirl to tell her that she has been "marked for death" by the underworld for "knowing too much."

Virginia had been staying at the Westminster Hotel in Paris.

QUESTION—

Asked if she was alone when she left, the hotel manager was quoted as saying:

"That's not a very discreet question."

Miss Hill arrived in Paris only a few days before Bugsy was shot to death in the mansion she was renting in Beverly Hills.

With Siegel at the time was his pal, Allen Smiley, whose clothing was nicked by a couple of bullets. Now it is said that Smiley has been "earmarked" for death, too, and that he is in hiding.

Beverly Hills Chief of Police Clinton H. Anderson, who received the death tip on Virginia, says he does not think it is about Smiley.

He said Smiley was seen in Las Vegas on July 4 and, so far as Anderson knows, still is there.

HONEYMOON—

On their honeymoon yesterday were two other occupants of the death mansion, Charles Hill, 41, Virginia's brother and Verri Mason, 24, her secretary.

They were married in Las Vegas on Wednesday and left for Florida where Miss Hill, it is said, has ordered her home reopened.

After Virginia quarreled with Bugsy and departed for Paris, she was rumored to be interested in a "Frenchman."

Certain sources said the man in question was Nicholas Feuillatte, 21-year-old U. S. Army veteran, now said to be living at 4 Rue de Castiglione, Paris.

The reports were that Virginia had shipped her luggage in his care.

The Flamingo Hotel in Las Vegas, Nevada, formerly operated by the late Ben (Bugsy) Siegel, slain hoodlum, was sold last night.

The new owners are a syndicate of Las Vegas hotel owners and business men headed by Sanford D. Adler.

Adler is the owner of the Rosslyn Hotel in Los Angeles, the Del Mar Hotel at Del Mar, Calif., and the El Rancho Vegas at Las Vegas.

Heavy gambling losses sustained by Siegel at the hotel casino plus a disappointing revenue from the property in general are believed to have been contributing factors in his assassination in Beverly Hills.

The new owners take possession July 14.

The purchase price was about \$3,000,000. The hotel cost \$5,750,000. The real estate broker who handled the deal is Murray Randolph of Los Angeles. All former owners are not in on this deal.

The new men will seek, among other things, special airplane shuttle service free of charge, to oblige people from Los Angeles, San Francisco, Denver and other cities.

BUGSIE'S FLAMINGO SOLD TO HOTEL MAN

Adler of El Rancho Vegas Pays \$3,000,000
for Slain Gangster's Ornate Desert Club

LAS VEGAS (Nev.) July 12. (U.P.)—One of Benjamin (Bugsie) Siegel's rival hotel owners disclosed today he had bought the slain gangster's ornate Flamingo casino for \$3,000,000.

He is Sanford D. Adler, who by the deal became president both of the Flamingo and El Rancho Vegas.

The Flamingo reportedly had been losing money as fast as did the customers at its gaming tables. Siegel's need to make up the losses was believed to have contributed to his assassination June 20 in Beverly Hills.

Costing almost \$6,000,000 to build, the Flamingo had red-and-blue lighted bushes and a

green pond, rugs thicker than a dealer's bank roll and more mirrors than a crazy house. Behind a fountain in the lobby were \$7 to \$30 rooms frequented by movie stars who liked the custom-made beds—six inches wider and six inches longer.

Backing the desert colossus, besides Siegel, were Harry Rothberg, vice-president of the American Distilleries Co. of Peoria, Ill.; Billy Wilkerson, publisher of a movie trade journal, and Joe Ross, a Hollywood lawyer.

The Flamingo was sold by the Nevada Hotel Corp., acting through Murray Randolph, Los Angeles broker.

Siegel Death Warning by Virginia Hill Bared

As slain Bugsy Siegel's friend, Virginia Hill, was reported en route to New York from Paris last night, a warning she gave him in Las Vegas was reported.

Flying back with her, it was said, was Actor George Raft, lifelong friend of the gangster who was "rubbed out" in Miss Hill's Beverly Hills home last June 20.

She went to Paris two weeks before Siegel was slain; Raft left after the killing.

Miss Hill's warning was uttered as she lay in a Las Vegas hospital, just awakened from an apparently self-administered overdose of sleeping pills.

PREMONITION? —

For saving her life, Bugsy was offering the physician a new hospital wing, among other things, the account has it. Miss Hill interjected:

"Give him your hotel (the Flamingo); and let him turn it into a hospital. We'll both get

out of here before those guys kill you."

Activities of three men, associated with the Flamingo, on the day Bugsy was killed also are under investigation.

The men left Las Vegas by car about 5 p. m., after learning planes had been grounded. They were said to be in a great hurry.

Although key men at the hotel, none showed up there until 2 p. m. the next day.

Driving time from Las Vegas to Los Angeles is about five and a half hours. Bugsy was killed about 11 p. m.

[REDACTED] advised on 6/26/47 that Los Angeles County was again opened up on 6/25/47 for gambling and for what reasons informant did not know. This informant alleged that he had learned the gambling establishment which was being operated by [REDACTED] and which is being guarded by [REDACTED] and others, that BENJAMIN SIEGEL was very erratic in the manner that he was handling his employees at the Flamingo Hotel in Las Vegas. [REDACTED] told him that while he was in Las Vegas he heard other gamblers say that SIEGEL had been unfair in firing some of his employees there. On one occasion SIEGEL entered the kitchen of the Flamingo Hotel and fired an ex-GI who was shell-shocked and employed there merely as a favor, because he was only eating an orange. Bugsy was no gangster, says Virginia

NICE, France, July 17.—(AP)—Sultry Virginia Hill, blue-eyed, fast-talking girl friend of gangland's lately departed Benjamin (Bugsy) Siegel, said today that she accidentally took an overdose of sleeping pills last week because she was "worried and nervous."

Virginia, chatting gaily and sipping cognac at the edge of a swimming pool at plush Hotel La Reserve at nearby Beaulieu, said, however, that her worries weren't about the Los Angeles gunmen said to be on her trail.

"I'm hiding from sorrow, not killers," she said. "There are no gangsters on my track. Ben wasn't a gangster, either."

Virginia didn't appear sad. She laughed gaily, tossing her long auburn hair in the soft Riviera breeze throughout an hour-long interview.

Virginia said she was angry at Riviera police and officials at Villa Albert I clinic for saying she tried to commit suicide by taking a full vial of sleeping tablets.

"I was just worried and nervous, that's all," she said. "I took the tablets so I could sleep. I took too many, I guess."

Virginia said Bugsy had hoped to come to Europe with her, but that "he was too busy." If her sorrow was caused by Siegel's erasure in Los Angeles, she didn't show it. She was sun-tanned and apparently in good health. Two enormous gold bracelets and a heavy string of pearls set off a white suit with a navy blue blouse.

"All I want is to be left alone with my sorrows. What I seek most is solitude," she said, refilling her glass.

Adler, owner of El Rancho Vegas in Las Vegas, Del Mar Hotel in Del Mar, Calif., and the Rosslyn Hotel here, was to have advanced the syndicate the \$600,000 down payment on the \$3,000,000 purchase price, but only on condition that the new syndicate include none of the former stockholders.

Bugsy's girl defies killers

PARIS, July 16. (UP) - Red haired Virginia Hill, who attempted suicide rather than continue her flight from underworld killers, changed her mind today and defiantly announced that, "They can come ahead—they'll find me here."

Miss Hill, ex-girl friend of the murdered Benjamin (Bugsy) Siegel, told the Paris edition of the New York Herald Tribune by telephone that she was at the La Reserve Hotel in Beaulieu, on the French Riviera.

"I read in the paper that two men have come over here to shoot me," she said. "They can come ahead—they'll find me here."

Miss Hill felt differently not so long ago. Police at Nice disclosed yesterday that she swallowed a whole tube of sleeping tablets a week ago, and was saved only when servants found her in a serious condition and rushed her to a private clinic.

Although the police and hospital records listed the suicide attempt, a special nurse who answered the telephone when a call was placed for Miss Hill today denied it.

"She did not try to commit suicide," the nurse said. "She is merely sick from all those things newspapers are saying. You can understand that. I was called in by the doctor to take care of her. She is sleeping now and cannot be disturbed."

It was the second time that the shapely glamour girl had taken an overdose of sleeping tablets. The other time came immediately after she and Siegel quarreled in Las Vegas, Nev., where the former New York underworld character built a multi-million dollar casino, the Flamingo Club.

Miss Hill, who usually seemed to have a plentiful supply of 1000 bills from an unknown source, later left for France and was soon afterwards that Siegel on June 20—was shot to death in her home in Beverly Hills, Calif. The murder remains unsolved.

Beverly Hills Police Chief C. H. Anderson, however, reported that gangland assassins left for France early this month to kill Virginia.

She had been dating a wealthy Frenchman and making all of the night clubs, but when she heard that someone had put the finger on her, she quietly checked out of her Paris hotel and fled.

Miss Hill had professed to be little concerned with Siegel's fate, and declined to look at pictures of the gambler's bloody corpse.

After her latest encounter with too many sleeping tablets, she left her Monte Carlo hotel. A switchboard operator at the hotel La Reserve in nearby Beaulieu said she checked in there under an assumed name.

In her telephonic interview today, Miss Hill said:

"I am not hiding. I am sick. All on account of the awful things people say. I am down here just trying to get well."

She again complained of news stories about Siegel.

"He was one of the finest men I ever met, and he had the greatest respect for me," she said.

Referring to Siegel's death in her house, she said: "Why shouldn't he have a key? What's wrong with that? It was a big house."

Virginia Hill In Breakdown Over 'Bugsy' Siegel Death

By International News Service

NICE, France, July 16. — The fabulous Virginia Hill, reportedly marked for death by underworld "triggermen" because of her knowledge of the murdered Benjamin "Bugsy" Siegel's activities, denied today that she attempted suicide last week.

In a statement issued through her nurse, the attractive 30-year-old "mystery girl" — in whose Beverly Hills home, Siegel was slain June 30 — explained her hospitalization in Monaco.

Authorities revealed she had been found unconscious in her room July 8 at an exclusive Monte Carlo hotel. An emptied tube for sleeping medicine reportedly was found beside her, leading to the report that she had tried to take her own life.

Records at the Monaco hospital showed that Virginia had been treated for "intoxicating effects" of an overdose of a sleeping drug. The record said she was not in a comatose state when admitted, but was hysterical.

Virginia, however, said a nervous breakdown due to all the unfavorable publicity following the shocking news of Siegel's tempt,

"liquidation" — necessitated the hospitalization.

Following her release the day after being admitted to the hospital, the 30-year-old Virginia retired to semi-seclusion in the Reserve de Beaulieu, a luxurious Riviera hotel midway between Nice and Monte Carlo.

Virginia's nurse quoted the American oil heiress as saying:

"While in Paris I had a nervous breakdown because I loved Mr. Siegel so much. I decided to go to the Riviera because there were too many distractions in Paris.

"I arrived at the Monte Carlo Beach hotel and received reports of what was being said about me in America. Then I had another, and worse, breakdown and was rushed to the hospital."

The nurse, an English-speaking woman, said Virginia is depressed and spends hours without talking. She added that her patient does not fear gangsters who reportedly are trailing her, and has not asked French police for protection.

Monte Carlo police records show no entry of a suicide attempt.

Virginia Hill Denies Death Try Over 'Bugsy'

Frank admission that she deeply loved gangster Bugsy Siegel came yesterday from mysterious Virginia Hill in France.

But the thrice-married, sultry-eyed Virginia denied she had tried to end her life with sleeping tablets at Monte Carlo.

Wire dispatches from the Riviera said that Virginia explained her hospitalization in Monaco hospital in a statement released through an English-speaking nurse.

LOVED SIEGEL—

"While in Paris I had a nervous breakdown because I loved Mr. Siegel so much," she was quoted as saying.

"I decided to go to the Riviera because there were too many distractions in Paris."

(Bugsy was slain in Miss Hill's Beverly Hills mansion as he sat reading a newspaper on June 20).

"I arrived at the Monte

Carlo Beach Hotel," Virginia said, "and there I received reports that two men had come to France to shoot me.

"I had another and worse breakdown and was rushed to the hospital."

The nurse described Virginia as being "depressed" and said she spends hours "without talking."

"But, she does not fear the gangsters who reportedly are trailing her," the nurse declared. "She has not asked the French police for protection."

Monte Carlo police records, it was disclosed, show no entry of a suicide attempt.

Records at the hospital, however, revealed that Miss Hill was treated there for "intoxicating effects" of an overdose of a sleeping drug.

HYSTERICAL—

The record said she was not in a comatose state when admitted, but was hysterical.

Virginia tried to kill herself in Las Vegas before Siegel's murder. The attempt followed a bitter quarrel with Bugsy, who rushed her to the hospital.

Hospital attendants said that Bugsy learned from Virginia's own lips at that time that he was "marked for murder."

LET THEM COME, SAYS— VIRGINIA HILL, OF KILLERS

PARIS, July 16. (U.P.)—Virginia Hill, breathing defiance at the Los Angeles gunmen reported on the way to liquidate her as they did her boy friend Benjamin (Bugsie) Siegel, said in a telephone call from the Riviera: "I have read in the paper that two men have come here to shoot me. They can come ahead. They'll find me here."

Miss Hill made the call last night to the Paris edition of the New York Herald Tribune from the Hotel La Reserve at Beauveine.

She had disappeared from Paris two weeks ago, going to a beach hotel at Monte Carlo. It was a week ago today that the Los Angeles police announced that two anti-Siegel operatives had left for Paris to kill Miss Hill for knowing and talking too much.

The same day, according to Riviera police and the Villa Albert I Clinic, Miss Hill tried to kill herself by taking a full vial of sleeping tablets. She was taken to the clinic. Released two days later, she went to the Hotel La Reserve and registered under an assumed name.

In an interview at her hotel later Miss Hill said that she accidentally took an overdose of sleeping pills last week because she was "worried and nervous." She added, however, that her worries weren't about the Los Angeles gunmen said to be on her trail.

"I'm hiding from sorrow, not killers," she said. "There are no gangsters on my track. Ben wasn't a gangster, either."

Virginia said she was angry at Riviera police and officials at Villa Albert I Clinic for saying she tried to commit suicide by taking a full vial of sleeping tablets.

"I was just worried and nervous, that's all," she said. "I took the tablets so I could sleep. I took too many, I guess."

U.S. Tip on Gangsters Denied by Paris Police

Chicago Tribune Press Service

PARIS, July 16.—Both Charles Badin, underdirector of judiciary police at the Prefecture, and N. Bouriscot, chief of the national Surete police at the Ministry of the Interior, today denied to the Tribune that they had ever received any warning message from the Chief of Police of Beverly Hills, Cal., about gangsters being en route to France to slay Virginia Hill.

Prefecture officials opined that the Beverly Hills Police Chief announced gangsters were going to Europe to knock off Virginia solely to take public interest off their own inability to arrest

Bugsie Siegel's slayers and focus attention elsewhere.

The American Embassy here asserted that it had received no message from California police or sheriffs to be forwarded to the Prefecture.

(Beverly Hills Police Chief C. H. Anderson said that his department had sent an air mail letter "about a week ago" to the Prefecture of Police in Paris about Virginia Hill.

"We wanted to know whether she was in Paris on business and if so on what kind of business," he said. "As to the other thing the report that two gunmen had come to Paris to kill Miss Hill, we have heard all kinds of rumors, but we don't know anything authentic."

\$100,000 Paid 'Bugsy' by Rich Friend Probed

By Ray Richards

Los Angeles Examiner Washington Bureau

WASHINGTON, July 19.—Payment in 1937 of \$100,000 to Ben "Bugsy" Siegel, gangster, by Charles Ward, multi-millionaire president of a St. Paul calendar-making firm, has been placed under investigation as an aftermath of Siegel's recent gunshot death in California.

Letters showing the payment was made to Siegel in two installments have been scrutinized by Federal officers and turned over to the Los Angeles Police Department, it was learned.

The investigation has revived the remarkable story of the relations of Ward and Herbert H. Bigelow of the big Brown and Bigelow advertising specialty firm of St. Paul.

The two met in the early 1920's as fellow convicts in the Federal penitentiary at Leavenworth, Kan. Bigelow was doing time for income tax fraud, Ward for narcotics law violation.

When Ward was released, Bigelow sent him to a job with the firm. When Bigelow regained his freedom, he raised Ward rapidly to a high position in the company.

BIGELOW KILLED

In 1933 Bigelow and a woman companion were killed on a lake near Bigelow's North Woods hunting lodge.

The bodies were never recovered. Accidental drowning was the final official theory. But the capsized canoe was found with

perforations which some of the investigating officers insisted could have been made only by bullets, probably fired from a rifle on the shore.

Ward inherited \$1,000,000 from Bigelow and soon succeeded him as president of the firm, which last year did a \$21,000,000 business.

The letters to Siegel were found by Federal officers in the investigation of Brooklyn's "Murder, Inc.," of which Siegel was a member.

The first letter, bearing the signature "Charles Ward" and the date of October 14, 1937, on Brown and Bigelow letterhead, was addressed to the gangster at 328 South McCarty drive, Beverly Hills, Calif., shortly after Siegel had become West Coast representative of "Murder, Inc." The letter follows:

"Dear Ben: Enclosed find two Liberty bonds for \$20,000. Sorry I couldn't make it \$25,000, but as you know I am short of cash on account of my stock deals. Am lucky to have enough to eat on. Hope this will help."

SECOND LETTER

The second letter to Siegel at the same address was dated December 6, 1937, on the letterhead of the Midway National Bank of St. Paul and bore the signature of the bank's president, A. L. Ritt. It follows:

"Dear Mr. Siegel: At the request of Mr. Charles Ward we are enclosing our draft No. 7128 in the amount of \$80,000, drawn on the Guarantee Trust Company of New York, payable to yourself. Will you kindly acknowledge receipt and forward same in the enclosed envelope?"

Ward is quoted as explaining that the \$100,000 was repayment of a loan from Siegel.

When Siegel was tried at Los Angeles in 1940 for the killing of a "Murder, Inc.," gangster suspected of giving information to the law, he was asked if he had visited Ward at St. Paul at about the time of the Bigelow death. He denied it, and the line of questioning was not pursued.

Siegel's killers last month, and the reason for their act, remain unknown.

Ward's career has been widely publicized as one of the strangest in American big business. Born at Seattle 60 years ago, he crossed the Pacific many times as a seaman, was a flunky in an Alaskan saloon, and joined the revolutionary forces of Pancho Villa in Mexico.

In 1919 he was arrested for a narcotics law violation at El Paso and met his benefactor at Leavenworth as the result of that misadventure.

Owner of a big farm at Hudson, Wis., Ward was for several years a power in the Progressive Party of that state, and was referred to by some publications as political boss of St. Paul as well.

The Bureau has been previously advised of negotiations pending on the part of SANFORD D. ADLER and his associates whereby ADLER hoped to lease or purchase the Flamingo Hotel in Las Vegas, Nevada, after the death of BENJAMIN "BUGS" SIEGEL. These negotiations were being made on the behalf of SANFORD D. ADLER and SIEGEL's former associates in the Flamingo Hotel by MOR SEIDWAY, an associate of SIEGEL at Las Vegas, Nevada.

Members of the Eastern Criminal Syndicate, who were interested in the Flamingo Hotel with SIEGEL, were represented in the negotiation by MORRIS ROSEN, an official of the American Distillers Corporation and an associate of MEYER LANSKY and other members of the Eastern Criminal Syndicate.

On July 12, 1947, the Las Vegas Evening Review-Journal, Las Vegas, Nevada, announced the sale of the Flamingo Hotel by the Nevada Projects Corporation, the corporate legal owner of the Flamingo Hotel, to SANFORD D. ADLER and the latter's associates who were not named. The newspaper article reflected that the consideration paid by ADLER for the Flamingo Hotel was in excess of \$3,000,000.

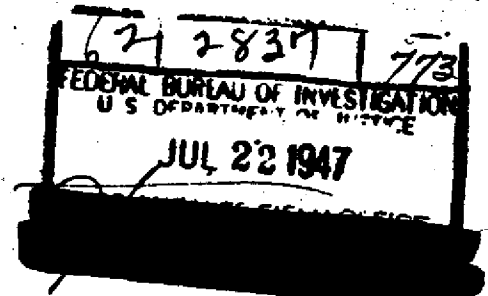

'Bugsy' Murder

Howser Sees Wire Service Motive

Gangland slaying of Benjamin "Bugsy" Siegel, gambling czar, probably was motivated because he "muscled his racetrack wire service into Nevada and was attempting to take over northern and Southern California."

This was the theory advanced today by Attorney General Fred N. Howser after he and other officials broke open Siegel's safety deposit vault box and found assorted men's jewelry and an insurance policy to the reputed gangster's mother.

Although the box yielded no clue to the murder, Howser said:

"We think we know who had the best motive. Either the director or the actual perpetrator of the shooting was a western man."

Investigations showed Siegel to be the representative of Trans-america Wire Service, the attorney general stated, adding that on June 13, seven days before Siegel's death, the wire service sent the following telegram to bookmakers it serviced:

"Due to circumstances beyond our control, we are compelled to discontinue our

business after the last race of June 14."

Howser intimated that this wire followed a direct threat to Siegel. A complete investigation of all racetrack wire services were called for by the circumstances, it was said.

BUGSY'S GIRL ATTEMPTS SUICIDE, FEARING GUNMEN

L. A. hoods stalk her in Europe

NICE, July 15.—(U.P.)—Virginia Hill, glamorous girl friend of late Benjamin (Bugsy) Siegel, tried to commit suicide by swallowing a tube of sleeping tablets, it was learned today from the record of the Villa Labert clinic in Monte Carlo.

It was reported that she was in hiding from two Los Angeles gunmen, supposedly seeking to kill her.

Police said the gunmen were sent here to liquidate her for knowing too much—and talking too much—regarding the murder of her gangster boy friend.

Miss Hill swallowed a full tube of sleeping tablets in the attempt, police said, but hotel employees found her in her room and she was sent to the Villa Albert clinic, where she recovered.

She was discharged from the clinic, operated by the Monte Carlo Hospital, last Friday, two days after the attempt, it was said.

Miss Hill had come to France the week before her boy friend Siegel was shot to death June 20 through a front window of her Beverly Hills home in which he was staying.

She talked freely in Paris of Siegel.

It was reported from Los Angeles last week that two gunmen had been sent to Paris to liquidate her, as they had rubbed out Siegel because she knew too much and talked too much.

Police believe that Miss Hill left her Paris hotel secretly and went to nearby Monte Carlo to hide.

The police and attendants at the Albert clinic indicated that her condition was serious when she was found but physicians managed to save her, they said.

Police said they believed that Miss Hill despaired of eluding the gunmen.

Los Angeles police had said that they notified the Surete Nationale, the French Scotland Yard, that the gunmen were en route. French authorities have denied that they received any such warning.

Reports have been published that Miss Hill tried to kill herself by taking sleeping tablets several weeks ago at Las Vegas, Nev., after a quarrel with Siegel at his white elephant gambling palace.

Monte Carlo police said Miss Hill never asked them for protection.

They reported that she checked out of her Monte Carlo hotel the day she left the clinic, leaving no forwarding address.

An employee of the Hotel Le Reserve in nearby Beaulieu said she checked in there the same day but that by agreement with the management she registered under an assumed name.

Before she sought seclusion on the Riviera, Miss Hill said Paris that she was on vacation when she heard of Bugsy's death. She last saw him during the first week in June in his Flamingo Casino in Las Vegas, she said, and they quarreled when she wouldn't let him eat dinner with "all those nice people" in "a dirty sport shirt."

"I 'phone goodbye from Chicago and said I was coming to Europe," she said. "He said goodbye and I never heard from him afterward."

Miss Hill said then she intended to be in Europe three months.

She also said she never had been very friendly with Bugsy—Ben, she called him—and they did not have mutual friends. She never knew, she said, that he was a gangster.

The house in which Bugsy was killed, she said, was not actually hers, but was lent to her by a friend.

Bugsy rubout scared fake money gang

Federal agents in San Francisco have seized plates used to print \$1,000,000 in counterfeit currency discovered in the Utah desert. Washington headquarters of the secret service said the plates were found in a repossessed automobile, and agents are hunting the defaulting buyer, whose identity they know.

Bugsy Siegel's gangland rubout here was credited today with thwarting a cleanout of Las Vegas gambling casinos by a \$1,000,000 counterfeit ring.

Discovery of a \$1,000,000 cache of phony \$10 bills near the Utah-Nevada line, led to the belief the money was abandoned when Siegel's death brought a swarm of police to Las Vegas.

Secret service men said the huge cache of bogus bills was found hidden in a culvert about 20 miles west of St. George, Utah, by a Los Angeles bus driver.

There were 16 bundles of the bills, each containing \$200,000.

Authorities said the bills were in an unfinished state, being in sheets of two bills each. However, they said they would have been easily passable after they had been cut and put through a coffee-grounds aging process.

J. H. Bracken, driver who found the cache, said he first noticed

one to the bills about three weeks ago, while making his weekly run between Los Angeles and St. George.

He saw the bill alongside the road, stopped and picked it up. The following week he saw two bills scurrying along the roadside before the wind.

Last Friday Bracken stopped his bus, got out and searched the area. He found the cache in a culvert beside the road.

He later walked into Las Vegas police headquarters and turned over a sack containing \$100,000 in the spurious money.

Chief of Detectives Ollie Stark of Las Vegas said, "It is quite possible that the heat generated from Bugsy's rubout may have delayed the operations of the counterfeiters."

He pointed out that the bundles may have been broken and a few bills scattered by a heavy wind in the Utah area shortly after Bugsy's murder.

F. C. Wasson, Los Angeles secret service agent, said a \$60,000 packet of the counterfeit money is being sent here for investigation.

The investigation will center in Salt Lake City, Utah, however, since the find was made within the Denver, Colo., federal district.

Because of Bugsy Siegel's connections in Las Vegas, where he operated the lavish Flamingo Club, the heat was on the gambling city during investigation of his death.

It was believed the counterfeit money was brought into the area by a national ring which intended to work a \$1,000,000 swindle on the Las Vegas clubs until the Siegel scandal scared them off.

Spurious Bills Link 'Bugsy' Rubout to Counterfeiting

The Los Angeles office of the Secret Service today was investigating the possibility that a cache of \$1,000,000 in counterfeit \$10 bills, found hidden in a tree near St. George, Utah, might be connected with the gangland slaying of Benjamin "Bugsy" Siegel.

Authorities in Las Vegas, Nev., advanced the theory that the bogus bills may have been abandoned by a counterfeiting ring because of the "heat" generated by Siegel's rubout.

The fake money was found by a Los Angeles truck driver, J. R. Bracken, who said he stopped to pick up one bill lodged in a tree and discovered 12 large bundles.

He turned over approximately \$100,000 in the counterfeit money to Las Vegas authorities. The rest of the bills were scattered over a 20-mile area by the wind. Sheriff's deputies recovered most of it.

Although Las Vegas police said they experimented with some of the bills and successfully passed them on six out of seven gambling casino cashiers in Las Vegas, the local Secret Service office said the bills were "crude and unfinished."

MR. ROSEN telephoned at 12:50 P.M. 7-1-47 regarding our letter setting out the interview with [REDACTED] b7c

MR. ROSEN pointed out that we obviously have no Federal violation and, therefore, no reason to enter the investigation. He does not want us to "stick our necks out" like we did in the NSPA case recently.

He asked how we know whether or not the local authorities are on the right trail or not, and I advised him that we know only from the newspapers and from [REDACTED] that they are investigating the fringes by talking to Hollywood celebrities, etc. and really don't have any concrete leads. ROSEN pointed out that if we give the information to the local authorities they will probably make their own trips to the East and will give considerable publicity to what they will do and whom they will interview. b7c

It was suggested to him that if he desires, we can have [REDACTED] give his information direct to some police agency and leave us out of it, and he said that the Bureau might so instruct and to stand by until he gives us definite instructions as to how to handle the information we are getting. b7c

It was reported that she was hiding from two Los Angeles gunmen, supposedly seeking to kill her.

According to the report, corroborated by the Monte Carlo police, the girl swallowed a full tube of powerful sleeping tablets in her room at the Monte Carlo Beach Hotel on July 9.

She was discovered by hotel employees and taken to the Villa Albert, a private clinic operated by the Monte Carlo Hospital.

There doctors managed to save her and she was released July 11.

Clinic employees said they believed that the former night club entertainer had despaired of eluding two gunmen who Los Angeles police said last week had left for France to kill her.

Los Angeles police said they had informed French police, but authorities here denied they received any such word.
