[REDACTED] In this connection, [REDACTED] Agent in Charge of the Local Office of the Immigration and Naturalization Service, Professional Building, Miami, Florida, was contacted, and he advised that there is practically no way to check individuals to and from Havana if they are citizens. No passports are necessary and if a person is actually a citizen and returns to this country using an assumed name, there is no offense committed for which he could be held. [REDACTED] stated his office would cooperate to the fullest extent and that if photographs were furnished to him, they would be placed with the officials at the airport and steamship depots so that a lookout could be kept for SIEGEL and he could be thoroughly questioned upon arrival in this country. It was suggested by [REDACTED] that Customs officials could be contacted and arrangements be made to thoroughly search SIEGEL if he were discovered entering this country regardless of what name he might use. If SIEGEL comes to this area it was planned to request the Customs officials to be on the lookout for him.



Reference is made to your letter dated January 13, 1947, in the above-captioned matter calling my attention to the fact that in my teletype of December 24, 1946, I advised that technical surveillances were installed on LD Lines 1, 2, 3, and 4, Las Vegas Turf Club, telephone 7070, located on the second floor of the Las Vegas Club, 23 East Fremont Street at 2:00 PM on that date and that the same symbol numbers were utilized for those technical surveillances that were formerly used on similar installations in July, 1946, at which times the telephone numbers were listed as Las Vegas 2460, for LD Line 1; Las Vegas 2283 for LD Line 2; and Las Vegas 2284 for LD Line 3.

On December 24, 1946, technical surveillances were installed on the same four LD Lines at the Las Vegas Turf Club that were previously covered by technical surveillances in July, 1946. Hence, the same symbol numbers were used in December, 1946.

In addition to the four LD Lines, the Las Vegas Turf Club, located upstairs over the Las Vegas Club, has three local lines. The local lines are numbered 2283 (which is the listed telephone number of the Las Vegas Turf Club), 2284, and 2460. The latter two numbers are unlisted. At no time were technical surveillances installed by this office on any of the three local lines numbered 2283, 2284, and 2460.

The telephone number 2442, listed for the Las Vegas Club in the Las Vegas, Nevada telephone directory, is located downstairs in the Las Vegas Club proper (the gambling casino) and has no connection with the upstairs Las Vegas Turf Club, which is a suite of rooms located on the second floor whose business is to handle bets on horse races, and other sporting events, which bets are made by telephone and are received from all over the United States. Therefore, telephone number 2442 had no connection with any technical surveillances maintained by this office.

When the original technical surveillances were installed on the four LD Lines in the Las Vegas Turf Club in July, 1946, [redacted] advised that there were no numbers for these LD Lines [redacted]

Activities of Jack Dragna

The following information was furnished by [redacted] unless otherwise indicated.

Informant advised that Trans-American News Service, of which JACK DRAGNA is the head in Los Angeles, has been operating at a loss of approximately \$300.00 a week and because of this DRAGNA has been in constant contact with [redacted] regarding this matter and also concerning the operation of a track crew at Santa Anita Race Track. Informant continued that DRAGNA has also been in contact with [redacted]

[redacted] is presently staying at the Chateau Marmont Apartments and occupies the penthouse suite formerly occupied by BENJAMIN "BUGS" SINGEL and VIRGINIA HILL. According to the informant, this rental was arranged for [redacted]

Details concerning this loan were furnished the Bureau in the report of Special Agent [redacted] dated January 17, 1947 at Los Angeles and captioned: "BENJAMIN 'BUGS' SINGEL, with aliases".

Informant further advised that an individual referred to by DRAGNA [redacted] is presently in Los Angeles and has been in contact with DRAGNA [redacted]

During the period covered by this report arrangements were completed by DRAGNA for the reinstallation of a lookout at Santa Anita Race Track and on January 25, 1947 this service to subscribers of Trans-American was commenced. On January 24, 1947 DRAGNA contacted [redacted] and advised him that the house at the track was ready and that they would be able to obtain it for \$350.00 a week. DRAGNA stated that "I got the fix over there with the local people so they won't bother them". Also on January 24, 1947 DRAGNA contacted an individual by the name [redacted] (Phonetic), whereupon [redacted] advised that he had obtained 65 feet of wire and had placed it in the house and also had the glasses available. [redacted] referred to the house as the "old standby". He told DRAGNA that he was going to put two fellows in the house and that one man will work on the inside of the track signaling to the house. Informant advised that due to the arrest recently of members of the track crew at Santa Anita DRAGNA contemplates using a different person in the In-field daily. Informant stated that DRAGNA also is not contemplating further arrests in view of the fact that he has "fixed things with the D.A.'s Office and an Arcadia policeman".

In connection with the "fix" DRAGNA on January 23, 1947 contacted [redacted] in Chicago and advised him that they had a house in Arcadia and that the District Attorney's Office of Los Angeles County as well as the city policemen in Arcadia would no longer bother them. SIEGEL threatened to kill [REDACTED] the El Rancho Hotel, and to burn the latter down if he, SIEGEL, heard any more such remarks. He informed [REDACTED] that he had built the Flamingo "for Las Vegas," that he was here to stay and nobody was going to interfere with him. SIEGEL further told [REDACTED] to go look at "that man of yours [REDACTED] I just gave him 50 stitches."

[REDACTED] advised on December 19, 1946 that a representative of the Western Union Telegraph Company at Las Vegas, Nevada contacted an unknown person at the Flamingo Hotel and stated that a telegram had been received from [REDACTED] New York City, directed to [REDACTED] Flamingo Hotel, advising "Four met. Leaving today".

The New York City Office was requested by teletype to contact the Immigration and Naturalization Service and attempt to ascertain if a ship arrived recently with four persons of Italian citizenship aboard, sponsored by subject, [REDACTED] or the Flamingo Hotel, whose destination was Las Vegas. The Philadelphia Office was requested to conduct a similar inquiry at the Headquarters of Immigration and Naturalization Service at Philadelphia.

By teletype dated December 27, 1946, the Philadelphia Office advised that [REDACTED] Exemptions and Record Amendment Unit in Charge of Foreign Contract Labor or Immigration and Naturalization Service, Philadelphia, was unable to locate the letter addressed to the Immigration and Naturalization Service by the Las Vegas Chamber of Commerce and

that he was further unable to locate or identify information relative to the entrance of four unknown Italians at New York City.

By teletype dated January 6, 1947, the New York Office advised that all ships arriving from a European port between December 18 and 19, 1946 were checked without locating a record of four persons of Italian citizenship.

[REDACTED] stated that subject and [REDACTED] made elaborate plans for the formal opening of the Flamingo Casino and restaurant on December 26, 1946, which plans included the bringing of a number of prominent Hollywood movie celebrities to Las Vegas by a privately chartered Lockheed Constellation airplane and by chartering a special all-Pullman Union Pacific train for southern California residents who desired to attend the opening. Informants advised subsequently from time to time that subject and his co-owners of the Flamingo encountered a great deal of difficulty in persuading celebrities and patrons to attend the opening, with the result that the special train had to be canceled due to the fact that, [REDACTED] not one request for reservation was received.

Among the movie celebrities scheduled to attend the opening was GEORGE RAFT, whose presence at the opening was compelled by subject. [REDACTED]

The formal opening of the casino and dining room was held as scheduled on December 26, 1946, and among the celebrities present were [REDACTED] Los Angeles, GEORGE RAFT, and a few persons of lesser importance. In order to fill the dining room, subject extended invitations for complimentary dinners to all local, county, and state officials, many of whom declined by telegram and telephone.

A second opening night was held on December 28, 1946, at which time a larger number of movie celebrities were present. Among these were VERONICA LAKE, LUCILLE BALL, GEORGE RAFT, SONNY TUFTS, ELEANOR PARKER, BILL HOLDEN, BRIAN DONLEVY, JUNE HAVER, and BRIAN ARNOLD.

During the opening nights, SIEGEL assumed the responsibility of handling all arrangements and greeting the patrons. [REDACTED] were relegated to the background. The casino patronage was large but not lucrative, and opinions were expressed by Las Vegas residents that the operation of the Flamingo Hotel could not continue successfully because it was too large, too elaborate, and too expensive for Las Vegas. The casino was dominated by the presence, as employees of the casino, of local gambling figures of questionable or known bad reputations. Among these individuals were [REDACTED]

Pursuant to an announcement by the Army Air Corps that unless commercial airlines were removed from McCarran Field, Las Vegas, the Las Vegas Army Air Field would be deactivated. Clark County officials delegated a local committee to select a site for a new commercial air field and to spend one-half million dollars, in addition to Federal funds, to construct or improve a commercial field. [REDACTED]

[REDACTED] was designated chairman of the Airport Committee. SIEGEL immediately approached [REDACTED] for the purpose of attempting to persuade [REDACTED] to locate the commercial airport at the Alamo Airport located approximately one mile from the Flamingo Hotel on the Las Vegas-Los Angeles highway.

[REDACTED] advised on December 23, 1946 that [REDACTED] telephonically contacted subject and stated that the committee had approved the use of the Alamo Airport and that these plans were acceptable to the Army. Informant stated that the use of the Alamo Airport by the commercial airlines at Las Vegas would materially benefit SIEGEL and the Flamingo Hotel.

Due to the pressure of business and financial loss at the Flamingo, SIEGEL was forced to take a ten-day vacation in January, 1947, which he spent at Palm Springs, California, with his mistress, VIRGINIA HILL. During this time, the casino was operated by [REDACTED] of Los Angeles, who were sent to Las Vegas by SIEGEL to work and look after SIEGEL'S interests.

RACE WIRE SERVICE

In addition to SIEGEL'S activities in completing, opening, and operating the Flamingo Hotel during the period covered by this investigation, SIEGEL was also active in promoting the distribution of race wire service by the Trans-American Publishing and News Service, Inc., the new nation-wide wire service operated by the criminal syndicate in competition with the Continental Press. SIEGEL devoted little actual time to the promotion of this race wire service, however, delegating most of these functions to MOE SEDWAY an associate and employee respectively in the race wire service and race books operating in Las Vegas.

Details as to the plans and steps actually taken by subject in bringing the Trans-American Wire Service to Las Vegas and the actual cutting off of service furnished by the Continental Press in Las Vegas to various Las Vegas race books were reported in the matter entitled "REACTIVATION OF THE CAPORE GANG", Chicago origin.

\_\_\_\_\_ stated that as of 8:00 AM December 9, 1946, SIEGEL and MOE SEDWAY terminated their use of the Continental Press

Service at all race books in Las Vegas and "cut in" the new Trans-American Service furnished to their distribution center in offices located on the second floor of the Golden Nugget Gambling Hall. In addition to the race books previously existing at the Las Vegas Club, the Frontier Club, the Golden Nugget Gambling Hall, the Boulder Club, the Savoy Club, and the Eldorado Club, SIEGEL and SEINWAY furnished wire service on the same date to the Monte Carlo Casino and opened negotiations with the Hotel El Rancho Vegas and Hotel Last Frontier for the operation of race books. The contemplated race books in the two hotels have not as yet materialized.

At the present time, SIEGEL is furnishing all race wire service to race books operating in the Las Vegas area through his use of Trans-American Wire Service, and Continental Press has no local outlets.

On December 22, 1946, [redacted] stated that he was present when [redacted] telephonically contacted subject from Reno, Nevada, and inquired about the availability of Trans-American Wire Service to Reno. [redacted] stated that a friend of his wanted to own a race book at the Frontier Club in Reno. SIEGEL stated that [redacted] was to come to Las Vegas after January 1, 1947, for the purpose of talking to SIEGEL about installing Trans-American Service in Reno. SIEGEL advised [redacted] that "my outfit is direct to all tracks and the service is good."

Informant stated that SIEGEL was also contacted by a member of the DEL E. WEBB Construction Company in Phoenix, Arizona, who advised SIEGEL that a former Portland, Oregon newspaperman was attempting to obtain competitive news service in Portland and that [redacted] desired SIEGEL'S assistance in prohibiting this competition and in obtaining the Trans-American outlet at Portland for [redacted] is presently using Continental Press Service and serves as distributor for Continental Press Service in the Portland area.
