SAC, New York has been advised by Immigration and Naturalization Service that Carlo Gambino "boss" of New York La Cosa Nostra "family" was examined this morning, 11/5/71, by three Public Health Service physicians, two cardiologists and one intern to determine his physical condition in connection with his deportation which was ordered for today. Physicians report Gambino cannot travel and there is the possibility that he may not be able to leave the hospital alive. His health condition is deteriorating with no chance of improvement. His stay of deportation for which he applied 11/2/71 has been granted. For information.

CARLO CAMPINO continues to maintain residences at 123 Ocean Parkway, Brooklyn, New York, and 34 Club Drive, Massapequa, New York.

On November 2, 1971, HARGIS GRANT, Deportation Section, Immigration and Naturalization Service (INS), New York, New York, advised that CAMPINO was served with a notice to surrender for deportation at 9 a.m., Friday, November 5, 1971, at 100 West Broadway, New York City.

On November 3, 1971, HAROLD GRACE, Deportation Section, INS, New York, New York, advised subject's attorney, STANLEY ZWAIK, that subject's physician, (presently in Europe), filed a stay of deportation for the subject due to ill health. Subject was scheduled to appear on November 3, 1971, for physical examination at the Public Health Service, Staten Island, to determine his ability to travel.

He also advised that subject's physician, Dr. JOSEPH FLORES, advised that subject is unable to report to the Public Health Service due to a heart attack and was admitted to Victory Memorial Hospital, Brooklyn, New York, on the morning of November 3, 1971.

On November 3, 1971, HAROLD GRACE, Deportation Section, INS, New York, New York, advised subject's attorney and physician that subject is unable to appear for examination by a Public Health Service physician on the morning of November 4, 1971, at the Public Health Service, Staten Island. The Public Health Service cardiologist requested to examine subject without the presence of subject's attorney. INS investigator obtained written authorization for subject's attorney, subject's lawyer, physician and the Victory Memorial Hospital.

Subject's attorney, ZWAIK, advised GRACE that the subject did not have a heart attack, but did suffer a "coronary artery disease" with which he has to live.

On November 4, 1971, HAROLD GRACE, Deportation Section, INS, New York, New York, advised that at approximately noon, that date, attorney JACK WASSERMAN filed a temporary restraining order at the District Court, Washington, D.C., concerning the subject's deportation. Federal Judge in Washington granted the subject a six hour stay of deportation after the District Director of INS makes his decision to deport the subject with the further stipulation that any further court action on the subject's part must take place and/or be presented at the Federal District Court, Southern District of New York (SDNY).

He also stated that three Public Health Service physicians were conducting a physical examination of the subject at Victory Memorial Hospital, Brooklyn, New York. Their findings had not yet been made known to INS.



Don Carlo: There's More Than Meets the Eye

GAMBINI, Carlo, alias Don Carlo, Carlo Gambino, FBI No. 324432, NYID No. 12-120, records from 1933 include larceny and violation of liquor and immigration laws, reputed to be the most powerful Mafia leader in the U.S.

Gambino's name is prominent in the files of federal, state and local law enforcement agencies, and has been linked to the full story of the rise of the Mafia in New York City, business executive and Mafia boss.

The Federal Bureau of Investigation has conducted a long and intensive investigation of Gambino, and has been successful in identifying him as a major figure in the Mafia. He has been linked to a wide range of criminal activities, including racketeering, gambling, and the distribution of narcotics.

Still silent partner

He still is a silent partner in these and other businesses—construction, real estate, imported cheeses and olive oil, meat products, fat rendering, paper products, garbage hauling, and so on. Many of his firms employ Italian aliens who entered the U.S. by jumping ship, just as Don Carlo did a half-century ago.

Gambino also is a labor consultant. He formerly was a partner in S.G.S. Associates, a labor relations firm whose clients included several major business and industrial companies. One client said a contract with S.G.S. was "a virtual guarantee that there would be no strikes or other labor trouble."

S.G.S. (the "G" stood for Gambino; his partners were Henry Saltzstein, a convicted burglar and bookie, and George Schiller) folded in the heat of investigations by the FBI, two federal grand juries and other probers.

Gambino works both sides of the labor street, squeezing money from employers, unions and workers. His men have infiltrated and taken over several union locals.

During an investigation of mob activities in New York locals of the Mason Tenders' Union, electronic eavesdroppers recorded a conversation between Michael Scandifia, Peter (Petey Pumps) Ferrara and Accursion (Cus) Marinelli. Scandifia and Ferrara are both captains in the Gambino crime family; Marinelli is a soldier in the same group.

They discussed a meeting of their gang leaders, respectfully called "the administration," at which it was decided that a shop steward called Tommy should be made assistant business representative of Mason Tender Local 47.

Marinelli: "Who was present?"

Ferrara: "Joe Riccobono, Carlo (Gambino), Carmine (Lombardozzi), Joe Bandi and myself and Joe Zingara. They made it up, the Administration, that Tommy is to be the next delegate."

How one thing leads to another in Don Carlo's conglomerate was described during the State Investigation Commission's 1969 hearings on criminal infiltration of honest businesses.

Witnesses testified that the Gambino clan moved into the cutlery-grinding trade a few years ago and cost members of the New York Grinders Association nearly \$650,000.

Association officers said they lost 2,000 customers and \$474,000 worth of business in three years to a new grinding outfit headed by Paolo Gambino. Not surprisingly, many of the customers who switched to the Gambino service were store owners who had been buying meats and other products from Gambino-controlled firms.

Paolo finally offered to get out of the grinding game for \$300,000. The association said this was too much, so he settled for \$175,000.

Don Carlo's more shadowy enterprises include bookmaking, shylocking, extortion, hijacking and all the underworld operations on the New York waterfront and Kennedy Airport. Investigators believe he has been deeply involved in the smuggling of aliens and narcotics.

Gambino was the last Mafia boss to collect monthly "dues" from his followers. Each of the estimated 1,000 members and associate members of his crime family kicked in \$25 a month to the chief until this traditional levy was discontinued four or five years ago.

Don Carlo does not flaunt his wealth. His comfortable homes in Brooklyn and Long Island are not the most expensive in their neighborhoods. But people familiar with his operations say he could raise \$10 million cash on a few hours' notice.

A model husband

Unlike most other Mafia dons, he never hung out in nightclubs or dallied with sexy showgirls. He never had a mistress. He was always a devoted husband and father, the kind who carries snapshots of the kids around in his wallet.

Friendly, soft-spoken, with considerable Old World charm, he got along well with his Mafia superiors and underlings alike. This is why he has lasted so long. From his earliest days in Brooklyn, he made friends and influenced people in as many mobs as possible.

These contacts helped him gain control of the underworld and even saved his life.

Gambino's steady climb to the mob's top command accelerated in the 1950s, starting with the sudden demise of his bosses, Philip and Vincent Mangano.

Phil was shot three times in the head and dumped in the Bergen Beach marshes near Jamaica Bay on April 19, 1951. When Vince failed to attend his brother's funeral, there was speculation that he had gone the same way. He was never seen again. According to one unconfirmed report, he was shot and buried in the wet cement of a Brooklyn housing project's foundation.

Giuseppe Antonio Doto, better known as Joe Adonis, took over the Mangano gang but left the country in 1950 to avoid a prison term. He was succeeded by Albert Anastasia, called the Mad Hatter because he had put so many bullet holes in the hats—and heads—of his friends and foes.

Carlo Gambino now became underboss, only one step away from the mob leadership. He took that step less than a year after Joe Adonis sailed home to Italy.

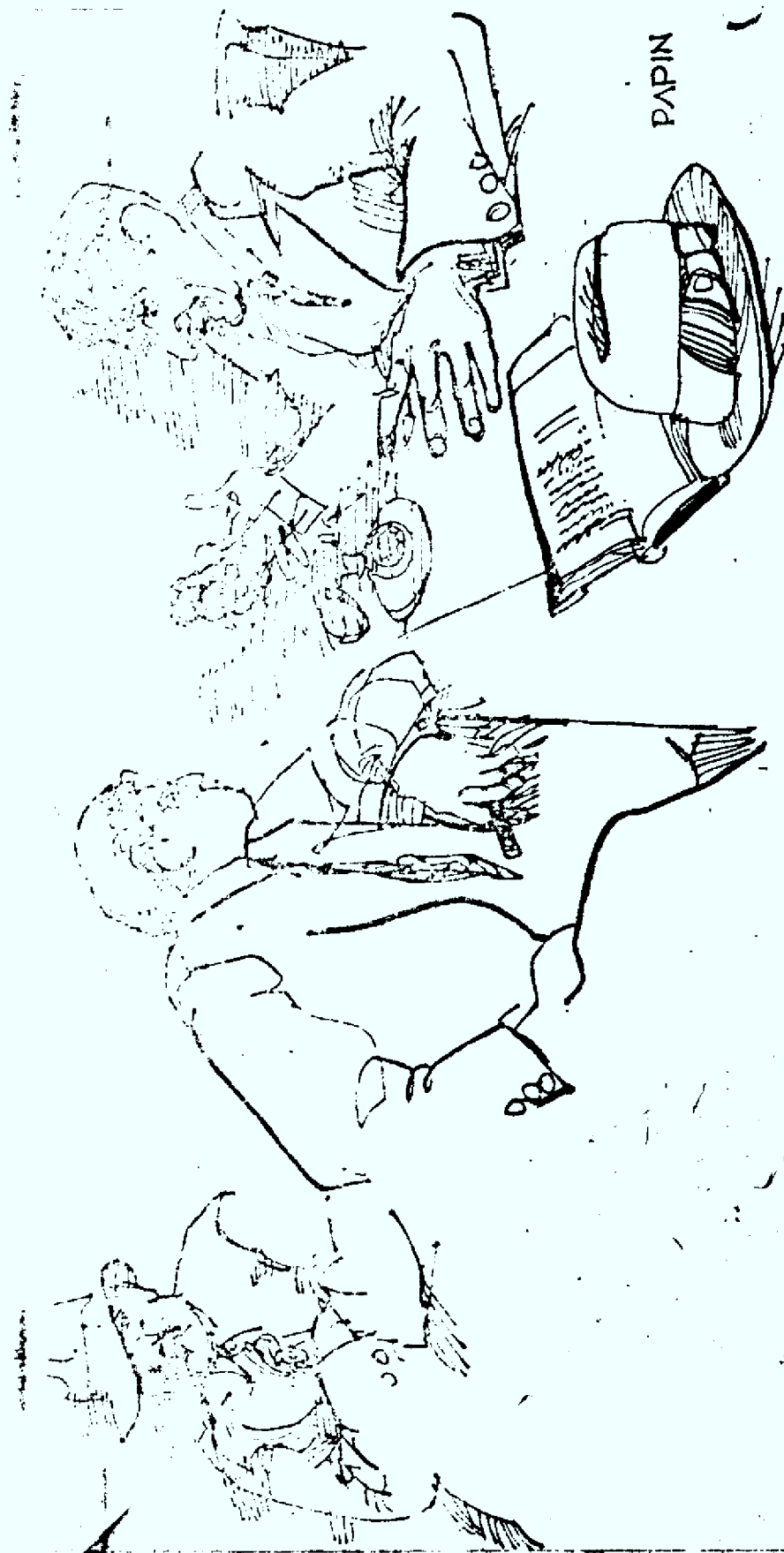

II. Subject's Status with Immigration
and Naturalization Service (INS)

On April 5, 1973, the following information was received from the Office of INS, New York City:

On March 21, 1973, a joint plan was finalized between this Office, ~~EDWARD J. ENNIS~~, Attorney in Charge, Joint Strike Force, and ~~STANLEY M. ZWAIK~~, Special Assistant United States Attorney, whereby the objectives were to be undertaken with respect to the subject. Firstly, the outstanding bond posted in his behalf by the Public Service Mutual Insurance Company on March 12, 1965, in the amount of \$10,000.00 would be cancelled. Secondly, that the subject be placed under an Order of Supervision pursuant to the provisions of Section 242 (a).

In addition to the standard written conditions contained in an Order of Supervision, it was determined that the alien shall not travel outside the Eastern District of New York for a period in excess of 48 hours without first having notified the Service of the dates and places of each proposed travel. Further, that the subject report in person to the Deportation Section on the first and third day of each month commencing April 6, 1973.

The same date an appointment letter was prepared requiring his appearance on Wednesday, March 28, 1973, at 9:00 am, for an interview regarding cancellation of the outstanding bond and to be placed under an Order of Supervision. At 4:25 pm, March 21, 1973, the subject was served with the letter in person by Criminal Investigators [redacted] and [redacted] upon his arrival by car at his residence in Brooklyn. On Thursday, March 22, 1973, the subject's Attorney, ~~EDWARD J. ENNIS~~, was served with a copy of the letter at his office by Criminal Investigators [redacted] and [redacted] at 10:30 am.

On March 28, 1973, at 9:00 am, the subject, accompanied by his son, TOMMY GAMBINO, ~~EDWARD J. ENNIS~~ and Attorney STANLEY M. ZWAIK, an associate of Attorney ENNIS, appeared in the Deportation Section in response to the appointment letter. The Deportation Officer opened the interview by advising that the delivery bond would be cancelled and surety notified of such. Attorney ENNIS was then given the original of the Order of Supervision and asked that he read and explain the contents to his client. No objection or

question was raised until they reached the portion which contained the travel restriction, at which time Attorney ENNIS asked for and received assurance that the subject's home in Massapequa Park, Long Island, was within the defined area. Attorney ENNIS next commented on the undue stringency of his client being required to report so often. They offered no further comment when it was explained to them that in some instances daily or weekly appearances are required. Mr. ENNIS next asked what should be done in event his client was ill and could not appear. They were advised that in such case telephonic notification should be given to the Deportation Section, followed immediately with written confirmation from the subject's physician.

The next issue that arose concerned the subject having to report on Friday. Attorney ENNIS and TOMMY GAMBINO explained that it was his practice to travel to his home in Long Island on Thursdays and remain over the weekend. Therefore, travel into the city on Friday would create a hardship in view of the subject's need to remain quiet as much as possible. They suggested that perhaps the date could be changed to Wednesday. They were advised that a written request, which would be given consideration. At this time, Attorney ENNIS asked his client to sign the Order of Supervision in duplicate and he complied.

Immediately thereafter, the subject was given an appointment letter informing that on Friday, April 6, 1973, pursuant to the Order of Supervisor, he would be required to give information under oath, as to his nationality, circumstances, habits, associations and activities, and such other information relating to his availability for deportation. Attorney ENNIS was furnished a copy of the appointment letter.

On March 23, 1973, a letter was received from Attorney ENNIS requesting that the date be changed to Wednesday instead of Friday beginning April 4, 1973, if possible, or after he reports on April 6, 1973, then beginning on April 18, 1973. I quote a portion of this correspondence, "he habitually leaves his home on Ocean Parkway in Brooklyn on Thursday and remains at his home in Massapequa Park, Long Island, until Sunday or Monday. Because of his precarious health, disclosed by your records, he is under medical orders to remain completely quiet at all times and it is beneficial to his health to spend long weekends, and in the summer, longer periods at his home in Massapequa Park".

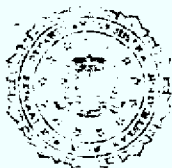

Carlo Gambino

On January 8, 1974, Edward M. Shaw, Attorney in Charge, Strike Force, Southern District of New York (SDNY), advised that in consideration of the poor health of Carlo Gambino, the prosecution of his Interstate Transportation of Stolen Property-Conspiracy matter is being held in abeyance pending the outcome of the Immigration and Naturalization Service (INS) deportation proceedings against him.

On the same date, [REDACTED] INS, Strike Force, representative, SDNY, advised that the deportation proceedings against Gambino are being pursued by [REDACTED] organization.

However, Gambino is fighting the action on several counts, one of which is poor health. Additionally, Italy has not yet indicated whether they will grant Gambino a Travel Document should deportation proceedings against him succeed. In view of this, [REDACTED] was unable to estimate how long it would take to conclude this matter.

This document contains neither recommendations nor conclusions of the Federal Bureau of Investigation (FBI). It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.
