ago. Gambino also is a labor consultant. He formerly was a partner in S.G.S. Associates, a labor relations firm whose clients included several major business and industrial companies. One client said a contract with S.G.S. was "a virtual guarantee that there would be no strikes or other labor trouble."

S.G.S. (the "G" stood for Gambino; his partners were Henry Saltzstein, a convicted burglar and book-ic, and George Schiller) folded in the heat of inestigations by the FBI, two federal grand juries and other probers.

Gambino works both sides of the labor street. squeezing money from employers, unions and workers. His men have infiltrated and taken over several union locals.

During an investigation of mob activities in New York locals of the Mason Tenders' Union, electronic eavesdroppers recorded a conversation between Michael Scandifia, Peter (Petey Pumps) Ferrara and Accursion (Cus) Marinelli, Scandifia and Ferrara are both captains in the Gambino crime family, Marmelli is a soldier in the same group.

They discussed a meeting of their gang leaders, respectfully called "the administration," at which it was decided that a shop steward called Tommy should he made assistant business representative of Mason

Tender Local 47, Marinelli: "Who was present?"

Ferrara: "Jee Riccobono, Carlo (Gambino), Carmine (Lombardozzi), Joe Bandi and myself and Joe Zingara. They made it up, the Administration, that Tommy is to be the next delegate."

How one thing leads to another in Don Carlo's conglomerate was described during the State Investigation Commission's 1969 hearings on criminal infiltration of honest businesses.

Witnesses testified that the Gambino clan moved into the cutlery-grinding trade a few years ago and cost mambers of the New York Grinders Association nearly \$650,000.

Association officers said they lost 2,000 customers: 17 and \$474.000 worth of business in three years to a new grinding outfit headed by Paolo Gambino, Not surprisingly, many of the customers who switched to the Gambino service were store owners. who had been buying meats and other products from; Gambine-controlled firms.

Paolo finally offered to get out of the grinding game for \$300,000. The association said this was too much, so he settled for \$175,000.

Don Carlo's more shadowy enterprises include beokmaking, shylocking, extortion, hijacking and all the underworld operations on the New York waterfront and Kennedy Airport. Investigators believe he has been deeply involved in the smuggling of sliens and narcotics.

Gambino was the last Mafia boss to collect month-ly "dues" from his followers. Each of the estimated 1,000 members and associate members of his crime family kicked in \$25 a month to the chief with this traditional levy was discontinued four or eve
