

ON JANUARY FOURTEEN INSTANT, A REPRESENTATIVE OF THE ONE HUNDRED FIFTEENTH MILITARY INTELLIGENCE GROUP, FORT LAWTON, WASHINGTON, REPORTED ABOUT THIRTY HIPPIE-TYPE INDIVIDUALS, SOME OF WHOM WERE CARRYING PICKET SIGNS, APPEARED AT MAIN GATE OF FORT LEWIS, WASHINGTON. THEY WERE REFUSED AND TOLD TO DISPERSE.

SOME OF THE SIGNS INDICATED THE GROUP REPRESENTED THE UNITED THEY URGED THAT "SCAB" LETTUCE BE REMOVED FROM THE MESS HALLS. FOLLOWING THEIR FAILURE TO DISPERSE, DEMONSTRATORS WERE TEMPORARILY DETAINED BY MILITARY POLICE FOR IDENTIFICATION PURPOSES. NAMES AND IDENTIFYING DATA NOT AVAILABLE AT TIME OF THIS COMMUNICATION.



On January 13, 1971, a source reported the United Farm Workers (UFW) have scheduled a demonstration at Fort Lewis, Washington, on January 14, 1971. Interested persons were to meet at the Lucky Food Store in Southcenter, the University YMCA near the University of Washington, both Seattle, or at Tacoma, Washington, and proceed to Fort Lewis.

The source said the demonstration is a continuation of a program to protest the sale or use of lettuce picked by persons other than members of the UFW. The UFW has been attempting to organize farm laborers and to get a better wage for them. No violence in connection with the demonstration was proposed and no violence had been experienced in previous demonstrations against various food store chains in the recent past.

On January 15, 1971, the "Seattle Post-Intelligencer," a daily newspaper published at Seattle, Washington, reported approximately 60 members of the UFW were turned back by military police at Fort Lewis when they attempted to demonstrate against "scab lettuce" on that Army base the previous day. The article indicated the demonstrators arrived at the main gate of Fort Lewis in automobiles displaying signs condemning Army use of lettuce picked by non-union labor.

Spokesmen of the group said they wanted to see Major General WILLARD PEARSON, Commanding General, or the base purchasing officer to protest against the use of "scab lettuce."

Gate sentries told them they would not be admitted to the base and asked them to leave. About 30 left but those who did not leave were given letters of expulsion. The article indicated that if the expulsion letters were not obeyed, offenders could be arrested and charged before a U.S. Magistrate.

On January 15, 1971, the 115th Military Intelligence Group at Fort Lewis reported 30 individuals who had refused to leave the main gate area at Fort Lewis were taken into custody, escorted to the military police station, and 26 were issued letters of expulsion. One individual, FRANCIS STONE GOODROW, who had been given a letter of expulsion on June 14, 1970 for disrupting a service in the Fort Lewis main chapel, was confined in the Tacoma City Jail on January 14, 1971 pending appearance before a U. S. Commissioner on a charge of trespassing. Three individuals, LEE C. HARSHBERGER, CHRIS G. GREIMES, and RODGER C. GREIMES, were found to be juveniles and were escorted off the post.

Two persons we're arrested in the Overseas Replacement Station area at Fort Lewis on a charge of unauthorized distribution of dissident literature. Both persons were given letters of expulsion. Each had about 250 copies of a leaflet captioned "Military Largest Buyer of Scab Lettuce." The organizations who had distributed the leaflets according to printing on them were the UFW and the GI-Airman-Seaman Coalition, a group which had been trying to create dissension among the military forces in the area.

A. DETERMAN,
Security Number 586-03-3280, and DOUGLAS W. JONES,
Social Security Number

The military source stated that FRANCIS STONE GOODROW reportedly had been a member of the Pacific Counseling Service (PCS), a group which has been furnishing information regarding Selective Service to those desiring it and Clergy and Laymen Concerned About Vietnam, a group opposed to U. S. policy in Southeast Asia.

Another arrestee listed later in this communication by the name of MARK W. SULLIVAN has been a member of the PCS


and reportedly was active in anti-military demonstrations in the California area. On August 3, 1970, he rented a Post Office box which has been used as the address of the "Lewis-McChord Free Press," an underground newspaper of which the editorial policy has been to create dissension among military personnel at Fort Lewis and McChord Air Force Base. At the time of obtaining the box, SULLIVAN indicated GIs United was an affiliated organization.

Another arrestee, DALE V. BORGESON, was a former PFC at the U. S. Army Training Center at Fort Lewis who wrote an article entitled "Comment on Conscience" which appeared in Volume 1, #1, of the "Free Press" in August, 1970. BORGESON was separated as a conscientious objector at Fort Lewis, Washington in October, 1970.

The Pacific Counseling Service has been located at 917 Court C, Tacoma, Washington. The "Staff House" of the PCS has indicated its address is 420 "L" Street, Tacoma.





## MILITAL LARGES BUYER OF SCAB LETTUCE CONFINENTIAL

Bud Antle is the subject of a nationwide boycott; not only of his lettuce, but of all the crops he grows - celery, cauliflower, artichokes, and broccoli. His markets have been closed off, one by one, all across the country, as store managers realize that Antle produce will be met with an instant picket line.

Antie's only market that is not affected by the consumer boycottie the DEPARTMENT OF DEFENSE. The Army specifically requests BUD ANTLE'S SCAB LETTUCE for ever 60% of its supply. THE DEFENSE DEFARTMENT, famous for its strike-breaking from the days of the grape boycott is at '1 again. Petween and substant 1970, the Defense Department brught as much lettuce from Antle as they had bought in all of 1969.

The union lawyers have filed a suit against the DEFENSE DETARTHANT processing the use of the ARMY as strike-breakers. Soldiers at FORT LEWIS ARMY BASE have organized a coalition to epread the boycott inside the base, and inform the "CIST how they are being used. Stickers are appearing on valle saying, "LIFERS EAT SCAB LETTUCE". The coalition has organized a boycott of commissary food. "I ARMY'S SCABBING IS NOT GOING UNNOTICED.

Today the Washington state boycott supports are here at FORT LEWIS to demonstragainst the Defense Department's collusion with Bud Antie in keeping farmworkers englaved. All across the country similar demonstrations will be taking place.

#### PROGRESSIVE LABOR PARTY

"The New York Times" city edition, Tuesday, April 20, 1965, page 27, reported that a new party of "revolutionary socialism" was formally founded on April 18, 1965, under the name of the Progressive Labor Party (PLP) which had been known as the Progressive Labor Movement.

According to the article, "The Progressive Labor Movement was founded in 1962 by Milton Rosen and Mortimer Scheer after they were expelled from the Communist Party of the United States for assertedly following the Chinese Communist line."

A source advised on June 3, 1968, that the PLP held its Second National Convention in New York City, May 31 to June 2, 1968, at which time the PLP reasserted its objective of the establishment of a militant working class movement based on Marxism-Leninism.

The source also advised that at the Second National Convention Milton Rosen was unanimously reelected National Chairman of the PLP and Levi Laub, Fred Jerome, Jared Israel, William Epton, Jacob Rosen, Jeffrey Gordon, and Walter Linder were elected as the National Committee to lead the PLP until the next convention.

The PLP publishes "Progressive Labor," a bimonthly magazine, and "Challenge-Desafio," a monthly newspaper.

Source advised on May 25, 1970, that the PLP utilizes an address of General Post Office Box 808, Brooklyn, New York, and also utilizes an office in Room 617, 1 Union Square West, New York, New York

#### REVOLUTIONARY YOUTH MOVEMENT

A source advised that the Revolutionary Youth Movement II (RYMII) faction of Students for a Democratic Society (SDS) held a national conference at Atlanta, Georgia, from November 26 to 30, 1969. At this conference it was decided to form a new organization to be known as Revolutionary Youth Movement (RYM), characterized as a mass anti-imperialist youth organization, said organization being proposed as separate and distinct in form and content from SDS. The "Principles of Unity" adopted by the conference included a struggle against white supremacy and male supremacy; fights against imperialism, anticommunism, fascism and oppression of youth; and support of the right of self-determination of all "oppressed nations," also support of the right of all "oppressed and exploited" peoples "to armed self-defense." It was agreed that RYM would not be a Marxist-Leninist organization; however, source said this was decided in order to indicate an organization broad enough in form to be acceptable to everyone. A temporary National Steering Committee (NSC) made up of eight females and two males was elected to govern RYM until national officers could be elected during the Spring of 1970.

RYM publications have listed the RYM National Office (NO) at Post Office Box 5421 and Post Office Box 77012 C, both Atlanta, Georgia, and a second source has advised that the NO has no office space but would probably be considered as located at Apartment 27, 1067 Alta Avenue N.E., Atlanta.

Second source advised that women dominated the founding conference and have continued to dominate NSC meetings to the point that "women's liberation" has apparently become the RYM's principal issue - also that RYM's poor financial condition has resulted in its failure to publish a paper. During early 1970, RYM has decided to cater to the working class rather than youth, since the potential for social revolution lies in workers.

A third source has stated that it was decided at the March, 1970, NSC meeting that RYM women had decided the organization will be molded into a "working class, Marxist-Leninist, revolutionary, anti-imperialist, problack nationalist, people's women's liberation organization."

#### SEATTLE LIBERATION FRONT

On February 25, 1970, a first source reported that the Seattle Liberation Front (SLF) held an organizational meeting in the Student Union Building, University of Washington (UW), at Seattle, Washington, on January 23, 1970. This meeting was called by UW Visiting Assistant Professor of Philosophy, MICHAEL PHILIP LERNER. At this meeting, a fourteen point platform to provide basic guidelines and set objectives for the newly organized SLF was introduced by LERNER and accepted by those present.

The platform calls for creation of a revolutionary culture everywhere, turning schools into training grounds for liberation, destruction of the University unless it serves the people, struggle against American imperialism, full liberation for women, protection and expansion of drug culture, defense against law and order, and creation of machinery for a "People's Government".

A second source advised on March 31, 1970, that the SLF consists of approximately fourteen collectives, each made up of fifteen to thirty members who may or may not reside in communal fashion. The SLF leadership makes up the "Sundance Collective" located at 2815 Northeast 105th, Seattle, Washington. The leadership consists primarily of CHARLES CLARK "CHIP" MARSHALL, III and JOSEPH HUGH KELLY, former Students for a Democratic Society (SDS) Regional Travelers from Cornell University, Ithaca, New York; JEFFREY ALAN DOWD and MICHAEL VICTOR ABELES, former SDS members at Cornell University.

A third source advised on April 15, 1970, that the SLF is primarily a non-student organization consisting of "street people" and "drop outs" from society. The SLF conducts meetings on the UN campus through the sponsorship of a recognized student organization, the Radical Speakers Platform (RSP), to which Professor LERNER is faculty advisor.



#### APPENDIX



#### STUDENTS FOR A DEMOCRATIC SOCIETY

Students for a Democratic Society, commonly known as SDS, came into existence at a founding convention held during June 1962, at Port Huron, Michigan. From an initial posture of "participatory democracy," Marxist-Leninist ideology of various shadings became predominant during 1968-1969 with debate centering on how best to create a revolutionary youth movement. SDS moved from involvement in the civil rights struggle to an anti-Vietnam war position to advocacy of a militant anti-imperialist line linking up the oppressed peoples of Asia, Africa and Latin America with the black liberation movement in the United States. All major factions within SDS embrace Marxism-Leninism and identify internationally with China, Cuba and North Vietnam as countries leading the worldwide struggles against the United States. However, the Soviet Union was regarded as imperialist and with the Communist Party, United States of America, "revisionist" in nature.

SDS operated under a national constitution which called for an annual National Convention (NC) and quarterly National Council meetings wherein programs were initiated and debated. Three national officers were elected annually with a National Interim Committee to run the organization. Regional offices and college chapters elected delegates to the national meetings but each functioned independently on local matters. Its official publication "Fire" (formerly "New Left Notes") last appeared in December 1969.

Internal factionalism of serious proportions developed during 1968 - 1969 and the following three factions evolved as a result of a split at the June 1969, NC: Weatherman, Worker Student Alliance (WSA), and Revolutionary Youth Movement (RYM). The effect of the split on SDS chapters throughout the country was divisive. Some aligned with one or the other of the three major factions. Others, unable to identify with any faction, disassociated with SDS completely and changed names.

The SDS national office in recent years was located at 1608 West Madison Street, Chicago, Illinois. It was closed in February 1970.

The Weatherman and RYM groups no longer consider themselves associated with SDS, and the WSA group refers to itself as the true SDS.

#### WEATHERMAN

Initially called the "Action Faction," Weatherman came into being immediately before the June, 1969, Students for a Democratic Society (SDS) National Convention (NC). At this NC Weatherman won all three national officer positions and a majority of the National Interim Committee as well. Subsequently, they took over the SDS National Office (NO) in Chicago, and controlled its funds, paper and national records. Although internal struggle existed until late 1969, Weatherman for all major purposes controlled SDS nationally from June, 1969, until its NO closed in February, 1970. At this time it no longer considered itself part of SDS.

The term Weatherman emerged from an ideological paper prepared by its leaders entitled "You Don't Need a Weatherman to Know Which Way the Wind Blows" ("New Left Notes" June 18, 1969). This statement outlined the basic stance of Weatherman: Marxist-Leninist in content but with strong advocacy that action not theory would bring about revolution in the United States. This posture was complemented with an international identification to the Cuban revolution and Castro's statement that the duty of a revolutionary is to make revolution.

During October, 1969, Weatherman riots in Chicago resulted in more than 260 arrests for mob action and related charges. A program of armed struggle was finalized during a December, 1969, "War Council" wherein terrorist tactics and political assassination were contemplated. The basic strength of Weatherman was then revealed to be some 300 - 350 nationally and geographically apportioned to the Midwest, New York, and some Northwest.

As its rhetoric of violence escalated, Weatherman leaders increasingly discussed the necessity of an underground operation wherein more than 90 per cent of the organization would be submerged; "affinity groups" of three - five members would function independently. In February, 1970, Weatherman leaders announced a program of "strategic sabotage" with police and military installations as primary targets.

In February, 1970, Weatherman abandoned the SDS NO, 1608 West Madison Street, Chicago, Illinois, and throughout the country entered an underground status.

#### WORKER STUDENT ALLIANCE/PROGRESSIVE LABOR PARTY

A source advised during August, 1969, that at the National Convention (NC) of Students for a Democratic Society (SDS) held in Chicago, Illinois, during June, 1969, a split arose between the Progressive Labor Party (PLP) and the National Office (NO), the NO becoming known as the Weatherman faction. The PLP faction drew the largest support among those in attendance at the NC.

Source further advised that during late Summer, 1969, the PLP faction of SDS established its National Headquarters (NH) on the second floor of a loft-type building at 173A Massachusetts Avenue, Boston, Massachusetts. The campaign on which the PLP faction centered was to build a worker student alliance or a campus worker student alliance. Thus, they adopted the names of Worker Student Alliance (WSA) or Campus Worker Student Alliance.

Source stated that the "New Left Notes," printed in New York City, is the official publication of the WSA faction.

A second source advised during January, 1970, that within the SDS, the WSA is a caucus of which the PLP constitutes the leadership.

A third source advised during July, 1970, that during demonstrations staged in the Boston area during the Spring and Summer of 1970 by the NH, the main theme of previous demonstrations staged by the NH shifted from protestations of the Vietnam War and other United States foreign policy matters to attacking domestic issues such as racism and unemployment and demonstrating support of the "workers' struggle."

#### "YOUNG SOCIALIST"

The "Young Socialist" is a magazine published monthly, except during the summer, by the Young Socialist Alliance. The October, 1964, edition, the initial edition utilizing the magazine format, relates that this magazine succeeds the "Young Socialist" newspaper in an effort to provide "more facts on more general issues than a small newspaper can."

The "Young Socialist" newspaper was formerly described as the official organ of the Young Socialist Alliance (YSA).

The "Young Socialist" maintains office space at the headquarters of the YSA, Room 532-536, 41 Union Square West, New York City, and has a mailing address of Post Office Box 471, Cooper Station, New York, New York 10003.





#### YOUNG SOCIALIST ALLIANCE

A source advised on May 14, 1970 that the Young Socialist Alliance (YSA) maintains its national headquarters at 41 Union Square West, New York, New York, and has as its official publication "The Young Socialist Organizer" (YSO). The YSA is the youth organization of the Socialist Workers Party (SWP) and serves as the main source of recruitment into the SWP.

According to the masthead of the "YSO" dated April 29, 1970, the YSA is described as "A multi-national revolutionary socialist youth organization."

The SWP has been designated pursuant to Executive Order 10450.





## YOUNG SOCIALIST ALLIANCE UNIVERSITY OF WASHINGTON CHAPTER

On March 3, 1967, a source reported concerning an "application for recognition as a student organization" on the campus of the University of Washington (UW), Seattle, Washington, dated February 16, 1967, indicating that recognition had been given by the University to the formation of a UW Chapter of the Young Socialist Alliance, which would have connections with the Young Socialist Alliance (YSA) National Office, New York.

On August 8, 1967, a second source reported a flyer issued by the SWP and the YSA indicated meetings were to be held at 5257 University Way N.E., in Seattle.

The Socialist Workers Party (SWP) has been designated pursuant to Executive Order 10450.

The September 12, 1969, issue of "The Militant" listed under the heading "Meet Socialists in Your Area" the address for the Seattle YSA as 5257 University Way N.E., Seattle, Washington 98105, telephone: 206-523-2555.

"The Militant" is a weekly newspaper of the SWP.

On October 30, 1969, a third source furnished a Student Organization for Recognition or Renewal of Recognition application dated September 29, 1969, and executed by the YSA, which listed JAY LA VASSAR as the Chairman.

Attached reports United Farm Workers (UFW) plan to hold a picket-type demonstration at the Americana Hotel, New York City, protesting the appearance of Vice President Agnew at the Friendly Sons of St. Patrick's annual dinner this evening. According to a spokesman of the UFW, approximately 50 persons are expected to participate in the demonstration, which is being held because the UFW feels the National Labor Relations Board (NLRB) is now dominated by Republican Party appointees and the NLRB is cooperating with the large farmers and growers to the detriment of the UFW. This spokesman also stated the UFW has launched a campaign of confronting the Republican Party wherever any of its spokesmen or principal candidates appear. Subsequent information received indicated about 50 UFW demonstrators protested on evening 3/17/72. There were no incidents or arrests. The UFW is a recognized labor organization, principally representing migrant farm workers and headed by Desar Chavez.

This information has been furnished by our New York Office to the Secret Service and the New York City Police Department. It has also been furnished by tolletype to the President, the Vice President, Secret Service, and the Acting Attorney General.



On March 31, 1972, Source One advised a group led by Gustavo Gutierrez, representing the United Farm Workers (UFW) Union, planned a protest demonstration at the State Capitol Building, Legislative Quarters, Phoenix, Arizona.

Gutierrez and approximately ten to fifteen persons will stage a silent vigil in front of the State Capitol Building on April 3, 1972. They plan to remain throughout the night and be present when House Bill 2134 is brought before the Arizona House on April 4, 1972. Arizona House Bill 2134 deals with farm workers and management with one portion that would allow a temporary injunction for ten days against any strikes of farm laborers engaged in harvesting. The UFW are opposed to this bill and have urged many local organizations to oppose this bill. A large-scale letter writing campaign was initiated by UFW. Gustavo Gutierrez is known to be in contact with Cesar Chavez of the California UFW and it is believed Gutierrez gets guidance from Chavez.


Source Two on April 6, 1972, advised House Bill 2134 came to vote on April 4, 1972. Prior to the vote, the gallery composed mainly of Chicano farm workers, became noisy. At this time, the House Sergeant of Arms asked the gallery to leave and they did so without incident. The UFW held a peaceful vigil on Capitol grounds while this bill was being considered.





As of November 30, 1970, Cesar Chavez, continued to visit Julio Prado Valdez, a known member of the Mexican Communist Party (PCM). Chavez's interest in Prado reportedly was to have Prado run a health clinic in the Mexicali, Baja California, Mexico, area, for the United Farm Workers Organizing Committee (UFWOC) members. The health clinic would be subsidized by UFWOC funds as a supplement for the nominal fees charged to the chapter.

An article of the "Imperial Valley Press," a newspoper publication at El Centro, California, captioned, "Teen Walk Seeks Release of Chavez," dated December 12, 1970, reflected that approximately 300 students shouting, "Free Chavez", 'Chicano Power", and "Viva La Raza", marched on the County Courthouse in El Centro, California, for a two hour demonstration protesting the incarceration of Cesar Chavez, the UFWOC leader, in Salinas, California.

An article appearing in the December 12, 1970, edition of the "Imperial Valley Press", El Centro, California, captioned, "Former Chavez Supporter Links Brown Movement to Communism," reflected that "Melchor O'Campo, who said he once supported Cesar Chavez, told a group of about 70 people at a public meeting in Brawley, Friday night that Chavez and the 'Brown Movement' is part of a communist plot to take over the U.S. Food Supply."

On August 25, 1971, it was reported that a fund raising benefit at the Academy Theater, 3721 University Avenue, San Diego, California, was scheduled for September 5, 1971, for Cesar Chavez, and the Labor Union sponsored by the Non-Violent Action Committee (NVA).

The NVA was organized early in 1971 for the purpose of preventing the departure of the USS Constellation, which was to sail from San Diego to Vietnam on October 1, 1971.

Cesar Chavez visited with Julio Prado Valdez in Mexicali, Baja California, Mexico, on October 3, 1971, at which time financial problems that Prado was having and the fact that he needed more money for the health clinic in Mexicali, were discussed. The UFWOC was paying 5,000 to 6,000 pesos (approximately \$500.00) a month to Prado and was to sent \$200.00 to \$300.00 more per month for the rent of the health clinic in Mexicali.

The medical clinic at Mexicali, Mexico, providing medical services to UFWOC members was closed due to a disagreement between Cesar Chavez and Julio Prado Valdez over the fact that Prado demanded more money for providing these services.

On Wednesday, March 1, 1972, Ronald Nibbe of the San Diego Convention Coalition (SDCC), Labor Committee, attended a meeting of the UFWOC and advised that the SDCC supported them 100%.

The San Diego Convention Coalition (SDCC) is a group comprised of representatives of various radical groups in San Diego, California, which was formed for active opposition to the United States government through "serious, determined, and long-term social upheaval".

On March 16, 1972, Special Agents of the Federal Bureau of Investigation observed an estimated 200 members of the UFWOC picket the Republican National Convention headquarters at the Royal Inn on Harbor Drive, San Diego, California, as a result of an injunction against the UFWOC by the National Labor Relations Board.

At approximately 11:00 A.N, on March 16, 1972, several members of the SDCC joined the UFWOC picket which began at 9:00 A.M., and ended at 5:00 P.M. SDCC members had agreed at a recent meeting of the Coordinating Body Committee that they would support and recognize the UFWOC and any demonstrations, rallies or picket lines they conducted.




