persons in any terrorist plans. His captors threaten to kill him if he does not write out this statement in his own handwriting. Carlos complies. He is then released -- being told that he will be approached again, within ten days, by his captors and taken to a public press conference where he will be required to publicly read his handwritten statement before television cameras.

Carlos, once freed, seeks out the Plaintiffs and asks for their help in escaping from the Defendants. The Plaintiffs arrange for security guards to live with Carlos and his family and after several weeks arrange for them to leave Costa Rica for the second time.

Agents of the Defendants, during this period of time, also make threatening telephone calls to the Plaintiffs TONY AVIRGAN and MARTHA HONEY - threatening to kill them if they do not stop their investigation of La Penca and of the information given to Carlos. A note stating this is also slipped under Carlos' front door.

In addition, the Plaintiffs are repeatedly followed by cars without license plates and with two-way radios and one of these cars stops in front of their house. One of the male occupants takes photos of the house. Several nights, cars without lights on park in front of their house. The Plaintiffs, in fear for their lives and those of their children, keep their children out of the country briefly, adopt strict security measures whenever leaving the house, and install expensive security systems in their house and office.

The Plaintiffs share their information with Associated Press

~~reporter Brian Barger and with The Christic Institute, a~~

Washington, D.C.-based public interst law firm, whom they ask for help.

During 1985, AP reporter Brian Barger, with his associate Bob ~~Perry~~, investigate the Plaintiffs' claims and begin to break a series of nationally-publicized stories linking the Defendants with illegal drug-smuggling and arms dealing.

The Plaintiffs' information is then communicated to United States Senator John ~~Kerry~~ on the United States Senate Foreign Relations Committee. His staff investigates this information and substantiates the Plaintiffs' charges of gun-running and cocaine trafficking by the Defendants.

Attorney Daniel Sheehan, General Counsel for The Christic Institute, also investigates the charges of the Plaintiffs and, upon obtaining evidence adequate to convince him of the likeihood of the truth of these charges, agrees to represent the Plaintiffs in this Federal lawsuit.

Despite the efforts of David, Carlos and certain Costa Rican officials, the La Penca terrorist group is still very much at large. As such, it represents a danger not only to Eden Pastora and to those around him but it represents a danger to many innocent civilians -- as well as to efforts to bring peace and stability to Central America.

As a result of this conduct on the part of the Defendants and their agents, the Plaintiff TONY AVIRGAN has been seriously injured in his person and both he and Plaintiff MARTHA HONEY have been caused great mental distress and their practice of their profession has been intentionally interfered with by the Defendants.

Para su información le adjunto copia de reciente correspondencia al Señor Abrams en la cual explicamos nuestra política con respecto al tráfico ilícito de drogas. Quedo convencido que cualquier persona que observe las condiciones debidas para creer que sobreviven nuestra organización, no tiene la menor razón de creer por un instante que exista algún tipo de acuerdo o algún muy lucrativo negocio del tráfico ilícito de drogas.

Con referencia al atentado en contra de mi vida en La Penca el 30 de Mayo 1984, yo le aseguro categoricamente que jamás he acusado a ninguna entidad del gobierno de los Estados Unidos. Press Conference Day of Filing, May 29th, in Washington

WASHINGTON, DC -- A federal lawsuit charging 29 Americans, Nicaraguan contras (including FDN leader Adolfo Calero), and others with criminal conspiracy involving gun-running, drug-smuggling, murder and the bombing of a press conference with American reporters will be filed in Miami Federal Court on Thursday, May 29th. The suit also names World Anti-Communist League chairman John Singlaub for violations of the Neutrality Act.

Details of the lawsuit will be announced at a press conference on Thursday, May 29, at 10:30 am in the Bourke-White/Zenger Room, 13th Floor of the National Press Club in Washington, to be attended by the plaintiffs and their attorney.

The lawsuit, filed on behalf of two U.S. journalists who investigated the 1984 bombing of a press conference called by former contra leader Eden Pastora (one of whom was crippled in the attack), charges that the contras and their American supporters committed murder, trafficked in cocaine, plotted the unsuccessful assassination attempt on Pastora and planned to kill U.S. Ambassador Lewis Tambs, laundered money, smuggled weapons, threatened investigators and obstructed justice.

The federal lawsuit naming Calero, Singlaub, and others represents the first time that allegations of contra involvement in gun and drug smuggling, terrorist bombings and murder are united in a coherent case and presented in a U.S. court of law, with specifics and sources clearly identified.

Speakers at the news conference will include the plaintiffs, journalists Tony Avirgan and Martha Honey, and their attorney, Daniel Sheehan of the Christic Institute. Avirgan was injured while covering the bombed Pastora press conference for ABC. His wife, journalist Martha Honey (a stringer for ABC, CBC, and others) has been threatened with death for investigating the Pastora bombing on behalf of the Newspaper Guild. Attorney Sheehan was the lawyer in the Karen Silkwood and Greensboro Civil Rights cases.

others), have been threatened with death for investigating the Pastora bombing on behalf of the Newspaper Guild Committee to Protect Journalists. Dave Marash, anchorman at WRC-TV in Washington, spoke at the news conference representing the Committee.

The RICO conspiracy civil suit asks a total of \$2,340,000 in actual and punitive damages charged the defendants with injuries, battery, assault, intentional infliction of mental distress and intentional interference with the business of the plaintiffs.

Attorney Sheehan was the lawyer in the Karen Silkwood and Greensboro Civil Rights cases, and has since April of 1984 been investigating private paramilitary operations directed at Central America.

In addition to this litigation, the Christic Institute is launching a nationwide campaign focusing on public education and calling for a congressional investigation into the charges outlined in the legal complaint.
