





Special Agents of the Federal Bureau of Investigation (FBI) Observed an anti-war demonstration held in Chicago at the Civic Center Plaza on October 13, 1971. Sponsors included the National Peace Action Coalition (NPAC), Chicago Peace Council and the CALC.



Speakers called for continuing resistance to the war and they claimed that the wage price freeze proved that the Nixon Administration is trying to force the nations workers to bear the economic burden of the war. Approximately 150 persons participated in the demonstration which started at noon and ended at 2:10 p.m. There were no incidents and no arrests.

The NPAC was founded in 1970 by members of the Socialist Workers Party (SWP). Its basic objective is to unite masses of people, including labor unions, GIs, and the black community in the struggle to end United States intervention in Southeast Asia through orderly and peaceful tactics. The SWP has been designated pursuant to Executive Order 10450.

The Chicago Peace Council is a coalition of anti-war and anti-draft organizations in the Chicago area.






On November 19, 1971, Special Agents of the FBI at Washington, D.C. observed participants in the "Daily Death Toll Project". On that date, at 9:30 a.m., a group of about 65 persons from the Madison. Wisconsin, Chicago and Indiana areas gathered at a church in the vicinity of 4th and Carolina Avenue. S.E. Washington, D.C. At approximately 2:30 p.m. the group dressed in robes with faces painted white began to march to the White House and at 4:00 p.m. arrived at the White House and marched in front of the building for 25 minutes when more than half of the group layed down in the entrance of the west gate. Shortly thereafter, an official for the U.S. Park Police advised those lying in the entrance that they were in violation of the law and that the group had five minutes to disperse or be arrested. Subsequently about 37 persons were arrested. All arrests were completed shortly after 5:00 p.m. and the group dispersed without further incidents.

The "Chicago Sun Times" issue of April 19, 1972, page 54 reflected that the CALC "an international anti-war group" had announced that it had started a national campaign aimed at forcing Honeywell, Incorporated, to stop manufacturing fragmentation bombs used in the Southcast Asia war. The article reflected that the Reverend Martin Deppe, Chairman of the Chicago Chapter of the CALC and Associate Pastor of the First United Methodist Church of Evanston, had held a press conference to make the announcement. It was shown that a similar announcement had been made at the organizations New York City headquarters. It was shown that the CALC activities locally would concentrate on showing the public all Honeywell's activities in the war and meet with corporation officials.

On April 29, 1972, a silent vigil in protest of the war in Vietnam was held by representatives of the North Shore Community of the CALC and the North Shore Women for Peace from 11:00 a.m. to 12:30 p.m. at the main entrance to the Glenview Naval Air Station. Approximately 70 to 80 people represented these two groups. Ten members of the group, accompanied by the Reverend William Hogan conducted a guerilla theater play. The group requested permission to enter the base to plant some trees, however, permission was denied by naval authorities. There were no incidents and no arrests. Ar

The "Chicago Daily News" issue of May 9, 1972, reflected that anti-war demonstrators were on the Eisenhower Expressway in Chicago on May 9, 1972. It was stated that five autos were used to block off Loop bound traffic in all but one lane of the Eisenhower Expressway just past the U.S. Post Office at the height of the morning rush hour. The blockade started at about 7:30 a.m. May 9 and by 8:10 a.m. nine individuals had been arrested in connection with the blockade. The article reflected that those arrested were all from the CALC. 

The PCPJ has described itself as being headquartered at 1029 Vermont Avenue, N.W., Washington, D.C., and as consisting of over 100 organizations which are using massive civil disobedience to combat racism, poverty, repression and war.



Special Agents of the FBI observed a group who were identified as belonging to the CALC assembled at the AME Church, Washington, D.C. at 9:30 a.m. on May 16, 1972. The group numbered approximately 300 and they passed outs news release that indicated the CALC had come to Washington, D.C. to persuade Congress to end the War in Southeast Asia. It was also shown that the group intended to remain in Washington at least three days and that individuals were present from as far away as Chicago.

The group remained at the church until 12:30 p.m. when they left individually for the Capitol. Eventually, approximately 200 individuals entered the Rotunda area of the Capitol and these individuals were told that the Rotunda was closed to the public at 4:00 p.m. Those individuals who did not subsequently leave were arrested.

date two unidentified representatives of the CALC had made a presentation at Immaculate Heart of Mary High School, Westchester, Illinois. Slides were shown, as were films dealing with the war in Vietnam. The presentation lasted about one hour and was given a number of times to various groups at the school. The presentation was allegedly very much anti-administration and anti-American.

CLERGY AND LAYMEN CONCERNED (CALC)

Honeywell, Incorporated, Minneaports, Francesota, advised on June 1, 1972, that the Clergy and Laymen Concerned group had exerted considerable pressure on Honeywell, Incorporated, in Minneapolis, Minnesota, in connection with the annual stockholders' meeting held in Minneapolis on April 26, 1972. According to this group was highly active for some weeks preceding April 26, 1972, by conducting antiwar demonstrations, holding meetings, disseminating literature and in general, propagandizing the ill effects of Honeywell, Incorporated war production. He recalled that the CALC held an antiwar march in St. Paul, Minnesota, late in March, 1972, in which about 200 Twin City clergymen, seminarians and laymen participated in an antiwar protest during Holy Week.

He further informed that on April 6, 1972,
James H. Binger, Chairman of the Board of Honeywell, Incorporated;
and two other top Honeywell officials met with four national
leaders of the CalC in Minneapolis. Honeywell officials met
with Richard R. Fernandez of New York City, Executive Director
of Clergy and Laymen Concerned; Richard A. Falk, professor
of international law at Princeton University and two
other CALC leaders. The purpose of the meeting was to attempt
to have Honeywell disclose its defense contracts and to name
a committee to study the manner in which peacetime conversion
could be introduced. The CALC officials filed three resolutions
with the Board for inclusion in the corporation's proxy
statement. Discussion was also had relative to the format of
the forth-coming annual stockholders' meeting.

A newspaper release in the April 19, 1972, issue of the Minneapolis Star was captioned, "Campaign seeks to dissuade Honeywell from weapons field." This release indicated that a nationwide campaign to persuade Honeywell, Incorporated, to stop making antipersonnel weapons was introduced on April 18, 1972, by the Minnesota Clergy and Laymen Concerned. In a related

development, Honeywell officials claimed it had made only five of the twelve weapons attributed to the company by the antiwar group. Members of the CALC stated that the "supreme goal" of the groups' campaign was "to get Honeywell to publicly announce it will cease and desist the manufacture of antipersonnel weapons used in Southeast Asia, by their stockholders' meeting in 1973.

The Minneapolis Star is a daily newspaper of general circulation published in Minneapolis, Minnesota.

The Minnesota Clergy and Laymen Concerned was incorporated in the State of Minnesota in February, 1968.

Its purpose is to promote responsible action of clergy and lay citizens directed to bring the Vietnam War to a sane and peaceful end and towards the eradication of those conditions which obstruct world peace. Its local office, a branch of the organization of CALC is located at 122 West Franklin Avenue, Minneapolis, Minnesota.

A news item appearing in the Minnesota Daily on April 24, 1972, stated that a group of 80 antiwar demonstrators participated in a rally on April 21, 1972, sponsored by the Clergy and Laymen Concerned. The rally occurred at the new Federal Building in Minneapolis, Minnesota, and the principal speaker was Reverend Vincent/Hawkinson of Grace University Lutheran Church in Minneapolis, The demonstration was conducted in a peaceful manner.

The Minnesota Daily is a daily student newspaper of the University of Minnesota published in Minneapolis, Minnesota.

A news release in the Minnesota Daily on April 27, 1972, states that Reverend Robert McAffee Brown, Dean of the Stanford University School of Theology, gave a sermon on April 24, 1972, at the Hennepin Avenue United Methodist Church in Minneapolis. He spoke to a congregation of about 300 persons on the subject of corporate responsibility.

Brown spoke principally concerning the ill effects of war production by Honeywell, Incorporated and was quoted as saying "We must accompany our plea to stockholders with a plea to ourselves." Brown called for a reversal of Honeywell's tendency to "beat plowshares into swords and pruning hooks into spears." This affair was sponsored by the Minnesota CALC.

On April 26, 1972, advised that the CALC would actively participate in the annual stockholders' meeting held at the Minneapolis Auditorium on April 26, 1972. A group of about 15 to 20 persons remained outside of the auditorium at the entrance immediately proceding the opening of the meeting at 2:00 p.m., and demonstrated at the entrance for a period of about 45 minutes. They protested against Honeywell by carrying signs, reciting poetry, conducting skits and other peaceful-type activities. Much of the outside demonstration was led by Robert McAffee Brown. Only qualified persons were permitted in the auditorium to attend the stockholders' meeting. There appeared to be at least one half dozen representing the CALC group in the auditorium. Through a prearranged agreement with Honeywell officials, the meeting was opened in the auditorium with a prayer by Sister Mary Luke Tobin of the National Office of the CALC. During the meeting which was conducted in an orderly fashion, several spokesmen for the CALC and other church groups read speeches condemning the war in Vietnam and Honeywell's contribution. There was no apparent attempt to obstruct the meeting by any of the persons within the auditorium and the stockholders' meeting terminated at about 5:00 p.m., in an orderly manner.

A column appearing in the Minneapolis Tribune on May 30, 1972, was captioned, "30 protest Honeywell war policies." The item stated that about 30 persons gathered on May 29, 1972, outside the homes of two officials of Honeywell, Incorporated, to pray for a change in the corporation's policy. They went to the homes of James H. Binger, Chairman of the Board, and Stephen F. Keating, President of Honeywell, Incorporated. Neither Binger nor Keating were home on the occasion, however, the group conducted prayers and proceeded with their demonstration nevertheless. The affair was sponsored by the Minnesota CALC which was described as the local chapter of the national antiwar organization of the CALC.

The Minneapolis Tribune is a daily newspaper published in Minneapolis, Minnesota.

Several Minneapolis confidential informants and sources who are completely familiar with the membership and activities of radical revolutionaries and other subversive or violence-prone elements in the Minnesota area, all advised, during the course of this inquiry that the local CALC is not infiltrated, or controlled by any of these mentioned elements. These same sources stated that they know of no individuals within the local organization who were known to them to be affiliated with subversive elements.

On 12/21/71, at 7:15 PM approximately 200 white predominately young male and female marchers participated in a candlelight march through downtown Louisville. The march was sponsored by CALC and was meant to recognize the deaths being caused by the Vietnam War. At a service after the march, 300 candles were lit at a Louisville church symbolizing the number of people who die daily in the war. CALC had obtained a parade permit for the march and there were no arrests or incidents associated with the march.

Between the period of 12/22/71, and 4/18/72, the CALC was not active in any public demonstrations or marches and they did not voice their opinion on the war in Vietnam or any other national problem to the various news medias in the Louisville, Kentucky area. Clergy and Laymen Conserned

CALC of Kentucky was one of the organizations to have speakers at the rally. The rally was peaceful and orderly.

On 7/29/72, 8/5/72, 8/12/72, 8/19/72, CALC picketed in front of two Louisville stores to protest the selling of Honeywell Inc. photographic equipment. The picketing was beaceful and was a part of CALC's effort to halt Honeywell's anti-personnel book manufacturing.

The demonstrations, rallies and picketing that have been spansored or co-sponsored by the CALC of Kentucky, have been peaceful in nature and no incidents or arrests have resulted from these demonstrations. The CALC of Kentucky has not advocated overthrow of the United States Government or participated in any violent or militant activities.

In the event that the Kentucky chapter of the CALC engages in any pertinent activity in the future, the Bureau and New York will be appropriately advised.

Special Agents of the FBI observed a group who were identified as belonging to the CALC assembled at the AME Church, Washington D.C. at 9:30 AM, on May 16, 1972. The group numbered approximately 300 and they passed out news release that indicated the CALC had come to Washington D.C. to persuade Congress to end the war in Southeast Asia. It was also shown that the group intended to remain in Washington at least three days and that individuals were present from as far away as Chicago. The group remained at the church until 12:30 PM when they left individually for the Capitol. Eventually approximately 200 individuals entered the Rotunda area of the Capitol and these individuals were told that the Rotunds was closed to the public at 4:00 PM. Those individuals who did not subsequently leave were arrested. (U)

on May 24, 1972 advised that on this date two unidentified representatives of the CALC had made a presentation at Immaculate Heart of Mary High School, Westchester, Illinois. Slides were shown, as were films dealing with the war in Vietnam. The presentation lasted about one hour and was given a number of times to various groups at the school. Honeywell Incorporated, Minneapolis, Minnesota, advised on June 1, 1972 that the Clergy and Laymen Concerned group had exerted considerable pressure on Honeywell Incorporated, in Minneapolis, Minnesota, in connection with the annual stockholders' meeting held in Minneapolis on April 26, 1972. According to this group was highly active for some weeks preceding April 26, 1972, by conducting antiwar demonstrations, holding meetings, disseminating literature and in general, propagandizing the ill effects of Honeywell, Incorporated, war production. He recalled that the CALC held an antiwar march in St. Paul, Minnesota, late in March, 1972, in which about 200 Twin City clergymen, seminarians and laymen participated in an antiwar protest during Holy Week. (U)

A news item appearing in the Minnesota Daily on April 24, 1972, stated that a group of 80 antiwar demonstrators participated in a rally on April 21, 1972 sponsored by the Clergy and Laymen Concerned. The rally occurred at the new Federal Building in Minneapolis, Minnesota, and the principal speaker was Reverend VINCENT/HAWKINSON of Grace University Lutheran Church in Minneapolis. The demonstration was conducted in a peaceful manner. (U)

The Minnesota Daily is a daily student newspaper of the University of Minnesota published in Minneapolis, Minnesota. (U)

A news release in the Minnesota Daily on April 27, 1972 states that Reverend ROBERT MC AFFEE BROWN, Dean of the Stanford University School of Theology, gave a sermon on April 24, 1972, at the Hennepin Avenue United Methodist Church in Minneapolis. He spoke to a congregation of about 300 persons on the subject of corporate responsibility. BROWN spoke principally concerning the ill effects of war production by Honeywell, Incorporated and was quoted as saying "We must accompany our plea to stockholders with a plea to ourselves". BROWN called for a reversal of Honeywell's tendency to "beat plowshares into swords and pruning hooks into spears". This affair was sponsored by the Minnesota CALC. (U)

would actively participate in the annual stockholders' meeting held at the Minneapolis Auditorium on April 26. 1972.

Argroup of about 15 to 20 persons remained outside of the auditorium at the entrance immediately proceding the opening of the meeting at 2:00 PM, and demonstrated at the entrance for a period of about 45 minutes. They protested against Honeywell by carrying signs, reciting poetry, conducting skits and other peaceful-type activities. Much of the outside demonstration was led by ROBERT MC AFFEE BROWN. Only qualified persons were permitted in the auditorium to attend the stockholders' meeting. There appeared to be at least one half dozen representing the

CALC group in the auditorium. Through a prearranged agreement with Honeywell officials, the meeting was opened in the auditorium with a prayer by Sister MARY LUKE TOBIN of the National Office of the CALC. During the meeting, which was conducted in an orderly fashion, several spokesmen for the CALC and other church groups read speeches condemming the war in Vietnam and Honeywell's contribution. There was no apparent attempt to obstruct the meeting by any of the persons within the auditorium and the stockholders' meeting terminated at about 5:00 PM. in an orderly manner. (U)

A column appearing in the Minneapolis Tribune on May 30, 1972, was captioned, "30 protest Honeywell war policies". The item stated that about 30 persons gathered on May 29, 1972, outside the homes of two officials of Honeywell, Incorporated, to pray for a change in the corporation's policy. They went to the homes of JAMES H. BINGER, Chairman of the Board, and STEPHEN F. KEATING, President of Honeywell, Incorporated. Neither BINGER nor KEATING were home on the occasion, however, the group conducted prayers and proceeded with their demonstrations nevertheless. The affair was sponsored by the Minnesota CALC which was described as the local chapter of the national antiwar organization of the CALC. (U)

The Minneapolis Tribune is a daily newspaper published in Minneapolis, Minnesota. (U)

D. South Carolina

On April 15, 1972 a "Walk for Life" was initiated. It was sponsored by the South Carolina clergy and Laity Concerned. The walk covered the distance from Greenville, South Carolina to Columbia, South Carolina. The purpose of this walk was to dramatize demends for United States withdrawal from Southeast Asia. The leader and coordinator of this march was Reverend MICHAEL F KANEY, of the Greenville, South Carolina Chapter of CAIC. When KANEY arrived at the South Carolina State Capitol grounds, April 22, 1972 he was observed

by SAS of the FBI leading a group of about 150 protesters. A number of these marchers were carrying posters protesting the draft and the war in Vietnam. A rally was held on these grounds and later removed to St. Peter's Roman Catholic Church, Columbia, South Carolina because of inclement weather. No incidents or arrests took place. (U)

The above information concerning this march was carried by local South Carolina papers, specifically the Greenville Piedmont. (U)

On May 4, 1972

Building, Greenville, South Caroline advised that on that date thirteen members of CALC demonstrated in front of the Federal Building. They displayed anti-war placards and handed out membership applications for the Greenville CALC. (U)

An article in the May 11, 1972 issue of the Greenville Piedmont, a Greenville South Carolina daily newspaper, reported that six Greenville members of CALC were among demonstrators at PCPJ rally in Washington D.C. (U)

On May 11, 1972 Honeywell Electronic Data Processing, 820 East Washington Street, Greenville, South Carolina, advised that a group of six to ten CALC members had picketed his office on April 26, 1972, May 3, 1972 and May 10, 1972. He said the group carried signs and distributed leaflets expressing opposition to the firms manufacturing of war material. (U)


E. Tennessee

Appeal", a daily newspaper published in Memphis, Tennessee, contained an article entitled, "State Strange Props Familiar" by THOMAS BEVIER. According to this article, the International Telegraph and Telephone Corporation's (ITT) annual meeting of stockholders held in Memphis, Tennessee on May 10, 1972 was picketed by about fifty anti-war demonstrators protesting ITT's contributions to the Vietnam War effort. At this demonstration a Franciscan priest, Reverend DALE/OLINE, representing CALC, presented two proposals to curtail ITT's manufacturing of items used in warfare. (U)





Weatherman, formerly a faction of SDS, controlled the SDS National Office from June, 1969, until its closing in February, 1970. Weatherman then entered an underground status and adopted a tactic of "strategic sabotage," with police and military installations designated as primary targets.

RYM, a pro-Communist revolutionary youth organization was organized in 1969, first as a faction within the SDS, then as a separate group with headquarters in Atlanta, Georgia. RYM was unsuccessful in attracting support and by mid-1970, it was practically defunct.

The PLP was founded in 1962 by individuals expelled from the Communist Party, USA, for following the Chinese communist line. Its objective is the establishment of a militant working-class movement based on Marxism-Leninism and MAO Tse-tung thought.



The PCPJ has described itself as being headquartered at 1029 Vermont Avenue, N.W., Washington, D.C., and as consisting of over 100 organizations which are using massive civil disobedience to combat racism, poverty, repression, and war.



The Indo-China Peace Campaign (IPC) is an ad hoc group of war resistors that was organized as an educational and action program designed to keep the Vietnam War primary in the public consciousness through the November, 1972, Presidential election.

An article in the March 2, 1973, issue of The Greenville News, a newspaper published daily at Greenville, South Carolina, reported that members of the Greenville Chapter of CALC plan to picket Graham Photo Supply, Incorporated, at 100 West Camperdown Way and 1110 North Pleasantburg Drive, in Greenville during March 19-23, 1973, to protest their selling Honeywell and Pentax equipment "because Honeywell is in the business of making antipersonnel weapons".
Mrs. Leslie Turner, CALC representative, said a week-long vigil during regular store hours is planned.

Mrs. Turner further stated that CALC members plan to pass out literature in front of the two stores explaining how stock in Honeywell goes to finance the manufacture of bombs, ammunition and other military equipment.

Mrs. Turner said CALC is also encouraging citizens to write their congressman urging them to support legislation curbing the President's warmaking powers. She said CALC is also requesting citizens to contribute to the efforts to rebuild north and south Vietnam.


A review has been made of the programs and activities pursued by captioned organization since October, 1968. It is noted that this organization is primarily a pacifist group. It has continuously participated in non-violent anti-war, anti-draft peace-oriented activities. Now that the Vietnam War has ended and compulsory conscription into the armed services has been abolished, the impetus to mount any meaningful drive has been taken away. The only real cause that CALC seems to have at the present time is the repatriation of deserters, draft-dodgers and fugitive peace protestors. This cause, in and of itself, is not subversive or radical. It is espoused by many legitimate organizations and individuals. It is, therefore, recommended that no further investigation be conducted into the activities of this organization either by the NYO or any auxiliary office. Any field office presently conducting active investigation in this matter is instructed to discontinue, UACB.



B. Leadership and Membership

CALC continues to list its co-directors as Reverend RICHARD FERNANDEZ and TRUDI YOUNG. There is no exact number of individuals in this organization, but there are numerous support individuals.



PCPJ is self-described as a broad coalition of local and national organizations including the Communist Party, USA, committed to conducting ing demonstrations aimed at ending the war in Indochina, and poverty, racism and injustice at home. Its National Office is located at 156 Fifth Avenue, New York City (NYC).

C. Statement of Purpose

CALC is an association of national and local groups formed in response to the United States action in Southeast Asia. Its primary goal is to bring a total end to the Indochina War and to demilitarize American life. It seeks to change those values which corrupt America's public policy, foreign and domestic. CALC brings religious witness to bear on such policy and enables religious communities to become effective agents of social change. The committee pursues this program through

education and direct action.



II. ACTIVITIES OF CALC

On January 19, 1973, Special Agents (SAS) of the Federal Bureau of Investigation (FBI) observed a Mass and demonstration sponsored by CALC condemning United States involvement in Southeast Asia; the further purpose of this peace demonstration was to demand total withdrawal of United States troops from Vietnam. In order to dramatize their point, representatives of CALC called for individuals to go to Washington, D. C., on January 20, 1973, to participate in demonstrations opposing President NIXON's inauguration on that date.

Reverend DANIEL BERRIGAN, well known anti-war activist priest, gave the sermon at the above peace mass, which was celebrated at the Church of the Holy Family, 315 East 47th Street, NYC, NY. Immediately after this Mass, a rally for peace was held at DAG HAMMASKOLD PLAZA, directly across the street from Holy Family Church. Two noted speakers at this rally were EILEEN EAGAN and Sister MARY LUKE TOBIN, both of whom were introduced as national directors of CALC.

In the February 6, 1973 edition of the "New York Times," a daily NY newspaper, there was an article headlined, "AMNESTY STRATEGY PARLEY SET FOR PARIS." This article reported, among other things, that TOD ENSIGN, a lawyer for the Safe Return Committee (SRC), announced at a news conference on February 5, 1973 in NYC that representatives from CALC would be present at a strategy meeting to be heldin Paris, France from February 19-February 22, 1973. The purpose of this meeting was to form strategy to move Congress to pass legislation calling for exiled military deserters and draft-dodgers as well as fugitive anti-war protestors, to be allowed back into this country without reprisals.

Safe Return Committee (SRC) is composed of Citizens Committee of Inquiry (CCI) activists who plan to assist some of the many self-retired veterans (deserters) who wish to return home.

CCI has been characterized as an anti-war group with a New Left political orientation seeking a national inquest into the war crimes question.

The February 6, 1973 edition of the "Staten Island Advance," a Staten Island, NY, daily newspaper, reported that DEBBIE PECK, from Springfield, Massachusetts is to walk 400 miles from her home to Washington, D. C. Miss PECK is being sponsored by CALC. The purpose of this walk is to raise money for BAC MAI, Hanoi's largest hospital, destroyed by United States bombing in December, 1972.

III. MISCELLANEOUS

New Left sources in the NY area were contacted in March and April, 1973 regarding the activity of CALC, but could offer no additional positive information.







In response to your name check request, the central files of this Bureau reveal the following which may relate to the subject of your inquiry.

The Clergy and Laity Concerned (CALC) was the subject of an internal security-type investigation conducted by this Bureau until 1973, at which time it was closed as its activities no longer met the criterion for such investigations.

The CALC was described as an association of national and local groups formed in 1965 in response to the United States action in Southeast Asia. Its primary goal was to bring a total end to the Indochina War and to demilitarize American life. It sought to change those values which corrupt American public policy, foreign and domestic. The CALC sought the repatriation without reprisals of United States deserters, draftdodgers and fugitive war protestors. The CALC headquarters was located at 475 Riverside Drive, New York, New York.
