Postmark on letter indicates it was mailed 3/31/68, at South Haven, Michigan. Return address reads, "Roland Terrintine 72nd Covert Mich 49090". The letter includes a sketch for a rifle silencer and states in part, "In case you don't believe I'll kill him I have a silencer in my rifle. Still don't believe me? Well I'll tell you a silencer for a 22 will have to be exactly 8 in. long and 3 in. in around and made of heavy metal casing." Scotch-taped to the upper right corner of the first page is a .22 caliber bullet.

PAGE advised letter and envelope had been handled by numerous office personnel whose fingerprints are being obtained for elimination purposes.

The initials "ROB" and "TSP" appearing on the envelope and letter are those of SA [REDACTED], FBI, and THOMAS S. PAGE, Mc CARTHY for President Headquarters.

Tom Page of the McCarthy for President Committee contacted Special Agent Bowers on 4-3-68, and advised he has in his possession a letter signed by captioned subject threatening the life of both Senator McCarthy and his wife. Page stated the letter enclosed a .22 caliber bullet, a picture of a rifle silencer, and included various obscene remarks. He stated he could be contacted concerning this matter at Committee Headquarters in Suite 314 in the Capitol Hill Hotel at 301 1st Street, Northeast.

*[Redacted]* in Washington Field Office was advised of the foregoing information and instructed to have an Agent contact Page for the threatening communication and to take appropriate action.

A letter was received on April 3, 1968, at the office of the National Finance Committee, McCarthy for President, Thomas S. Page, Director, Suite 314, Capitol Hill Hotel, 301 First Street, N.E., Washington, D.C. The letter was postmarked March 31, 1968, at South Haven, Michigan, and bore the return address "Roland Terrintine 72nd Covent Mich. 49090." The letter was addressed to "Citizens for McCarthy Washington, D.C. 20002."

The three-page letter, hand printed in red ink on standard, lined stenographic paper, contained extensive obscenities and a .22 caliber rifle bullet Scotch-taped to the upper right-hand corner of the first page immediately after this wording, "This will be my contribution to McCarthy if he don't get his (obsценities)... In case you don't believe I'll kill him I have a silencer on my rifle still don't believe me? Well I'll tell you a silencer for a .22 will have to be excatly 8n long and 3n around and made of heavy metal casing."

The writer then included a sketch of a rifle barrel illustrating how acoustical packing may be used to make a silencer.

On December 21, 1967, [REDACTED], Route #1, Covert, received anonymous letter, postmarked Kalamazoo, Michigan, 12/20/67, instructing her to put \$25.00 in a hole on the south pier at South Haven. Letter contained a drawing showing location of hole.

On 12/25/67, ROLAND B. TERRENTINE, Route #1, Covert, reported to Michigan State Police, he had received letter, postmarked Kalamazoo, 12/22/67, requesting he place \$25.00 in hole on south pier at South Haven, and letter also contained drawing showing location.

Michigan State Police latent print section, East Lansing, found several identifiable latents on envelope and letter to [REDACTED], but none on envelope to TERRENTINE.

On 1/2/68, TERRENTINE reported another letter, similar to the first but requesting \$50.00.

On 2/2/68, [REDACTED] came to the post with an obscene letter addressed to President JOHNSON and bearing the name of ROLAND TERRENTINE as sender. No further information known concerning this except Michigan State Police report states JORDAN interviewed ROLAND B. TERRENTINE and is convinced he is not the person who prepared the letter.

\* On 4/1/68, ROLAND B. TERRENTINE reported receiving another letter. This berated TERRENTINE for not having left the requested \$25.00 and in it the writer says TERRENTINE will probably be hearing from the letter which the writer had sent to Senator MC CARTHY and other persons and to which he had signed TERRENTINE's name.

ROLAND B. TERRENTINE also informed the Michigan State Police he had received a letter from Klein's Sporting Goods, Chicago, requesting credit references. TERRENTINE then learned someone had ordered a Browning shotgun giving TERRENTINE's name and address as the purchaser.

DE 9-2379

[REDACTED], Michigan State Police, stated Detective [REDACTED], who made the investigation to date, is out of town, but that TERRENTINE and [REDACTED] have no suspects and that surveillances of the south pier, which goes into Lake Michigan at South Haven, have been made each time a request to leave money there has been made. However, no one has ever called for dummy packages which have been left.
