Attached to this report is the transcript of a Federal Grand Jury Indictment against JOHN WILLIAM SHERMAN, THERESE ANN COUPEZ, and JANINE DARCY BERTRAM. This indictment was obtained on March 28, 1978, in the Western District of Washington, Seattle, Washington. The Indictment reflects nine counts which includes conspiracy, bank robbery, and bombing activity.

Also attached to this report are three Judgment and Commitment forms from the United States District Court, Western District of Washington, reflecting the sentence received by JOHN WILLIAM SHERMAN, THERESE ANN COUPEZ, and JANINE DARCY BERTRAM.

An information copy of this report is being furnished to Portland and San Francisco.

IT IS ADJUDGED that the defendant is hereby committed to the custody of the Attorney General or his authorized representative for imprisonment with respect to:

Count I for a period of FIVE (5) YEARS;

Count II for a period of TWENTY (20) YEARS;

Count IV for a period of TWENTY (20) YEARS; and

Count VI for a period of TEN (10) YEARS.

Said sentence in each of Counts II, IV and VI to run concurrently with the sentence in Count I and with each other.

Count VIII for a period of TEN (10) YEARS.

Said sentence in each of Counts V, VII and VIII to run concurrently with the sentence in Count III and with each other, but consecutive to the last of the concurrent sentences in Counts I, II, IV and VI.

The execution of said concurrent sentences of imprisonment as to Counts III, V, VII and VIII of the Indictment are hereby suspended and defendant placed on probation for a period of FIVE (5) YEARS to commence upon the expiration of the longest of the concurrent sentences in Counts I, II, IV and VI, upon the following terms and conditions:

1. That he obey all local, state and federal laws;
2. That he comply with the rules and regulations of the probation department; and
3. That he shall not aid, abet, counsel, command, induce or procure the commission of any crime of violence.

He described it as looking like a "sparkler" (like on the Fourth of July) with small flames. It did burn brightly and was later extinguished by a resident of the apartment house next door, who said the flames were yellow-orange in color, shooting to an approximate height of 15 feet. The type of fire extinguisher used was a FireMaster, Type II-A, Soda-Acid.

Items #1 - 10 have been sent to the Laboratory in the original containers used by the Berkeley Police Department inasmuch as initial examination indicated various and often pungent odors present in the evidence which could be lost if the materials had been transferred to plastic bags for shipping to the Laboratory.

1 E. Used radio equipment to monitor law enforcement
2 personnel (police) movements and keep logs of such movements.

3 F. Made and caused to be made, false reports of crimes
4 and accidents to law enforcement agencies as diversion during
5 bank robberies.

6 G. Made and obtained explosives and explosive and
7 destructive devices and bombs; and used and attempted to use
8 the same to damage buildings, vehicles and real and personal
9 property.

10
11 OVERT ACTS

12 The Grand Jury charges that in furtherance of the aforesaid
13 conspiracy and to accomplish the objects thereof, the
14 defendants at the times and places hereinafter set forth did
15 commit overt acts, those acts set forth below:

16 A. On or about May 9, 1977, JANINE DARCY BERTRAM, a/k/a
17 JORI UHURU, was involved in the rental of a safe deposit box at
18 the Bellevue Midlake Office of Rainier National Bank, rented in
19 the name of Karl J. and Carol A. Newland, a bomb being found in
20 said safety deposit box on May 12, 1977, the same day bank
21 records show it was entered by Carol A. Newland.

22 B. On or about November 4, 1977, defendants, at a house
23 at 13746 Roosevelt Way North, Seattle, Washington, possessed
24 bombs, explosives and bomb-making paraphernalia.

25 C. On or about November 11, 1977, defendants acquired a
26 1967 Dodge Dart, Washington license No. CHX 935, for use as a
27 getaway car in the December 8, 1977 robbery of the Northeast
28 Tacoma Branch of Puget Sound National Bank.

1 D. On or about December 8, 1977, **THERESE ANN COUPEZ**
2 disguised as a male, entered the Northeast Tacoma Branch of
3 Puget Sound National Bank, and used a bank robbery demand note
4 and brandished a pistol in robbing said bank.

5 E. On or about December 8, 1977, minutes prior to the
6 robbery of the Northeast Tacoma Branch of Puget Sound National
7 Bank, defendants made and caused to be made to the Police and
8 Sheriff's Office Communications Department, Tacoma-Pierce
9 County Courthouse, a false report of an accident on Lincoln
10 between Maxwell and Thorne in Tacoma.

11 F. On or about November 5, 1977, defendants acquired a
12 1967 Chevrolet, Washington license No. IEM 255, in the name of
13 Nikki Simpson for use as a getaway car in the January 10, 1978
14 robbery of the Westgate Branch of Great Northwest Federal
15 Savings and Loan Association.

16 G. On or about January 10, 1978, **THERESE ANN COUPEZ**,
17 disguised as a male, entered the Westgate Branch of Great
18 Northwest Federal Savings and Loan Association, used a robbery
19 demand note and brandished a pistol in robbing said savings and
20 loan.

21 H. On or about January 10, 1978, minutes prior to the
22 robbery of the Westgate Branch of Great Northwest Federal
23 Savings and Loan Association, defendants made and caused to be
24 made to the Police and Sheriff's Office Communications
25 Department, Tacoma-Pierce County Courthouse, a false report of
26 a robbery at 19th and Jackson.

27 I. Around the early part of November 1977, defendants
28 acquired a 1967 Chevrolet Bel Air, Washington license No. BM
29 324, for use as a getaway car in the February 23, 1978 robbery
30 of the 99th and Pacific Avenue Branch of Union Bank.

1 On or about February 23, 1978, THERESE ANN COUPEZ,
2 disguised as a male, entered the 99th and Pacific Avenue Branch
3 of Union Bank, used a robbery demand note and exhibited a
4 pistol in robbing said bank.

5 K. On or about February 23, 1978, minutes prior to the
6 robbery of the 99th and Pacific Avenue Branch of Union Bank,
7 defendants made and caused to be made to the Police and
8 Sheriff's Office Communications Department, Tacoma-Pierce
9 County Courthouse, a false report of a robbery at 112th East
10 and Vickery.

11 L. On or about January 18, 1978, defendants acquired a
12 1968 Ford, Washington license No. BSB 324, for use as a getaway
13 car in the March 1, 1978 robbery of the University Place Branch
14 of Puget Sound National Bank.

15 M. On or about March 1, 1978, THERESE ANN COUPEZ,
16 disguised as a male, entered the University Place Branch of
17 Puget Sound National Bank, used a demand note and exhibited a
18 pistol in robbing said bank.

19 N. On or about February 8, 1978, JANINE DARCY BERTRAM,
20 a/k/a JORI UHURU, using the name Joanne Mason, purchased and
21 acquired a 1960 Oldsmobile, Washington license No. BDL 110.

22 O. On or about March 21, 1978, defendants parked and
23 caused to be parked a 1960 Oldsmobile, Washington license No.
24 BDL 110, near South 37th and South "L" Street.

25 P. On or about March 21, 1978, THERESE ANN COUPEZ; JANINE
26 DARCY BERTRAM, a/k/a JORI UHURU; and JOHN WILLIAM SHERMAN, were
27 together in Tacoma near the Jubilee Hamburger Restaurant, 858
28 South 38th Street in a 1965 Buick Electra; SHERMAN, disguised
29 as a cleric with a loaded pistol next to him; COUPEZ, disguised
30 as a male, armed with a loaded pistol and possessing a printed
31

1 note stating, "This is a stickup! Give me all the money. No
2 no alarm or I'll shoot!"; BERTRAM possessing two loaded
3 ammunition clips that fit COUPEZ' pistol, and sitting next to a
4 third pistol; and the car containing a radio scanner for
5 monitoring police radio calls, a log of police movements, and a
6 written scenario for a diversion report to law enforcement
7 agencies.

8 Q. Before and on or about March 21, 1978, defendants, at
9 a house at 3601 East Grandview, Tacoma, Washington, possessed
10 some bomb-making paraphernalia.

11 All in violation of Title 18, United States Code, Section
12 371 and Section 2.

13 COUNT II

14 On or about December 8, 1977, at Tacoma, within the Western
15 District of Washington, THERESE ANN COUPEZ, JOHN WILLIAM
16 SHERMAN, and JANINE DARCY BERTRAM, a/k/a JORI UHURU, by force,
17 violence and intimidation, did take from the person and
18 presence of Jean Wyman, a bank employee, approximately Three
19 Thousand Nine Hundred Sixty-Six Dollars (\$3,966.00), in money
20 belonging to and in the care, custody, control, management and
21 possession of the Northeast Tacoma Branch of Puget Sound
22 National Bank, a bank as defined in Title 18, United States
23 Code, Section 2113(f); that in committing the offense of
24 robbery hereinabove charged, the defendants, THERESE ANN
25 COUPEZ, JANINE DARCY BERTRAM, a/k/a JORI UHURU, and JOHN
26 WILLIAM SHERMAN, assaulted and put in jeopardy the life of the
27 aforementioned Jean Wyman, a bank employee, by the use of a
28 dangerous weapon and device, to wit, a gun.


