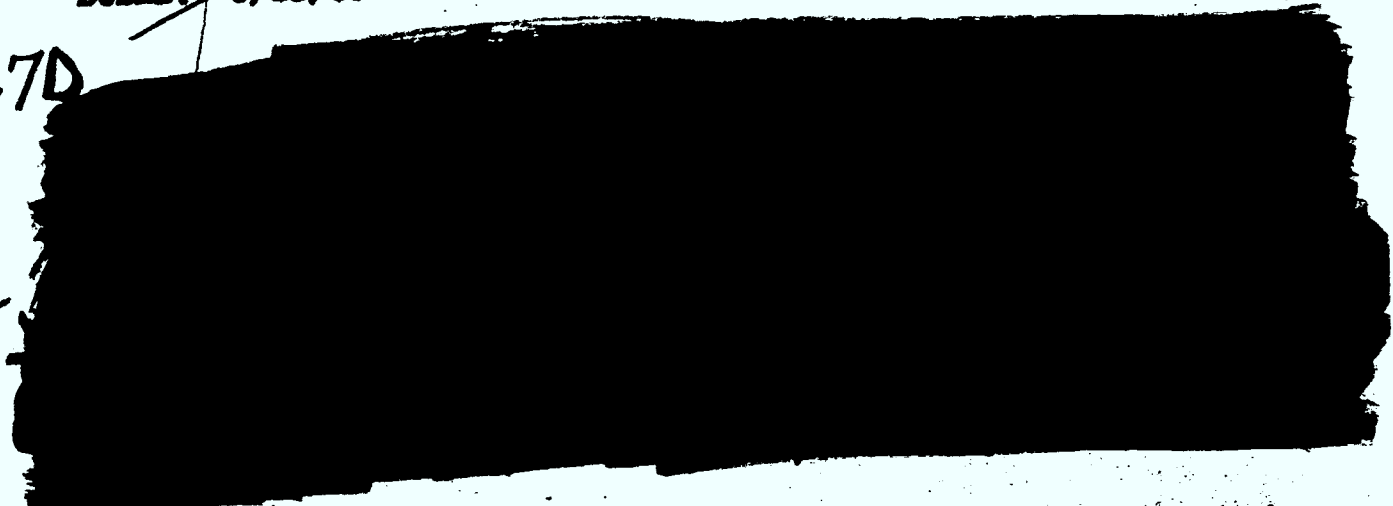

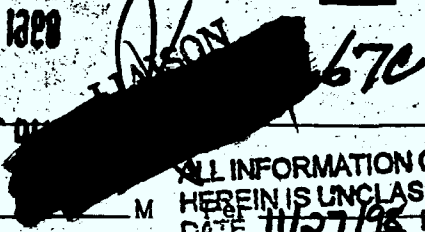

No information was contained in the files of the Los Angeles Office of the Federal Bureau of Investigation that could be identified as being identical with the subject of this communication.

On September 17, 1968, a source of the Los Angeles Office who is familiar with the entertainment field on a nation-wide basis, as well as in the Los Angeles area, advised that he had no information that Tiny Tim was associated with Frank Sinatra, a [REDACTED] or the hoodlum element. This source did believe it unusual for a relatively new star to appear for one week at the Caesar's Palace in Las Vegas, Nevada for a salary of \$50,000 per week with a return engagement promised, but stated he had no positive knowledge of association of Tiny Tim with any hoodlum interests. b7c

On September 18, 1968, a source who has extensive contacts with the hoodlum element in Chicago, Illinois, Las Vegas, Nevada and Los Angeles California, could furnish no information concerning any association of Tiny Tim with Frank Sinatra, a [REDACTED] or the hoodlum element. b7c

Another source of the Los Angeles Office who is extremely cognizant concerning hoodlums and hoodlum activities and interests advised on September 19, 1968, that he knew of no association of Tiny Tim with the hoodlum element or with Frank Sinatra or a [REDACTED] b7c
