Subject : International radio-telegraphic traffic.

In order to speed up the traffic of radio-electric transmissions, it would be particularly useful for the stations of the international system to have very close relations with each other. But, as some national stations also work in co-operation with national systems, it is impossible to fix new hours for transmission operations, without being informed of the periods during which these stations can be placed at the disposal of the international traffic.

I should, therefore, be very grateful to you for sending me to this office any information concerning the periods during which the station in your country could be used for the international traffic. According to the information obtained, I shall then work out a time-table taking into account the requirements peculiar to each station, and this plan will be submitted for your approval, before it comes into force.



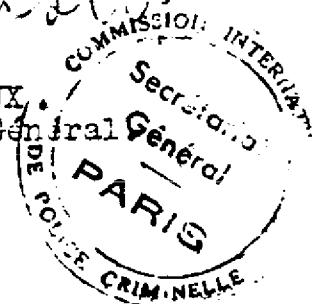

I presume that you have, by now, been informed by my representative in Paris, Mr. Horton A. Telford, of our decision with regard to the continuance of radio communication with your organization.

We will be most happy to establish this communication with your headquarters on a regular basis with the understanding, as I am sure Mr. Telford explained to you, that a universal code system be first worked out and further that the messages which are encoded for transmission to and from your headquarters be in the English language. 



There is attached hereto a communication, dated at Paris, France, October 2, 1947, received from the Secretary General of the International Commission of Criminal Police, concerning the Bureau's membership in the International Commission of Criminal Police.

It is noted in the first paragraph thereof, that Ducloux suggests that the Bureau, if at all possible, consider a complete settlement of the United States' share in the functioning of the Commission, that is, 24,000 Swiss francs.

Ducloux points out that the Secret Service of the Treasury Department is now collaborating directly with the International Commission of Criminal Police in connection with the minting of counterfeit money, and Ducloux feels the Director may wish to contact Mr. Maloney, head of the Secret Service, feeling that the Secret Service may wish to contribute part of the subscription costs.

The matter of the 24,000 Swiss francs has been brought to the Bureau's attention before by Ducloux, and he has been advised that only the amount of \$1,500 has been appropriated for this country's membership in the International Commission of Criminal Police.

We have paid our 1945-46 assessment in the full amount of \$1,500, which is approximately 6,420 Swiss francs. From the rate of exchange at the time that payment was paid, the 24,000 Swiss francs would approximate \$6,000.

We are, at the present time, processing the 1947 payment to be forwarded to the International Commission in the amount of \$1,500.

In our appropriation for the fiscal year 1949, we are requesting an amount of \$3,000 for participation in this Commission. We have not advised Ducloux of this fact.

I do not feel that the Director would want to contact Mr. Maloney of the Secret Service in connection with this matter. Unless the Director instructs otherwise, I will have prepared a communication to Ducloux pointing out that the present year's membership assessment of \$1,500, which is the total amount appropriated for this matter, is being processed, and that we are endeavoring to have this amount increased to \$3,000 for the fiscal year 1949.

Dear Mr. Hoover,

In a recent letter regarding the United States subscription for 1948, I had the honor of bringing to your attention, the financial situation of the International Commission of Criminal Police. I also asked you kindly to consider if it was at all possible, the complete settlement of your country's share in the functioning of our Commission, that is, 24,000 Swiss francs.

Since then, a new element has intervened. In fact, the Secret Service under the jurisdiction of the Treasury Department, has decided to collaborate directly with our Commission in the field of minting counterfeit money.

Consequently it seems that the Secret Service could also support a portion of the subscription, since it will also derive benefits and advantages from international collaboration.

May I take the liberty of suggesting that you contact Mr. Maloney, Head of the Secret Service so as to study with him what part of the subscription could be supported by each one of your Services.

In the same mail I wrote to Mr. Maloney on this subject.

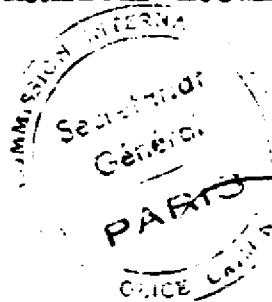

Reference is made to your letter of October 30, 1947, relative to the above entitled matter suggesting test contacts on radio frequencies and kilocycles.

Transmissions on kilocycles by the Federal Bureau of Investigation cannot be undertaken until the necessary authorization for use of this frequency is obtained locally. Efforts to secure the necessary authorization are in progress, and I shall advise you further as to the outcome of such efforts.

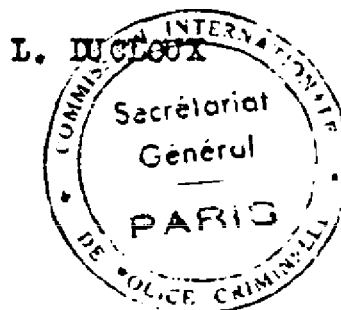

In accordance with your request for summary information of the organization of this Bureau, there is enclosed herewith a pamphlet entitled "The Story of the Federal Bureau of Investigation" which, it is believed, will supply the information which you desire.

As you have been advised previously this Bureau has no control over State and Municipal Police Departments throughout the United States. You also know, however, that we have agreed to act as a clearing house for inquiries directed to these police departments from membership nations of the International Criminal Police Commission.

We have followed the practice of referring inquiries received to the various police departments who have conducted the requested investigations, returned the information to us and we have then in turn supplied the data received to the original inquirer. This procedure, of course, is strictly voluntary as we are in no position to and would in any event not desire to compel police departments to stay within the designated channels.

We have made the above suggested procedure generally known through publication of same in the Law Enforcement Bulletin printed and distributed by this Bureau. It is believed that no difficulties will be encountered, and we anticipate continuance of the procedure described.

In making a check as to whether payment had been made of our dues in the above commission for the fiscal year 1947, it was ascertained that the State Department returned our voucher to the Department of Justice under date of December 4, 1947, advising that it would be unnecessary in the future to prepare a Form 1080 voucher to effect payment of our membership fee in the commission. Instead, the State Department will instruct its consul at Geneva, Switzerland to pay the fee and draw a draft against the Bureau's appropriation. This will have the effect of speeding up the payment to the International Criminal Police Commission. We will still have to write a letter to the State Department requesting that the payment be made but would not prepare any voucher.

In view of the above facts, the Machine Accounting Section is being instructed to enter in the Voucher Register the amount of the fee as an obligation upon the receipt of a copy of our letter to the State Department requesting that the payment be made. It will not be entered in the audited or paid voucher register until a copy of the draft has been received, indicating that the State Department has been reimbursed for the payment.

For your further information, it should be called to your attention that a draft, as far as I have been able to ascertain, is in the nature of a counter warrant, which means that it goes direct to the Treasury Department for payment and we probably would not get a copy for several months after payment has actually been made from our appropriation by the Treasury Department.



The Executive Conference of 12-11-47 considered the inquiry from Legal Attache Telford of Paris for the Bureau's views on the request of the International Criminal Police Commission, which inquired as to the Bureau's attitude toward extending to the U. S. Secret Service and the Narcotics Bureau an invitation to attend the annual general assembly of the ICPC next year in Prague, Czechoslovakia. It was not the expressed intention of the ICPC to offer membership to these organizations but to encourage their interest and cooperation in the sub-commission on counterfeiting and forgery and upon the international control and suppression of narcotics. It was suggested that an American representative of each of these services be invited to attend, either as observers or as members of the American delegation, with the "FBI as the head."

Messrs. Tolson, Mohr, McGuire, Ladd, Nease, Rosen, and Clegg recommend that the Bureau inform Mr. Telford that it understands that the FBI is the American representative in this organization and that if there is any information which they desire to relay to or receive from officials of other police agencies in the U. S. that they should make known their requests for such information and make their contacts through the FBI. It was thought possible that the ICPC might be laying the groundwork for eventually collecting a membership fee from other police agencies in the USA. If the FBI is to be the representative from the U. S. on this Commission, it would seem unwise for other agencies, not participating in paying the fee or assuming the responsibilities, to designate delegates to attend the conventions and conferences.

Messrs. Glavin, Harbo and Tamm were of the opinion that we should write to Mr. Telford, indicating that the Bureau has no desire to express any opinion as to whether they invite any other police agency in the United States and that this would be a matter to be left to the discretion of the ICPC.

A letter will be prepared for Agent Telford in keeping with the decision reached in this matter.

HIJACKING IN NEW YORK

By

A few minutes after midnight on December 1, 1943, John Stak and Pasquale Diaino, truck drivers, came out of a restaurant on Tenth Avenue in New York City. They had two big trucks loaded with \$100,000 worth of whisky to drive to New Haven, Connecticut. The trucks were parked on a street near by. While the drivers were making a last-minute inspection of the trucks before starting their run, they were startled by four bandits who, with drawn guns, stealthily converged on them from the shadows. Prodding their two victims with gun barrels, the bandits marched them to a near-by motor express terminal and forced one of them to unlock the door. All six men entered. Later, a fifth bandit, who had been serving as lookout, scouted down the street and followed the others into the terminal.

Inside the two truck drivers were crussed up with ropes, gagged with balls of tissue crammed down their throats, and immobilized with whiplike ropes across their eyes. Diaino, of course, was protesting, but the other drivers said,

"To hell with him. Let him croak." The drivers were locked inside a van which was parked in the terminal building.

The bandits left the warehouse in pairs. One pair strolled leisurely toward the trucks but were quietly taken into custody by Special Agents of the FBI at the intersection of 23rd Street and 10th Avenue. They made no resistance, but Agents found that each one was armed with a loaded revolver. Another pair of bandits left the terminal warehouse a few minutes later and walked south on 10th Avenue toward their parked automobile. FBI Agents, who had been waiting for them, arrested them just as they were getting into their automobile. Both of these men were also armed with loaded revolvers.

The fifth member of the gang came out of the express terminal in time to see that his companions were in trouble. He tried to bluff his way to freedom by strolling casually down the street as if he were on legitimate business. He was, nonetheless, arrested. He was the man who had served as look-out during the holdup, and was the only one of the gang of five who was not armed.

As soon as the bandits were in custody, one group of FBI Agents took them to the New York office of the FBI for questioning, while other Agents hurried to the terminal to free the two victims. Both Gimino and Piaz were beginning to suffer when the Special Agents arrived, although they had been tied up only a few minutes. Their wrists were blue and they were beginning to feel the lack of air. One of the men was showing the first signs of suffocation inasmuch as

the tape across his face made it almost impossible for him to breathe. Agents were obliged to take both the victims to a doctor's office to have the tape removed from their faces.

The leader of this gang was Kingdon William DeNormand. His companions were Joseph Peter Oddo, Joseph Alfred Lacascia, William Joseph King, and John Mugavero. Mugavero was in Army uniform and was a deserter. Lacascia and King were on parole for state offenses at the time of their arrest. DeNormand, the leader, was an ex-convict who had been discharged from a penitentiary in New York in May, 1943, after serving 13 years. He had been sent to prison for his activities as a strong-arm thug in the underworld gang of the late notorious "Dutch" Schultz. He had been one of Schultz's principal lieutenants. DeNormand had studied law while incarcerated in prison and had spent the 7 months of his freedom recruiting a gang of hoodlums and ex-convicts to commit hijackings.

It was no accident, of course, that FBI Agents were on hand the night of December 1, 1943, to round up this gang in their first hijacking act. Long before the crime was actually committed Agents got wind of the fact that DeNormand was rounding up a gang and was reconnoitering various trucking companies in New York City to find valuable cargo that could be easily hijacked. His plans were carefully laid, and he had already made arrangements to dispose of the \$100,000 shipment of whisky.

This case was presented to a Federal Grand Jury in the Southern District of New York on January 12, 1944, and a



9-count indictment was returned against the five hijackers. The trial lasted nine days and on March 9 the jury found all five defendants guilty on all 9 counts. On March 16, 1944, they were sentenced to serve a total of 68 years in prison. DeNormand was given 17 years, Odde, 15, and the other three men, 12 years each. (15-10127)

On February 12, 1948, the operator in the Washington Radio Station was requested by the ICPC station in Paris to accept a radio message for relay to Santiago, Chile. Inasmuch as the Santiago Radio Station which has been mentioned by the ICPC is not presently in operation, or at least is not in contact with the Bureau, the message was not accepted.

A letter from Prague, which does not have a radio station, requested that certain information be sent to it via the ICPC radio network. Complying with the latter request does not appear to be consistent with the action taken in connection with the refusal to relay via cable to Santiago.

It is noted the Executive Conference memorandum for the Director dated August 14, 1947, recommended the Bureau afford the services of its radio to communicate with Paris and to relay, when necessary, communications from the Commission to other Western Hemisphere countries when such relay work was practical; that this work be continued until the volume became so great as to involve necessary additional personnel and expense. A determination of how far the Bureau will go in relaying messages to other law enforcement agencies in this and other countries in the Western Hemisphere appears necessary.

RECOMMENDATION:

It is recommended that the Bureau accept messages at the Washington radio which are to be delivered to law enforcement agencies in the United States or which are to be relayed to foreign countries having radio stations in the ICPC radio network. Where some special provision for cable payment is made relay to foreign countries could be undertaken, however.

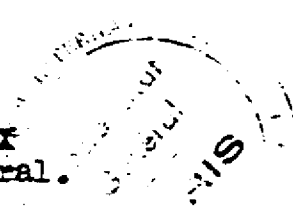

Of all the questions which have been to the fore at the annual conferences of the I.C.P.C., that of the provisional arrest with a view to extradition remains one of the most important, as is borne out by the numerous activities of the I.C.P.C. in this connection before the war.

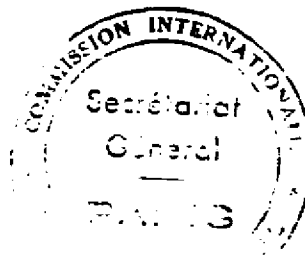

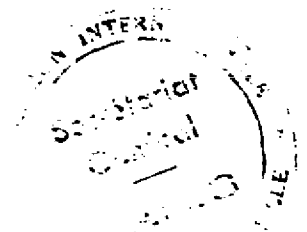

The drug-traffic and the counterfeiting of currency are two offences which typically concern the international relations.

The International Criminal Police Commission has, for a long time, studied these problems and, in the future, our General Meeting will still have to deal more fully with them.

Now and henceforth, I beg to draw your attention to the necessity of informing systematically the General Secretariat of the International Criminal Police Commission of any case in connection with the trafficking in drugs and the counterfeiting of currency.

With regard to the latter, it will be more particularly advisable to send me three specimens of the counterfeit or forged notes or coins.

It will not, indeed, ~~escape~~ <sup>escape</sup> your notice that, in order to struggle against these aspects of international crime, the centralization of information is absolutely necessary, and that the General Secretariat of the International Criminal Police Commission is the very place where the information thus gathered should be made use of.

RADIO COMMUNICATIONS WITH ICPC HEADQUARTERS IN PARIS

In October, 1947, the Bureau indicated to the International Criminal Police Commission through our Paris agent that we would agree to the establishment of a radio link between Washington and Paris. Under date of January 13, 1948, all preliminary matters having been taken care of, Bureau letter to Telford, our Paris agent, furnished detailed information concerning schedules and procedures to be followed, with the first schedule to begin on January 23. Since that time there have been four uses or attempted uses of the radio link. The first was a message originating in Copenhagen, relayed to us by Paris, requesting information from a New York bank for use in connection with an alleged violation of the Danish Exchange Control Act. The second was a request for us to relay a message to Santiago. This was refused since no arrangements for a radio link between Washington and Santiago have been made. The third was a letter from a police official in Prague requesting information to aid in establishing the identity of an individual whose picture was seen in a local magazine. The parents of a youth reported dead thought the picture was possibly that of their son. The letter requested that the reply be via radio to Paris. Radio communications between Washington and Paris had not been satisfactory either due to the poor quality of the equipment in Paris or because of use of a radio frequency which is unsuitable. Accordingly, the information was furnished by letter to Prague. This was prior to February 20. The fourth case was a radiogram from Paris which requests information in connection with some American Express Company traveler's checks.

The Foreign Liaison supervisor of the Security Division advises that the total requests from foreign police agencies, <sup>through ICPC</sup> exclusive of fingerprint matters, amount to three to five per month. Additional collateral information is that the Annual Convention of the ICPC is scheduled to be held in Prague in September. Among the Vice Presidents of ICPC are representatives of Yugoslavia and Czechoslovakia. Last summer Telford reported that the police representatives of the various countries attending the convention were of a high type and that the discussions were nonpolitical in character. Telford advised that he felt that the contacts with members of the ICPC were definitely advantageous to him.

messrs. Tolson, Tamm, Mohr, W. H. McCabe, Rosen and Harbo were in favor of discontinuing radio communication with Paris on the ground of lack of facilities and personnel. Presumably any letters we may receive in the future from police authorities in Prague or other Russian dominated countries will be ignored. We can much more easily ignore a letter from those countries than we could a radio message which is relayed to us through the Paris headquarters of the ICPC, since with our present radio link we are in daily radio contact with Paris and it might be awkward to explain to Paris why we have not replied to a request received via radio. Also, due to the unsettled conditions in Europe it might be embarrassing to us and we might be criticised for carrying on radio communications in behalf of police agencies in countries where the police may be Communist infiltrated or dominated, or where there may be some question as to whether the police are loyal to their own government as distinguished from a Communist group under the domination of Russia.

Messrs. Glavin, Ladd and Tracy felt that we should continue the radio communications; that failure to comply with the agreed operational procedures can be corrected by bringing these matters to the attention of Telford; that the requests received are of a police nature rather than of an intelligence character; that the continuance of the radio link will enable us to maintain a good contact and carries with it a certain prestige.

For the Director's information the State Department knows of our membership in ICPC since our \$1500.00 annual due is paid through the State Department; however, the files do not reflect that the State Department has been advised of the radio link between Washington and Paris.

It is also essential for the General Secretariat to know in what manner, in your Country, the problem of international relations has been solved.

There were three possible solutions to this problem :

- to let the regional or local authorities correspond with foreign Countries, provided they keep you informed of what is happening;
- to specify that you alone are entitled to correspond with foreign Countries, the regional or local authorities being not allowed to do so;
- to have all international relations centralized through the channel of your Office, the regional and local authorities having free scope to correspond with foreign Countries, in urgent cases.

It was emphasized that, in any case, the relations of regional or local authorities were to be placed under the control of the National Central Bureau.

I should be very grateful to you for informing me of the solution you adopted and of the directions you gave to the various police authorities in your Country, in the matter of international relations.

I think it advisable to recall that our General Meeting was in favour of the principle of centralisation.

If no arrangements have been made so far in this field, I strongly advise you to put this principle into practice, in so far as it is compatible with the administrative organization of your Country.

Whatever the provisions made to this effect may be in each Country as far as the relations with foreign police departments are concerned, it had been decided that the International Bureau would be informed of the correspondence exchanged between the police departments in two different Countries, in connection with a criminal.

...

This method constitutes, indeed, the safest means of adding to the documentation of the International Bureau and of disclosing the activities of international criminals.

I am sorry to note that this system has not been adopted and I think it advisable to draw your attention to this very omission.

As a matter of fact, practical experience showed that the centralization of information, even when it does not seem to be of the first importance, is likely to lead to the conclusion of judicial affairs on an international basis.

Therefore, I beg to ask you to be good enough to take care that the Resolution unanimously carried by the General Meeting shall be put in force.

Dear Mr. HOOVER,

With further reference to my letter n° I377 of the 7th October inst., I beg to inform you that two new frequencies have just been allocated by the International Centre for the radio-electric communications between PARIS and WASHINGTON :

████████ kilocycles and █████████ kilocycles.

It was specified, however, that the █████████ frequency should be used by the PARIS transmitting Station, and the █████████ K frequency by the WASHINGTON transmitting Station.

The French technicians consider that the said frequencies could be used during the month of November, between █████████ (GMT), although a severance of communications is to be feared in the middle of the day.

I therefore request you to be good enough to cause, with the above-mentioned frequencies, new experiments, identical with those which have already been carried out, to be made on the days and at the times which you will fix.

I would add that more detailed arrangements should be made as soon as the permanent traffic is assured.

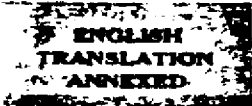

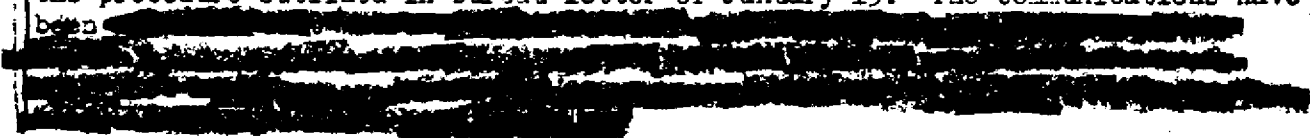

In October, 1947, the Bureau indicated to the International Criminal Police Commission through our Paris agent that we would agree to the establishment of a radio link between Washington and Paris. Under date of January 13, 1948, all preliminary matters having been taken care of, Bureau letter to Telford, our Paris agent, furnished detailed information concerning schedules and procedures to be followed, with the first schedule to begin on January 23. Since that time there have been four uses or attempted uses of the radio link. The first was a message originating in Copenhagen, relayed to us by Paris, requesting information from a New York bank for use in connection with an alleged violation of the Danish Exchange Control Act. The second was a request for us to relay a message to Santiago. This was refused since no arrangements for a radio link between Washington and Santiago have been made. The third was a letter from a police official in Prague requesting information to aid in establishing the identity of an individual whose picture was seen in a local magazine. The parents of a youth reported dead thought the picture was possibly that of their son. The letter requested that the reply be via radio to Paris. Radio communications between Washington and Paris had not been satisfactory either due to the poor quality of the equipment in Paris or because of use of a radio frequency which is unsuitable. Accordingly the information was furnished by letter to Prague. This was prior to February 20. The fourth case was a radiogram from Paris which requests information in connection with some American Express Company traveler's checks.

None of the radio transmissions from Paris have been in conformity with the procedure outlined in Bureau letter of January 13. The communications have been



The Foreign Liaison supervisor of the Security Division advises that the total requests from foreign police agencies, <sup>through ICPC</sup> exclusive of fingerprint matters, amount to three to five per month. Additional collateral information is that the Annual Convention of the ICPC is scheduled to be held in Prague in September. Among the Vice Presidents of ICPC are representatives of Yugoslavia and Czechoslovakia. Last summer Telford reported that the police representatives of the various countries attending the convention were of a high type and that the discussions were nonpolitical in character. Telford advised that he felt that the contacts with members of the ICPC were definitely advantageous to him.

Messrs. Tolson, Ladd, Mohr, W. H. McCabe, Rosen and Harbo were in favor of discontinuing radio communication with Paris on the ground of lack of facilities and personnel. Presumably any letters we may receive in the future from police authorities in Prague or other Russian dominated countries will be ignored. We can much more easily ignore a letter from those countries than we could a radio message which is relayed to us through the Paris headquarters of the ICPC, since with our present radio link we are in daily radio contact with Paris and it might be awkward to explain to Paris why we have not replied to a request received via radio. Also, due to the unsettled conditions in Europe it might be embarrassing to us and we might be criticized for carrying on radio communications in behalf of police agencies in countries where the police may be Communist infiltrated or dominated, or where there may be some question as to whether the police are loyal to their own government as distinguished from a Communist group under the domination of Russia.

Messrs. Glavin, Ladd and Tracy felt that we should continue the radio communications; that failure to comply with the agreed operational procedures can be corrected by bringing these matters to the attention of Telford; that the requests received are of a police nature rather than of an intelligence character; that the continuance of the radio link will enable us to maintain a good contact and carries with it a certain prestige.

For the Director's information the State Department knows of our membership in ICPC since our \$1500.00 annual due is paid through the State Department; however, the files do not reflect that the State Department has been advised of the radio link between Washington and Paris.

Dear Sir:

During a recent conversation with M. DUCLOUX, Secretary General of the International Criminal Police Commission, he made the observation that the Bureau has been most cooperative and helpful to the Commission, which is deeply appreciated, but the Commission has rendered little or no service to the Bureau.

He refers particularly to the primary function of the I.C.P.C., viz: the international dissemination of wanted notices and information regarding international criminals, and remarked that the Bureau has filed no wanted notices with the Commission nor has it requested any information from the Commission files regarding international criminals.

M. DUCLOUX pointed out that in spite of the fact that only a portion of the files of the Commission has been recovered from Berlin, the Commission has nevertheless accumulated from various members, information on between 20,000 and 30,000 known international criminals. This deposit of information has been most helpful to European Commission members in the apprehension of these criminals and the suppression of crime among this type of criminal. An "international criminal" is defined as anyone who travels internationally, or likely to do so. Any criminal who has been arrested in various countries falls into this category and are confined principally to smugglers, confidence men, jewel thieves, narcotic traffickers, etc.

M. DUCLOUX suggested that more use can be made of the Commission by the Bureau submitting wanted notices and information on this type of criminal as well as requesting information from the Commission regarding individuals on whom they have, or can, be of value to the Bureau.

Radio Communication between Bureau and the  
International Criminal Police Commission, Paris

Reference is made to letter of January 10, submitting schedule data and operating procedure suggestions for use in the operation of the RUC circuit between Paris and Washington. The first message received from Paris was one that originated at Copenhagen and was received by the Bureau on February 5, 1948. It appears that Paris had completely ignored the suggestions outlined to you in the referenced letter and the Bureau's letter of September 24, 1947; the message was ~~unintelligible~~ and did not contain any of the operational features suggested by the Bureau.

Subsequently, on February 12, 1948, the Paris radio station requested the Bureau operator to accept a message destined for Santiago, Chile. Inasmuch as the Bureau had not been advised of the completion of arrangements for including Santiago in the network, it was necessary to refuse to accept the message. The Bureau had no radio communication with Santiago. Again on February 19, a message was received from Paris which failed to follow any of the previously suggested procedure, inasmuch as the message was in uncodified French.

In another instance, the Bureau received a letter from Paris requesting that certain information be forwarded by radio to Paris for relay to France. Therefore, based on difficulty in securing agreement on the method of operating the network and further because it is felt that it might be embarrassing to the Bureau to carry on radio communications in behalf of police agencies in countries where the police may be Marxist dominated, the Bureau has decided to abstain from participation in the RUC radio network.

The suggestions you made for operations have received careful attention by our technicians and serve as a basis for transmission regulations. As a matter of fact the regulations used by the Paris-Washington operations, in my opinion, should be adopted by all the other stations of our network, and I will propose them to our other members with whom we maintain radio communications.

I would be grateful if you would bring these observations to the attention of Mr. Hoover.

As a matter of information, it is noted that in connection with the radio circuit with the International Police Commission at Paris, which in accordance with the Bureau's letter of January 10, 1948, was placed in regular scheduled operation January 23, 1948, the Paris Terminal has been experiencing considerable difficulty in providing readable signal at Washington. This difficulty was expected, based on our earlier test with the Paris station and is primarily occasioned by the frequencies selected for operation by Paris. It is known that they are seeking new and better frequency authorizations.

To date, only a single message has been received from Paris since the initiation of regularly scheduled service, that message having been received on February 5, 1948.

On May 3 the Conference composed of Messrs. Tolson, Tamm, Glavin, Tracy, Mohr, Nichols, N. H. McCabe, Ladd, Rosen and Harbo considered the proposal of Horton R. Telford, Legal Attache at Paris, France, that the Bureau reestablish the radio link between Washington and ICPC at Paris. This radio link was in operation for several weeks but was terminated on March 27 pursuant to the Director's approval of Executives Conference recommendation dated March 9, 1948.

Mr. Telford, in his letter of April 23, points out that the former ICPC-Bureau radio link was the only radio communication facility between Paris and Washington except the regular commercial French telegraphic and radio service under the control of the Ministry of Post, Telephone and Telegraph; the latter is now used by all the government agencies in the Embassy including the State Department, Military Attache, Naval Attache, CIA and Mr. Telford. He further points out that the Embassy has for some time been perfecting plans for evacuation and destruction of records in case of emergency; that the Ambassador is much concerned lest we are overlooking a possibility of communication with Washington in case of emergency and has requested Telford to call this to the attention of the Director, since it is felt that in case of an invasion of France the French government radio and telegraphic system will be one of the first ministries to be taken over, leaving the Embassy completely cut off from the outside. Telford concedes there is no assurance that the same thing would not happen insofar as the ICPC radio station is concerned since it is not located at the Embassy for obvious reasons.

The Conference was unanimously of the opinion that Telford's recommendation be disapproved. It is felt that in the event there is a need for an emergency radio station it should be located at the Embassy; that this is the responsibility of the State Department or CIA. Certainly it is not the responsibility of the FBI.

We withdrew from the ICPC radio network last March on the ground of lack of facilities and personnel; further, because of the unsettled conditions in Europe and the possible embarrassment and criticism which might be directed at us for carrying on radio communications in behalf of police agencies in countries where the police may be Communist infiltrated or dominated.

If the Director approves the Conference recommendation, the proposed cablegram should go forward to Telford.

Dear Sir:

Please refer to Bureau letter of March 17, 1948, advising that the Bureau has decided to withdraw from participation in the I.C.P.C. radio network, and my cablegram #566 of April 23.

Sometime ago the Embassy security officer, upon instructions of the State Department, made a survey of communication facilities available to the Embassy in case of emergency, at which time the I.C.P.C. radio set-up with the Bureau was explained, and it was pointed out that the Commission had offered their facilities to this office at any time desired.

I am now advised that the I.C.P.C.-Bureau facilities are the only ones now existent between Paris and Washington except the regular commercial French telegraphic and radio service under the control of the Ministry of Post, Telephone and Telegraph, which is now used by all the government agencies in the Embassy; the State Department, Military Attache, Naval Attache, C.I.A., etc., besides this office.

The Embassy has for some time been perfecting plans for evacuation, destruction of records, etc., in case of emergency. This office, of course, is participating in the plan and arrangements have been made for the burning of files, codes, etc., as well as in other phases of the program.

Since the Bureau's decision to withdraw from participation in the I.C.P.C. radio network, the Ambassador is much concerned lest we are overlooking a possibility of communication with Washington in case of emergency, and has requested me to call this to the attention of the Director.

It is felt that in case of an invasion of France that the French government radio and telegraphic system will be one of the first industries to be taken over, leaving the Embassy completely cut off from the outside. Of course there is no assurance that the same thing might not happen insofar as the I.C.P.C. radio network is concerned. On the other hand there is always the possibility that this may be overlooked or that an exception may be made in view of the international character of the Commission. In any case it is strongly felt that this possibility should not be ignored.

The Ambassador has therefore suggested that the Bureau consider re-establishing radio communication with the I.C.P.C. if for no other reason than to have it available in case of emergency and if and when no other means of communication is possible.

It has furthermore been suggested that if the Bureau agrees to the above plan that the Bureau be prepared to automatically pass on to the State Department any coded message received which is obviously not in the Bureau code. If this is agreed to, the Embassy will make advance arrangements with the State Department communication center as to what code, etc., will be used in such an emergency. In such a case the Bureau would act simply as a receiving station for the State Department.

Inasmuch as the I.C.P.C.'s offer to transmit coded messages to the Bureau from this office still stands, it is respectfully suggested that the Bureau give serious consideration to the Ambassador's recommendation, with which the writer concurs.

In view of the importance attached to this problem locally it is suggested that a cablegram reply be despatched.
