On September 20, 1948, the "Morning Freiheit" contained on page six an article entitled "Israel Leaders, Dr. Moshe Sneh and Svi Lurie Come to America." This article related that these individuals would arrive in the United States within a few days. Sneh was said to have been invited by the Progressive Zionist League for a series of lectures throughout the country. It was reported that Lurie was proceeding to this country to take office as one of the six newly elected members of the American Section of the Executive Committee of the World Zionist movement. The article finally stated that in honor of the two guests a welcoming party was being held at the St. Nicholas Arena in New York City on October 14, 1948.

The Department of State is being furnished with the additional data received to date concerning Menachem Beigin. At the same time I am advising the State Department of the investigation which you have requested concerning the Freedom Movement in Israel.

Our New York Office is also being given these additional data and is being advised to report all further information which is received concerning Beigin or which is developed during its inquiries concerning the Freedom Movement. In the event you have any specific investigation which you desire conducted with respect to this matter, your advice would be appreciated.
