b7D In April, 1947 [redacted] had been received at the Consulate. Investigation in an effort to [redacted] was conducted by the New York City Police Department at the time. The Bureau was advised of the facts at that time and no active investigation was undertaken by this office. The September 10, 1947 [redacted] apparently dissimilar to those previously received at the Consulate.

b7D On the same day it was tactfully suggested to [redacted] that in view of the protective measures instituted and continued by the New York City Police Department and the continuing investigation of the numerous anonymous telephonic threats referred to that Department by the Consulate, that instant [redacted] be referred to the police for their information and assistance in the investigation. The [redacted] was thereupon returned to him. Mr. ROBEY expressed satisfaction with this procedure and extended thanks for Bureau cooperation in the matter.

No further investigation is being conducted by this office.

ASAC Lynch of the New York Division advised that the [redacted]

[redacted] Mr. Lynch stated that a previous threat of this type had been sent to the British Consulate and since that time the Consulate had been receiving 24 hours protection from the New York Police Department.

I advised Mr. Lynch that since this is a threat to kill the matter should be discussed with the FBI and if he does not feel that action should be taken by us a copy should be made of the [redacted] threat and sent to the New York Police Department.

ADDITIONAL: 9/12/47 ASAC R. J. Lynch advised that the U. S. Attorney, Southern District of New York, declined prosecution and the [redacted] turned over to the New York City Police Department who were handling the matter.
