JACK SOBIE /MOCASE/, ESPIONAGE - R. MYRA SOBIE ARRESTED THIS DATE AT RESIDENCE, THREE TWO ONE WEST SEVENTY EIGHTH STREET BY BUREAU AGENTS. DURING INTERVIEW SUBSEQUENT TO ARREST DENIED IMPLICATION ESPIONAGE ACTIVITIES. HAS NO KNOWLEDGE OF ESPIONAGE BY OTHERS. NEVER ACTED AS AGENT OF FOREIGN POWER. INFORMANT CONFRONTATION RESULTS NEGATIVE. SOBIE ARRAIGNED BEFORE USC, EARL N. DISKOPF, SDNY THIS DATE AND RHAILED CUSTODY USK, SDNY IN LIEU OF ONE HUNDRED THOUSAND DOLLAR BOND. PRESENTLY LODGED WOMEN-S HOUSE OF DETENTION, NYC. ON REINTERVIEW AT THAT INSTITUTION, SOBIE CONTINUED TO DENY GUILT. REMARKED ALLEGATIONS ABSOLUTELY UNSURE AND MEANS NEVER COMMITTEE CRIMES AGAINST U.S. DENIED INTENT TO LEAVE COUNTRY WITH FAMILY. IN ADDITION TO RELATIVES, ADMITTED ACQUAINTANCE WITH JANE AND GEORGE ZLATOVSKI, ALFRED STERN, JACOB ALBAN, BORIS MORRIS. CLAIMED NO KNOWLEDGE OF ILLEGAL ACTIVITIES BY ANY OF THESE INDIVIDUALS. DENIED KNOWING ZUBILIN, CHALIAPIN, JOSEPH KATZ, REBECCA GETZOFF AND MARK ZBROWSKI. SOBIE IS STEADFAST IN DENIAL OF HER GUILT. SHE WAS AMIABLE DURING INTERVIEWS. SHE IS NOT YET REPRESENTED BY COUNSEL AND HAS NO OBJECTION TO FUTURE INTERVIEW.

DIRECTOR URGENT

JACK SOBLE /MOCASE/, ESP DASH R. INTERVIEW WITH JACK SOBLE BEGAN TEN ZERO FIVE AM IN WARDEN-S OFFICE, FEDERAL HOUSE OF DETENTION. SOBLE FIRST REFUSED TO COME DOWN FROM CELL, BUT THEN CONSENTED TO COME DOWN AND READ ITEMIZED LIST OF PROPERTY REMOVED FROM HIS APARTMENT. SOBLE STATED THAT HE DID NOT WISH TO BE INTERVIEWED UNTIL HE HAD TALKED TO AN ATTORNEY, AND SAID THAT HE HAD NO PARTICULAR ATTORNEY IN MIND, BUT THAT HIS BROTHER, ROBERT, WAS OBTAINING AN ATTORNEY. THE ITEMIZED LIST OF PROPERTY WAS HANDED TO SOBLE AND HIS GLASSES WERE SENT FOR BECAUSE HE HAD FORGOTTEN THEM. WHILE WAITING FOR HIS GLASSES, SOBLE SAID "I WILL GET YOUR MAN AND PROVE HIM TO BE A LIAR". WHEN ASKED WHAT MAN, SOBLE SAID MORROS AND FLATLY REFUSED TO COMMENT FURTHER. SOBLE THEN COMPLAINED THAT HE HAD NOT SLEPT AND HAD A BAD HEADACH. SOBLE THEN READ AND SIGNED ITEMIZED LIST OF PROPERTY REMOVED FROM HIS APARTMENT. ARRANGMENTS WERE MADE WITH OFFICER PIERRE DE MONTRABEL TO HAVE HIM BROUGHT TO THE HOUSE OF DETENTION HOSPITAL FOR EXAMINATION. SOBLE THEN ROSE AND INSISTED THAT THE INTERVIEW BE TERMINATED. SOBLE SAID HE MIGHT SEE AGENTS AFTER TALKING TO HIS ATTORNEY. SOBLE WAS AGAIN REMINDED OF THE INFORMATION APPEARING IN THE LETTERS READ TO HIM THE PREVIOUS NIGHT AND URGED TO RECONSIDER SERIOUSNESS OF HIS PREDICAMENT. SOBLE THEN REQUESTED KENNEDY TO RETURN HIM TO CELL. INTERVIEW TERMINATE TEN NINETEEN AM.

JACK SOBLE /HOCASE/, ESP DASH R. NYRA SOBLE REINTERVIEWED WOMEN-S HOUSE OF DETENTION, NYC, ONE TWENTYSIX FIFTYSEVEN. FURNISHED BACKGROUND INFORMATION INCLUDING PLACES OF RESIDENCE OF HERSELF AND HUSBAND IN EUROPE PRIOR TO NINETEEN FORTYONE, IDENTITY OF HER RELATIVES AND RELATIVES OF HUSBAND. ADVISED CONCERNING ACQUAINTANCE WITH JACOB AND BERTHA ALDAM, GEORGE AND JANE ZLATOVSKI, AND ALFRED STERN DENIED SHE OR HUSBAND EVER IN PRISON OR CONCENTRATION CAMP. DENIED KNOWING OR RECOGNIZING PHOTOS OF FEDOTOV, KOROTKOV, VASILY AND ELIZABETH ZUBILIN, DOCTOR HENRY SPITZ AND BEATRICE SPITZ. ADMITTED KNOWING THE FOLLOWING.... ALEXANDER POSEN, FORMER RESIDENT OF POLAND AND AUSTRALIA WHO MARRIED EXWIFE OF BORIS SOBLES, OSCAR VOLLES WHOSE ENMIGRATION TO CANADA FROM GERMANY JACK SOBLES PARTIALLY FINANCED ABOUT NINETEEN THIRTY, ALEXANDER IAS, BORIS ELIAS AND ADA ANCHELWITZ. STATED KNOWS HENDAL LADSKY WHO DEPARTED LITHUANIA AND ARRIVED JAPAN SAME TIME AS SOBLES. LADSKY ARRIVED CANADA SIX YEARRRRRRRR AGO FROM AUSTRALIA WHEN HE WENT FROM JAPAN AFTER WORLD WAR TWO. FURNISHED SIGNED STATEMENT SETTING FORTH INFORMATION CONCERNING ABOVE MENTIONED ACQUAINTANCES AND DENYING ESPIONAGE ACTIVITY BY HERSELF OR HUSBAND.

JACK SOBLE /MOCASE/, ESPIONAGE DASH R. RE INTERVIEW WITH JACK SOBLE
BEGAN FIVE FORTY PM CAPTAIN-S OFFICE, FEDERAL HOUSE OF DETENTION.
SOBLE ADVISED HE HAD TRIED TO GET IN TOUCH WITH HIS BROTHER, ROBERT,
AND HAD MANAGED TO GET HIS SON. SOBLE SAID THAT HE WAS TRYING TO OBTAIN
A LAWYER BUT HAD NO PARTICULAR LAWYER IN MIND. HE WAS AGAIN ADVISED
OF HIS RIGHT TO ATTORNEY AND RIGHT NOT TO MAKE STATEMENT. SOBLE
AGAIN QUESTIONED RE ASSOCIATION WITH ZUBILIN WHOM HE KNEW AS FOMIN AND
ADVISED ZUBILIN GOT IN TOUCH WITH SOBLE BY LETTER AND OFFERED TO
SELL SOBLE BRISTLES. ZUBILIN MET WITH SOBLE SEVERAL TIMES IN NINETEEN
FORTYTHREE. HE ADVISED THAT HE MET FOMIN PAREN ZUBILIN END PAREN
SEVERAL TIMES WHILE HE, SOBLE, THOUGHT THE ASSOCIATION WAS STRICTLY
SUSPECT THAT ZUBILIN WAS ATTEMPTING TO RECRUIT SOBLE TO SERVE IN THE
SOVIET UNION AND HE THEREUPON DROPPED ZUBILIN. SOBLE PRESSED ON THIS
POINT BUT WOULD NOT ELABORATE. ADVISED THAT HE HAD PURCHASED THE
CAFETERIA AT THIRTYEIGHTH STREET AND FIFTH AVENUE IN ABOUT NINETEEN
FORTYFOUR AND PAID FOR IT WITH PART OF THE FOURTEEN THOUSAND DOLLARS
HE HAD OBTAINED FROM HIS FATHER IN NINETEEN FORTYONE. SOBLE ADMITTED
MEMBERSHIP FROM NINETEEN TWENTYONE TO NINETEEN TWENTYEIGHT IN THE
SOCIALISTISCHE STUDENTEN FRACTION IN LEIPZIG, GERMANY WHICH CONTAINED
ALL TYPES OF QUOTE PROGRESSIVE PEOPLE SUCH AS COMMUNISTS,
END PAGE ONE.....

ANARCHISTS, AND OTHER ANTI CAPITALIST END QUOTE. IN PARIS IN NINETEEN FORTYEIGHT SOBLE ADVISED HE INTRODUCED BORIS MORROS TO JACK ALBAN AND TOLD MORROS THAT ALBAN WAS A PHOTOGRAPHER. SOBLE ADVISED HE RECALLS INCIDENT OF HANDING ENVELOPE FULL OF MONEY TO MORROS TO CARRY THROUGH CUSTOMS. HE SAID HE RECALLED THE ENVELOPE CONTAINED TWO TO THREE HUNDRED DOLLARS. SOBLE ADVISED HE MET JANE FOSTER ZLATOVSKI AT STERN-S HOME IN NINETEEN FORTY SIX. THIS HOME WAS LOCATED ON CENTRAL PARK WEST BETWEEN SEVENTY SECOND AND SEVENTY FIRST STREETS. HE ADVISED THAT HE MET GEORGE ZLATOVSKI IN NINETEEN FORTY EIGHT WHEN GEORGE CALLED HIM RE TWO THOUSAND DOLLAR LOAN MADE BY JANE TO SOBLE. SOBLE MET GEORGE IN FRONT OF FORTY SECOND STREET CAFETERIA TO REPAY THIS LOAN. SOBLE WOULD NOT SPECIFY WHETHER LOAN REPAYED BY CHECK OR WITH CASH. SOBLE THEN QUESTIONED RE DOCUMENT GIVEN TO MORROS ON MAY THIRTY NINETEEN FIFTYSIX. HE WAS PERMITTED TO SEE ONE PAGE OF WRITING AND DENIED IT WAS HIS HANDWRITING. HE APPEARED UPSET. HE WAS THEN QUESTIONED ABOUT CONTENTS OF DOCUMENTS. HE ADMITTED SOME OF THE STATEMENTS PERTAINING TO PERSONAL DETAILS WERE TRUE. HE ADMITTED KNOWING MARK ZBROWSKY, MENTIONED IN DOCUMENT AND SAID HE KNEW ZBROWSKY RESIDED IN BRONX. WHEN QUESTIONED RE HIS KNOWLEDGE OF ZBROWSKY HE REFUSED TO COMMENT. HE ADMITTED KNOWING STERN, THAT STERN WAS IN MEXICO AND THAT STERN HAD A BUSINESS IN MEXICO. HE WOULD NOT ELABORATE ON THIS. WITH REGARD TO OSCAR VOLLES HE ADMITTED KNOWING ACQUAINTANCE. SOBLE BECAME RESTIVE, SAID HE WAS TIRED AND WISHED TO END INTERVIEW. MENTION OF NAME OF LADSKY ELICITED ADMISSION THAT HE KNEW LADSKY. HE AGAIN REITERATED DESIRE FOR ATTORNEY AND WAS AGAIN ADVISED OF RIGHT TO COUNSEL. INTERVIEW TERMINATED AT SEVEN FORTY TWO PM AS HE REFUSED TO BE QUESTIONED FURTHER. HE REFUSED TO COMMENT AS TO FURTHER INTERVIEW.

MYRA INTRODUCED ALBAM TO ALICE MARTIN SO LATTER COULD GET HIM A BRIDE. MYRA BELIEVES ALICE KNEW OF BACKGROUND AND PURPOSE OF ALBAM. MYRA MET MAMES MARTIN JULY NINETEEN FIFTY TO GET A REPORT FROM HIM

JACK SOBLE ESP-R. MOCASE. JACK SOBLE INTERVIEWED MORNING AND AFTERNOON FOUR TWELVE INSTANT AT FEDERAL CORRECTIONAL INSTITUTION, DANBURY, CONN. SOBLE ASSERTED THAT HE DESIRED TO COOPERATE FULLY AND DISCLOSE ALL INFO KNOWN TO HIM TRUTHFULLY AND IN DETAIL. SOBLE GAVE THE APPEARANCE OF BEING UNDER PHYSICAL AND MENTAL STRAIN. IN INTERVIEW HE ATTEMPTED TO RAMBLE AND TO DISCUSS MATTERS OTHER THAN POINT IN DISCUSSION. SOBLE WAS SLOW IN SPEECH AND GAVE THE APPEARANCE OF ATTEMPTING TO RECALL NAMES, DATES, ETC. SOBLE STATED THAT AFTER ARRIVAL IN THE US IN FORTYONE HE PROCEEDED TO BOSTON. SHORTLY THEREAFTER HE WENT TO CANADA TO ASSIST HIS BROTHER BORIS SOBLE, IN THE CANADIAN ANIMAL HAIR COMPANY WHICH WAS BEING BUILT. SOBLE STATED THAT THERE WAS A POLITICAL SPLIT IN HIS FAMILY WITH HIS FATHER MOTHER AND SISTERS BECOMING ANTI COMMUNIST. SOBLE STATED THAT AFTER HE WENT TO CANADA HE TRAVELLED SOMEWHAT IN RELATION TO THE CANADIAN ANIMAL HAIR BUSINESS. HE STATED THAT SOMETIME IN FORTYTWO HE RECEIVED A LETTER FROM AMTORG SIGNED BY FOMIN, CHIEF OF THE BRISTLE DIVISION AT AMTORG, WHICH PROPOSED A SALE OF RUSSIAN BRISTLES. SOBLE ADVISED AT THIS.

POINT THAT ON LEAVING RUSSIA NO FORMAL CONTACT IN THE US HAD BEEN ARRANGED. SOBLE ADVISED THAT OVER PROTEST FROM HIS BROTHER, BORIS, HE WENT TO NYC TO MEET FOMIN AT AMTORG ON MADISON AVE IN NYC. SOBLE STATED THAT HE HAD TWO MEETINGS WITH FOMIN AND AT THE SECOND MEETING, FOMIN STATED THAT HE HAD A MAN WHO WANTED TO MEET SOBLE. SOBLE RELATED THAT HE WAS AT THIS TIME RESIDING AT THE HOTEL PARIS IN NYC AND A DAY OR TWO LATER HE WAS CONTACTED BY VASSILI ZUBILIN. SOBLE STATED THAT UNTIL MUCH LATER HE ONLY KNEW ZUBILIN BY THE NAME VASSILI MIKHAILOVICH AND NEVER KNEW HIS LAST NAME. ZUBILIN TOLD SOBLE THAT HE WANTED SOBLE TO BE OF ASSISTANCE TO HIM AND THE SOVIETS IN AN ALLIED EFFORT TO DEFEAT THE GERMANS AND THE JAPANESE. SOBLE STATED THAT ZUBILIN HAD TOLD HIM "YOU ARE AT MY MERCY" AND INSISTED THAT SOBLE JOIN THE EFFORT IN RELATION TO WINNING THE WAR. SOBLE CONTINUED CONTACTS WITH ZUBILIN UNTIL ZUBILIN INTRODUCED HIM TO CHALIAPIN WHOM SOBLE KNEW AS MISHA, BUT WHO TOLD SOBLE THAT HIS NAME WAS THE SAME AS THAT OF A FAMOUS RUSSIAN SINGER AND SOBLE TOLD CHALIAPIN THAT MUST BE HIS NAME. SUBJECT RELATED THAT BOTH CHALIAPIN AND ZUBILIN BECAME ANNOYED WITH SOBLE-S RESIDENCE IN CANADA AND INSISTED THAT HE MOVE TO NY WHERE HE COULD BE OF MORE SERVICE TO THEM. SOBLE PRESENTED HIS PROBLEM TO THEM OF LACK OF FUNDS AND THE

FACT THAT HE HAD FOURTEEN THOUSAND DOLLARS IN THE IMPERIAL BANK OF CANADA AND NO WAY OF BRINGING IT INTO THE US. SOBLE RELATED THAT ZUBILIN AND CHALIAPIN STATED THEY WOULD TAKE CARE OF THIS MATTER. THE FOURTEEN THOUSAND DOLLARS WAS A DISTRIBUTION TO SOBLE OF HIS FATHER-S ASSETS WHICH AMOUNTED TO ONE HUNDRED AND THIRTYFIVE THOUSAND DOLLARS. SOBLE MENTIONED THAT HE TOLD ALEXANDER ELIAS THAT THE SOVIETS WERE HELPING HIM TO TRANSFER PART OF THIS MONEY, THIS AMOUNT BEING PLACED AT ABOUT FOUR THOUSAND DOLLARS TO THE US. SOBLE RELATED THAT ELIAS DID NOT SEE THE SOVIETS IN CANADA. SOBLE RECALLED THAT THE SOVIET

ZUBILIN AND CHALIAPIN DROVE TO CANADA BY CAR AND PICKED UP A PORTION OF THE FOURTEEN THOUSAND DOLLARS WHICH WAS LOCATED AT THE IMPERIAL BANK IN CANADA IN THE ACCOUNT OF JACK AND MYRA SOBLE. SOBLE RELATED THAT THE SOVIETS TOOK FOUR THOUSAND DOLLARS IN CASH BACK TO THE UNITED STATES FOR HIM. SOBLE STATED THAT HE HAD NO IMMEDIATE ASSIGNMENT OR CONTACTS AND THAT MARK ZBOROWSKI WAS INTRODUCED TO SOBLE BY CHALIAPIN IN FORTYTHREE. SOBLE STATED THAT ZBOROWSKI WAS AN ENTHUSIASTIC AND EAGER SUPPLIER OF INFO AND SAID ZBOROWSKI FURNISHED WRITTEN REPORTS ON A REGULAR BASIS AND THAT SOBLE-S PRESENT RECOLLECTION IS THAT THESE CONCERNED TROTSKYITES, MENSHEVIKS AND ON^e PROFESSOR DALLIN AND MRS DALLIN. SOBLE STATED THAT ZBOROWSKI TOLD HIM THAT A SOVIET WAS GOING TO FLEE FROM ONE OF THE SOVIET ESTABLISHMENTS IN THE US AND ZBOROWSKI DID NOT KNOW WHETHER THE FLEEING SOVIET WAS FROM AMTORG OR THE SOVIET EMBASSY NOR DID HE KNOW THE NAME. SOBLE RELATED THAT ZBOROWSKI HAD APPARENTLY MET THE PROSPECTIVE SOVIET DEFECTOR ON THE STREET IN THE VICINITY OF DALLIN-S HOUSE AND DIRECTED THE INDIVIDUAL TO DALLIN-S HOUSE. SOBLE SAID THAT ZBOROWSKI IMMEDIATELY CONTACTED HIM, TOLD HIM OF THE SITUATION AND REQUESTED THAT SOBLE-S SUPERIORS BE NOTIFIED. SOBLE NOTIFIED CHALIAPIN, WHO IN TURN NOTIFIED ZUBILIN. SOBLE WAS THEN CONTACTED BY ZUBILIN WHO CENSURED HIM FOR SUCH INFO AS ZUBILIN APPARENTLY DID NOT BELIEVE THERE WAS TO BE A DEFECTION.

SOBLE SAID THAT SEVERAL DAYS LATER THE ANNOUNCEMENT OF VICTOR KRAVCHENKO-S DEFECTION APPEARED IN THE NEWSPAPERS AND THIS WAS THE INDIVIDUAL TO WHOM ZBOROWSKI HAD REFERRED. SOBLE SAID THAT HE PAID ZBOROWSKI ONE HUNDRED FIFTY DOLARS A MONTH. SUBSEQUENT TO THE TIME THAT SOBLE WAS TURNED OVER BY CHALIAPIN TO CHOUNDENKO, CHOUNDENKO REQUESTED TO MEET ZBOROWSKI. CHOUNDENKO, KNOWN TO SOBLE AS THE "PROFESSOR", CLAIMED THAT ZBOROWSKI WAS NOT SUPPLYING SUFFICIENT INFO FOR THE PAYMENT BEING MADE. SUBSEQUENT TO SOBLE-S INTRODUCTION OF CHOUNDENKO AND ZBOROWSKI, SOBLE DID NOT THEREAFTER, SEE ZBOROWSKI. SOBLE CLAIMED THAT ZBOROWSKI KNEW SOBLE-S NAME AND WAS OF A FRIENDLY DISPOSITION TO SOBLE, SINCE SOBLE HAD NOT PUSHED HIM FOR INFO. ZBOROWSKI TOLD SOBLE OF PREVIOUS ACTIVITY FOR THE SOVIETS IN THE TROTSKYITE MOVEMENT IN EUROPE AND MENTIONED HIS RELATION TO TROTSKY-S SON, LEON SEDON. SOBLE RELATED IN RELATION TO JACOB ALBAM THAT HE HAD KNOWN HIM IN VILKAVISKIS, LITHUANIA, CASUALLY. SOBLE STATED THAT HIS RELATION TO ALBAM IN THEIR HOME TOWN WAS LIMITED BECAUSE OF THE FACT THAT ALBAM WAS OF AN OLDER AGE GROUP THAN HIMSELF. SOBLE RELATED THAT HE HAD MET ALBAM FOR THE FIRST TIME AFTER LEAVING LITHUANIA IN TWENTY NINE IN PARIS, WITH SOBLE-S WIFE MYRA. SOBLE RECALLED THAT HE MET ALBAM AGAIN IN THIRTY THREE OR THIRTYFOUR IN MOSCOW. SOBLE STATED THAT TO THE BEST OF HIS RECOLLECTION ALBAM WAS EMPLOYED IN MOSCOW AT THAT TIME. SOBLE

STATED THAT HE HIMSELF HAD SPENT FROM THIRTY THREE UNTIL FORTY WORKING IN MOSCOW AS A JOURNALIST. SOBLE STATED THAT THE NEXT TIME HE SAW ALBAM WAS IN FORTY SEVEN IN PARIS. SOBLE STATED THAT DURING THE YEARS HE, HIMSELF, SPENT IN MOSCOW HE WAS NOT SURE WHETHER ALBAM RESIDED THERE FOR ANY LENGTH OF TIME BUT INDICATED THAT ALBAM MIGHT HAVE HAD SOME ASSIGNMENTS UNKNOWN TO HIM. IN FORTY SEVEN ALBAM TOLD SOBLE WHEN THEY MET IN PARIS THAT HE HAD SPENT THE WAR IN SIBERIA HAVING BEEN EVACUATED FROM MOSCOW. SOBLE RELATED THAT THE FORTYSEVEN MEETING IN PARIS TOOK PLACE WITH THE ASSISTANCE OF JACOB ALBAM-S BROTHER, SOLOMON ALBAM WHO HAD GIVEN TO SOBLE JACOB ALBAM-S ADDRESS IN PARIS. SOBLE AT THIS POINT RELATED THAT HE WAS NOT AWARE HIMSELF OF SOLOMON ALBAM-S KNOWLEDGE OF HIS BROTHER JACOB-S ACTIVITIES. WHEN SOBLE MET ALBAM IN PARIS SOBLE DID NOT HAVE A SOVIET CONTACT. ALBAM INTRODUCED SOBLE TO HIS SOVIET CONTACT NAMED MISHA. SOBLE STATED MISHA-S LAST NAME WAS PROBABLY KOUZNETZOV. KOUZNETZOV TOLD SOBLE THAT SOBLE SHOULD GO TO MOSCOW. SOBLE PROCEEDED ON HIS AMERICAN PASSPORT TO PRAGUE WHERE HE WAS MET AND TRAVELLED ON SOVIET PAPERS TO MOSCOW. IN MOSCOW SOBLE WAS INTERVIEWED BY PETROV AND MET FEDOTOV AND ZUBILIN. SOBLE STATED THAT HE WAS QUESTIONED AT THIS TIME IN RELATION TO HIS KNOWLEDGE OF MARTHA

AND ALFRED STERN, ESTHER RAND AND POSSIBLE THE MARTINS, ALSO CONCERNING SOBLES POSSIBLE FUTURE USEFULNESS TO THE SOVIETS, SOBLE TOLD THEM OF THE FACTORY IN VERBERIE AND HIS DESIRE TO PURCHASE IT FROM HIS BROTHER. FODOTOV PROPOSED GIVING SOBLE TWENTY FIVE THOUSAND DOLLARS FOR THIS AND ZUBILIN OBJECTED SAYING THE MONEY WOULD BE PAID IN FRANCE. ON RETURN TO PARIS VIA VIENNA AND PRAGUE SOBLE AGAIN MET ALBAM. SOBLE STATED HE DID NOT KNOW WHAT ALBAM-S ASSIGNMENTS WERE AT THAT TIME BUT SAID THAT THE SOVIETS THROUGHT KOUZNETSOV INSTRUCTED ALBAM TO PROCEED TO THE US. ALBAM PROCEEDED TO THE US AND SOBEL MET HIM IN LATE FORTYSEVEN IN US. SOBLE RELATED THAT ALBAM HAD TOLD HIM THAT HE HAD RETURNED TO PARIS IN FORTYSIX VIA A RUSSIAN PLANE WHICH WAS LANDED IN PARIS AND ALBAM WAS SMUGGLED FROM THE PLANE, INASHUCH AS ALBAM SPOKE FRENCH WELL AND ARRANGED FOR FRENCH PAPERS. SOBLE DENIED THAT HE HAD ASSIGNMENT TO GET WIFE IN US FOR ALBAM BUT ADMITTED THAT HE HAD CONTACTED ALICE MARTIN AND RAND IN EFFORT TO GET WIFE FOR ALBAM. ALBAM IN FORTYEIGHT RETURNED TO PARIS AFTER MARRIAGE AND SOBLE MET HIM THERE. SOBLE CLAIMED HE DID NOT KNOW RELATIONS OF ALBAM WITH KOUZNETSOV THOUGH SOBLE ADMITTED KOUZNETSOV WAS HIS SOVIET CONTACT AT SAME TIME. SOBLE CLAIMED THAT HE DID NOT KNOW ASSIGNMENT OF ALBAM FOR SOVIETS IN US BUT SAID ALBAM TOLD HIM SOVIETS HAD FINANCED TRIP AND GIVE ALBAM FUNDS FOR MAINTENANCE. SOBLE STATED THAT ONLY REPORT HE SECURED

FROM ALBAM IN THE US WAS STATEMENT BY ALBAM CONCERNING HIS UNSUCCESSFUL VENTURE INTO PLASTICS INDUSTRY AND HIS LIVING STATUS HERE. DATE OF THIS REPORT WAS PROBABLY FORTYNINE. ALBAM AT SAME TIME ASKED SOVIETS AS TO STATUS OF ALBAM-S WIFE AND DAUGHTER STILL RESIDING IN SOVIET UNION. SOBLE CLAIMED HE DID NOT OBTAIN FROM SOVIETS ASSIGNMENT FOR ALBAM IN US BUT WAS INSTRUCTED TO MAKE FINANCIAL PAYMENTS TO ALBAM. SOBLE SAID ALBAM HAD TOLD HIM OF TWO SOVIET CONTACTS HE HAD IN US, ONE FO WHOM PAID ALBAM ONE THOUSAND DOLLARS AND THE OTHER IN RELATION TO ALBAM-S PROJECTED VENTURE IN STATIONARY STORE. SOBLE CLAIMED ALBAM WAS MOST SECRETIVE EVEN WITH SOBLE AND SOBLE DID NOT LEARN DETAILS OF ALBAM-S CONTACTS OR ASSIGNMENTS. IN FIFTY MEETING IN VIENNA WITH PETROV, PETROV INSTRUCTED SOBLE THAT ALBAM WAS BEING OVERPAID AND TO REDUCE PAYMENTS TO HIM. SOBLE STATED THAT AFTER ARREST OF SOBLES AND ALBAM HE MET ALBAM IN COURT APPEARANCES AND ALBAM STATED THAT DOCUMENT HE HAD GIVEN TO MORROS WAS HIS DOCUMENT BUT HE WOULD DENY AUTHORSHIP. ALBAM TOLD SOBLE THAT HE WOULD SAY THAT THE "A" MENTIONED IN DOCUMENT WHICH REFERRED TO ABRASHA-JACK SOBLE/ WAS ABELIEN, A PERSON ALBAM KNEW IN FRANCE, WHO WAS NOW DECEASED. ALBAM TOLD SOBLE HE HAD SEEN THE DOCUMENT COPY IN POSSESSION HIS ATTORNEY. SOBLE HAD ALSO SEEN DOCUMENT AND STATED HE BELIEVED DOCUMENT WAS SIGNED "BELOVO" WHICH SOBLE SAID WAS SOVIET CODE NAME FOR

ALBAM. SOBLE STATED THAT ALBAM WAS VERY TALENTED TECHNICALLY INCLUDING PHOTOGRAPHY AND ALBAM HAD MENTIONED THE FACILITY SOVIETS HAD IN MAKING FALSE PASSPORTS AND MAY WORKED IN SUCH DEPT IN MOSCOW. CONCERNING ILYA WOLSTON, SOBLE MENTIONED THAT WHILE HE WAS IN MOSCOW IN THIRTIES, HE CONTINUALLY RECEIVED LETTERS FROM ILYA WOLSTON INDICATING DESIRE OF WOLSTON TO COME TO RUSSIA BUT THIS HAD NEVER BEEN EFFECTED. IN DISCUSSION ILYA WOLSTON AND ROBERT SOBLE, JACK BECAME EMOTIONAL AND HESITATED FOR LONG PERIODS OF TIME BEFORE ANSWERING THE QUESTION OR DIVERTED TO OTHER SUBJECTS. WITH RELATION TO ROBERT SOBLE, JACK STATED THAT ROBERT WAS MORE DEEPLY INVOLVED THAN JACK AND THAT IF ROBERT SOBLE DID NOT MAKE FULL DISCLOSURE OF HIS ACTIVITIES, JACK WOULD DO SO. JACK SOBLE ALSO MENTIONED THAT CHOUDENKO IN FORTYFIVE ARRANGED MEETING IN NY WITH INDIVIDUAL SUBJ CLAIMS HE DOES NOT KNOW. CHOUDENKO DESCRIBED THIS SOVIET AS AN IMPORTANT PERSONALITY. SOBLE MET THIS INDIVIDUAL AT A MEETING PREARRANGED ON RIVERSIDE DRIVE, NY, AND AGREED TO MEET HIM IN WASH, DC. SOBLE CLAIMED THAT HE AVOIDED WASH, DC MEETING ON FIRST SCHEDULED DATE, BUT WAS BOTHERED BY CHOUDENKO TO MAKE SECOND MEETING. AT MEETING IN WASH, DC, SOBLE WAS PROPOSITIONED TO OPERATING A DRESS AND FASHION STORE FOR WHICH SOVIETS WERE TO ADVANCE THREE HUNDRED THOUSAND DOLLARS. SOBLE OBJECTED THAT HE COULD NOT ACCOUNT FOR THREE HUNDRED THOUSAND DOLLARS TO FINANCE THIS VENTURE. SOBLE IN RELATION TO THIS MEETING STATED THAT HE WAS ALSO PROPOSITIONED TO TAKE CHARGE OF A

SOVIET GROUP IN WASH WHICH WAS OPERATED BY THE INDIVIDUAL HE MET. DESCRIPTION OF THIS INDIVIDUAL GIVEN BY SOBLE AND MAY POSSIBLY BE ANATOLI GROMOV OR GROMOV ASSOCIATE. SOBLE ALSO MENTIONED THAT ESTHER RAND HAD GIVEN HIM WRITTEN REPORTS RELATING TO HER WORK AT UNITED JEWISH APPEAL AND STATED THAT ESTHER HAD SOVIET CONTACT PRIOR TO SOBLE. INTERVIEW WAS TERMINATED ON FOUR TWELVE WHEN SOBLE CLAIMED PHYSICAL AND MENTAL STRAIN PREVENTED HIM FROM CONTINUING. SOBLE EXPRESSED CONCERN OVER THE STATUS OF HIS SON, LARR, INASMUCH AS LARRY IS PRESENTLY RESIDING WITH ROBERT AND DINA SOBLE. AT AGENT-S INSISTENCE, JACK SOBLE STATED HE WOULD DEFINITELY DISCLOSE ON FOUR THIRTEEN NEXT, INFO IN HIS POSSESSION CONCERNING ROBERT SOBLE. INTERVIEWS OF SOBLE CONTINUING ON FOUR THIRTEEN NEXT AND AS OFTEN AS PRISON ROUTINE AND SOBLE-S CONDITION MAKES IT POSSIBLE. PURSUANT TO BUREAU AUTHORIZATION RECEIVED PM OF FOUR TWELVE, AUSA GILCHRIST WAS ADVISED ON LATE AFTERNOON FOUR TWELVE THAT JACK SOBLE DURING INTERVIEWS ADVISED THAT ALBAM HAD ADMITTED TO SOBLE ALBAM WAS AUTHOR OF LETTER TO MORROS. THAT ALBAM TOLD SOBLE THAT ALBAM HAD MADE UP A STORY CONCERNING THIS LETTER TO BE USED IF ALBAM HAD TO TESTIFY CONCERNING THE LETTER. THAT JACK SOBLE STATED ALBAM HAD OTHER SOVIET PRINCIPAL IN US AND THAT JACK SOBLE WOULD DISCLOSE DETAILS CONCERNING ROBERT SOBLE IF ROBERT SOBLE DOES NOT FURNISH THIS INFO. KOROTKOV. NOW STATES MET KOROTKOV DURING NINETEEN FORTYEIGHT AT GENEVA. PHOTOS OR NAMES OF ANATOLI B. GROMOV, SOVIET CONSULAR OFFICIAL, NY, NINETEEN FORTYFIVE, JOHANNA BECKER, DR. IN NYC. THE ZUBILINS TOLD HIM THAT HE WAS TO PAY THE RENT FOR BOOKER-S APARTMENT. ON VISITS TO BOOKER-S HE WOULD OBTAIN INFORMATION FROM DOXSEE WHO WAS THE SECRETARY TO CANNON OF THE SWP. SOBLE CLAIMED THAT DOXSEE FURNISHED HIM WITH TYPEWRITTEN REPORTS CONCERNING THE FACTIONAL FIGHTS WITHIN THE TROTSKYITE MOVEMENT. HE SAID THAT DOXSEE CONTINUALLY REQUESTED THAT SHE BE RELEASED FROM THIS WORK AS SUCH WORK MADE HER NERVOUS. SOBLE STATED HE TURNED DOXSEE-S REPORTS OVER TO CHALIAPIN AND LATER TO CHOUDENKO. CHOUDENKO IN LATE NINETEEN FORTYFIVE AUTHORIZED HIM TO PERMIT DOXSEE TO LEAVE THE SWP AND GO BACK TO CHICAGO. SOBLE CLAIMED THAT HE KNEW NOTHING OF DOXSEE-S LIFE, INCLUDING HER HUSBAND AND CLAIMED SHE NEVER DISCUSSED HER ACTIVITY OR SUPERIORS PRIOR TO SOBLE. SOBLE STATED THAT WHEN HE WAS INTRODUCED TO BOOKER BY THE ZUBILINS THEY INDICATED THAT BOOKER HAD WORKED WITH THEM IN BERLIN AND WAS COMPLETELY TRUSTWORTHY. RE MARK ZBOROWSKI COLON SOBLE INTENSIVELY INTERROGATED CONCERNING MARK ZBOROWSKI. HE REITERATED INFORMATION PREVIOUSLY GIVEN RE ZBOROWSKI, ADDING ONLY THAT SUBSEQUENT TO SOBLE-S INTRODUCTION OF ZBOROWSKI TO CHOUDENKO, SOBLE OUT OF FRIENDSHIP MET ZBOROWSKI ON TWO SUBSEQUENT OCCASIONS. HE CLAIMED THAT ZBOROWSKI TOLD HIM THAT CHOUDENKO HAD BEEN MUCH MORE STRICT IN DEMANDING INFORMATION FROM ZBOROWSKI AND AKSING ZBOROWSKI TO INTENSIFY HIS INFILTRATION OF THE TROTSKYITE AND MENSHEVIK MOVEMENTS. IN MOSCOW FEDOTOV TOLD SOBLE THAT ZBOROWSKI HAD BEEN MISHANDLED. SOBLE INDICATED THAT THIS REFERRED TO CHOUNDENKO HANDLING OF ZBOROWSKI. IT WAS INDICATED THAT ZBOROWSKI MIGHT BE RECONTACTED BY THE SOVIETS. SOBLE CALIMED HE DID NOT CONTACT ZBOROWSKI AGAIN. THE REPORTS OF ZBOROWSKI, ACCORDING TO SOBLE, WERE HANDWRITTEN IN ENGLISH. IN THE LAST CONTACTS OF SOBLE WITH ZBOROWSKI, ZBOROWSKI EXPRESSED FEAR BOTH THAT THE RUSSIANS WOULD PRESSURE HIM AND THAT THE FBI WOULD FIND OUT ABOUT HIM. CONCERNING MENDEL LADSKY, SOBLE STATED THAT LADSKY NEVER FURNISHED A REPORT TO HIM, HOWEVER, AT THE INSISTENCE OF THE RUSSIANS, HE CONTACTED LADSKY TO ATTEMPT TO GET A REPORT FROM HIM. LADSKY TOLD HIM AT THAT TIME, WHICH WAS PROBABLY NINETEEN FORTYEIGHT OR FORTYNINE, THAT HE WOULD BE READY TO WORK FOR THE SOVIETS IN ANOTHER YEAR. ON SUBSEQUENT CONTACTS BY SOBLE WITH LADSKY, LADSKY ADVISED THAT HE HAD GOTTEN A JOB WITH THE JEWISH ORGANIZATIONS AND WAS THEN ANTI SOVIET. SOBLE CALIMED HE DID NOT KNOW IF LADSKY WAS EVER CONTACTED

BY ANY OTHER SOVIETS. CONCERNING ALEXANDER ELIAS, SOBLE RELATED THAT SOMETIME IN THE WINTER OF NINETEEN FORTY TWO DASH FORTYTHREE, THAT ZUBILIN HAD ASKED HIM TO GET IN TOUCH WITH ELIAS AND THAT ELIAS HAD COME TO NYC AND THAT ZUBILIN, SOBLE AND ELIAS TOOK A RIDE IN ZUBILIN-S CAR TO NEW JERSEY VIA THE GEORGE WASHINGTON BRIDGE TO AN OLD FARM HOUSE WHICH ZUBILIN STATED WAS OWNED BY THE RUSSIANS. SOBLE CLAIMED HE DID NOT KNOW WHAT TYPE OF ASSIGNMENT ELIAS WAS TO RECEIVE, BUT HE STATED THAT ELIAS WAS QUESTIONED BY ZUBILIN AS TO POSSIBLE SOURCES IN CANADA THAT ELIAS KNEW WHO MIGHT BE OF VALUE TO THE SOVIETS. SOBLE STATED THAT ELIAS FURNISHED ZUBILIN WITH SOME NAMES OF COMMUNISTS WHO COULD BE APPROACHED IN CANADA. SOBLE CLAIMED HE COULD NOT RECALL WHO THESE PEOPLE WERE. SOBLE CLAIMED THAT HE DID NOT KNOW WHETHER THE SOVIETS HAD CONTACTED ELIAS IN CANADA. HE STATED THAT BOTH ALEXANDER AND ELIZA ELIAS HAD BEEN COMMUNISTS IN CANADA AND THAT PROMINENT COMMUNISTS VISITED A SUMMER HOME THE ELIASES HAD OUTSIDE OF MONTREAL IN A PLACE CALLED RENOIR /PH/, INCLUDING FRED ROSE. SOBLE STATED THAT THIS SUMMER HOME WAS AT ONE TIME SEARCHED BY THE RCMP, BUT THAT NO ARRESTS WERE MADE. SOBLE SAID THAT WHEN HE TRANSFERRED THE APPROXIMATELY FOUR

ACTIVITIES FOR THE SOVIETS IN THE US HE RECEIVED A SALARY OF ONE HUNDRED
FIFTY DOLLARS PER MONTH PLUS THE FUNDS HE HAD TO PAY HIS AGENTS AS LUCY
