By letter dated March 19 last [REDACTED] of Metro-Goldwyn-Mayer Studios, Culver City, California, transmitted to the Los Angeles Field Division the following described communications which were received from subject:

(1) One penny postal card postmarked [REDACTED], March 13, 1946, addressed to "Messrs. Louis B. Mayer & Samuel Goldwyn, c/o M.G.M. Studios, Inc., Culver City, California." This postal card, which was typewritten and signed with a typewriter [REDACTED] contained the following text:

3/11/46

"Dear Friends:

"The whole International set-up is this: British Financiers do not like the idea of Russian Power on the Continent of Europe anymore than they liked Nazi Power on the Continent of Europe: Hence, the potentiality of a third World War: A war with Russia would dispense with Russian power on the Continent of Europe and would KILL GIVE American Industry, natural resources and Finance (\$) and at the same time ENHANCE British Maritime Trade, Industry, agricultural exports, and FINANCE (\$), etc., etc. The Rothschilds, of England, are founders and head Executives of the British Financial System, Lombard and Threadneedle Sts., London, England.

Result of Examination:

It was further concluded that [redacted], whose signatures appear on fingerprint cards on file in the Bureau, wrote the [redacted] signatures on the following specimens: Q4, Q1, Q2, Q3, Q5, Q6, Q7, Q8, Q9, Q10, Q11, Q12, Q13, Q14 and Q15 in File FD-11821.

Specimen Q1 in this case was submitted by the Washington Field Office on August 21, 1944. Specimens Q1 through Q3, File FD-11821, were submitted by the Miami Field Division under date of December 7, 1943 in connection with the case entitled [redacted]; Darryl Zanuck, Victim, Extortion".

SYNOPSIS OF FACTS: Subject located and interviewed [REDACTED] his home town, where he is regarded by acquaintances and relatives as mentally deranged. USAs, EDNC and MDC, declined prosecution.

DETAILS:

[REDACTED] advised that he has been acquainted with subject and his family for many years, and that he is generally regarded in the community as a "mental case". [REDACTED] knows of subject's tendencies toward writing letters, and stated that he is not taken seriously by those who know him.

[REDACTED] has known for a long time that subject is mentally deranged. He explained that subject has been treated in mental institutions, but still seems in need of treatment. He said he had never heard anything which might indicate that subject is dangerous, but has some obsession about the Government and prominent people. He said subject was born in [REDACTED] that he attended [REDACTED] college, but did not graduate; and that he was generally unbalanced since after leaving school. According to [REDACTED]

[redacted] this mental disturbance first manifested itself by subject proclaiming himself to be an atheist. B 79  
62

[redacted] confidentially expressed a desire for the Bureau to proceed against subject in some way, in order that he might be admitted to some institution for treatment. He said he would not like to have subject's aged parents know he had made this suggestion, because he felt that they would oppose such a move. In view of the fact that such cases are handled through the office of the Clerk of Superior Court, in North Carolina, he was asked why he had not taken some action in this respect. He replied that he hesitated to offend [redacted] and also that the [redacted] had been exceeded already. [redacted] said he knew of subject's letter writing activities; in fact, had recently been seriously embarrassed by a scurrilous letter written by subject to the Governor of North Carolina, for which he personally apologized and explained the situation to the Governor when asked about it. He said he had no influence with subject, but that [redacted] might be of some assistance.

[redacted] advised that he had been expecting a call from some Government authority regarding [redacted] who he said is mentally deranged. He related that this derangement became pronounced in the early 1920's when subject was discharged from the U. S. Marine Corps. He said subject joined the Marine Corps after World War I, and served for some time in China. Although he did not know definitely, he said he believed subject had been discharged because of his mental condition. Shortly thereafter, subject was placed in an asylum [redacted] and later transferred to [redacted] State Hospital for the Insane [redacted] he was transferred to [redacted]

[redacted] stated it is possible [redacted] may be able to exercise sufficient influence over subject to cause him to stop writing libelous and defamatory letters; however, he expressed doubt concerning this possibility. He stated he believes the best course of action would be to have subject confined in some institution where he could obtain medical care, and asked if the Bureau could accomplish this.

On January 23, 1944, the Charlotte Office received a letter from [redacted]

little attention. The writer attempted to interview subject in a cramped  
nearby, and as soon as subject was seated in the car he began a loud and lengthy  
tirade against the Government, the New Deal, Jews, England and such interna-  
tionally known personalities as the Director, Mr. BERNARD BASHUK, the late  
President ROOSEVELT, and WINSTON CHURCHILL. His speech was loud, incoherent  
and frequently very obscene. It was difficult to determine whether there was  
any central theme in his thinking, unless it was that he and the public gener-  
ally is victimized by some fantastic international Jewish financial conspiracy.  
Although he was warned of the consequences of violating the Federal extortion  
laws, it is doubted that such a warning had any effect, as it seemed to  
represent another example of Government oppression in that he was being denied  
his constitutional right of free speech.

The Honorable GREGORY CHERRY, Governor of North Carolina, advised that  
he had a hazy recollection of having received a letter from subject, but did  
not recall its contents and could not locate the letter.

[redacted] advised Special Agent [redacted]  
to interview subject as a result of a letter addressed to the  
President of the United States, in which he made reference to the writer's  
visit and the FBI generally in a derogatory and obscene manner.

The Miami and Los Angeles Offices were advised by telegram March 23,  
1944 that subject had been located.

The facts pertaining to communications mailed from the Eastern District  
of North Carolina were presented to U. S. Attorney JOHN HILLMAN, who de-  
clined to authorize prosecution because the contents of the letters in the

Possession of this Office do not constitute a violation. It is noted the obscene material has not been furnished the Charlotte Office.

B7C It is noted that the last letter received from the Los Angeles Office which contains a threat to kill Rubin. RUBIN was postmarked at [redacted] which is in the Middle District of North Carolina. Accordingly, the facts were presented to Assistant U. S. Attorney Rubin [redacted], who declined prosecution because of subject's mental condition. She stated that it appeared from the investigation that subject was mentally unsound, as he had been treated at several mental institutions, and that a mentally incompetent person could not enter a plea if tried.

On March 30, 1946, [REDACTED] **B7C**  
[REDACTED] of the Charlotte Post Office Department, advised that her  
office was in possession of ten postal cards of a declamatory  
nature, eight of which were addressed to the FBI, Washington, D.  
C., and the remaining two, to Army Intelligence, c/o General  
DWIGHT D. EISENHOWER, Washington, D. C. In addition, [REDACTED]  
advised that they were in possession of ten magazines of the  
movie mirror variety which were unaddressed but had the words,  
"FBI OO" appearing on the inside covers.

[REDACTED] stated that the post cards and magazines were found in  
street letter box on [REDACTED]  
just in front of the Courthouse Building on March 5, 1946. She  
advised that the magazines were not considered as mail inasmuch  
as no stamps were thereon, and also because the post cards were  
defaced (writing appearing on the address side of the cards) they  
were not eligible for mailing.

It is believed that the writing appearing on the instant post  
cards and magazines were prepared by [REDACTED] the sub-  
ject of the instant case, who is mentally deranged.

Inasmuch as the United States Attorneys in the Eastern and Middle  
Districts of North Carolina have previously declined prosecution  
of subject because of his mental condition as advised in the  
report of Special Agent [REDACTED] dated April 9, 1946, at  
Charlotte, North Carolina, no further prosecutive action is  
anticipated at this time.

The Laboratory is requested to conduct an investigation of the  
handwriting appearing on the instant ten post cards to ascertain  
whether the writer is identical with [REDACTED]

**SYNOPSIS OF FACTS**

Communications written during past three years by subject and forwarded to victims via U.S. mail contained messages ranging from nuisance and obscene matter to threats to kill. Subject located and interviewed. [REDACTED] USA, Middle District, North Carolina declined prosecution. Subject considered mentally deranged, having had previous treatment in mental institutions, and not considered mentally capable of entering plea if brought into court.

**DETAILS:**

The activities of subject first came to the attention of the Los Angeles Field Division in November of 1943 when a letter addressed to Miss DOROTHY LAMOUR, Hollywood, California and postmarked [REDACTED] September 18, 1943 at 3:00 P.M. was referred to this office for evaluation and handling. Although this letter contains no threats or any statement which would constitute a violation of the Extortion Statute, it was felt that the information should be forwarded to the Bureau and placed on file, and that some investigation should be conducted to determine if the writer of the letter was of sound mind and also to prevent any further letters to be written to Miss LAMOUR.

The letter which was signed by [REDACTED] was pencil writ-

ten and contained instructions to the effect that Miss LAMOUR should proceed to Oakland, California and contact one [redacted] described as an airplane manufacturer representative, and further instructed that Miss LAMOUR should charter a plane from him. Miss LAMOUR was then given instructions to proceed to [redacted] to meet the writer of the letter.

During 1944, the FBI Laboratory in Washington, D.C. was in receipt of additional communications directed to people of prominence in this country which were identified as having been written by the same party who had written to Miss LAMOUR, and had signed his name as [redacted]. Victims in these additional communications include the French Ambassador, Washington, D.C. and the Director of the Federal Bureau of Investigation at the seat of government.

By letter dated February 27, 1946, [redacted] Cagney Productions, Inc., 1041 North Formosa, Hollywood 48, California, transmitted additional communications apparently written by subject to Mr. JAMES CAGNEY, well known motion picture actor.

By letter dated March 5, 1946, [redacted] Twentieth Century Fox Film Corporation, Beverly Hills, California furnished additional communications apparently written by subject and were received by Mr. DARRYL L. ZANUCK.

A description of the items received by Mr. CAGNEY and Mr. ZANUCK are being set forth herewith: These documents were forwarded to the FBI Laboratory for appropriate examination by letter dated March 1, 1946.

(1) A three-page letter dated and postmarked February 16, 1946, [redacted] On the back of the envelope it states: "ADOLPH HITLER is still alive in Germany (Berlin) Germans are smart (for the F.B.I.)" The letter itself begins: "Dear Darryl. Those nugs and yeggs will lay off of you: Now let's see if the F.B.I. is smart. I love LANA TURNER. You look like a bunch of saps to me. Signed, Your Friend, [redacted]"

The letter then continues "ADOLPH ZUKOR is the LEAD; The SCICH of the West Coast; The aincoanpoop from Frisco. Tell the F.B.I. that Adolph ZUKOR is the LEAD." The second page is obscene.

(2) A two-page letter and envelope dated and [redacted] February 14, 1946, addressed to Mr. DARRYL ZANUCK at Hollywood. This letter begins:

"Dear Darryl:- Give me time, for 'Christ sake' (\$), Rome wasn't built in a day; you've been a 'wet nurse' a long time."

The rest of the letter is of a rambling nature and mentioned many

prominent Hollywood characters.

(3) Envelope and one-page letter addressed to Mr. JAMES CAGNEY, Hollywood, California, date-stamped February 8, 1946. This letter is obscene and contains no threat of any nature.

(4) Envelope and four-page letter dated [redacted] addressed to Mr. JAMES CAGNEY at Hollywood. It begins:

"Dear Jimmy ole' boy: - You got in the biggest deal (\$) in history; I've been on them Rothschilds' [redacted] for years. Talk freely to the F.B.I. - and look out for my future wife, Miss LANA TURNER."

In this letter he says that ADOLPH ZUKOR is the man he is after; that ZUKOR sold information to the Germans during World War 2 and is tied up with an international opium ring and smuggling outfit. On page 2 he says:

"The F.B.I. and Scotland Yards, London, England are paid off (so you will have to be sure who you talk with); The F.B.I. was paid off (\$) by Jews - and Scotland Yards was paid off (pound sign) by the ROTHSCHILDS and the British Lords. Russia had absolutely nothing to do with it."

On Page 3 [redacted] says: "I was born [redacted] an of English, Scotch, Irish & Welsh descent -- and not a German." Further on he says he is a direct descendant of [redacted] of England and of [redacted] of Wales; that for confirmation CAGNEY should call his mother & father [redacted]

(5) Nine picture postcards, all postmarked 9:30 A.M., February 15, 1946. The following extracts are taken from some of these cards:

"F.B.I. paid off by Jews. J. EDGAR HOOVER is a Jew."

"Casablanca. Don't know any thing about it. Shanghai smart. Look out for LANA TURNER. Pay-off Big (\$)"

"WALTER WINCHELL is a STOOGE - Russian Jew. The pay-off is Big (\$). Am not tying you in."

"Black Hand, Rome and Naples, Italy, No good. Can't be trusted. MUGS dumb but trustworthy. F.B.I. paid off by JEWS."

"Black Dragon smartest outfit on earth. F.B.I. paid off by Jews (\$)"

(6) Letter dated at Weldon, N.C., 2/23/46, in envelope postmarked

[redacted], February 22, 1946, on stationery of [redacted] addressed to  
Mr. JAMES CAGNEY. The letter begins: "Dear Jimmy: - Go up there to see  
LANA. My word is my bond (\$)."

Although there appeared to be no direct threats contained in these  
communications, it was believed that the slander against the Federal Bureau  
of Investigation and the allegations regarding ADOLPH ZUCKOR, and obscene  
character of some of the letters warranted an investigation to determine  
the whereabouts of [redacted] and an extensive interview with him, and then  
presentation of facts to the appropriate United States Attorney. Accord-  
ingly, the Miami and Charlotte Field Divisions were requested to instigate  
an investigation of [redacted]

By letter dated March 19, 1946, [redacted] of the Metro-  
Goldwyn-Mayer Pictures, Culver City, California transmitted additional  
letters and one postal card, which were addressed to Messrs. SAMUEL GOLDWYN  
& LOUIS B. MAYER, in care of M.G.M. Studios, Inc., Culver City, California  
and all signed by [redacted]. These communications described below  
were forwarded to the FBI Laboratory for appropriate examination by letter  
dated March 26, 1946.

(1) One penny postal card postmarked [redacted] March 13,  
1946, addressed to "Messr. Louis B. Mayer & Samuel Goldwyn, c/o M.G.M.  
Studios, Inc., Culver City, California." This postal card, which was type-  
written and signed with a typewriter [redacted] contained the  
following text:

"3/11/46

"Dear Friends:

"The whole International set-up is this: British  
Financiers do not like the idea of Russian Power on the  
Continent of Europe anymore than they liked Nazi Power  
on the Continent of Europe: Hence, the potentiality of  
a third World War: A war with Russia would dispense with  
Russian power on the Continent of Europe and would RELIEVE  
GIVE American Industry, natural resources and Finance (\$).  
And at the same time ENHANCE British Maritime Trade, In-  
dustry, agricultural exports, and FINANCE (\$), etc., etc.

"The Rothschilds, of England, are founders and head  
Executives of the British Financial Systems, Lombard and  
Threadneedle Sts., London, England.

"Your Friend, [redacted]

(2) One letter postmarked [redacted] March 12, 1946, ad-  
dressed "Messrs. Samuel Goldwyn & Louis B. Mayer, c/o M.G.M. Studios, Inc.,  
Culver City, California. (Strictly Personal)." This letter is also type-  
written and is dated "3/10/46" [redacted] However, the signature

(3) One letter postmarked [redacted], March 13, 1946, ad-  
dressed "Messrs. Louis B. Mayer & Samuel Goldwyn, c/o M.G.M. Studios, Inc.,  
Culver City, California (Strictly Personal)." This communication, which  
was dated [redacted] 3/12/46," contained for the most part a type-  
written text. The signature, however, was in pencil, the name of [redacted]  
[redacted] and there was a post script at the bottom of the letter which  
was in pencil, partly handwritten and partly handprinted. The contents are  
set forth herewith:

"Movies have a brilliant FUTURE (\$): The sky \$ is the limit.

"Floyd Gibbons wrote the 'Red Napoleon' about me--I had ABSOLUTELY NOTHING TO DO WITH IT.

I'll handle Lana's Personal affairs: For 'Christ Sake' don't tell 'er! She'll be all right: She has the erroneous idea of all Cinema Stars--that actresses have to be TEMPERMENTAL or temperamental (I forget). You can handle her easily--I'm sure of that: Why don't you star her again with Clark Gable and Robert Taylor? Clark Gable made her in 'Honky Tonk'--Wonderful cinema production.

"I just woke up -- I'm kinda DOPEY. I can't type, anyway: Can't write, either, for that matter.

"I knew FINANCE (\$), though: They (Wall St.) won't let me in. Ask Miss Turner. Ain't that classy? Clark Gable is a good guy."

(4) Letter postmarked [REDACTED], March 18, 1946, and addressed "Messrs. Samuel Goldwyn & Louis B. Mayer, c/o M.G.M. Studios, Inc., Culver City, California." This letter is dated [REDACTED] 3/18/46.

vised this office and Miami Field Division that subject had been located at  
[REDACTED], and was strongly believed to be mentally deranged.

By teletype dated April 2, 1946, the Bureau and this office were  
advised by the Charlotte Field Division that subject had been located and  
interviewed at [REDACTED]. It was also disclosed that in-  
vestigations in that district had reflected that subject had been treated in  
a mental institution.

The Charlotte Field Division also advised that the facts pertain-  
ing to the communications mailed from the Eastern District of North Carolina  
had been presented to the United States Attorney who declined prosecution be-

cause contents of the letters in possession of the Charlotte Office did not constitute a violation.

The teletype reflected that the facts pertaining to the letter mailed from ██████████ containing a threat to kill ADOLPH EULER had been presented to the Assistant United States Attorney of the Middle District of North Carolina who had declined prosecution, inasmuch as subject is considered mentally deranged and is not capable of entering any type of plea if brought into court. BK

In view of the fact of subject's mental condition, it is not deemed advisable to continue investigation in this matter and the victims have been appropriately notified.

A copy of this report is being furnished the Charlotte Field Division for information purposes; in view of the fact that subject resides in that district.
