After considering the matter Mr. Friedman indicated that it was his spinion that this is a product message in which there are some mistakes, the key being the use of a Newwood alphabet in connection with the true alphabet. The A of the reversed alphabet begins at M of the true alphabet as follows:

ABCDIFORIJELMNOPQROTOTYE

-LYANIMEN OF JUSTICE

This key works for the lirst four words "No not morry no". In the next word, however, there is an obvious mistake, the word reading "mail" them it should wend "will". he to the last word it is the idea of Mr. Friedman that the bord is "spring", whereas the symbols are slearly unde and the winstitution reads "ypring". It may be that a different key is used for this word or the two letters at the perintal this and of the words are deliberately substituted for the purpose of indicating the sender of the message or some other data which will be known its the recipient but which is not clear to the emminer. The initials of such a person could be ION or NIZ.

The Priedman stated that recently the Marden of the Penitentiany at Columbus, thio, forwarded a long eigher message which his unit deciphered. This was published in the necessages and is the probable reason sky the truy. Signal Corps was requested to assist with the cipher indicated above. One of the important things in desiphering such messages is to have available all siphers which seem to have any relation to each other. It, therefore, would seem that the prosecutor or other authorities the are handling the Dillinger Case should forward all sipher messages to one place.

The examiner states that notwithstanding the fact the slip of paper beginning "JY ES" appears to be a sipher message, it is believed that this is the work of a grank and not a granine attempt of Fillinger to communicate with Barry Pierpont, unless it be through the hope that the faller or others will release the information to the newspapers. Every time such a release deturns difficulty is placed in the way of deciphering such messages because now devices are immediately employed which must be deciphered and run down.

An effort is being unde to develop fingerprints on the envelope and paper and it is suggested that if the Division is to continue assisting in this connection in the Dillinger Case arrangements be unde so that the suspicious correspondence to any of these prisoners be protected and forwarded promptly for laboratory attention.



This will confirm my long distance telephone conversation with Mr. Clegg of the Division night before last at about ten o'clock. Mr. Clegg advised that the Division was in receipt of a telegram from the Citizens State Bank 1st. Cloud, Florida, informing that the bank had been robbed on March 21, 1934, by two or three men, one of whom had been identified as John Dillinger.

At 3 P. M. on March 21, 1934, the writer was advised by the Jacksonville Police Department that the Citizens State Bank at St. Cloud, Florida, had been robbed a few minutes prior to that time and that information had been received that Dillinger might have been one of the robbers. Mr. John Montgomery, Secretary, Detective Bureau, advised that this information had been broadcast to all officers in the State of Florida, and they were instructed to be on the lookout for these robbers. All law-enforcement officers were furnished with a description of the automobile used in the robbery.

Pursuant to Mr. Clegg's instructions, I immediately contacted Resident Agent R. L. Shivers at Tampa, Florida, and instructed him to proceed as soon as possible to St. Cloud to contact the officials of the Citizens State Bank in that town and to exhibit to them photographs of Dillinger to determine whether he was one of the participants in the bank robbery. Agent Shivers informed me that he had previously been advised of the robbery and that all officers in Osceola County, in which St. Cloud is located, and surrounding counties were on the roads in an effort to apprehend the robbers.

Pursuant to Mr. Clegg's instructions, I also by long distance telephone communicated with E. G. Hunter, Chairman of the Board, Citizens State Bank, St. Cloud, Florida. He informed that representatives of the insurance company had appeared in St. Cloud with photographs of Dillinger and other bank robbers and that persons in the bank during the robbery, after viewing pictures of Dillinger, had stated they believed he was one of the men involved. Mr. Hunter stated that the robbery took place

M. on March 21, 1934, and that the robbers obtained about ten thousand dollars in currency; that two of the robbers entered the bank; one remained in the door way. That in front of the bank they had parked a Plymouth coach bearing 1934 Indiana license tags number 572458; that this car had been stolen on March 15, 1934, from Haines City, Florida, the motor number being 90379, serial number 1831352. This car was used in the get-away. The robbers forced the cashier of the bank to accompany them for about two blocks, when they kicked him off. Mr. Hunter advised that the robbers had been chased into Orlando by the officers and they were headed toward Tavares, Florida, which is located about thirty miles northwest of Orlando, Florida.

During the night of March 21st the writer conferred with police officials and the sheriff's office in Jacksonville, Florida, and they advised that all officers attached to their departments had been instructed to be on the lookout for the automobile previously described and the robbers. They also informed that all officers in Florida, by radio and other methods of communication, had been informed of the robbery and requested to take appropriate action with a view of apprehending the persons involved in this robbery.

ADDENDUM: Since the above letter was typed, by long distance telephone, Special Agent R. L. Shivers from Orlando, Florida, communicated with me and advised that persons in the bank at St. Cloud, Florida, when the same was robbed on March 21, 1934, who had an opportunity to observe the robbers, were unable to identify any one of the three as being Dillinger. Agent Shivers informed that the descriptions of the robbers in no way tallied with the description of Dillinger. One of the men in the bank during the robbery stated that one of the robbers had a dimple in his chin.

Concerning this matter, further information will be furnished the Division as soon as I receive Agent Shivers' report.



Reference is made to Division letter of March 21, 1934, relative to Division telegram Wated March 6, 1934, quoting the telegram received from S. J. Iles, Chief of Police, Lake Charles, Louisiana, to the effect that he had in custody Dwight Rumbaugh, in whose possession the address of John Dillinger was found, and requesting immediate investigation.

You are advised that there is no record of the Division telegram referred to in the New Orleans office file. Immediately upon receipt of the Division's letter today, I communicated with Chief of Police S. J. Iles. Jr.. at Lake Charles, Louisiana, by telephone. He advised that at the request of the Sheriff at Erie, Kansas, he arrested Dwight Rumbaugh at Lake Charles: that at the time of his arrest, Tumbaugh had in his possession a note book containing numerous names and addresses, including the name of John Dillinger; that the address given for Dillinger in the book was the Vienna Restaurant. Trenton, New Jersey; that he, Chief Iles, endeavored to ascertain from Rumbaugh whether the John Dillinger listed in the note book is identical with the Subject of this investigation but that he was unsuccessful in eliciting any satisfactory information from Rumbaugh regarding this matter; that at the time of his arrest at Lake Charles, Emmbaugh also had in his possession a map of a robbery or prospective robbery at St. Louis, Missouri; that Rumbaugh had all the appearance of being a dangerous criminal, although he, Chief Iles, could get no definite or satisfactory information concerning his connections and activities.

Chief Iles stated that on March 5, 1934, Tumbengh was returned by the Sheriff to Erie, Kansas, and that he, Chief Iles, gave the Sheriff from Erie, Kansas, the above mentioned note book and maps at the time the Sheriff took custody of Rumbaugh for the return trip to Brie.

Chief Iles stated that he has no further information regarding this matter; that on the day following the departure of the Sheriff for Erie with Rumbaugh, he, Iles, addressed a telegram to the Division relative to this matter; that this telegram was not sent to the New Orleans office because he knew that Rumbaugh was no longer in this territory.

It appears that any further information will have to be obtained from the Sheriff at Erie, Kamsas, who has the note book and maps above referred to COPIES DESTROYED







He stated Special Agent Shivers would be instructed to call upon the bank officials for this purpose.



MEMORANDUM FOR THE DIRECTOR

Early this week, Mr. Coffey, of the Technical Laboratory, telephoned to inquire as to the identity of one Frank Carpenter, who, according to a letter received from the Sheriff, Mason City, Iowa, is believed to be an associate of John Dillinger. I advised Mr. Coffey that so far as the Dillinger file reflects, there was no connection between the two. Mr. Coffey later advised me that the Carpenter referred to by the Sheriff is identical with Frank Dennis Carpenter, a Division fugitive in a National Motor Vehicle Theft Act case of which the Los Angeles Office is the origin.

In accordance with the present practice, there has been prepared a memoranoum on Frank Dennis Carpenter for transmittal to the office of origin as of possible assistance in conducting its investigation of the case. Attached to the memoranoum was a photograph of Carpenter, and the complete criminal record as reflected from the files of the Identification Unit.

A comparison of the photograph of Carpenter with that of Dillinger reflects a striking resemblance between the two, and it is quite possible that one is being mistaken for the other. The criminal record of Carpenter, attached hereto, reflects errests from one end of the country to the other. The physical description of both Carpenter and Dillinger are nearly the same:

This communication is with reference to my long distance telephone conversation with Mr. Clegg of the Division on March 21, 1934, and to my letter of March 23, 1934.

I am now in receipt of a memorandum from Special Agent R. L. Shivers, Resident Agent at Tampa, Florida, in which he informs that on March 22, 1934, he made an investigation at Orlando and St. Cloud, Florida, to determine, if possible, whether John Dillinger was a participant in the robbery of the Citizens State Bank at St. Cloud, Florida, on the afternoon of March 21, 1934. Agent Shivers informed that from press accounts of the robbery appearing in the Orlando, Florida, papers for March 22, 1934, it seemed that several persons who witnessed the robbery identified the photograph of Dillinger as that of one of the participants.

At St. Cloud, Florida, Agent Shivers contacted E. G. Hunter, Chairman of the Board of the Citizens State Bank, and interviewed employees of the bank who were present during the hold-up and customers who were in the bank at the time. In no instance was any person able to identify Dillinger as one of the robbers except R. M. Scranton, a customer, who, when shown Dillinger's photograph, stated that he was sure it was of one of the men. He described Dillinger as wearing a light suit at the time. Agent Shivers states that as a matter of fact all three of the robbers were dressed in blue or black suits, and in questioning Mr. Scranton it was found that he did not have an opportunity to view the robbers sufficiently well to make an identification, and the person he identified as Dillinger was a different man from the one Mrs. Mary E. Gray, another customer who was in the bank at the time, thought was Dillinger, and her only way of making the identification was that the man she referred to had a dimple in his chin. It is Agent Shivers' opinion that the bank employees and customers were too frightened at the time to think of looking at the robbers with a view of future identification.

The robbery was staged by three men, according to agent Shivers, whom Paul Kirkpatrick, Cashier of the bank, described as follows:

The man named as "Number 1" was the leader and cleaned the vault and cage, forcing Kirkpatrick to take the money out of the vault and take it to the waiting automobile. At all times "Number 1" told the employees and customers to turn their faces from him and not to look at him, yet as they drove away from the bank "Number 1" told the cashier, who was forced to ride on the running board of the car for one block, that if any one asked him who called to tell them it was John Dillinger.

George Costin, Constable, Orlando, Florida, a reliable contact of the Jacksonville Division office, and Sheriff Harry Hand, Orlando, informed that they were satisfied Dillinger had nothing to do with the instant robbery; that in their opinion, from the methods employed, this job was pulled by the same gang who recently robbed the bank at Orange City, Florida, and that they have a line on these men and believe they will eventually take them into custody.

Gorre Carruthers, Deputy Sheriff of Orange County, Orlando, who

first appeared in St. Cloud, Florida, as an investigating officer of the Sheriff's force, exhibited many photographs of criminals to the persons who were in the bank during the robbery. Sheriff Harry Hand, under whom Carruthers is employed, stated to Agent Shivers that probably Carruthers in his desire for publicity had been over sealous in getting Dillinger identified as one of the participants.

Mr. Larson stated that they have had considerable difficulty in securing this information; that the Indiana State police have been covering the house and have not been giving the local police any information; that he, Larson, took the matter up with the local police and furnished them information from our files to show that the girl being covered is the girl by the name of Frichette who has been traveling with Dillinger; that they got rid of the man from the Indiana State Police and the Detroit police are relying on the Division to furnish assistance; that he is making arrangements to rent rooms across the street from where the girl is located and will keep her under surveillance.



MEMORANDUM FOR THE DIRECTOR

Concerning your memorandum dated March 24, 1934, relative to the surveillance of the Frichette girl in Detroit, you are adwised that I have talked with Mr. Larson about this matter by telephone, and have told him to keep the Division advised in detail and frequently, as to developments, in view of the importance of this lead. He stated that there were several women in this house, and several of them probably were directly or indirectly associated with members of Dillinger's gang. The mother of Prisoner Glark, who is being tried now in Indiana, is there and another woman by the name of Opal, as well as Ann Martin, Evelyn Frichette and a Wackson woman. It was at one time thought by Mr. Larson that Martin, Frichette and Jackson were identical, but from photographs received, it now appears that they are different. It had been assumed that the Frichette woman had come to Detroit from Arizona for the purpose of communicating with Dillinger. There is still another woman in the house by the name of Cherrington, who is from Chicago. They leave the house only at very infrequent intervals and the house is being watched twenty-four hours per day, and two or three times a night groups of men enter the house. The information as to the identity of those on the inside was obtained. from a police informant and Mr. Larson expects that he will be placed into touch with this informant today. Two Special Agents from Cincinnati are in Detroit and are being kept active on this assignment.

The Chicago Office will, by means of photographs, attempt to verify the identity of the woman who called on Dillinger at Crown Point, Indiana prior to his escape, as she may be in this house also. Frequent telegrams are received in this house and at various other places which are visited by different ones of this group, although the telegrams are addressed to different names and none of them are in code. Several of the wires have a tendency to connect up this entire mob with the Dillinger gang. Mr. Larson stated that he will keep active on the assignment and advise the Division of the results.

MEMORANDUM FOR MR. CLINGG.

There is attached hereto a memorandum from Mr. Milliam F. Friedman, chief cryptographer of the Intelligence Section of the Mar Department, together with carbon copies of communications covering a coded message and reputed safe deposit box key which were transmitted to the Mar Department for deciphering. The coded message and safe deposit box key were mailed, postmarked New York, New York, March 20, addressed to Harry Pierpont, Lima, Ohio, and purporting to be from Dillinger. Neither Mr. Friedman's Section nor the laboratory has yet been successful in decoding the message. It has been referred to the laboratory for treatment of latent fingerprints and at the present photographs are being made and you will be furnished copies of the same for the completion of the Division file.

The safe deposit box key has been submitted by Mr. Friedman with the suggestion Division agents undertake to determine whether it is, in fact, a key for a safe deposit box and its location. In this connection it is noted the key was manufactured by the Engle Lock Company, Terryville, Connecticut. The coded letter was postmarked New York and for some reason unknown the Lima authorities suggested the safe deposit box may be located in Tucson, arizons. Mr. Friedman has asked for the eventual return of the key and the original coded messages and I suggest he be advised by letter whether the Division is undertaking the suggested investigation.

Mr. Friedman has offered the full cooperation of his office in the attempted deciphering of any coded messages which the laboratory is unable to solve.

1. With reference to gangster code telephoned to your office by Major Bender this morning, I am enclosing herewith the original code as it came to us after being intercepted at Lima, Ohio, on March 21st, where Harry Pierpont, a notorious gangster is under trial. It will be noted that the letter was postmarked, New York City, March 20th, and that the envelope contains a return address to John Dillinger, another notorious gangster who escaped from an Indiana jail a few weeks ago. The code part of the return address may have some bearing on Dillinger's present address.

- 2. The letter included a key to a safety deposit box, and, while the entire matter may be the work of a crank, yet it is possible that it is real, and the entire letter is being forwarded in hopes that it may be of assistance to your code experts in solving the code.
- 3. Should the code prove to be a real one, and the return address give Dillinger's present address, it is suggested that you might report this to the Department of Justice officials in Washington, since they probably would like to bring about his capture.
- 4. The return of the original code, together with the envelop it was posted in, will be appreciated.

Confirming my telephone conversation with you this afternoon, please be advised that last year some time one of Chicago, Illinois, called at my office and informed me that he believed that he could furnish me with valuable information as to the location of John Dillinger. This was previous to the time when he was apprehended and sent to the Crown Point jail. Subsequent to Dillinger's escape I have been endeavoring to contact and I succeeded today in doing so.

He called at my office this morning and I laid the proposition out before him and told him that I would like him to endeavor to secure information in a confidential manner, as to Dillinger's whereabouts. He stated that he was out of work at the present time, and would be perfectly willing to work for me in this capacity, and stated that in view of the expenses which would be incurred by reason of his work in this respect, such as taking girls out to dinner and also contacting with men whom he knew would know where Dillinger is, he stated that he believed it would require about ten dollars a day, in order that he might be able to pay expenses and also have some left over for his work.

He informed me that there is one person in Chicago who is a contact of John Dillinger, and that if anybody in Chicago knows where he is, it is Illinois. He is there with one last name unkrown, who is one of the owners of this He informed me that







HARRY COPELAND was apprehended in Movember, 1933 in Chicago and is now incareerated in the Indiana State Penitentiary as a Parole Violator. Mr. Ernest M. Botkin, Prosecuting Attorney at Lima, Ohio informs me that he will undoubtedly take steps to have Copeland returned to Lima on the indictment now pending in that sity charging him with being implicated in the murder of Sheriff Jesse Sarber on October 12, 1935, on which date John Dillinger was liberated from the County Jail at Lima while being held awaiting prosecution regarding a bank robbery at Bluffton, Ohio.

EDNARD SHOUSE who escaped from the Indiana State Penitentiary on September 26, 1933 with mine others, was apprehended at Paris, Illinois in December and is also now incarcerated in the Indiana S tate Penitentiary. The Prosecuting Attorney at Lima has indicated that Shouse probably will not be prosecuted in that city for the murder of Sheriff Jesse Sarber, in which crime he is also implicated, but testified for the State during the prosecution of other Subjects.

HARRY PIERPONT, who was apprehended on J anuary 25 at Tucson, Arizona, was convicted at Lima, Ohio on Merch 10 for the murder of Sheriff Jesse Sarber and was sentenced to be electrocuted. The electrocution date is Friday, July 15, 1934.

CHARLES MAKLEY, who was arrested at Tucson, Arizona on January 25, 1934 was convicted at Lima, Ohio for the murder of Sheriff Jesse Sarber on March 17 and was also sentenced to be electrocuted, the electrocution date being the same as above.

HUSSELL CLARK, who was also arrested at Tucson, Arizona was convicted at Lima, Ohio on March 24, 1934 for the murder of Sheriff Jesse Sarber, the jury bringing in a verdict with recommendations, hence, he was sentenced to serve life in the Ohio State Penitentiary at Columbus, Ohio.

The three last above named men were today, M arch 27, transferred by automobile from the County Jail at Lima, Ohio to the Ohio State Penitentiary at Columbus, Ohio.

JOHN HAMILTON is the only individual now at liberty who took part in the murder of Sheriff Jesse Sarber at Lima, Ohio. He is also wanted in Chicago for the murder of a policeman who was attempting to take him into custody.

All the above named individuals with the exception of C opeland escaped from the Indiana State Penitentiary on September 26, 1953.

As indicated in memorandum of Special Agent J. L. Murphy of this office dated March 17, 1934, copies of which were forwarded to interested offices, HERBERT YOUNGELOOD, who escaped with Dillinger from the County Jail at Crown Point, Indiana, March 8, 1934, was shot and killed at Port Huron, Michigan on March 16, 1934 while resisting arrest. Undersheriff Charles Cavanaugh died on the following date, M arch 17, as the result of wounds received during the arrest of Youngblood.

During the course of investigation at Detroit by this office following the shooting at Port Huron, the metter was discussed with Inspector William J. Collins in tharge of the Hold-up Squad and he advised that his office was working on the matter in this city in conjunction with officers of the Indiana State Police. It was then ascertained that the home of Mr. and Mrs. Andy Strachen, daughter and son-in-law of Mrs. MacClark, mother of Russell Clark at 75 Windsmere Street, Highland Park, Michigan, was being kept under surveillance as well as the home of Mrs. Mac Clark at 531 Chandler Street, Detroit.

It appears from the information furnished by the local police that a member of the Indiana State Police, Gene R yan, is alleged to have followed a woman from the Indiana State Penitentiary at Detroit. At the Penitentiary this woman is alleged to have visited H arry Copeland. She proceeded to 75 Windemere and was seen to ply between that address and 531 Chandler. Also it was ascertained that Opal Long alias Bernice Thompson, a sweetheart of Russell Clark and who was arrested with him at Tucson, Arizona on January 25, 1934 was also in Detroit living at the above addresses.

Stegner, from which residence the home of Mrs. Mae Clark could be clearly observed. The last two named Agents have been loaned to this office by Cincinnati It was determined, immediately upon taking over the investigation in Detroit, that the police did not have complete information as to the occupants of the above addresses and therefore considerable difficulty was experienced in determining the identities of the persons coming and going. There appeared to be activity all hours of the day and night. was finally ascertained that Mr. and Mrs. Andy Strachen, daughter and son-in-law of Mrs. Clark resided at 75 Windemers, Highland Park, which is a distance of about two miles from the Chandler Street address. With them resided the woman called, "Pat" with her twelve year old daughter and also Opal Long lived at this address. However, about the time that we became engaged in this surveillance, Mrs. Mae Clark proceeded to Lima, Ohio and thereupon the Strachen family closed up their house and all moved to 531 Chandler. There were several women and several men in the house and it was absolutely necessary to in some way determine the identity of each and every person. It appears that prior to this time it had been somewhat of a guessing proposition with the police and the Indiana officers and of course, little progress could be made.

During the course of inquiries, it was learned that and his wife. had within the past few days moved from 531 Chandler Street. It was further learned that these two people had been boarding at the Clark address for a period of five years and his wife for approximately two years, although they were not relatives. On March 24 was located at and brought to this office where she was carefully interrogated. Itmay here be stated that the Clark family has resided at 531 Chandler Street for a period of only two weeks prior to that date at 408 Bethune Street and they moved while surveillance was being maintained by the Detroit and Indiana Police. accounted for sixteen persons in the Clark residence at the present time, these persons being as follows:

She also advised that this Billie, while at the Clark residence, wore a black broadcloth coat with a caracul collar and also had a black crape dress, together with a red suede jacket and a striped dress. It will be observed that the "Mrs. Dillinger" who called on John Dillinger at the County Jail in Crown Point, Indiana on February 16, 1934 wore a black broadcloth coat 🕟 with a caracul collar and a black crape dress. The description furnished by Sheriff Holley of Crown Point, Indiana, is identical with the description of Evelyn Frechette. From this it will be noted that Evelyn Frechette uses several aliases, including Sparks. It is noted in previous reports that Welton Sparks, the alleged husband of Evelyn. is now incarcerated at the United States Penitentiary at Leavenworth. stated that Evelyn Frechette stayed at the Clark residence for a period of only two or three days and departed and as near as she could recall, her departure was

a day or two before the escape of Dillinger at Crown Point, Indiana. It was very evident to that Opal Long and Evelyn Frechette were very chummy as they were around together practically all of the time. stated that Evelyn used considerable profane language and seemed to indulge in intoxicants considerably. She stated that the photograph which was secured by the Chicago office is a very good likeness of could not furnish any information where Evelyn Frechette. the Frechette woman is located at the present time, stating that although was closely associated with the Clark family, Opal Long, Pat and the Frechette woman were very secretive and rarely did they make any statements concerning themselves or their movements. She stated that she did not know "Pat" by any other name but that she felt certain that the twelve year old girl was Pat's daughter. It is noted that Evelynin reply wired to Ann Jackson that instead of meeting her in Highland Park the meeting place would be 901 Addison Street, Chicago. It is noted in previous reports that Mr. Welton Sparks, at Leavenworth, Kansas, is communicating with a Mrs. W. Sparks at 901 Addison Street, Chicago.

had advised the Indianapolis Police that Mary Kinder is in Chicago, Ille,
and had contacted one "Pat", a moll of Harry Copeland --".

Prior to the examination given to June Young, information reached this office through the Sheriff's Department at Ithaca, Michigan that on February 12, 1934 a Ford V-8 Sedan, Michigan 1934 license Y6030 appeared at North Star, Michigan and picked up a girl known as June Young age 12.

Accompanied by members of the Michigan State Police, Young, age 12. Special Agent D. E. Hall proceeded to North Star, Michigan and there interviewed Mrs. Pearl Essenberg, who advised that one Verne Miner, during the early part of December, 1933 was residing with his wife at Ithaca, Michigan and about the first part of January 1934 moved to North Star, at which time the twelve year old girl, June Young, was residing with them; that she attended the North Star school; that about February 12 she was taken from the school and Mrs. Essenberg observed the above described automobile in front of a poolroom operated by Miner and later observed that the girl was being taken from North Star. Mrs. Essenberg stated that she has a daughter about the same age as June Young and that the Young child had mentioned the names of Cherrington and Jacques to her daughter. She also furnished the Essenberg girl practically the same information as that obtained by the Highland Park school authorities as set out in this report. Mrs. Essenberg states that her little girl frequently receives communications from June Young at Detroit and in one letter she stated that her mother had been in the hospital but that the information should be kept confidential.

Further information developed that Mr. Verne Miner is a

LTC.

Upon being interviewed, Miner, who is 45 years of age, advised that he had always resided near Ithaca, Michigan with the exception of an enlistment in the Army prior to the World War. He stated that he married one Betty Hazelton in 1915; that they resided near Ithaca. Michigan until 1926 when his wife and he separated, his wife going to Chicago where she obtained employment and for two years prior to 1932 took care of June Young in Chicago. He stated that in August, 1932 he and his wife again made up for the sake of their twelve year old son and she than returned to Ithaca, Michigan to live with him. He further advised that either in the latter part of September or first part of October, 1953 his wife received a letter, presumably from "Pat" alias Young alias Ann Jackson, requesting Mrs. Miner to again take care of her daughter. June. For this care Mrs. Miner was offered \$26 a month. Mrs. Miner accepted this offer and in the latter part of October, June Young was brought to the Miner home at Ithaca, Michigan by her mother who was introduced to him, Miner, as Pat. Another woman accompanied her and from the description. furnished, it is believed that this second woman was Opal Long. There were two men with these women who were introduced to Miner as Harry and Lee. Harry was perhaps Harry Copeland, although Miner was not able to give a very good description of the men. Miner states that these persons. evidently came from Chicago as they were driving a new Plymouth Sedan with Illinois license plates, numbers unknown. He stated that they spent the night at the Seaver Hotel at Ithaca and upon examination of the records in this hotel it was ascertained that on October 20, 1933 four people, believed to be the persons named above, registered as J. P. Phillips, wife and daughter and Mr. J. H. Norton and wife. They gave their address as "Decator." The Manager of the hotel was unable to furnish any further information. Photographs of Harry Copeland, Billinger, Hamilton and others were exhibited to Miner but he failed to identify them. He further advised that the woman known to him as Opal, last name unknown, who was one of the party that brought June Young to Ithaca, called for her at North Star, Michigan on either February 11 or 12, 1934 with a man whom they called Jerry, last name unknown. He stated that these people had not given the Miners any notice that they were calling to take the child away and that Opal made a statement to the effect that they were taking the girl to Chicago. The Miners both observed that the car used on that occasion was a Ford V-8 Sedan. It will be observed that the Sheriff at Ithaca reported seeing a Ford V-8 Sedan, Michigan license Y6030 in North Star on the above date so from this, it is quite definite that the

Ford Sedan now in possession of the Clarks and which was brought to Detroit from Chicago by Opal Long was the car used in transporting the girl. Miner states that he and his wife did not get along very well and on March 1, 1934 she departed from North Star for Chicago and furnished him with the following addresses where she could be located:

W. J. Moore, c/o Orpheum Restaurant, 3864 Cottage Grove Avenue, Chicago, Illinois. (Miner stated that he understood W. J. Moore was a street car conductor and usually eats his meals at the above restaurant and receives mail there).

Mrs. W. J. Moore, 524 Belden Avenue, Chicago, Illinois (Miner stated that Mrs. Moore is the wife of W. J. Moore aforementioned)

Mrs. Miner also told her husband that she could also be reached through Mrs. Charles Bertrand, Apartment 2-G, street address unknown, telephone Mohawk 2548, Chicago. This woman is believed to be a sister to Mrs. Moore mentioned above.

Upon interrogating Miner closely it was finally ascertained that when Pat brought the girl to Ithaca, Michigan she was observed to have white hair. In the event he is correct in this information, Pat is wearing a wig as her real hair is black. It will be noted in other parts of this report that she has, however, been suspected of wearing a wig. Miner finally stated that he believed that his wife would be able to furnish much more information regarding June Young and her mother.

With regard to the Michigan license plates issued to Jess Wilson, 1195 Webb Avenue, Detroit, as indicated in this report, investigation conducted at that address reflected that nobody by that name had ever resided there.

The local police advised this office that while recently at Lima, Ohio they were told by officers of the Tucson Police Department that Ann Russell alias Evelyn Frechette had light red hair when arrested with Dillinger. The description furnished by the Los Angeles office indicated that her hair was black and which corroborated information furnished by Mr. and Mrs. Wilson. However, to be absolutely certain in this respect, a wire was dispatched to Los Angeles and this office was advised that her hair was black when arrested and therefore there was no indication that same had been dyed.

It now appears that Opal Long is the only member of the Dillinger gang residing with the Clark family, although it is presumed hat Pat alias Ann Jackson alias Patricia Young will return to Detroit as: child is still here. Mr. and Mrs. Wilson advised that when Evelyn

Frechette alias Billie came to Detroit she brought a smell Boston bulldog with her, which animal was left, upon her departure from Detroit, she indicating that she would call for the dog later. This dog, the Wilsons advised, during the past week strayed away from the home and has not been found. Opal Long, who is known to the Wilsons only as "Opal" appeared considerably upset over the loss of the dog and stated that she would have to do much explaining to Evelyn when she sees her. This would indicate that she expects to contact Evelyn. From all indications, of course, she knows the whereabouts of Evelyn and Pat.

During the past few days Opal Long has made several trips from 531 Chandler Street, it being noted that she is now residing at this address, whereas prior to March 20 she lived almost entirely at 75 Windemers. She has been closely followed and it was observed yesterday that she purchased the following out-of-town newspapers, New York Journal, Chicago Tribune and Toledo Blade. She was also observed making a long distance telephone call from a drug store nearby.

Long as well as other members of the family, had been followed to a great extent by police officers and this fact became known to the suspected parties. Therefore, at the present time their actions clearly indicate that they are very suspicious and the Agents following them have found it somewhat difficult. We are concentrating, however, practically entirely on Opal Long as it is felt that she is the person who will evidently go to Evelyn Frechette and perhaps to Dillinger. It is known that she, during the past two months, has made several trips to Chicago and the police believe that her purpose for the trips was to obtain money from Dillinger for attorneys representing the trio at Lima.

The local telegraph companies, who have cooperated very fully during the course of this investigation, advised this office that a telegram was delivered to 531 Chandler Street yesterday afternoon addressed to Mrs. Clark signed "Mary." It was a local wire and was sent from the Woodward-Garfield branch of the Western Union and read, "Call me third floor old building tonight." Shortly after receipt of this telegram Opal Long was seen to leave the Clark residence and seen to proceed to a drug heard because of the noise in the store. Shortly after she returned to the Clark residence and accompanied by three other members of the family, two of whom could not be definitely identified but one thought to be Ed Clark, drove cautiously in the Essex Sedan about a 1928 model, which is owned by Mrs. Clark, to the Women's Hospital which is located at Forest and Bethune

Streets, Detroit. They were followed there by Agents who were keeping the house under surveillance and after circling the hospital twice, stopped for a few minutes on one corner and she mystericusly drove to another street where they all remained in the car for a period of several-minutes and finally Ed Clark and Opal Long stepped from the car and walked to the entrance of an old building which adjoins the Women's Hospital and which was formerly occupied by this hospital. Opal Long entered, remained inside ten er fifteen minutes and finally returned to the car, and drove back to 531 Chandler.

Investigation in the hospital disclosed that this old building is now being used entirely by maids and nurses. A careful investigation was made today of the entire hospital. All of the patients were closely observed but we were unable to find anyone answering the description of persons in whom we are interested. Contact was had with maids residing on the third floor who will notify this office of any information which they are able to discreetly ascertain.

The manager of the Western Union branch where the wire was sent was contacted and the description he furnished of the person who sent the wire does not fit the description of any of the nurses or maids residing on the third floor. Neither Opal Long nor any of the Clark family have been known to enter this building before and of course the trip to this old building is quite mysterious.

In previous communications received at Detroit from Chicago it is noted that one Miles Burpy, allegedly from Highland Park, Michigan, visited the Indian Reservation at Shawano, Wisconsin in the summer of 1933 driving an Auburn automobile, at which time he stayed with friends of Evelyn Frechette. We have conducted a very thorough investigation at Highland Park but have failed to find anyone answering the name of Miles Burpy.

Special Agent M. W. Meekins of this office is at the present time at Lima, Ohio where he will interview Miss Levy, an attorney representing the trio on trial there, for any information which she might furnish which is in accordance with request contained in letter from the Chicago office dated March 21, 1934.

Investigation is also being made at Toledo, Chie in compliance with an undeveloped lead set out in the report of Special Agent T. F. Mullen, Chicago, Illinois dated 3/19/34 concerning the alleged connections of John Hamilton at Toledo, Chio, it being noted that an interview with Raymond Gleason of the Kenosha, Wisconsin Police Department, whose half sister is the wife of Elmer Hamilton, brother of John, advised that John Hamilton's wife is dead; that she disappeared leaving two boys twelve and sixteen who are now alleged to be residing with John Hamilton's mother-in-law, who is believed to be a Mrs. Stevens or Stephenson at 1008 E. Bancroft Street, Toledo; that Hamilton is supposed to have some sort of a trust fund for these boys in a bank in Toledo which was created through Claude Hamilton, a brother of John, who is now

residing at Cleveland, Ohio. The investigation at Cleveland has been conducted without developments.

The Los Angeles office has advised that Ann Martin alias Frechette and Opal Long departed from Tucson, Arizona about February 1, 1934 following their release in that city and proceeded to Kansas City, Missouri.

In compliance with request contained in telegram from the Chicago office dated March 24, copies of photographs of Evelyn Frechette furnished this office by the Division were forwarded to Chicago.

UNDEVELOPED LEADS: The CHICAGO OFFICE It is respectfully requested that the Chicago office conduct appropriate investigation at the Cherrington home, 1832 Belmont and at 901 Addison Street in an attempt to obtain the present location of Pat alias Ann Jackson alias Young.

It is very possible that Mrs. Verne Miner, who, it will be noted in the body of this report can be reached at either 3864 Cottage Grove, 524 Belden Avenue or through Mes. Moore, telephone Mohawk 2548, Chicago, will be able to furnish valuable information regarding the gang. However, it is possible that she should be approached under a pretext as undoubtedly she is very closely associated with Pat and Opal Long. There is of course, an indication that these two women will return the child, June Young, age 12, to Chicago and turn her over again to Mrs. Miner. It will be interesting to note that it was during the early part of October that she was delivered to the Miner family at North Star, Michigan. In this respect it will be noted that the escape at the Indiana State Penitentiary at Michigan City took place on September 26 and from all indications Dillinger, Copeland and the entire gang resided in Chicago for a period of several weeks immediately thereafter. Undoubtedly they were in close contact with Opal Long, Pat and others during that period and evidently it was necessary to keep the child at some distant point. It might be advisable to contact Harry Copeland at the Indiana State Penitentiary to determine his connections with "Pat" and why he assumed the name of Cherrington.

It will be noted it was indicated in letter from Detroit dated March 21, 1934 that there was some question as to whether the photograph of Evelyn Frechette secured from the Shawano, Wisconsin and the photograph of Ann Martin arrested with Millinger at Tueson were identical. It has now, however, been definitely determined that they are one and the same. It will be noted in the body of this report that Mrs. Wilson, who formerly resided at the Clark home and who was there while Evelyn Frechette visited that home during the latter part of February, readily identified the suede jacket worn by Ann Martin at Tueson. Also, quickly identified the striped waste.

It is also suggested that the Chicago Office make inquiry at 428 S. Oak Park Avenue, Oak Park, Illinois to determine if there is anyone there at the present time having any connection with the Dillinger outfit. It will be noted that this address was given when the Ford DeLuxe V-8 Sedan was purchased on December 14, 1933 from Charles J. Dempsey 2300 W. Madison Street, Chicago

The DETROIT OFFICE

will maintain surveillance over the homes of Mr. and Mrs. Andy Strachen, 75 Windemere, Highland Park and Mrs. Mae Clark, 531 Chandler Street, the main object being at the present time, Opal Long who, it is presumed, will contact Dillinger either directly er indirectly. There are no telephones at either of the above two addresses and therefore no information can be obtained through that medium.

Investigation will also be continued at the Women's Hospital concerning the activities of Opal Long in the old building adjoining the institution which building was formerly occupied by the hospital.

This will be given careful attention.

It will be further noted in my communication of yesterday, that she departed early yesterday morning for Chicago, Illinois.







Mr. Rorer telephoned. There had been reported to the St. Paul office that a woman by the name of Mrs. Carl T. Hellman had rented an apartment on March 19 for herself and her husband at 95 South Lexington Street. Agents were sent out to look the place over and found that the apartment was one in which all the curtains were drawn. The information received indicated that three men and two women were using the apartment and that they were acting as suspicious characters.

After the observation that the curtains were drawn was made Mr. Rorer instructed the Agents to go to the police department and get any assistance that was needed in order to enter the apartment. Two Special Agents, R. C. Coulter and R. L. Nalls, went to the police department and obtained the services of one police officer. The three then proceeded to the premises, knocked on the door but they could not get in. Someone from the outside then came up and Coulter started questioning him and the individual states that "You have asked for it so I am going to give it to you". He immediately pulled a revolver and started shooting at Agent Coulter. Coulter stepped to the side of the door, which afforded some protection, and started shooting back and his assailant left. In the meantime a man came from within the apartment with a machine gun and started shooting at the officer down the hall. In the gun fight that followed Special Agent Nalls shot the tire off of the Plymouth Coupe in which the first assailant had arrived. The group occupying the apartment then ran out of the building and entered a Hudson automobile and made their get-away in this automobile. Two of the men who were observed appeared to be 5' 8 or 9" in height and about 37 years of age. The third appeared to be 5'7" in height and about 45 years of age. The two women were apparently in their 20's. Forer stated that inside the apartment they found machine guns and various types of artillery and firearms equipment, including one gum the size of an automatic pistol with a grip on it which makes it, in fact, a small sized machine gum. stated that none of these individuals fitted the description of the Barker-Karpis gang members and it is his idea that they are "bank men". They have broadcast information by telephone to all surrounding cities located and apprehended. He has stationed three Special Agents in the apartment and they are processing the place for fingerprints. They will also process the Plymouth automobile for fingerprints. Orders have been issued that no one expept police officers can come to that floor of the apartment building.
