Murtha's 12th District Office, Johnstown, Pennsylvania (PA), telephone number [REDACTED] telephonically contacted the writer and advised that [REDACTED] white male, date of birth [REDACTED] Social Security Account Number [REDACTED] e-mailed a threatening communication to the Commonwealth of Pennsylvania Office of the Attorney General in which he stated he may have to kill traitors, terrorists, and murderers like Murtha and others in Harrisburg. The e-mail was sent from the e-mail address [REDACTED]@hotmail.com and sent to the e-mail address of info@attorneygeneral.gov on Saturday, 10/04/2003 at 3:47 p.m. The subject of the e-mail was "The murderer, traitor, terrorist: Congressman John Murtha." The e-mail read, "Dear Attorney General, This is [REDACTED] here. I know you know who I am. I am supposed to be in Centre County Court in front of a magistrate on 10/8/03. The reason I am writing you is because I was convicted in Cambria County on 10/98. As I stood outside the courthouse talking on camera to [REDACTED] of WJAC, a laser dot from a rifle scope appeared on my forehead. Not long ago my apt. in the Oakhurst Homes was shot up in the middle of the night. I could feel the shock of the bullets hitting my apt. as I lay on my couch sleeping. At the same time, my friends store was being torched by arsons. In the morning I saw a cop and a news crew from WWCP Channel 8 in Johnstown. I told the Johnstown cop that I wanted to file a

AUSA [redacted] advised that he would issue a subpoena to hotmail to obtain the subscriber information for the e-mail address [redacted]@hotmail.com. The letter was also facsimiled to Detective [redacted] at the Johnstown Police Department. Writer followed up with AUSA [redacted] later in the day and learned that there was a bench warrant out from Center County for [redacted] and that Cambria County issued an arrest warrant for [redacted] due to his violation of his probation.

Man who threatened Murtha gets his probation extended

EBENSBURG - A Johnstown man convicted five years ago of making terroristic threats about U.S. Rep John P. Murtha and others, was found guilty yesterday of violating his probation by allegedly making new threats.

Donald L. Fenton, 56, was placed on an additional 23 months probation by Judge Thomas Swope because of new criminal charges against him in Centre County.

Swope directed that Fenton will remain in the county jail until he can be admitted to Pittsburgh VA Hospital for a mental evaluation and exam.

George Stiles, a county probation officer, told Swope that Fenton is accused of sending a threatening e-mail to a woman working in a grant program in State College.

Stiles reported that police found several weapons, including a 15-inch survival knife and a pellet gun - along with a marijuana pipe, in Fen-

ton's apartment when they went there to arrest him last month on a Centre County warrant.

Fenton, obviously agitated, begged the judge to "show me justice, especially if the courts wouldn't protect you. I have not committed a crime. I'm allowed to defend myself."

He complained to Swope that Murtha, D-Johnstown, "was at the heart of his troubles."

He also talked about murder plots against him and his daily fear of being killed.

Threat-maker back behind bars

EBENSBURG - The man convicted of terroristic threats and barred from contact with U.S. Rep. John Murtha, D-Johnstown, The Tribune-Democrat and others, is in jail, charged with violating his probation.

Donald L. Fenton, 56, of Geistown has been sent to Cambria County Jail and may face new criminal charges, court papers show.

The new charges may not be connected to anyone in this region.

In 1998, Fenton was sentenced to five years' probation on the terroristic threats conviction, which stemmed from threats to Murtha and calls to Randy Leventry about problems with the repair of Fenton's truck and insurance coverage on the repair.

Fenton threatened to "blow the (expletive) head off" of Murtha and one of his aides, court testimony showed.

Judge Thomas Swope placed Fenton on probation for 60 months and ordered him not to have any contact with Murtha, The Tribune-Democrat and its employees, Leventry or the auto dealership where Fenton's truck was repaired.

Fenton also was required to undergo a mental evaluation and anger management counseling and follow recommendations.

Fenton failed to comply with orders about not displaying overt behavior and other conditions, said papers filed by the county Probation Office. Those papers also refer to "new criminal charges," but do not specify what they are, or the incident from which they stem.

"We can't release that information as of yet. But it has nothing to do with this area," said a probation office employee, who declined further comment in a telephone interview.

Murtha aide Brad Clemenson said he was not authorized to comment on Fenton's most recent arrest.

Even Fenton's attorney was in the dark.

"I haven't heard any of this until now," said public defender Richard Corcoran, who represented Fenton in his 1998 trial and appeals.

"It would be up to Mr. Fenton to contact me," Corcoran said in a telephone interview from his Ebensburg law office.

In the past, Corcoran has said Fenton was disappointed with his probation conditions, especially not being able to write to The Tribune-Democrat, a condition he thinks violates his free-speech rights.

State Superior Court disagreed when Fenton appealed, saying: "Writing one's congressman or newspaper and expressing one's displeasure with the current political system is one thing, contacting such officials after one has credibly and categorically threatened their lives is another."

Swope scheduled a Nov. 13 hearing on the probation violation charges. Fenton will remain jailed until then.

It was meant as a threat and intimidation to prosecute me for something that isn't even a crime. He wants to make a mountain out of a mole hill. A few days later i got a letter telling me I'm being charged.

Now they want me to travel about a hundred miles with no transportation to Bellfonte to answer these bogus charges. With snipers runnin around. I guess I'll try to get there but I will also try to be armed. Then we can all have a shoot out. After all I don't expect you or any other pussy in Harrisburgh to defend my life or my rights.

You people bowed down to a traitor, terrorist, and murderer in Murtha. That makes you people traitors, and tools of oppression by a tyrant. I will always protect and defend the constitution of the United States. By any means necessary. Even if I have to kill traitors, terrorists, and murderers like Murtha and you pussys in Harrisburgh.

On October 10, 2003, [redacted] facsimiled a copy of the e-mail to the writer. Writer contacted AUSA [redacted] and advised him of the e-mail. AUSA [redacted] was also facsimiled a copy of the e-mail. AUSA [redacted] advised that he would issue a subpoena to hotmail [redacted]@hotmail.com. The letter was also

facsimiled to Detective [] at the Johnstown Police Department. Writer followed up with AUSA [] later in the day and learned that there was a bench warrant out of Centre County for [] and that Cambria County issued an arrest warrant for [] due to his violation of his probation.

Hotmail responded to the subpoena and advised that they had no records available because the account was purged. [] was incarcerated in Cambria County Jail for violation of his probation and voluntarily committed himself to the VA Hospital in Pittsburgh, PA, for psychiatric care in accordance with Cambria County Judge Thomas Swopes' Order.
