JOHN P. MURTHA, Democrat, of Johnstown, Pa.; born in New Martinsville, W. Va., June 17, 1932; Ramsey High School, Mount Pleasant, Pa.; Kiskiminetas Spring School; B.A. in economics, University of Pittsburgh; graduate study at Indiana University of Pennsylvania; married Joyce Bell; three children: Donna Sue and twin sons, John and Patrick; served in Marine Corps during Korean war as an enlisted Marine who was commissioned as an officer; discharged as a first

lieutenant; maintained active reserve officer status; volunteered for 1 year of active duty in Vietnam as a major; served with 1st Marines, a Marine infantry regiment, 1966-67, south of Danang; awarded Bronze Star Medal with combat "V", two Purple Heart Medals, Vietnamese Cross of Gallantry, and service medals; now colonel, U.S. Marine Corps Reserve; elected to Pennsylvania House of Representatives in 1969; served continuously until elected to U.S. House of Representatives; an officer and member of many organizations, including chairman, Cambria County U.S. Savings Bond Committee; board of directors of Mercy Hospital in Johnstown; Penns Woods Council, Boy Scouts of America; Johnstown Flood Museum; Veterans of Foreign Wars; American Legion; received 1972 Conemaugh (Pennsylvania) Chapter Reserve Officers Association, Minuteman Award; SAR; elected to the 93d Congress, February 5, 1974; reelected to each succeeding Congress; member of House Appropriations Committee; 1978, received Pennsylvania Distinguished Service Award, highest civilian recognition by the Commonwealth.
