Q1 One VHS video cassette tape with "Tozai" label marked in part "Michael Jackson's Neverland Favorites An All Boy Anthology"

Result of examination:

95A-HQ-1148159-2

A physical and electronic examination of Q1 revealed that it is a poor quality third or fourth generation recording. The Q1 recording contains linear audio and real-time mistracking through the entire tape. The recorder used to make the most recent copy apparently was not functioning properly, resulting in the mistracking anomaly. Numerous stop/start transitions were observed but the nature of these observed transitions suggest that they were produced during one of the previous recordings, not during the latest recording.

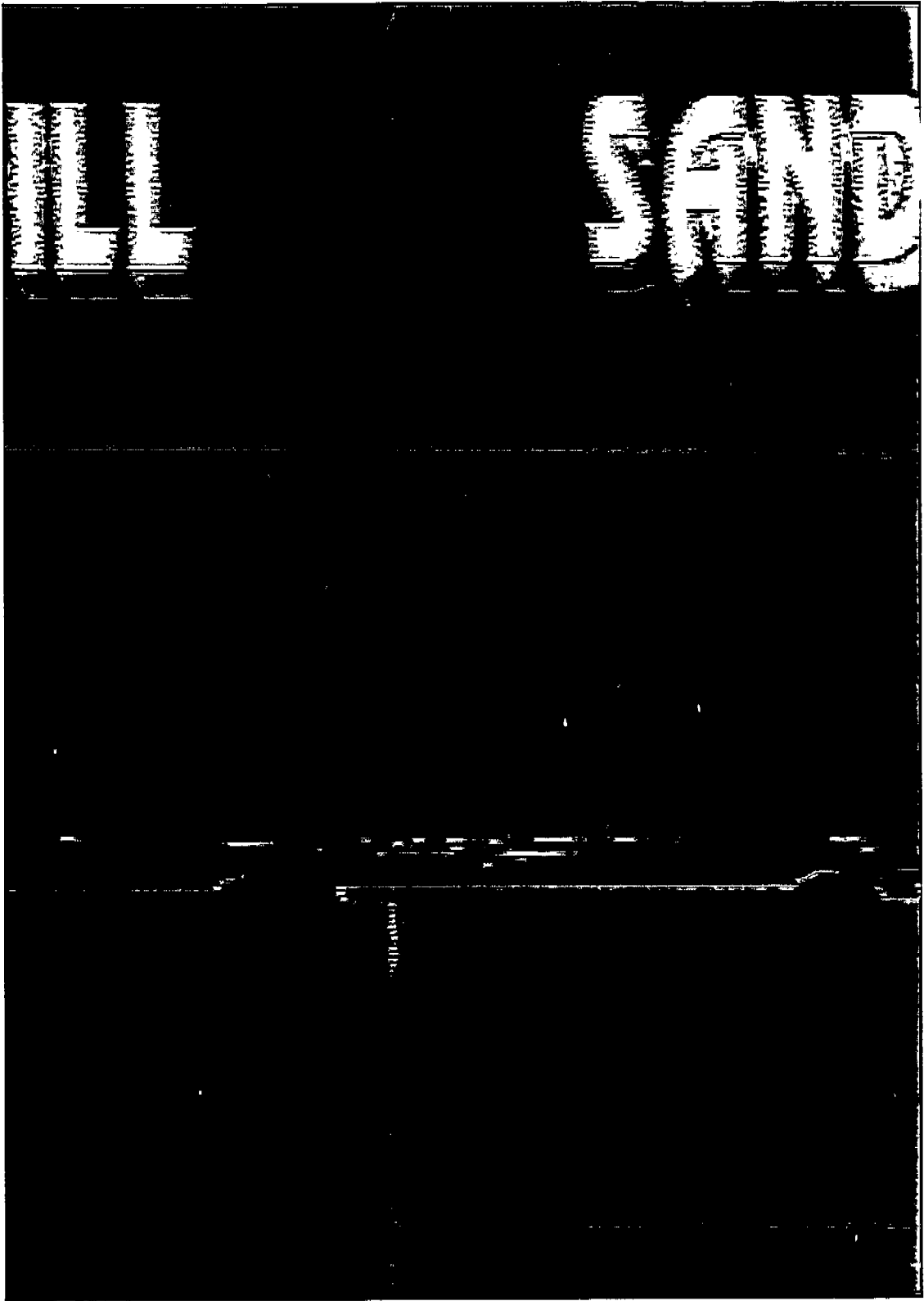

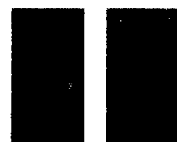

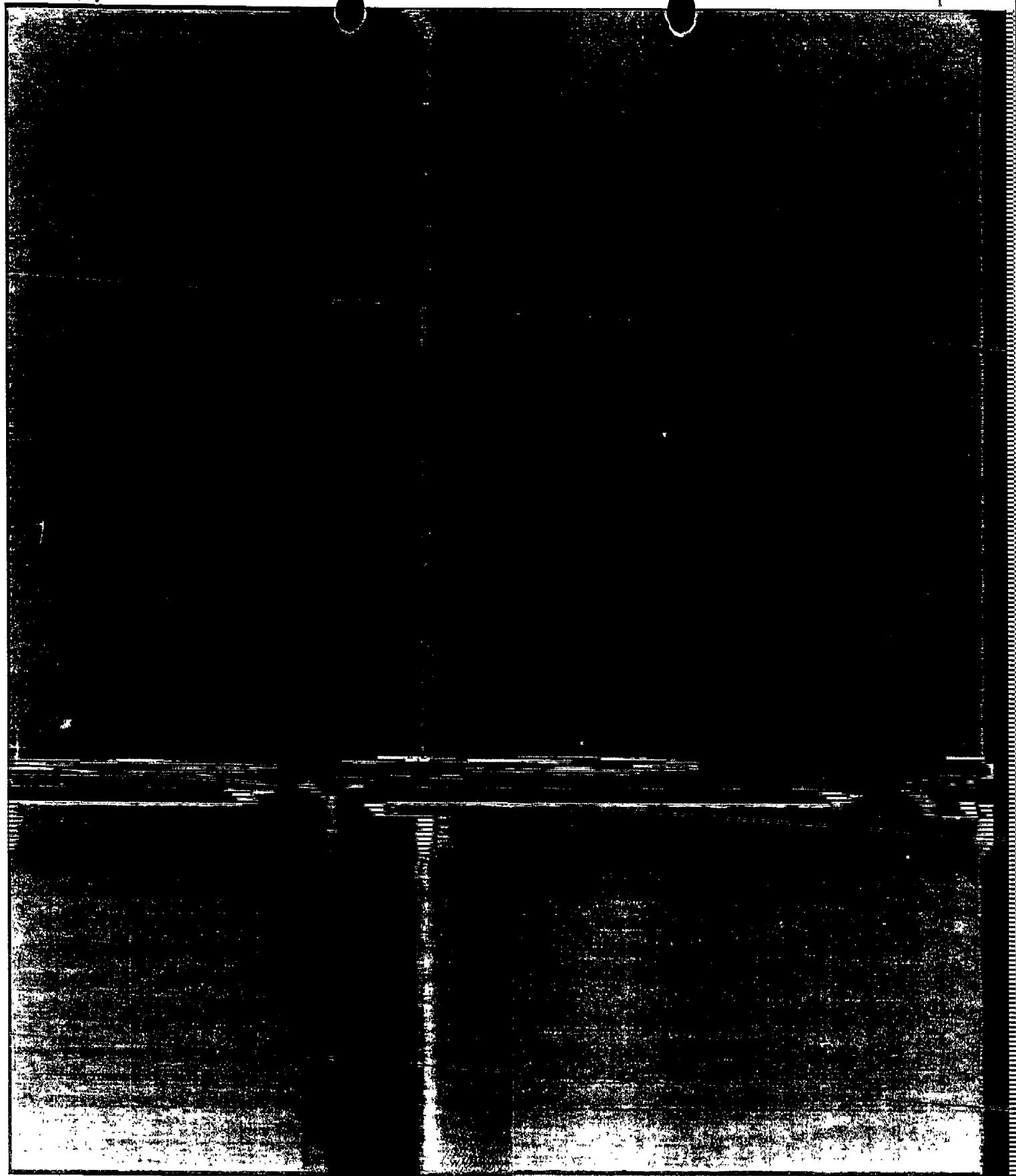
