[redacted] of the Wabash Building, Pittsburgh, advised that he was [redacted] in the Wabash Building in 1925, the year subject was employed. He stated that at that time the age of the subject would have had no bearing on his employment and that he would have been hired just as quickly had he been 40 as 23. [redacted] made an examination of his employment records which reflected that around the same time subject was employed, other colored porters of much older ages had been employed. These records reflected that one HENRY FULLER, colored, had been employed as a porter on August 16, 1920 and at the time of this employment had given his birthdate as July 5, 1860. The records also reflected that a HENRY DANIEL MEADS, colored, had been employed as a porter on September 19, 1918 and at the time of his employment had given his birthdate as May 15, 1870.

[redacted] that his records reflect that prior to being employed by their concern subject had been employed from 1920 to 1924 as a janitor and chauffeur for the [redacted] under [redacted] and from 1924 to 1925 he was employed as a dishwasher for the [redacted] formerly at [redacted] Pittsburgh, Pennsylvania.

It is noted that the City Directory does not list the [redacted] Pittsburgh Credit Bureau have any record of any such company.

[REDACTED] that at the time of the subject's accident which is mentioned in the referenced report, he gave his age as 57 and on filing a claim to the Metropolitan Life Insurance Company for compensation which claim is dated July 26, 1943 and signed by the subject his age is also given as 57. Later correspondence between the subject and [REDACTED] in connection with his insurance claim reflects that the subject advised that the statement that his age is 57 was an error and that he is really 58, having been born on [REDACTED]. In this letter he explained that he had falsified his age when he was employed in 1925 so that he might obtain a job.

Synopsis of facts:

Subject organization incorporated as a religious organization in Illinois. Was originally founded in Newark, New Jersey, in 1913 by the Prophet ROBLE DREW ALI, who died in Chicago, Illinois, in 1929. Membership in organization at the time of Prophet's death numbered into thousands. Jealousy of the Prophet's lucrative enterprise by other prominent members resulted in a riot at Chicago in 1929, causing the death of two Chicago policemen and one member of the organization. After the Prophet's death, several divisions of the organization resulted under the leadership of CHARLES KIRKMAN BEY, JESSE [Redacted] and [Redacted].

The members' belief is that of Mohammed and they worship ALLAH in a modified form of true Mohammedanism. The members claim to be Moors, and not Negroes. Members of the organization as a whole have complied to Selective Service laws. There has been indication of pro-Japanese propensities in the various groups.

[REDACTED] Chicago, Illinois. The information was compiled by [REDACTED] of the now defunct Illinois Writers Project, which was a WPA project. [REDACTED] is now affiliated with the Office of Civilian Defense in the Chicago area. The research was conducted for anthropological reasons to determine if there was any cultural connection between the various Negro cults in Chicago and vicinity. This investigation shows KIRKMAN's connection with the early history of the Moorish Science Temple of America.

Two organizations striving to foster racial pride have attracted numbers of Chicago Negroes from time to time. These are the Moorish American Science Temple and the Nation of Islam, ordinarily referred to as "Nation." Inasmuch as these are religious bodies, opposing the Christian faith. Members of the Moorish American Science Temple insist that they are not Negroes and avoid use of the word, or of "black" when referred to themselves, insisting that they are really Moors and that their skin is "olive-mad." On the other hand, the Islamites not only call themselves Negroes but are proud of the name, contending that the Negro is the original man. Neither endorses the "Back to Africa" Movement.

In 1925 a small Negro wearing a flaming red fez, similar to those worn by Turks, appeared in empty lots and on street corners of Chicago's South Side to proclaim a startling new doctrine. He was NOBLE DREW ALI, born TIMOTHY DREW in North Carolina; Prophet of Islam, and founder of the Moorish American Science Temple. Little is known of DREW ALI's early history. He is reputed to have been an expressman in Newark, New Jersey, where he is said to have founded the first Moorish American Science Temple as early as 1915. There is also some evidence to indicate that he had established branches of his cult in Pittsburgh and Detroit before he came to Chicago.

DREW's main contention was that the people commonly known in America as Negroes are of Moorish descent and thus Asiatics. Act six of his "Divine Constitution and By-Laws" reads:

With us all members must declare their nationality and their Divine Creed that they may know that they are a part and partial (six) of this said government and that they are not Negroes, Colored Folks, Black People or Ethiopians, because these names were given to slaves, by slave holders in 1779 and lasted until 1865 during the time of slavery, but this is a new era of time now, and all men must proclaim their true national name to be recognized by the government, in which they live and the nations of the earth, this is the reason why ALLAH the Great God of the universe ordained NOBLE DREW ALI, the prophet, to redeem his people from their sinful ways. The Moorish Americans are the descendants of the ancient Moabites who inhabited the North Western and South Western shores of Africa.

Prophet NOBLE DREW ALI did not immediately rally many disciples to his banner, the Moorish star and crescent on a field of red. But he persisted, and at length was able to set up permanent headquarters. Though semi-literate, he possessed an eloquent tongue, a persuasive manner, and a native shrewdness.

which enabled him to sway the poor and unlettered people who listened to him. Most of them remembered the race riots of 1919; all of them had experienced discrimination and other wrongs. DREW ALI was offering them pride of race and dignity. In 1927 a successful convention encouraged DREW ALI to expand his proselytizing activities to other cities. It is difficult to ascertain just how many temples resulted, but those in Pittsburgh, Detroit; Charleston, West Virginia; Lansing, Michigan; and Youngstown, Ohio are fairly well authenticated.

DREW ALI had written and published his "Koran," a slim pamphlet consisting of a curious mixture of the Mohammedan holy book of the same name, the Christian Bible and anecdotes of the life of Jesus--the whole bound together with the Prophet's own pronouncements and interpretations. The Prophet began to do a profitable business in various nostrums and charms he had concocted, among them Old Moorish Healing Oil, Moorish Purifier Bath Compound and Moorish Herb Tea for Human Ailments.

More and more "Asiatics" flocked to the star and crescent standard. They flaunted their fezzes on the street and treated the white man with undisguised contempt. The Prophet announced that each devout Moorish American must carry a card bearing his credentials and his real (or Asiatic) name, signed by the Prophet with his seal. Often enough "slave" names were transformed into "real" ones by the simple addition of "El" or "Boy", these being titles signifying Moorish dignity. The membership card and button, when displayed to Europeans, would convince them that the bearer was enlightened and a member of an organization to be feared and respected.

To the Prophet this theory of new-found independence had been a more or less purely ethical or theoretical point, and he had not reckoned on its practical effect among his zealous followers. Alarming reports of street brawls, threats, insults, and minor violence centering around Moorish Americans were brought to his notice. Members were accosting the white enemy on the streets, showing their membership cards and buttons, and proclaiming in the name of their Prophet, NOBLE DREW ALI, that they had been freed of European domination.

Recalling the downfall of the militant Abyssinians and contemplating the current difficulties of the Garvey movement, DREW ALI issued this Ukase:

"I hereby warn all Moors that they must cease from all radical or agitating speeches while on their jobs, or in their homes, or on the streets. Stop flashing your cards before Europeans as this only causes confusion. We did not come to cause confusion; our work is to uplift the nation."

DREW ALI's leadership was soon contested. In 1929 he became embroiled in a quarrel with CLAUDE GREENE, politician and former butler of JULIUS ROSENWALD, who previously had joined the temple. One day DREW arrived at his office to find that GREENE had moved all the furniture outside and declared himself Grand Sheik. A civil war ensued, each faction enlisting support from temples in other cities. GREENE was shot and stabbed to death in his offices at the Unity Club on the night of March 15, 1929.

DREW ALI, arrested as he sat with his wife and group of followers celebrating (authorities charged) the murder of his rival, was defended by Attorneys AARON PAYNE and WILLIAM L. DAWSON, temple members who later gained political prominence. The Prophet, from prison, issued a message to his flock:

"To the Heads of all Temples, Islam:

"I, your Prophet, do hereby and now write you a letter as a warning and appeal to your good judgment for the present and the future. Though I am now in custody for you and the cause, it is all right and it is well for all who still believe in me and my father, God. I have redeemed all of you and you shall be saved, all of you, even with me. I go to bat Monday, May 20, before the Grand Jury. If you are with me, be there. Hold on and keep faith and great shall be your reward. Remember my laws and love ye one another. Prefer not a stranger to your brother. Love and truth and my peace I leave all.

"Peace from

Your Prophet

NOBLE DREW ALI"

This proved to be DREW ALI's final official proclamation. Released on bond, he died under mysterious circumstances a few weeks later. One theory is that he succumbed to injuries inflicted by the police during his imprisonment, another is that he was set upon by partisans of GREENE after his release and beaten so severely that he never recovered.

After DREW ALI's death Attorney AARON PAYNE attempted unsuccessfully to hold the group together. Each among several of the Prophet's disciples announced that he alone was the rightful inheritor of DREW ALI's leadership. JOHN GIVENS EL (formerly the Prophet's chauffeur) and IRA JOHNSON BEY (who had been imported from Pittsburgh to assist in quelling the GREENE revolt)

each maintained that the dead leader's spirit had entered his body. JOHNSON, a man of action, invaded the office of CALI EL, another aspirant, and demanded recognition as Grand Sheik. CALI EL demurred and received a terrific mauling. JOHNSON then dispatched his henchmen to kidnap ERIC KIRKMAN, who claimed possession of DREW ALI's last will and testament.

KIRKMAN's wife, secretly surmising that her husband was being detained in JOHNSON's apartment, directed the police thither. A gun battle ensued in which two policemen and one Moor were killed. Sixty-three cops were arrested, and JOHNSON was committed to the State hospital for the criminally insane. GIBENS EL also was apprehended after he had forced his way into Attorney PAYNE's home in search of DREW ALI's papers.

GIBENS EL, too, was sent to the insane asylum, but was released several years later. In 1941 he was heading a Chicago temple on East 40th Street and still asserting his claim to the title of Grand Sheik of all Moorish American Science Temples. GIBENS EL was one of six contestants, each one a temple leader and each one denigrating his own as Temple No. 1.

Services in each temple observe with minor deviations, the pattern established by DREW ALI. First, a minor sheik, a sheikess or the chairman reads and explains DREW ALI's version of the Koran. Then follows a more elaborate discourse by the Grand Sheik (in some temples called the Governor), the whole ceremony being punctuated at intervals by Christian hymns with the words Allah, DREW ALI, and Moslem substituted for God, Christ and Christian. Friday is observed as a holy day of rest, "because on a Friday the first man departed out of the flesh and on a Friday the first man was formed in flesh and on a Friday the first man departed out of the flesh and ascended unto his father GOD ALLAH, for that cause Friday is the Holy Day for all Moslems all over the world."

Since DREW ALI considered MARCUS GARVEY his forerunner (in a relationship analagous to that of John the Baptist and Jesus) and paid tribute to him in His Koran and in his sermons, Moorish Americans frequently laud and quote the Jamaican organizer.

January 8, the Prophet's birthday, is a special occasion in all temples. Full Moorish regalia is worn by those members who can afford it, and there is likely to be feasting and distribution of gifts as in Christmas celebrations in Christian churches. A number of unconverted guests are invited; the customary speeches take on a more evangelistic tone. Expositions of the teachings and principles of the Prophet are offered in a simplified form for the benefit of those still under the influence of "The Folly" (Christianity).

The leader of each of the bickering factions has striven in vain to build up an organization as powerful (and as lucrative) as the parent body disrupted by internal warfare and the death of DREW ALLI. According to Attorney AARON PAYME, the Prophet in one year amassed a fortune of \$35,000 and commanded a membership of 12,000. Politicians respected and courted him, and Congressman OSCAR DEPRIEST was reputed to have joined the temple.

The following information concerning the subject organization was obtained from the report of [REDACTED] dated November 13, 1942 at Springfield, Illinois:

In a signed statement taken from [REDACTED] an inmate of the Illinois State Penitentiary, Menard, Illinois, [REDACTED] that he did not know how the organization originally started but that his father [REDACTED] had become acquainted with an organization known as the Moorish Science Temple of America, whose headquarters were first located at [REDACTED] 1841 State Street, Chicago, Illinois. [REDACTED] that his father had started this organization at Chicago, Illinois and was the head of it until 1929 when he became involved in some trouble and was sent to the Penitentiary at Joliet, Illinois. His father had two associates in this organization known as DREW ALI and CHARLES KIRKMAN. These men succeeded in getting a large membership for the organization. DREW ALI was killed about 1929 or 1930. There was also a man by the name of GREEN who was also connected with the organization but he was also killed. GREEN was shot in the head and both DREW and [REDACTED] father were arrested for murder. DREW got out of the trouble as did [REDACTED] also, inasmuch as nothing could be proven about [REDACTED] concerning the murder. DREW was later killed and his death was put out as being heart trouble. [REDACTED] was voted out as the head of the organization in July 1929. KIRKMAN was voted in and [REDACTED] was then placed under him. [REDACTED] did not like the idea of being under KIRKMAN and actually kidnapped him on September 25, 1929, holding him at his [REDACTED] Chicago. Chicago Police Officers came to arrest [REDACTED] and rescue KIRKMAN. [REDACTED] resisted two of the police officers and the two officers were killed, [REDACTED] and other members of the kidnapping were arrested and [REDACTED] along with two others, were sent to the Penitentiary. The two men who assisted [REDACTED] in this crime were a man by the name of JACKSON and his son. The elderly JACKSON died in Joliet Prison and the son is presently at large. [REDACTED] has never been released from the prison but has since been transferred to the State Penitentiary at Menard, Illinois, where he is known as Convict [REDACTED]

[REDACTED] that he had become a member of the Moorish Science Temple of America in 1919 at Chicago, Illinois, at the insistence of his [REDACTED]. He stated that he remained a member until approximately 1935 at which time he became involved in trouble. In 1934 [REDACTED]

[redacted] who is the leader of the Peace Movement of Ethiopia, sent [redacted] to St. Louis, Missouri, to help organize that movement. Before [redacted] left, a Japanese, whose name was forgotten, was at the home of [redacted] and her husband, [redacted] and at which time a \$200 payment was made to defray expenses in going to St. Louis and getting a place to hold meetings and to organize the colored people there in the Moorish Science Temple of America. Later [redacted] went to Pittsburgh, Pennsylvania, in August or September 1935 and was met at the station by [redacted] of the organization known as the Allah Temple of Islam, and CHARLES KIRKMAN.

These individuals took [redacted] to meet a chap by the name of [redacted] who lived approximately twelve miles out of Pittsburgh, Pennsylvania. The Japanese explained to [redacted] that there would be a war between the United States and Japan in about 1944, that the colored or dark races are to hang together, that it was one of the duties of members of the Moorish Science Temple of America to try to get all colored members not to join the military forces of this country, that when war between this country and Japan was started and all the white men were in the Army, that there would be enough colored young men left to cause a revolution in this country and take over things here while the soldiers were away in the foreign service.

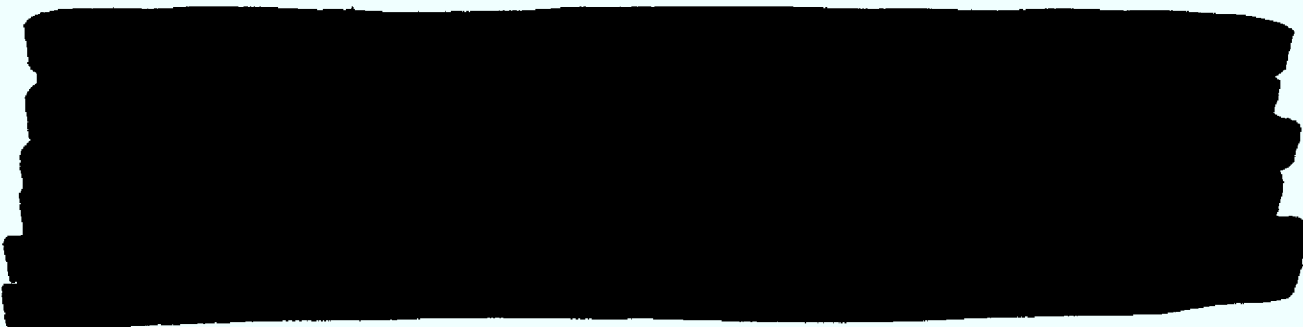
Of the branches listed, the investigation shows that Temple No. 1 of Chicago which is headed by [REDACTED] EL, was formerly affiliated with Temple No. 9, Chicago, which is KIRKMAN's central branch. Apparently friction arose between the two men causing No. 1 to be estranged and operated independently. Temple No. 4 of 632 Livingston Avenue, Detroit, Michigan, is affiliated with the Morgan Branch, 3716 South Prairie, Chicago, Illinois, claiming that as their national headquarters.

The branches claiming to be that of [REDACTED] EL or [REDACTED] (447 East 40th Street, Chicago, as their national headquarters) are Temple No. 8, 4003 West 8th Street, Pine Bluff, Arkansas; Temple No. 12, 1406 Laurens Avenue, Baltimore, Maryland; the temple located at 1039 Roberts Street, Augusta, Georgia, Temple at 18th and Christian, Philadelphia; Temple at 311 Burroughs, Pittsburgh, Pennsylvania; Temple at 628 Kaighn Avenue, Camden, New Jersey. All of the remaining chapters are affiliated with CHARLES KIRKMAN BEY or [REDACTED] EL of Brooklyn, New York. KIRKMAN was born September 7, 1896, at Eobridge, South Dakota.

The investigation conducted of the Branch thus far indicates that all members have complied with the Selective Service laws as a group; that there has been no indication of any pro-Japanese sentiments expressed in any of the meetings.

[REDACTED] Chicago, Illinois, janitor of the [REDACTED] wherein the meetings are conducted, has indicated that he has attended practically all of the meetings and that there has been no indication of any activity which is contrary to the best interests of the United States Government. [REDACTED] that he has always observed the American flag placed along side of the Moorish American flag to indicate the dual loyalty of the subject organization. This investigation conducted by the Chicago Field Division indicates that JESSIE SHELBY EL is a leader of a group at Moorish Science Temple, 3229 South Indiana, [REDACTED]

[REDACTED] advised that the group at 3229 South Indiana are a group who call themselves Moslems. He stated that they are a very reticent and distinct group of individuals, and that it has been practically impossible to gain entrance to the residence. He stated that while he knows this group, they are very undesirable tenants and he expressed his anxiety to evict them.

Investigation shows that all members of SHELBY Branch have complied with the Selective Service Laws and there are no delinquencies reported in their Selective Service status. The Selective Service records of Draft Board No. 2, 3104 South Michigan, show that Brother J. SHELBY EL, Shaik, was born June 4, 1886, at Clarksville, Tennessee. He stated in his Occupational Questionnaire that he was the savior of the world. The investigation conducted thus far has shown no indication that there are any pro-Japanese sentiments or subversive activities being conducted by this organization.

The investigation further shows that J. SHELBY EL and ALBERT STRICKLAND, who is an assistant to SHELBY, attempted to organize a branch of the Moorish Science Temple near Milestone, Mississippi, which resulted in the arrest of several members at Milestone during which time SHELBY and STRICKLAND returned to Chicago, there presently being an indictment outstanding against them in the State of Mississippi. The details of this will be found in the investigation conducted in the Jackson Field Division.

This group of the Moorish Science Temple of America is under the leadership of [REDACTED] EL, who calls himself [REDACTED]. [REDACTED] was one of the leaders of the subject organization at the time DREW ALI was alive, and following his death aspired to its leadership. [REDACTED] EL was successful in attracting a following [REDACTED]

Since 1930 the group has been meeting at 447 East 40th Street on Wednesday and Friday evenings, and Sunday afternoons. There have been several members of the organization living at 447 East 40th with the Subject and the vast majority of the members are residing in the immediate neighborhood. The membership [REDACTED] has been estimated from 60 to 150 persons in Chicago, Illinois. [REDACTED] reportedly has five wives living with him at 447 East 40th Street. These women are named [REDACTED] EL, [REDACTED] EL, [REDACTED] EL, [REDACTED] EL, and [REDACTED] EL. [REDACTED] has had three children by [REDACTED] EL, the oldest of which is now [REDACTED] years of age.

From information reported to the Chicago Field Division, [REDACTED] has been pro-Japanese in the past. An informant advised that [REDACTED] has not taken in new members into the subject organization but that in 1932 and 1933 was active in telling members that the Japanese were the friends of the colored man, and that when the Japanese came and conquered America that they would see that the Negro received his fair share in governing this country.

An investigation conducted by the Chicago Field Office has not established that statements at the present time made by [REDACTED] EL are seditious in

nature. The investigation of the male members of the [redacted] Branch reflects that they have complied with the requirements of the Selective Service Act. Subject [redacted] EL is registered in accordance with the Act and has claimed his common-law wife [redacted] EL and the three children as grounds for deferment, [redacted] who is [redacted] years of age, has been classified III-H by his local board.

This group has been reported to be extremely well financed by contributions received from members located in different cities principally along the East coast as will be developed further in this report. This group is also more fanatic and more closely resembles a cult group than do other branches of the Moorish Science Temple, male members of this branch wearing long beards and red fezzes, and women members wearing long flowered gowns and colored turbans. [redacted] enjoys a dictatorship status over the members of this branch. A school is conducted by [redacted] EL for the children in the subject organization. [redacted] a former school teacher, is reported to teach fundamentals of grade school education as well as the Moslem and Islam Religion.

[redacted] KEY is next in charge to [redacted]. The male members of this branch are employed in domestic positions and regularly contribute to the support of [redacted] and his wives and children.

This branch of the subject organization has been inactive for sometime. [redacted] EL was a member of the Adept Chamber while NOBLE DREW ALI was alive. Following the death of NOBLE DREW ALI at a meeting of the Adept Chamber, [redacted] EL was allegedly elected to be the Grand Shiek of the subject organization. However, he was not successful in retaining the leadership and attracted only a few persons to his group. However, [redacted] EL has filed with the Secretary of State at Springfield, Illinois, every year since 1938, and has received the State Charter. This is the only group on record with the Secretary of State. Meetings of this group were formerly held at 4848 South State Street until April, 1942, but since this time meetings have not been held.

[redacted] EL, [redacted] is the [redacted] of this branch. On August 1, 1942, [redacted] EL received a typewritten letter addressed to him, dated July 29, 1943, which is set forth as follows:

"Dear Brother:

The address [REDACTED] was known to be occupied by a number of Japanese aliens, including [REDACTED] who operates a rooming house at this address. A surveillance was conducted of this meeting with negative results. The recipient of the letter [REDACTED] EL, was observed to come to the entrance, but was met at the door by a Japanese woman, who it was subsequently ascertained, denied any knowledge of the letter and related to [REDACTED] EL that the occupants of this house were Chinese and were not Japanese.

Investigation was conducted of the Japanese residing at [REDACTED] with negative results. In connection with the Alien Enemy Control Program the Japanese residing at [REDACTED] were interviewed and a thorough search of the premises was made with their consent. A search of the premises failed to reveal the typewriter with type similar to the one writing the letter to [REDACTED] EL.

A physical surveillance maintained on the premises of [REDACTED] was negative in establishing any connection between the residents of [REDACTED] and the subject organization.

Subsequently [REDACTED] EL advised that in discussing the letter he had received with [REDACTED] EL, leader of Branch 1, 3122 South Cottage Grove Avenue, that [REDACTED] EL stated that he had received a similar letter but had declined to accept the invitation. [REDACTED] EL further advised that on interview [REDACTED] that a Japanese had come to his house in 1938 and endeavored to persuade him to sympathize with the Japanese cause. [REDACTED] EL advised that he had never known the identity of the Japanese calling on him, and he further stated that as soon as their purpose became clear, he invited them to leave his house, stating that America was the only country with which he was familiar and, therefore, he would do nothing to hurt the United States.

[REDACTED] EL further advised that the total membership was not over ten persons, and that for that reason meetings were discontinued in the Spring of 1942. He advised, however, that he and [REDACTED] EL, the [REDACTED] were discussing the advisability of again holding meetings of this branch of the subject organization. [REDACTED] EL insisted that under the teachings of Prophet NOBLE DREW ALI that members of the subject organization must abide by the laws of the United States, and must place their loyalty to this country in times of emergency.

This branch of the subject organization, under the leadership of [REDACTED] EL, meets at 322 East 43rd Street, Chicago, Illinois, on Friday and Sunday evenings at 8:00 p.m. [REDACTED] EL, [REDACTED] EL, [REDACTED] and [REDACTED] BEY, [REDACTED] came to the Chicago Field Office on September 26, 1942, to advise that their organization was in no way connected with the Ali Temple of Islam, although newspaper stories of the arrest of the Moslems had indicated that they were in fact connected with the Moorish Science Temple of America. [REDACTED] EL advised that members of this group abide by the teachings of NOBLE DREW ALI and that the members are taught to comply with all laws and regulations of the United States. Each of the three individuals above referred to exhibited Selective Service cards and advised that all members have been instructed specifically to comply with the requirements of the Selective Service Act. They advised further that the Koran used by this organization was printed by one [REDACTED]. EL advised that members of his group had never been in conflict with the Chicago Police Department, and that all members were employed at responsible positions, including many defense plants.

With reference to [REDACTED] BEY, [REDACTED] the Chicago Field Division received a letter dated October 6, 1942, from Chicago Local Board No. 7. [REDACTED] of Draft Board No. 7, advised that [REDACTED] BEY's order number was [REDACTED] and that he was born in [REDACTED] and had listed on his Selective Service Registration Card that his race was Oriental. In a questionnaire followed by [REDACTED] BEY, he stated he was opposed to noncombatant military service. He was classified III-A on [REDACTED] 1943. The Board received a letter dated [REDACTED] 1942, from [REDACTED] BEY in which he returned a special form for Conscientious Objector and stated that he was not opposed to the Selective Service Act, and any objections made by him to the Selective Service Act were a mistake. In this letter he claimed to be a Moorish American and to be a part of the United States Government.

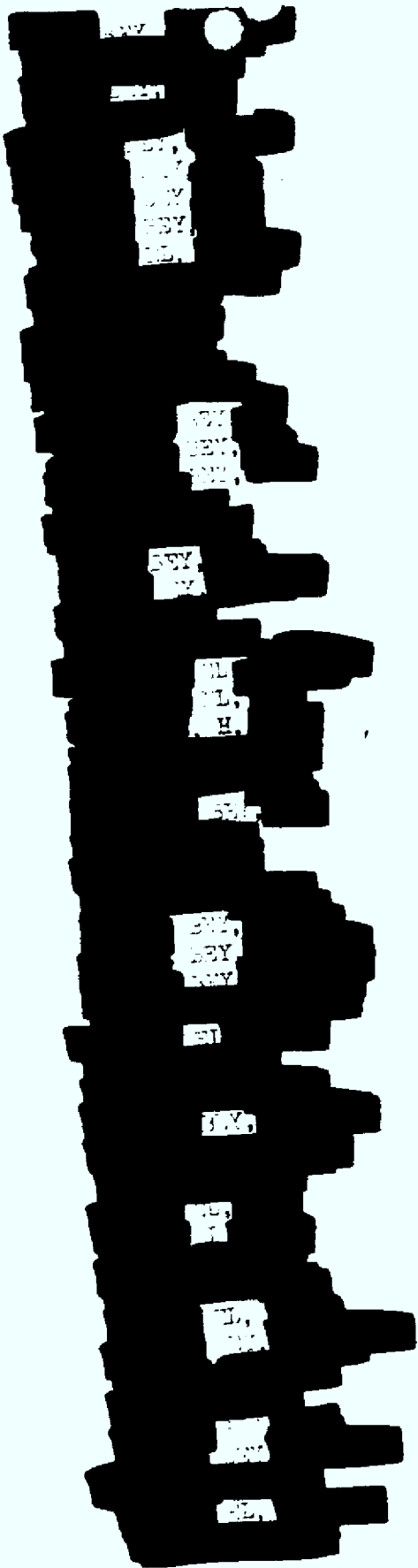

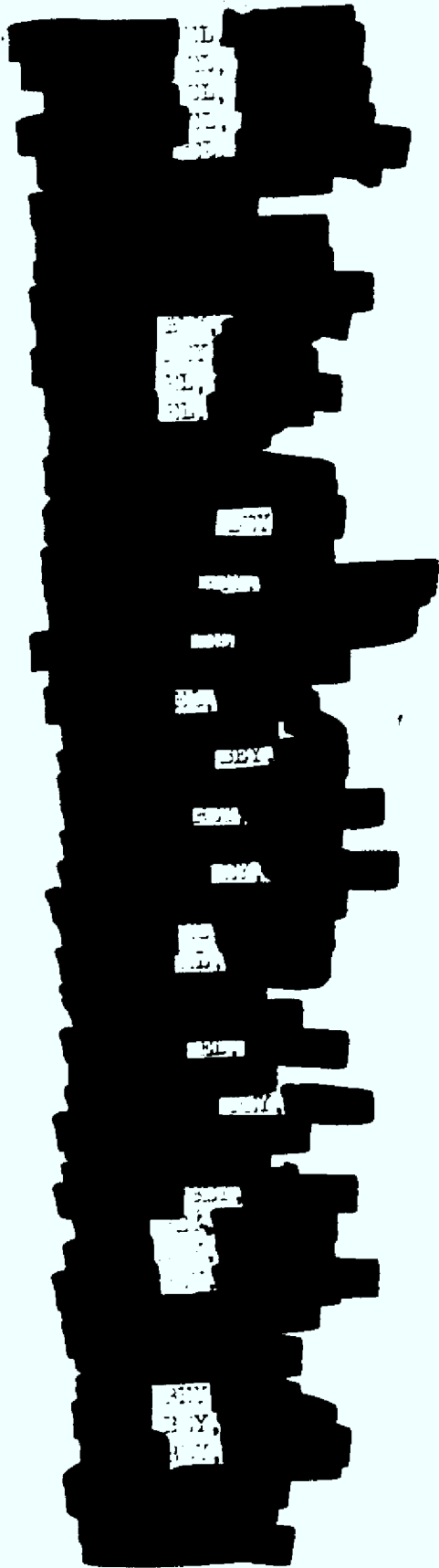

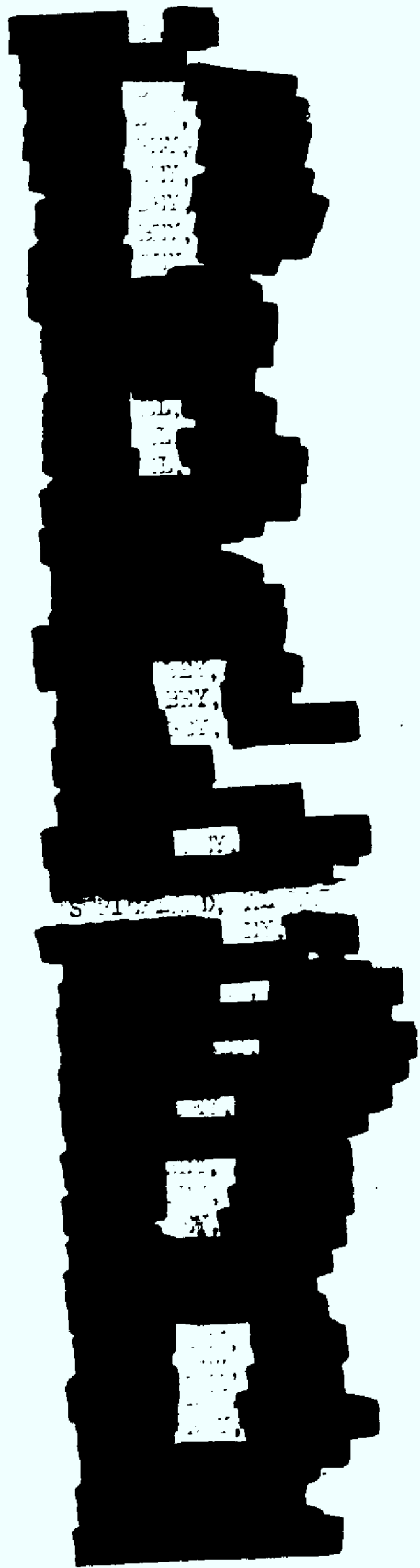

Approximately in August, a colored employee of the corporation named [REDACTED] advised him that his mother-in-law, now deceased, had been quite active in a cult known as the "Morans", a branch of the MORRISH SCIENCE TEMPLE, in Chicago, Illinois.

[REDACTED] a negro representative from the Calumet Area attended meetings regularly in Chicago, at 4448 State Street, which is the former building of the Masonic Temple. He also related that this building had secret passageways connecting with a nearby building.

[REDACTED] the cult assisted their members to become conscientious objectors and requested members to donate clothing and money for negroes in Africa.

A member of the St. Louis, Missouri Branch occasionally came to Chicago and collected these donations. [REDACTED] the Chicago organization has approximately 1500 to 1800 members who believe in the "Asiatic Brotherhood" and blood relationship with the Japanese.

[REDACTED] gave the above information to [REDACTED] (phonetic) of the [REDACTED] at the above address. [REDACTED] that [REDACTED] had given him the above information in confidence, since he was physically afraid of the members of the MORRISH SOCIETY. [REDACTED] was unable to give the first name of [REDACTED] but stated he was a rather intellectual type of negro employed in the ingot mold foundry of the [REDACTED]

He further stated that BERTHA ANDERSON EL was born October 10, 1910, in Hernando, Mississippi, and is presently living with a MAMIE BLACKWELL. She was formerly employed by Mrs. GEORGE YUREN, 340 Tyler Street. References given by her were JOHN BEY, 2226 Dunbar, and Mrs. BORENS, 2136 Adams Street, Gary, Indiana.

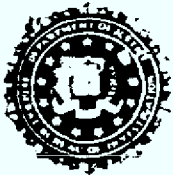

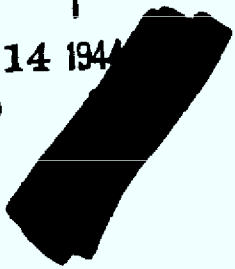

With reference to Bureau letter dated December 14, 1943, please be advised that a review of the above captioned file reflects that individuals who are members of instant organization in Chattanooga, Tennessee have made statements that were probably in violation of the Sedition Statute, however these statements were not made during the meetings of instant organization and were not made in the halls where the meetings are regularly held.

Due to the fact that prosecution would probably be declined regarding statements made by members of instant organization, as an organization, the individuals making the statements which could be termed as seditious will be interviewed in the immediate future and the Bureau advised in order that the additional evidence might be presented the Department for consideration as to prosecution.

Please refer to your letter of January 10, 1944, quoting the last paragraph of the report of Special Agent [redacted] dated November 22, 1943, at Chicago, Illinois, captioned [redacted] et al, Moorish Science Temple of America, Sedition, Security Matter, J", which contained the statement that the Bureau letter of October 5, 1943, "designated each Field Division where any branch was located as office of origin rather than Chicago which was originally the office of origin" and advised that the Newark Field Division would, therefore, consider itself as office of origin of the investigation pertaining to the group situated within its territorial jurisdiction.

The Bureau letter of reference clearly states only that each Field Division should proceed in its investigation with a view toward the prosecution, in each district, of the officials and speakers appearing before the local units of the Moorish Science Temple of America and does not contain any instructions relating to the designation of new offices of origin. The reference letter is to the effect that it appears improbable that a charge of conspiracy to violate the Sedition Statutes between the leaders of several of the units will lie and thus every effort should be made to develop sufficient facts to warrant prosecution of the captioned organization or its leaders within each district.

The Chicago Field Division will remain office of origin.

MEMORANDUM FOR MR. NICHOLS

As a matter of record, you are advised that Grand [redacted] el of the Moorish Science Temple, The Divine and National Movement of North America, Inc., [redacted]-bey and brother [redacted]-el Sheik were referred to this Section this afternoon by the Director's Office and in [redacted] absence were interviewed by Supervisor [redacted]. The Grand Sheik presented a letter from the Director dated October 21, 1943, which was in response to his letter of October 15, indicating an interest in juvenile delinquency. The Director's letter was just a perfunctory acknowledgment.

The Grand Sheik handed Special Agent [redacted] the attached literature and stated that he and his cohorts were in the city today on other matters and just wanted to drop by and pay their respects to the Director. Turner made quite an impassioned spiel on the nature of their group and pointed out that they were not interested in subversive activity in the least but were wholly American and interested in the American way of life. Special Agent [redacted] accented the pamphlets and indicated that they would be referred to the Director's attention.

The records of the above company reflect that one [REDACTED] was employed by their [REDACTED] from [REDACTED] to [REDACTED] at [REDACTED] Pennsylvania. It is noted that this [REDACTED] is the only colored individual on their payroll at their [REDACTED] operation. This employment record reflects that [REDACTED] was born [REDACTED] in the United States. It is noted that the physical description given in this record corresponds with the physical description of subject in instant case. Subject's address at the time of this employment was [REDACTED]

PROSECUTIVE STEPS

The facts in instant case were presented to Assistant United States Attorney, Mr. GEORGE MASHANK, who declined prosecution inasmuch as there is no evidence that the subject has wilfully tried to evade the provisions of the Selective Training and Service Act, and further, as there is no proof as to his correct birth date.

b7c Upon reinterview, subject stated that he does not know his true age, but is certain that he was born before 1900. He stated that the reason he changed his birth date from 1902 to 1885 at the time of registration for the draft was because he knew he couldn't stand the physical work of a man born in 1902. [redacted] that he was willing to go into the United States Army if he could serve with men of his own age. It is noted that [redacted] was thoroughly questioned as to his age at various periods of his life such as when he was married and his age during the last world war, but in each instance, subject stated that he could not recall his age inasmuch as he had never known his actual birth date. It is noted that subject stated he was not born in the city limits of [redacted] Delaware, but was born in some small town just outside of [redacted] the name of which he does not know.

It is noted that in connection with the above interview, subject advised the writer that he was still leader of the Moorish Science Temple of America in Pittsburgh. It is noted that no further information has been developed regarding subject's organizational activities in the Moorish Science Temple of America. This case is being placed in a closed status and information regarding subject's activities in the Moorish Science Temple of America will be reported in the Pittsburgh File entitled "Moorish Science Temple of America."

SYNOPSIS OF FACTS: Investigation fails to reveal any pro-Japanese activities or violations of the Selective Service laws on the part of the subject organization in this area. [REDACTED] of the MOORISH SCIENCE TEMPLE, THE DIVINE AND NATIONAL MOVEMENT OF NORTH AMERICA, INC., with headquarters at 1796 Fulton Street, Bklyn, N.Y. interviewed and records of organization examined; membership list, copy of the organization's charter, constitution, and By-laws obtained. Members of Temple located at [REDACTED] Brooklyn, N.Y. advised that [REDACTED] EL was the original founder of temples [REDACTED] and [REDACTED] but has severed all connections with the organization headed by C. Kirkman-Bey. [REDACTED] EL has established his own religious organization known as THE MOORISH SCIENCE TEMPLE THE DIVINE AND NATIONAL MOVEMENT OF NORTH AMERICA, INC., which is presently located at 1796 Fulton Street, Bklyn, N.Y. This organization is incorporated under the laws of the State of Connecticut and has several branches in that State.

The following Selective Service Boards, which cover the area in which the members of the MOORISH SCIENCE TEMPLE OF AMERICA, INC. and THE MOORISH SCIENCE TEMPLE THE DIVINE AND NATIONAL MOVEMENT OF NORTH AMERICA, INC. reside, were contacted by the reporting agent in regard to the possibility that the members of the previously mentioned organizations might be delinquent or might be violating or encouraging the violation of the Selective Service laws.

The Boards in question were Selective Service Board 205, 1263 Bedford Avenue, Brooklyn, New York; Selective Service Board 209, 1718 Pitkin Avenue, New York City; Selective Service Board 208, 1432 Pitkin Avenue, New York City; Selective Service Board 210, 1796 Pitkin Avenue, New York City.

Interviews with the Heads of the above mentioned Selective Service Boards indicated that several of the members of the Moorish Science Temple organizations under investigation are already in the Armed Forces, others have been honorably discharged, while other members have been declared not fit for Service or have been deferred. There was no indication that any movement has been instigated by the various Moorish organizations to interfere with the operation of the Selective Service laws.

The records of Local Selective Service Board 205, 1263 Bedford Avenue, Brooklyn, New York indicated that the Grand Sheik of [REDACTED]

[REDACTED] EL, order number [REDACTED] who resides at [REDACTED] as born at [REDACTED] He resides with his wife, [REDACTED] EL, and was presently requesting a 4-D classification on the grounds that he was a minister and entitled to this classification. Subject's file had been forwarded to Selective Service Headquarters 1 East 44th Street, New York City, where the subject is to be interviewed and a final decision in his case made.

A review of the Subject's file at Selective Service Headquarters indicated that he considered himself the Executive Counselor and Moderator of the [REDACTED]

He also listed [REDACTED] BEY as National Chairman, [REDACTED] BEY as Grand Deputy Counselor of the Eastern Division. Subject stated in his questionnaire that he officiated as a Moorish Minister at the Moorish Science Temple at [REDACTED] Brooklyn, New York. He gave as additional qualifications eight years elementary school education, four years High School education and four years at [REDACTED] Subject also claims to speak ten languages.

the Selective Service Headquarters reflected that the subject had been granted
a Hearing but that no definite conclusion had been reached as to whether or not
he was entitled to a 4-D classification. The matter has been turned over to
[REDACTED] of the [REDACTED] who has been instructed to
interview the subject and determine whether he is entitled to a 4-D classification
as a bone fide Minister.

The records of the New York Times morgue located at 229 West 43rd
Street, New York City were reviewed by the reporting agent in an attempt to

[REDACTED] EL was interviewed at his residence, [REDACTED] Brooklyn, New York, by Special Agent [REDACTED] and the reporting agent. He advised at that time that he had founded Temples [REDACTED] and [REDACTED] but that he had broken away from the organization headed by C. KIRKMAN-BEY and had founded his own religious movement known as THE MOORISH SCIENCE TEMPLE FOR DIVINE AND NATIONAL MOVEMENT OF THE AMERICAS, INC. He stated that Temple [REDACTED] located Halsey Street and Sumner Avenue, Brooklyn, New York was no longer in existence, Temple [REDACTED] West 176th Street, New York City was no longer in existence and that Temple [REDACTED] headed by [REDACTED]-EL, located at 135 Hance Street, Brooklyn, New York and Temple [REDACTED] located at 1709 Pitkin Avenue, Brooklyn, New York were very inactive, but still loyal to C. KIRKMAN-BEY in Chicago, Illinois.

[REDACTED]-EL advised that he was the Grand Sheik of all the Moorish Science Temples in [REDACTED] and part of [REDACTED]. He said that the only connection that existed between his organization and the Chicago organization was that they were bound together with bonds of brotherly love. His organization holds meetings twice a week on Friday and Sunday. A National Convention is held on September 15th of each year, the last being held on September 15, 1943 at Hartford, Connecticut at which time the Lieutenant Governor of the State of Connecticut attended.

✓ According to [REDACTED]-EL [REDACTED] BEY also known as [REDACTED] BEY was a member of some individual Moorish sect and had no connection with any other Moorish organization in Brooklyn. [REDACTED]-EL stated that [REDACTED] BEY was a bad actor and "no good".

[REDACTED]-EL was interviewed by the agents in regard to the "BB Plan" which represents the Black Followers of Buddhism and stated that Buddhism is the key to racial success and sets out a plan whereby American negroes were to become Buddhists and automatically Moorish citizens. [REDACTED]-EL denied that his followers had ever contemplated adhering to this plan. He stated

that he knew very little about it.

[REDACTED]-EL advised that his organization has a small branch located at [REDACTED] where they operate a small [REDACTED]. This branch has no number and will not receive one until it is chartered.

[REDACTED]-EL stated his duties as head of the organization was to ordain ministers, issue charters, and preside over the Moorish school, which consists in the teaching of Moorish catechism. The subject stated that his organization operated several temples in the State of Connecticut, the Temples in question are as follows:

Temple [REDACTED] State Headquarters, located at [REDACTED] Connecticut and headed by [REDACTED] BEY, who resides at the Moorish Home, which is owned by the organization and located near Woodstock at [REDACTED] Connecticut. This farm is to be used as an old age home for the members of the organization and is about 200 acres in size and according to [REDACTED]-EL is valued at \$10,000.

Temple [REDACTED] Connecticut, is headed by [REDACTED] BEY, [REDACTED] Connecticut.

Temple [REDACTED] located at [REDACTED] Connecticut is headed by [REDACTED] BEY, who resides at the above mentioned address.

Temple [REDACTED] is located at [REDACTED] Connecticut and is headed by [REDACTED] BEY, who resides at [REDACTED] Connecticut and he is assisted by [REDACTED] BEY, [REDACTED] Connecticut.

The Grand Governor of the State of Connecticut is [REDACTED]. [REDACTED]-EL stated that he is considering founding branches of his organization at [REDACTED] and [REDACTED] Connecticut. At the present time several of the members of his organization meet at [REDACTED] Connecticut.

Subject advised that the organization owned additional property in Massachusetts. This consisted of a 500 acre tract of land with buildings and was known as the Moorish National Religious Home. The [REDACTED] of this property is [REDACTED] BEY. Subject said that this property was purchased in September of 1943 from the [REDACTED] Massachusetts at a cost of \$50,000.
