darker races were brothers. He also advised them that one day Japanese airplanes would darken the sun and that the Japanese would take over this country. He stated that [REDACTED] BEY instructed the people that they were to help the Japanese when this invasion came inasmuch as they are brothers of the Japanese. [REDACTED] BEY instructed the people to put on their fizzes and hang out their Moorish flags in order that they might be recognized by the Japanese as brothers.

[REDACTED] BEY further instructed the people that when the Japanese came to this country the Moors were to move their families to specially designated safety zones and then the men were to return to town and set fire to the houses in order that the Japanese might see where to drop their bombs. He further told them that after the Japanese invasion had been completed that the members of the N.S.T.A. would take over the Buick plant in Flint.

[REDACTED] BEY advised that all of these statements were made prior to 1937 and that he has heard [REDACTED] BEY only once since that time. This speech was made about Thanksgiving of 1942 in Temple No. 52 and at this time [REDACTED] BEY talked strictly about religious principles which are laid down in the KORAN. [REDACTED] BEY advised that he, along with the other members of the N.S.T.A. considered [REDACTED] BEY to be an ignorant type of individual and that very few of the members paid any attention to his teachings. [REDACTED] BEY advised that he considers C. KIRKMAN BEY to be a person who is conscientious in his religious beliefs and that the only statement he has ever heard him make concerning the Japanese was about Thanksgiving of 1942 when KIRKMAN BEY made a statement to the effect that the Japanese are brothers of all the colored races and some day the white races will be ruled by Germany and the colored races by Japan.

It should be noted that [REDACTED] BEY appears to be a person of average intelligence and also appears to be trustful and conscientious in the statements which he made concerning the teachings of [REDACTED] BEY. He specifically advised that no other person except [REDACTED] BEY had ever taught the members of the Temple that they should support the Japanese in case of an invasion of this country. He stated that in his opinion [REDACTED] BEY is the only member of the organization who might be called pro-Japanese.

The pertinent parts of the interview with [REDACTED] BEY were incorporated into a signed statement. This statement sets out the statements made by [REDACTED] BEY which have previously been set out in this report. In view of this fact, the statement is not being set out herein but is being retained in the Detroit file of this case.

SUMMARY REPORT

The following summary is not prepared for prosecution purposes in this case, but at the request of the United States Attorney for the Western District of Kentucky for a thorough review of evidence obtained to date in this case and his suggestions for possible leads leading to prosecutive action.

SECTION A. GENERAL BACKGROUND INFORMATION ON NATIONAL ORGANIZATIONS OF MOORISH SCIENCE TEMPLE OF AMERICA, AND LOUISVILLE CHAPTER 45.

I. Founding of Moorish Science Temple of America Nationally.

From the information available to the Louisville Field Division, which information is incomplete to date, the Moorish Science Temple of America was known as the Moorish Holy Temple of Science and was founded by its prophet, NOBLE DREW ALI in 1913. According to the teachings of the Moorish Science Temple of America, NOBLE DREW ALI based his new religion upon the teachings of MARCUS GARVEY, a notorious negro agitator. NOBLE DREW ALI headed the Moorish Science Temple of America until his death in 1929 in a street fight before the temple doors in Chicago. He was succeeded in his work by the present leader of the MSTA, Colonel C. KIRKMAN BEY, with aliases William Kirkland Bey, and "Frog Eyes", who is known to his followers at present as the Extreme Moderator and Advisor. Although by constitution, the offices of the MSTA are declared vacant once a year, KIRKMAN BEY has been unanimously reelected to office each successive year. He presently resides in Chicago, Illinois, which is the headquarters of this organization.

b7d [redacted] stated that he was born in [redacted] and has been employed by the Buick Motor Company in Flint since 1927. He has had nine years of education and one year of preparation to become a Methodist minister. He stated that he joined the M.S.T.A in 1931 shortly after Temple No. 19 was founded and attended meetings of this Temple until about one year ago when he changed his membership to Temple No. 52. [redacted] executed a signed statement which deals with the teachings of [redacted] between the years 1932 and 1937, which is being set out here:

"Flint, Michigan
March 3, 1943

"I, William [redacted] who has identified himself to me as a Special Agent of the Federal Bureau of Investigation. No threats or promises were made to me and I make this statement of my own free will.

b7d "I have been a member of the Moorish Science Temple of America for about ten years, having joined Temple No. 19 while [redacted] Bey of Detroit was the Grand Sheikh. On several occasions between 1932 and about 1937 I have heard [redacted] Bey talk about the Japanese. He told the members of the Moorish Science Temple of America that the Japanese are our brothers and that they will invade the United States some day. They will have a good navy and the elements will be dark with Japanese bombers. He also stated that when the Japanese came to this country the Moors should hang out the Moorish flags and put on their red fezzes. Throughout the time that [redacted] Bey was Grand Sheikh he often told members of the Temple that they are brothers of the Japanese. I have heard [redacted] Bey make only one speech in the Moorish Science Temple of America since he left Flint in about 1937 and that was about Thanksgiving of 1942. On this occasion he did not mention the Japanese.

"I have read this statement consisting of this and one full page and am signing it because it is the truth to the best of my knowledge.

b7c, b7d [redacted] that he was present at the Baptist Church on Jameson some time during the year 1935 when TAKAHASHI held a meeting there which he called "Development of our Own." He stated that TAKAHASHI predicted that there would be a war between Japan and the United States and that hundreds of thousands of Japanese people would go down in the war. He stated that TAKAHASHI warned the people that the Japanese would be their savior in the end and that they should join up with the Japanese when this war came.

b7c, b7d He stated that TAKAHASHI appointed [redacted] as active head of the organization but insofar as he knows, no other meetings were ever held. [redacted] lost his position as Grand Sheikh of Temple No. 19 in 1937 and that he has heard him speak on only one occasion since that time. He stated that [redacted] spoke to the members of Temple No. 19 about Thanksgiving of 1940 but that the talk was purely religious and had nothing to do with the Japanese. [redacted] spoke highly of C. KIRKMAN EY, the grand Advisor, and advised that it was through him that [redacted] lost his position as Grand Sheikh inasmuch as KIRKMAN EY did not approve of the pro-Japanese teachings which [redacted] was inclined to disseminate. He stated that [redacted] EY is the only person he has ever talked to the people about the Japanese and that people in general do not agree with the statements of [redacted] EY but felt that he was somewhat of an ignorant old man.

b7c, b7d [redacted] that the organization held military training for two or three years after the Temple was founded. He stated that the purpose of this drilling was to teach the members to drill and for the protection of the Temple from drunk persons or other outsiders who might come into the premises uninvited.

b7c, b7d [redacted] appears to be a negro of more than average intelligence and he also appears to be quite sincere in statements which he made. [redacted] advised that he knew outside people felt that the U.S.T.A. was pro-Japanese and he was very anxious to clear up this matter by pointing out the one person of the organization who is inclined to feel that way.

SYNOPSIS OF FACTS:

Subject organization is national in scope, a religious group confined to members of colored races who teach their followers they are descendants of the Asiatics although they are supposed to be loyal to the laws of the country in which they reside. As a group, they are distrustful of the White race. Certain groups, because of their religious belief, have failed to comply with the Selective Service Act. Others are pro-Japanese. The expressions of the followers are in keeping with the Japanese propaganda pattern. Two temples are known to be active in Brooklyn, N.Y. and the indications are, they are closely connected with groups in Connecticut and Massachusetts. In the past, Japanese speakers have spoken before these groups and certain followers in Brooklyn have been reported to be pro-Japanese. [REDACTED] of New York has now been made a member of this group and will report further on this group.

The Headquarters of the MOORISH SCIENCE TEMPLE OF AMERICA, INC. is situated at Chicago, Illinois, under the leadership of C. KIRKMAN BEY - "Supreme Grand Adviser and Moderator", who also edits or causes to be published a pamphlet entitled "MOORISH VOICE".

The MOORISH SCIENCE TEMPLE was organized in 1913 by NOBLE DREW ALI who headed the Group until his death in 1929, being succeeded by C. KIRKMAN BEY. This organization proposed to recover the birthright of the Moors which they alleged was taken from them to enable them to govern their own country - Morocco.

The organization identifies the negroes as Asiatics and a strong pro-Japanese sympathy has been found in several of the branches.

It appears that ~~NAKA~~ NAKANE an alien Japanese under the alias of ~~SATOKATA~~ TAKAHASHI, and claiming that he was a Major in the Japanese Army, was instrumental in the promotion of a branch of this group in Detroit, Michigan.

b7c The existence of the group in New York City first became known at the time of the arrest of [redacted] on July 30, 1942, [redacted] being a subject in the case entitled "THE PACIFIC MOVEMENT OF THE EASTERN WORLD, INC. - ET AL - ESPIONAGE (J); SELECTIVE SERVICE, SEDITION", [redacted] admitted he had been active in organizing among the negroes for the PACIFIC MOVEMENT OF THE EASTERN WORLD and other colored organizations which had resulted in the propagandizing of the negroes for the Japanese cause.

At that time, he stated there was in Cleveland an organization known as the MOORISH SCIENCE TEMPLE Church whose purpose was identical with that of the PACIFIC MOVEMENT. He further stated that there was a group of this nature also in Brooklyn, New York, and that he had attended one of their open meetings, but that as a rule these groups did not admit outsiders and that their membership was almost entirely made up of people of african and Asiatic descent.

In order that the pro-Japanese sympathy among the followers of the subject organization might be more clearly understood the following information is set forth as furnished by [redacted] at the time of his arrest:

b7c, [redacted] he first began speaking before colored groups in 1931 in New York City at which time he spoke before an organization known as the Universal Negro Improvement Association (UNIA). On this occasion he met [redacted] who was an organizer for the UNIA, and he accompanied her to Chicago in 1932 on which occasion he was introduced to a Chinese named [redacted] and a Japanese named SATOHASHI TAKAHASHI who represented himself to be a Major in the Japanese Army.

b7c, [redacted] agreed to work with TAKAHASHI who was organizing the negroes in that section and TAKAHASHI outlined his program as follows:

b7c, b7d That the purpose of the group was to organize all the dark people in the world and to build a separate government in their respective governments under the leadership of Japan. In this connection he explained that [redacted] of Japan, and [redacted] of China, promulgated a plan that the policy of Japan will be that Asia shall be for the Asiatics. He said that the Japanese will help all the dark people organize and build a government; that he had been sent to the United States to fulfill the mission of organization of the colored races of the United States; and further that the Japanese are scattered in every city in America working for the same purpose and he feels they should be organized now because the time is not so very far off when the Japanese will strike.

He said the BLACK DRAGON SOCIETY adopted this plan and sponsored a LINGUIST SOCIETY with headquarters at the University of Tokyo. In this society the men and women from all Asiatic countries are already being trained to be lecturers and organizers and in other fields as propagandists to indoctrinate in the minds of the dark people the spirit of Asia for the Asiatics. In this connection he stated that now was the time to actively carry on their propaganda inasmuch as all the countries were presently on friendly relations and their efforts in this respect would probably be overlooked."

b7c, b7d In furtherance of the above work, it appears that [redacted] TAKAHASHI and others formed organizations in all the major cities of the United States and further, TAKAHASHI tried to infiltrate many of his followers into colored organizations that were already formed. Some of the known names of the above organizations are:

- THE DEVELOPMENT OUR OWN
- THE PACIFIC MOVEMENT OF THE EASTERN WORLD
- THE PACIFIC MOVEMENT
- THE ETHIOPIAN PACIFIC MOVEMENT
- THE ETHIOPIAN PEACE MOVEMENT

And Many Religious Groups of the Islam and Mohammedan faith.

b7c A review of the files of the New York Office reflects that a report was prepared by the New York Office on the subject organization by Special Agent [redacted] under date of April 6, 1940.

The case, entitled "MOORISH SCIENCE TEMPLE OF AMERICA - SUBVERSIVE ACTIVITIES", reflects that information was received that the Japanese Chamber of Commerce officials have on several occasions, spoken for the Hartford Connecticut chapter of the MOORISH SCIENCE TEMPLE OF AMERICA, INC, a negro organization in the United States, claiming over 8,000,000 members, who described themselves as Moors and not negroes.

At that time, a series of six articles prepared for a Hartford newspaper about this group was obtained and forwarded to the Bureau.

b7c This report further reflects that a negro individual known as Grand Sheikh [REDACTED] EL who resides in Brooklyn, New York, came to Hartford, Connecticut in the Summer of 1936 and established Local Chapter Number 35 of "THE MOORISH SCIENCE TEMPLE OF AMERICA, INC." which organization was believed originally founded by KINGMAN BEY of Chicago, Illinois. [REDACTED]

The file in this case further reflects that Grand Sheikh [REDACTED] EL Moorish representative of the MST, 340 Hancock Street, Brooklyn, New York, addressed two letters to the Japan Institute, 630 Fifth Avenue, New York City, December 25, and December 27, respectively. In the letter dated December 23, Grand Sheikh [REDACTED] EL makes reference to a telephone conversation of recent date and states he wished to request a speaker from the Institute for a Moorish Holiday Banquet on January 8, 1941 to be held at the Moorish Temple, 854 Gates Avenue Brooklyn, New York. In this instance, he requested a Japanese speaker to speak on the culture and history of Japan and the future outlook of the Asiatic race. Also, he stated that on previous Moorish Holidays, they had been fortunate enough to have [REDACTED] who had made very interesting speeches on Japan; further, that the Moorish American people are very much interested in the successes of Japan in her program for the establishment of a new order in Asia, which will eventually terminate emancipation of all Asiatic people of the world.

b7c In answer to this letter, [REDACTED] of the Japan Institute advised that he would be happy to furnish the speaker, but that a speaker would not be able to touch on current political situations in the Far East.

b7c Grand Sheikh [REDACTED] EL in his letter dated December 27, 1940, acknowledged the letter from the Japan Institute and advised the audience would be made up of 300 or 400 people of Moorish descent, all of the dark race, who are sympathetic and interested in the freedom of the whole Asiatic race and all of the darker races throughout the world.

He reiterated that the Japanese speaker might be free to speak as he chose.

On January 4, 1941, [redacted] of the Japan Institute in a letter to Grand Sheikh F. [redacted] EL cancelled an engagement of the Japanese speaker. [redacted]

b7c [redacted] It is noted further that on December 30, 1939, F. [redacted] EL visited the Institute to see [redacted] regarding a speaker and material. Further, that on May 10, 1940, he again visited the Institute to see [redacted] regarding literature.

It is generally known that the Japan Institute of New York City, was a propaganda Agency for the Japanese Government in the United States.

The file in this case further reflects a letter from San Diego, California to the Pittsburgh Field Division, dated September 16, 1942, of which New York received a copy. [redacted]

[REDACTED] Brooklyn, New York, is reported to be a prominent organizer for this organization in Brooklyn, and further, that meetings have been held at the home of [REDACTED] Brooklyn, [REDACTED] and further that recently (about April 1), [REDACTED] negro writer for the Negro Newspaper "Pittsburgh Courier", spoke at one of these meetings in [REDACTED] home.

In this connection, Special Agent [REDACTED] and the writer had an occasion to interview [REDACTED] in connection with another investigation and at that time he advised agents that he had attended a meeting of a Moorish Group in Brooklyn in the early part of 1942, at which time there was a Japanese and his wife present. [REDACTED] that the Japanese girl was born on the Pacific Coast and that the Japanese man was born in Japan and this couple appeared to be well acquainted among the followers of the Moorish Group and it was his understanding that this Japanese was to speak on the program. [REDACTED] went on to say that he was one of the speakers first to talk, and after he had made his address, he left and did not know for sure that the Japanese spoke. He went on to state that at that time, there was nothing to indicate that this group was pro-Japanese, that they appeared to be interested in racial matters and the uplifting of the negro race. He said, however, that it might be possible that the Japanese have attempted to influence groups such as these.

[REDACTED] was unable to furnish the date that he made this visit to Brooklyn, the name of the person who invited him, or the address of the meeting place.

It is pointed out that [REDACTED] although he has been extremely racial in many of the views, has been known to write Japanese articles before and since Pearl Harbor.

b7c [REDACTED] Franchise Tax Division in the State of Arkansas, was interviewed at his office in the State Capitol Building. He examined his records and files and advised that he found no record of the Moorish Science Temple of America.

b7c [REDACTED] in the office of the Secretary of State, was contacted at her office in the State Capitol Building. She examined the office files on corporation matters and advised that there was no record of the Moorish Science Temple of America or of a corporation under any similar name.

AT PINE BLUFF, ARKANSAS:

b7c [REDACTED] Sheriff, Jefferson County, was interviewed at his office in the County Courthouse. He advised that he knew of no organization or church in Pine Bluff operating under the name of Moorish Science Temple of America..

b7c [REDACTED] colored deputy sheriff of Jefferson County, was contacted in the county jail. He advised that he knew of no church or organization in that vicinity under the name Moorish Science Temple of America, Inc. He did say, however, that there were some colored people in Pine Bluff who wore beards and called themselves Mohammedans. He stated that he did not know where they held their meetings, nor what days or nights they meet. He further advised that there were not very many of those people in Pine Bluff, but he was unable to give any estimate of approximately how many there were.

b7c [REDACTED] Local Draft Board A, Jefferson County, was interviewed at her office in the Armory Building. She advised that there were approximately 20 persons listed in their files under the name BEY and EL. She advised also that the board had not experienced any difficulty with any of the persons listed under those names with regard to their draft status or induction into the army. The only difficulty the board experienced was in listing the parties under the names BEY and EL. All the persons using those names insisted that they be listed as Orientals rather than negroes and that BEY and EL were their correct last names.

b7c [REDACTED] Clerk of Local Board B, Jefferson County, was contacted at his office in the Armory. He advised that two persons registered in his board attempted to register under the names BEY and EL, one under the name BEY and one under the name EL, but that he refused to register either of them under those names. He stated that he advised both parties that the name they were born under was the name he was going to register them under. [REDACTED] that at no time had he

experienced any difficulty regarding the induction or classification of any party who attempted to register under the names EL or BEY.

[REDACTED] BEY, [REDACTED] was contacted at his home in connection with the difficulty the Draft Boards had experienced in obtaining the correct names of parties who insisted on registering under the names BEY and EL. He stated that the names BEY and EL were Moorish names and were part of their birth right, once they became members of the Moorish Science Temple. He stated that the Moorish Science Temple of America, Inc., was established in Pine Bluff in the year 1928 when the Prophet NOBLE DREW ALI and ARTHUR BROWN EL came to Pine Bluff and established the Temple #8 in 1928. [REDACTED] BEY advised that he became a member of the Temple late in the year 1928 and has been a member ever since [REDACTED]

[REDACTED] EL is the Grand Sheik of the Temple [REDACTED] He stated that Temple #8 is the only Temple in the State of Arkansas and that [REDACTED] BEY was the only other officer of the Temple, and that [REDACTED] BEY is also an Assistant Grand Sheik, but holds a rank inferior to him [REDACTED] BEY. He also advised that the total membership of the Temple was between 60 and 70 members but that only about 30 were active.

He exhibited a copy of the Koran and a copy of the Questionnaire bulletin which all new members must familiarize themselves with. In addition, he showed the writer two medallions; one about the size of a silver dollar constructed of dark blue celluloid and embossed with gilt figures and lettering; on one side the large figure 7 and on the other side, a crescent and star with a Turkish Sword resting across the top of the crescent. The word "Justice" was printed on the Turkish Sword. Around the border of each side of the medallion there were four curved solid links, [REDACTED] BEY explained that each of the four segments represented a corner of the earth. The other medallion was in the form of a pin similar to the Campaign Buttons worn during a presidential election, of black tin construction and about the size of a dime. A gilt crescent and star with the letters M. A. above the crescent were the only symbols and letters on this small pin.

[REDACTED] BEY explained that the small pin was for every day wear, whereas the large medallion was to be worn at the meetings. The large medallion was hung on a red string and apparently was worn with the string hung around the neck.

[REDACTED] BEY further advised that the Headquarters for the Temple is at Chicago where the prophet lives. He spoke of NOBLE DREW ALI as still being the prophet. He stated that he himself had served in the American Army in the First World War for a year and a half and had seen

active service in France. He exhibited photographs of himself in uniform during the First world War. He advised that there was no teaching in the Temple under which any persons claimed exemption from Military Service as Conscientious Objectors. He mentioned that he had been in Chicago at one time and had visited the main temple there.

It was observed that [REDACTED] BEY's home is a 1½ story frame house with dilapidated front porch extending across the width of the house and that a maroon colored flannel banner containing a white crescent and star is hung inside the front door so that it completely covers the pane of glass which comprises almost the entire top part of the front door to his house.

It was also observed that in the back of his home to the west of and adjacent to his house is another roughly constructed 1-story frame building about 15 feet wide and approximately 25 feet long. The building is covered by a tin roof and the lower half of the outside walls is partially covered by an imitation red brick asbestos veneer.

[REDACTED] BEY stated that the building above described is the Temple for the Moorish Science Temple of America, Inc., and that the meetings are held there very Wednesday, Friday, and Sunday evenings. He advised that the building could seat 50 persons.

He stated that he is suspicious of them but that at no time has he ever heard any un-American statements by any of them nor seen any evidence of any un-American activity. Mr. PAT M. BARRETT, Prosecuting Attorney of Holmes County where [redacted] and [redacted] were convicted under the Mississippi State Sedition Law, advised that he does not believe there is any doubt that the statements made by the four negroes mentioned above constituted a violation of the Federal Sedition Law. It was his opinion that [redacted] and [redacted] the two negroes from Chicago, were mainly to blame for the whole affair and

[redacted] he felt that they were sitting on a powder keg in this section and that something had to be done before this organization became too dangerous. It is his understanding that they were teaching that this is an Asiatic Continent, that they were all Asiatics and not negroes, that all of the Asiatics are related and that when (not "if") the Japs come over here, those with membership cards will be protected, that those without such cards will be beheaded. Mr. BARRETT advised that [redacted] local Attorney, had represented [redacted] when he was tried for the violation of the Mississippi Sedition Law. [redacted] that his client had denied to him that he or any of the others had made any statement that they could keep a negro out of the army, and had also denied that they had said that members of the organization would be taken care of by the Japs. He said that [redacted] had told him the way the statement was put was that if the members followed the teachings of the organization they would be so good and righteous that when the Germans and Japs come over here that the members would not be harmed. [redacted] furnished the writer with a letterhead received from [redacted] and [redacted] who make up the firm of O'CONNELL and O'CONNELL, Attorneys at Law, Suite 304, 82 West Washington Street, Chicago, Illinois, which stated that [redacted] EL, a brother of the defendant [redacted] would make necessary arrangements for taking care of [redacted] trial. [redacted] that from this letterhead it appeared that the firm of [redacted] represented instant organization. [redacted] also furnished a letter dated May 7, 1942 which he had received from [redacted] EL, regarding three Charters of the Moorish Science Temple of America, or the Moorish Holy Temple of Science of the World, that he believed he had left in [redacted] office. This letter was headed as follows: "The Moorish Divine and National Movement. Membership Free. The Moorish Science Temple of America Inc. Prophet Noble Drew Ali, Founder and Head. Mr. EARL THOMAS, District Attorney for the district covering Lexington, Holmes County, Miss., and the prosecutor in charge of prosecuting the cases against [redacted] and [redacted] suggested that [redacted] all reside near Mileston and could possibly give information concerning the activities of instant organization in Mississippi. It was his recollection that the above named negroes had testified that [redacted] and [redacted] had said that when the Japs and Germans conquer America the members of this organization will not be bothered and that the members do not have to comply with Selective Service regulations or go to war. Further, that "JIM CROW LAWS" would have no effect whatsoever on members of this organization. He believed that some of the negroes understood that when they were referred to as Asiatics in this organization, it was meant that they were kin to the "ape" and would not be bothered by the Japs.

[redacted] residing [redacted] that [redacted] who is his cousin, and the "governor" came from Chicago in about February, 1942 to organize the Moorish Science Temple and to solicit members. They told him that Uncle Sam knew about this organization and so he thought it was all right to join. They also told him that if he had a membership card in this organization he would not have to go to the army and if he had not already registered for Selective Service he would not have to do so, then if anyone asked him about his registration card, all he would have to do would be show him his membership card in this organization. They further told him that those who had membership buttons would not be harmed, by the Japs if the Japs came to the United States, [redacted] that he did not consider the statements about the Japs very seriously, but that his purpose in joining the organization was to get the sick and death benefits which were promised to members. It was promised that the members, upon becoming sick, would receive \$5.00 per week and if they became very sick they would receive \$10.00 a week. Upon death they would be furnished with a burial in addition to a \$60.00 death benefit. [redacted] that when [redacted] found out about the organization he told him [redacted] that this organization was wrong and for the Japs, and he said that he then realized that this was true when he thought back upon what had been told him by the above named organizers. He further stated that he is more than willing to testify as to the matters set out above because he did not appreciate his own cousin getting him mixed up with an organization that was wrong like this one is.

[redacted] that he also heard the "governor" say that members of this organization did not have to go to the army and did not have to register. [redacted] that he also attended the meeting at which the "governor" said that members of this organization did not have to register or go to the army and that when, not "if", the Japs come over here and take the United States the members will be protected, while non-members will be killed.

heard of the ALLAH TEMPLE OF ISLAM, the only connection with this title existing in the Moorish Science Temple being the fact that Islam is the religion of his group.

[redacted] stated, as he has on previous occasions to the writer, that he is a follower of Noble Drew Ali, whose headquarters are at 447 East 40th Street, Chicago, Illinois.

According to [redacted] if [redacted] EL was still a member of some Philadelphia Moorish Science Temple when he was apprehended at Athens, Georgia, he should have had his membership card with him, a fact which is not stated in reference report.

[redacted] was questioned regarding the names set forth in reference report concerning individuals that [redacted] EL referred to as Temple members, and the only one that [redacted] appeared to recognize was that of [redacted] BEY who is evidently actually [redacted] BEY, presently teacher of the Moorish Science Temple at Camden, New Jersey.

[redacted] said he did not know [redacted] A check made on January 25th with [redacted] the Manhattan Laundry, 338 Mercer Street, Jersey City, New Jersey, given in reference report as employer, disclosed that no negroes by that name had been employed at the plant for more than a year, the extent of the period covered by the available records.

Also, on January 16, 1943 [redacted] EL, Head of the second and smaller Moorish Science Temple in Newark, located at 2 12th Avenue, was contacted at his place of employment at [redacted]

He said that he did not know [redacted] EL but that it was plain that the latter's beard would stamp him as a member of [redacted] EL'S Newark Branch of the Moorish Science Temple inasmuch as the latter group do not cut their hair, nor smoke, nor eat meat. They believe in the re-incarnation of their Prophet Noble Drew Ali and it is on this point and the points above that they differ from the belief held to by [redacted] EL'S TEMPLE, which latter group organized C. BIRKMAN BAY, 1104 North Sedgwick Avenue, Chicago, Illinois as their leader.

Then, in 1928 ALLI dropped the word "holy" in a new incorporation of the group under its present title of Moorish Science Temple.

"PART I

"The heads of temples are to submit a report monthly on all finances.

"Every temple and head is to function by words, deed, and acts imitating the prophet—especially when teaching a group of Moors. These are the general laws which will be handed to the latter.

"The head of all temples is to refrain from all wrathful words, profanity in the mildest form, all members of his or her temple.

"They must live the life of love, peace, freedom and justice and refrain from all alcoholic liquors or any other harmful liquors. Possibility that will emanate to destroy peace or any other of the divine principles.

"They are not to contribute to anything that will cause the to disagree with he or she.

"And for one to head a group of Moors—you must keep this house clean, clean with good deeds, kind words, brother must bear good words, kind words, and not only of his good deed.

"If there are children you must see to their support. Follow this divine principle, for if you don't restrict to this divine principle, then you are not a true Moor.

"And heads are not to charge for membership. They are to charge for cards, button and anything issued by the prophet. Those who contribute to either of the preceding are not Moors but robbers. Membership fee for sisters and brothers is not only here but all over the world.

"The button is twenty-five cents, card twenty-five cents and one month dues is paid. Every member pays fifty cents monthly for dues. This money goes to the support of the temple.

"This if not paid does not entitle you to the protection that is provided for you, and especially if you are working or in a position to work. If you neglect to fulfill this small duty assigned you, how can you rightfully expect money or any other help when you are sick or otherwise disabled?

"And to be a real Moorish leader you must study the Choran and the divine constitution that is handed down to you by me, a prophet.

"The head of my temple can maintain an emergency fund, which cannot exceed the amount of from twenty-five cents to fifty cents a week per member.

"PART II

"All possible collection and dues also goes to the supporting of each said temple and domestic work.

"The head of every temple must by law obey the word of the prophet and if any head leader or head of any temple fails to obey these laws, embezzlement is his charge and is subject to enforcement of the law by the grand body.

"And the penalty may be a fine or removal from office; or placed under a very heavy restriction of the law.

"SUPREME WORDS OF THE PROPHET NOBLE DREW ALI

"I here-by inform all members that they must end all radical agitating speeches while at work, in their homes, or on the streets. We are for Peace and not destruction.

"Stop flashing your cards at Europeans. It causes confusion. Remember your card is your salvation. Failure to obey these orders will be of severe consequence. We are for love at home, peace, freedom and when these principles are violated, justice must then take its course.

"Any member or group of members who hold malicious feeling toward the Temple or the Prophet or violate the divine Covenant will receive their reward from ALLAH for their unjust deeds.

"All true Moors will and must obey the laws as laid down by the prophet. If they lose confidence in their prophet. They should turn their card, button, cease wearing their turban or fez, and return to the state in which the prophet found them.

that the Japanese prostitutes hang out at this place but, other than that, he knows of no association between the two races.

b7c [redacted] colored, residing at [redacted] that the Chief of the Salt Lake City Police had caused a group of Japanese prostitutes to be taken from local IWCA where a dance was being given for the colored soldiers and had lectured to these prostitutes about the Japanese being superior to the negroes even though the two countries were at war. He stated, however, that outside of the fact that some of the colored soldiers did associate with Japanese prostitutes, he knew of no organized association in Salt Lake City. [redacted] that he was the eldest negro resident in Salt Lake City and that if any union between the two groups were in progress, he would be the first to know about it. He stated that there was rivalry between the two races and that though at the present time the Japanese were taking jobs which the negroes should rightly have, he felt that after the war was over the negroes would come to the fore and would take over the jobs now held by Japanese. In addition, he advised that the Japanese in Salt Lake City had slighted the negroes and for that reason the negroes had no love for the Japanese. He then advised that he was the former president of the Society for the Advancement of the Colored People and that he would have ample opportunity to know of any concerted movement, however, he stated that he was not aware of any such movement.

This investigation was conducted upon a request received from the Bureau by letter dated December 3, 1942, relative to the Peace Movement to Ethiopia, also known as Ethiopian Peace Movement, etal, Internal Security - J, Sedition, in which reference was made to report of Special Employee Agent [REDACTED] dated November 12, 1942, at Grand Rapids, Michigan. This report reflected that [REDACTED] EL stated that there were thirty members of the Moors in Benton Harbor, Michigan. The Bureau letter requested that investigation of this organization be made to determine if there had been any violation of the Selective Service or Sedition Acts.

The investigation disclosed that the organization was affiliated with the Moorish Science Temple of America.

[REDACTED] described members of this group as being very radical in their views and said that he recalled some members saying that they could drink and do whatever they wished because the police could not arrest them. He said also that he believed that when a member of the group died, some high official of the order would come to Benton Harbor, from Chicago, to be present at the burial. This group has no faith or belief in the Christian religion according to [REDACTED] that in his discussions with members of this organization he had secured no information as to the organization's attitude toward Selective Service, nor had he heard any expressions which would indicate that the organization was pro-Japanese.
