

#### THE NATIONAL ASSOCIATION FOR THE ADVANCE BUT OF COLORED PEOPLE

According to a newspaper clipping from the Washington
Star dated February 23, 1934, the National Association for the
Advancement of Colored Reople (NAACP) was organized following the
race riot of 1908 at Springfield, Illinois. WILLIAM ENGLISH WALLING
suggested an organization for the protection of the colored race.
A call was sept out by OS ALD GARRISON VILLARD. Among those responding were JANE ADDAMS, LILLIAN DARALD, JOHN DEMEY, Rabbi STEPMEN
WISE, and SA UEL BOTLES.

On Lincoln's birthday, 1909, a Committee of Forty was formed for carrying out the purposes of the organization. In 1934 the NAACP had three hundred seventy-five branches and a membership of about eighty thousand. In 1911 the NAACP declared through its organ, the "Crisis" that it is an organization of persons who believe that the present prejudice against colored races and particularly

the denial of rights and opportunities to millions of Americans of negro descent is not only unjust and a menace to our free institution but also is a direct hindrance to world peace and the realization of human brotherhood.

At this time its methods of accomplishing its purposes were stated as:

- 1. A lecture bureau.
- 2. A bureau of legal assistance.
- 3. A bureau of information.
- 4. A bureau of publicity and research.

In the second annual report of the NAACP dated January 1, 1912, which is on file in the Library of Congress, its purposes were stated as follows:

"The NAACP seeks to uplift the colored man and woman of this country by securing to them the full enjoyment of their rights as citizens. Justice in all courts and equality of opportunity everywhere. It favors and aims to aid every kind of education among them save that which teaches special privilege or prerogative class or casts. It recognizes the national character of the negro problem and no sectionalism. It believes in the upholding of the Constitution of the United States and its administration in the spirit of ABRAHAR LINCOIN. It upholes the doctrine of 'all men up and no man down.' It abhors negro crime but still more the conditions which breed crime and most of all the crimes committed in the mockery of the law. It believes that the scientific truths of the negro problem must be available before the country can see its way clear to righting existing wrongs. It has no other belief than the best way to uplift the colored man is the best way to aid the white man to peace and social content; it has no other desire than exact justice, and no other notive than humanity."

Today the NAACP states that full citizenship rights for the negro is the rock upon which it is established. It claims to be an international organization, membership in which is open to all who believe in equality of mankind. The association has 350 branches and 122 college and youth groups in 44 states. The national headquarters is at 69 5th Avenue, New York City.





#### The NAACP today states its aims:

1. The end of lynching

2. The ending of disfranchisement

- 3. The abolition of injustice in legal procedure based solely upon color or race.
- 4. Equitable distribution of funds for public education.
- 5. Abolition of segregation and discrimination, insultand in humiliation based upon race or color.
- 6. Equality of opportunity to work in all fields with equal pay for equal work.
- 7. Abolition of discrimination against negroes in the right of collective bargaining through membership in organized labor unions.
- 8. The ending of peonage and the debt slavery of southern sharecroppers and tenant formers.
- 9. Abolition of segregation in the Army and Navy. (It will be noted that this is a new ein which has only recently appeared as one of the stated ends of the NAACP.)

According to its own statement the principal achievements of the NAACP have been:

- "1. A continuous war on lynching by writing, lecturing, mass demonstrations and the fights for the passage of the Dyer anti-lynching bill in 1922 and the Costigan-Wagner anti-lynching bill in 1934 and 1935. The campaign led by the NAACP resulted in the passage of the Gavagan anti-lynching bill in the House on April 15, 1937, by a vote of 277-119. The bill was taken up November 15, 1937, at the special session and debated for six days, when it was displaced by the farm bill. By agreement, it came up for debate January 6, 1938, and from that date to February 21, southern senators engineered a lengthy filibuster which resulted in the bill's being laid aside. The filibuster cost American taxpayers \$460,000. The bill was reintroduced in the 76th Congress in January, 1939, being sponsored in the House by Representative JOSEPH A. GAVAGAN, and in the Senate by Senators ROBERT F. NAGNER, FREDERICK VAN NUYS and ARTHUR CAPPER.
- 2. The NAAUP has won twelve out of thirteen cases before the highest court of the land. It has won the following U.S. supreme court decisions aiding colored people: Grandfather Clause disfranchising

Negroes declared unconstitutional in 1915; Louisville Residential Segregation ordinanace held unconstitutional in 1917: Arkansas sharecropper riot victims freed (12 from death, 67 from long term and life imprisonment) when trial in mob-dominated court was held not due process of law in 1923; Texas white primary law barring Negroes by statute from Democratic primaries held unconstitutional in 1927; New Orleans segregation law held unconstitutional in 1927; Texas white primary law (second case) barring Negroes by enabling act from Democratic primaries held unconstitutional in 1932. These memorable victories were achieved at the remarkably low cost of \$31,193.92; largely due to generosity of members of the national legal staff and other lawyers who contributed their services.

In the JESS HOLLINS case arising in Oklahoma, which was won by the association before the U. S. supreme court in 1935, the opinion of the court in the Scottsboro cases was sustained: That HOLLINS had been convicted by a jury from which Negroes had been systematically excluded. A similar decision was obtained in 1937 when a new trial was secured for JOE VALE, convicted by an all-white jury in McCracken County, Kentucky.

On December 12, 1938, the supreme court ruled in the case of GATLES vs. University of hissouri that the University of hissouri must either admit LLOYD GAINES, a Negro student, to its law school, or the state of Missouri must provide equal accommodations for the training of Negro graduate and professional students. The court held that out-of-state scholarships did not answer the constitutional requirement of equal rights and that states must provide equal training within their borders.

In 1937, the association secured a re-trial as a result of the United States supreme court decision in the case of ED BROWN, HENRY SHIELDS and YANK FILLINGTON, Negro sharecroppers who were convicted of murder by the supreme court of Mississippi in the death of RAY COND STEWART, April 4, 1934. The United States supreme court decision was based on the fact that the only evidence against these three men was procured through coercion and brutality. The court held unanimously "The rack and torture chamber may not be substituted for the witness chair."

The latest victory was won on May 22, 1939 when the United States supreme court ruled in the case of LANE vs. WILSON that the





Oblahoma registration law discriminating against Negroes was invalid. Mr. Justice FHANKFURTER, speaking for the court about the Fifteenth Amendment stated: 'The amendment nullifies sophisticated as well as simple-minded modes of discrimination.'

- 3. It was the first national organization to raise the question of the right of Negroes to sit on juries in the Arkansas sharecropper case, 1919-1923.
  - 4. With a group of other national organizations, the NAACP is a member of the joint national Scottsboro Defense Committee which is carrying on the light to free the world's most famous defendants.
  - 5. It launched and has continued the fight to abolish the system of lily-white Democratic primaries in the South. The association believes that free and independent use of the ballot is the right of every citizen in America.
- 6. In 1932 it twice investigated slave labor conditions on the Mississippi levees and won increases of \$100,000 weekly for 25,000 Negro workers, shorter hours and better conditions. Similar efforts were made in connection with other great public works such as Boulder Dam and TVA. TVA was investigated in 1938 and the evidence of discrimination against Negroes was presented to the joint committee of the U.S. Congress investigating TVA.
- 7. It has everywhere fought school segregation and discrimination in the allotment of educational monies to Negro schools. Lawyers for the association secured a ruling by the Maryland court of Appeals in January, 1936, which opened the doors of the University of Maryland law school to Negro students. This fight is being continued in Maryland where the third Negro was admitted in 1939. Similar cases are to be filed in Tennessee and Missouri.

The campaign to equalize the salaries of Negro and white teachers has spread to Maryland, Virginia, Florida, Alabama and Kentucky. As the result of two court cases, salaries have been equalized in nine out of twenty-three counties in Maryland, which means an additional \$100,000 a year on the pay checks of Maryland school teachers. One additional case is pending in the Circuit Court of Prince George's County, Maryland, and another in the federal court in Maryland.




- 8. Under the New Deal it fought at great expense all sorts of discrimination against Negro workers and persons on relief under the NRA, PWA, WPA, etc.
- 9. It has fought discrimination against Negroes in both federal and state civil service and is continuing its fight against discrimination in organized labor."

According to information received from the local branch of the NAACP at 1011 U Street, N.W., by reporting agent under suitable pretext, the various local branches of the organization operate in the following way:

When trouble is spotted or information sought, the local office is notified. The trouble-spotter or information-seeker reports to a full time clerk. By a regular system the secretary of the branch refers the matter to an appropriate committee—Legal, Labor, Education, or Youth. The Press Committee sees that the reading public is aroused; the Entertainment Committee provides fund raising and continual activities. The works of the branch are dove-tailed by a very alert Executive Committee fully representative of the groups which pay for the branch's operations.



So it would appear that the NAACP is divided itself between the conservative approach to the negro program as advanced by BOOKER T. WOSHINGTON, and the more radical program advocated by W. E. B. DUBOIS.

A review of the Bureau files on the NAACP indicates that prior to 1935 a concerted effort was made to keep politics out of the organization but since about the iddle of 1935 increasing communistic tendencies are noticeable along minor local branches the national administration of the NAACP. In July, 1938, the NAACP went on record at its annual convention in Columbus, Ohio, as saying that in the future it would cooperate with other groups on specific issues. It is known that the NAACP has allied itself with the lational Negro Congress, the American Civil Liberties Union, and the American People's Mobilization and other communist front organizations on specific issues in several respects.



#### \*ARTICLE I.

#### NAME AND OBJECT

Section 1 The name of this organization shall be the (name of city or county) Branch of the Name National Association for the Advancement of Colored People.

#### ARTICLE II.

#### **OFFICERS**

Section 1 The officers of the Branch shall be a President, Vice-President, Secretary, and Treasurer; also, at the option of the Branch, additional Vice-Presidents and an Assistant Secretary. The officers shall be elected as hereinafter provided.

Section 2 The duties of the President shall be:

(a) To preside at meetings of the Branch and to

(b) To appoint all committees not directly elected by the Branch or the Executive Committee.

(c) Between meetings of the Executive Committee and subject to the approval thereof, to exercise general executive authority on behalf of the Branch.

(d) To perform such other functions and exercise such further duties as may be voted from time to time by the Branch or the Executive Committee. (e) To countersign all requisitions by the Secretary for disbursements from the Branch treasury.

The President shall be ex-officio a member of all committees, except the Nominating Committee as provided in Article IV, Section 4. \*

Section 3 The duties of the Vice-President shall be to perform all the duties of the Fresident in his absence or disability. In case of more than one President Vice-President, the Vice-Presidents shall be designated as first, second, third, etc., and shall perform their duties according to their remerical rank.

(a) To receive all monies of the Branch and promptly to deposit the same in the name of the Branch in a separate account or accounts in a responsible bank or trust company. No money shall be withdrawn from any such account except on check signed by the Treasurer and countersigned by the President.

- (b) To act as Chief financial officer of the Branch and Chairman of the Finance Committee.
- (c) To make authorized disbursements upon requisitions signed by the Secretary and countersigned by the President. Each requisition shall recite the amount and purpose of the payment requested. Every requisition in the amount of one hundred dollars or more must further be approved by the Executive Committee before payment. The Branch by regulation may require that requisitions in smaller amount be approved by the Executive Committee.
- (d) To remit through the Secretary to the National Office the proportion of membership fees to which the National Office is entitled, as hereinafter provided, within fifteen days after their receipt (Article V, Section 4).
- (e) To submit reports to the Branch and the Executive Committee at all regular meetings, or whenever required by either body, covering the financial condition of the Branch, showing receipts and disbursements, outstanding accounts unpaid since his last report; to submit an annual report of the business of his office at the annual meeting of the Branch, to which shall be appended a statement signed by the President and Secretary that all funds received by the Branch have been listed in the Treasurer's report. #### ARTICLE III.

#### COMMITTEES

Section 1 The Executive Committee shall have general control of the affairs of the Eranch, subject to the authority of the Branch and to the provisions of Executive this Constitution. It shall consist of the Presi-Committee dent, First Vice-President, Secretary, Treasurer, the chairmen of the standing committees of the Branch, the President of the Youth Conncil, the President of each College Chapter in the same community, the Senior Branch Advisor in the Youth Council, the Senior Branch Adviser of the Junior Youth Council, and such other members to be elected at the annual meeting of the Branch as the Branch by by-law may decide: Provided, that the total membership of the Executive Committee shall not exceed twenty-five, except by written authorization of the Board of Directors of the Association.

The Executive Committee shall render a report to the Branch at the regular meetings of the Branch and whenever otherwise required by the Branch.

The further duties and powers of the Executive  $C_{\text{ommittee}}$  shall be:

- (a) At its first meeting following the annual meeting of the Branch, to appoint the standing committees.
  - (b) To appoint special committees from time to time.
- (c) To fill all vacancies in Branch offices or on committees for the unexpired term.

The quorum of the Executive Committee shall be determined by the Branch but shall not be less than one-third of its total membership.

Section 2 The standing committees of the Branch shall be the Committee on Membership, Finance, Press Standing and Publicity, Legal Redress and Legislation, Committees Labor and Industry, Education, Entertainments, and Youth Council and Junior Work.

With the exception of the Committees on Membership, Labor and Industry, Education, and Entertainments,

which may be larger if desired by the Branch, these standing committees shall consist of not less than three members nor more than seven members.

The duties of the standing corrittees shall be:

(a) MEMBERSHIP. The Membership Committee shall work to increase the membership of the Association.

(b) FINANCE. The Finance Committee, which shall consist of the President, Treasurer, and at least one other member, shall have the duty of raising funds for the Branch for special, local and other purposes within the scope of the Branch program.

(c) PRESS AND PUBLICITY. The Press and Purlicity Committee shall endeavor to secure publicity in the local press for the work of the Branch and the Association. By personal visits and correspondence, it shall attempt to interest editors in local conditions affecting colored people and in the race question in general.

It shall watch carefully the publications of the community and report thereon to the appropriate committee.

The Press and Publicity Committee shall be responsible for ferwarding to THE CRISIS items covering Branch activities and important local affairs. It shall also act as far as possible as an agency for the promotion and sale of THE CRISIS.

No publicity shall be released by the Press and Publicity Committee without first being approved by the President of the Branch.

(d) LEGAL REDRESS AND LEGISLATION. The Legal Redress and Legislation Committee if possible shall be comprised largely of lawyers. It shall examine the state laws and local ordinances for possibilities of discrimination, work for better and equal enforcement of the laws, sponsor beneficial legislation, and work for the repeal of discriminatory laws.

It shall keep the Executive Committee of the Branch and the National Office promptly informed of all proposed legislation affecting colored people.

It shall investigate all cases reported to it for legal redress, consulting when necessary with the attorneys of the National Legal Committee, and shall watch over all litigation in which the Branch is interested. The Legal Redress and Legislation Committee shall not given general legal advice.

(e) LABOR AND INDUSTRY. The Committee on Labor and Industry shall seek ways and means of improving the status of colored people in labor, industry and agriculture.

(f) EDUCATION. The Committee on Education shall study local educational conditions affecting colored people. It shall aim to be a center of pupular education on the race question and the work of the National Association. It shall seek to stimulate attendance of colored youth in schools and shall visit the schools so as to keep informed of conditions

(g) ENTERTAINMENTS. The Committee on Entertainments shall have charge of entertainments of such kind as shall be approved by the Executive Committee.

and strive to correct abuses where found.

(h) YOUTH COUNCIL AND JUNIOR WORK. The Committee on Youth Council and Junior Work shall consisy of the Senior Branch Adviser to the Viser to the Youth Council, The Senior Branch Adviser to the Junior Youth Council, the Youth Council President, and the Junior Youth Council President. The membership of this Committee may be increased by the Branch Executive Committee to seven members.

The Committee on Youth Council and Junior Work shall be responsible to the Branch Executive Committee. Its duties shall be to develop the youth program of the Branch and to coordinate the programs of the senior and youth groups.

Section 3 Members of the Executive Committee and of the several standing committees shall hold office for one year and until their successors are elected and qualify.

Section 4 Non-functioning committees shall be promptly discharged by the Executive Committee and, where necessary, new appointments made by the Executive and Committee for the unexpired terms of unful-Removals filled purposes.

The position of any member of the Executive Committee or of any standing or special committee who shall be absent from three consecutive meetings of the committee, without notice or explanation to the committee, may be declared vacant by the Executive Committee.

Section 1 Any person may become a member of the Branch in accordance with the articles of incorporation and Membership the constitution and by-laws of the Association by paying annually in advance a fee of at least one dollar. Membership in the Branch shall include membership in the National Association.

Section 2 Any person paying an annual membership of two dollars and fifty cents or more shall be ontitled to receive THE CRISIS without further charge during the year.

Section 3 Members of the National Association in good standing where branches are being formed may Members-at-affiliate with the new Branch and be entitled Large to vote up n presenting satisfactory evidence of their membership. They shall not be assessed annual membership fees by the new Branch until the expiration of the annual membership for which they have paid,

Section 4 The Branch shall remit to the Treasurer of the National Association the National Office's Share of all membership fees, within fifteen days of their receipt, in the following proportions, and may retain the balance in its treasury for local purposes:

- (a) SENIOR MEMBERSHIP (for persons twenty-one years of age or over) \$1.00; To National Office, \$0.50; local treasury \$0.50.
- (b) YOUTH MEMBERSHIP (for persons under twenty-one years of age) \$0.50; To National Office \$0.25; local treasury \$0.25.
- (c) CRISIS METBERSHIP (includes one year's subscription to THE CRISIS) \$2.50; to National Office \$2.00; local treasury \$0.50.
- (d) BLUE CERTIFICATE MEMBERSHIP (includes THE CRISIS and literature) \$5.00; To National Office \$3.75; local treasury \$1.25.

(e) GOLD CERTIFICATE MEMBERSHIP (includes THE CRISIS and all literature) \$10.00; to National Office \$6.25; local treasury \$3.75.

- (f) LIFE MEMBERSHIP -- \$500.00 or more. Life Membership shall constitute an endowment for the national work of the Association and the full sum shall be forwarded to the National Office.
- Section 5 The Branch may retain for the local treasury ten (\$10.00) dollars out of every contribution.

  Contributions of twenty-five (\$25.00) dollars or more which it obtains. The balance of such contributions shall be forwarded to the Treasurer of the National Association.
- Section 6 Wherever the Branch comes within the jurisdiction of a state or regional conference, assessments

  State and on the Branch for support of the conference shall be paid into the National Office and transmitted by the National Office to the treasury of the state or regional conference, The amount of such assessments shall be determined by the state or regional conference with the approval of the National Board of Directors.

Section 7 The Branch may raise and retain funds for local purposes within the scope of the Association Other program, through entertainments and other special activities; but in all announcements regarding such entertainments and special activities, the specific local purpose for which the funds are to be used must be made clear and a full financial report shall be rendered to the Branch, the National Office, and the public.

The Branch may raise funds with the consent of the National Office in the name of the National Association for the Advancement of Colored People, for other than local purposes, through entertainments and special activities, in which case fifty per cent of the net proceeds shall be sent to the National Office and fifty per cent retained in the Branch treasury. A financial report of all such entertainments and activities shall be rendered to the Branch, the National Office, and the public.

Section 1 Regular meetings of the Branch shall be held at lease once a month, and such other public Meetings or special meetings as may be required.

Section 2 The Annual Meeting for the election of officers, Annual which may coincide with the regular meeting of the Branch, shall be held between November 1 and December 15, unless the time of the meeting is changed with the written approval of the National Office. \*

Section 3 Written notice of time and place of the Annual Meeting shall be sent by the Secretary coescin member of the Branch in good standing at least seven days prior to the date of the Annual Meeting.

Notice of the regular monthly or special meetings shall be sent to each member in good standing in writing, or published in same local periodical, except that notice of regular meetings need not be sent where definite dates and places of such meetings have been set by resolution of the Branch.

Special meetings may be called at any time and place on three days' written notice by direction of the President, or of any three members of the Meetings Executive Committee; or on failure of these to act, by any ten members of the Branch.

Special Committees meetings may be called by the chairman or by two members on two days written notice. All standing committees shall report each month to the Executive Committee at its regular meeting.

Section 2 The National Board of Directors may also declare any office of the Branch vacant and order a new electful and Unit is guilty of gross neglect of his offical duties, or of such conduct as would be inimical to the best interest of the National association for the Advancement of Colored People or of the Branch.

The charges against the officer must be preferred in writing and signed by the person or persons making the same, and forwarded to the National Office. Immediately on receipt of the same, the Secretary of the National Association shall forward a copy of the charges by registered mail to the officer at his last address on file in the National Office. No action shall be taken on the charges until fifteen days after the copy should have reached the officer by ordinary course of post. He shall be entitled within the fifteen days to file with the National Office his answer in writing to the charges. The National Board of Directors reserves the right to hear and act on the charges and defense on written statement, affidavit, or oral testimony as in its judgment justice may require.

Natice of the findings and action of the Board shall be sent to the officer by registered mail at his last address on file in the National Office and, in the direction of the Board of Directors, published in the official organ of the National Association. In the event the charges are sustained and the office declared vacant, upon receipt of natice to that effect by mail, publication or otherwise, the officer shall perform no official act and shall hold all records and monies of the Branch subject to the disposition of the National Office or his successor in office.

#### ARTICLE X.

SUSPENSION AND REVOCATION OF CHARTER

Section 1 The Charter of authority received by the Branch upon its admission to the National Association for Suspension The Advancement of Colored People, may be suspended, and or revoked by the Board of Directors of the Association whenever the Board shall deem it for the best interest of the Association. Such revocation shall not invalidate the membership of any member of the Branch in the National Association.

Section 2 Notice of the findings and action of the board shall be sent by the Secretary of the Association, by Notice of registered mail, to the President and Secretary of Suspension the Branch, and may be published in the official organ of the National Association. In case the Charter of the Branch is suspended or revoked, upon receipt of notice by the President or Secretary by mail, publication, or otherwise, the Branch shall cease to function and the officers shall forthwith forward all records, property and nonies of the Branch to the National Office where the same may be applied in its discretion for the benefit of the community wherein the Branch was located.

#### ARTICLE XI.

#### AMENDMENTS

With the written approval of the National Board Amendments of Directors previously obtained, this Constitution By-Laws may be amended at any meeting of the Branch: Provided that (1) notice in writing of the proposed amendment shall be given to all members at least seven days prior to the meeting at which the same is to be acted upon; or that (2) the proposed amendment shall be approved at two successive regular meetings of the Branch.

#### ARTICLE XII.

#### AUTHORIZED COMMITTEES

Groups of sevon or more individuals in communities authorized too small to maintain a branch of the Association Committees may be authorized by the Board of Directors to work as Authorized Committees of the National Association for the Advancement of Colored People, carrying out its purposes and objects and raising funds for its support as does a Franch, subject to such rules and regulations as the National Board of Directors may enact.



On Thesday night, Jely 14, 1942, at an open mass meeting, ROT WHKIN, Assistant Secretary, N.A.A.C.P., New York, New York, gave the keynote address of the convention to some 4,000 assembled delegates and spectators. He stated that the N.A.A.C.P. would continue their fight against segregation and discrimination against the negroes and for equal rights of the Negroes with white people. He siad that "We are determined forever to be through with status quo". He further stated "This is no war — this is a social revolution. Nations and societies are being shattered and remolded almost overnight. I say to you that the reason why this association was born in 1909 and has lived 33 years — the reason why I am here and you are here — is because we are determined forever and a day to be through with the status quo. Are we worms to sit in a corner and say we yearn not for green pastures? We are impelled to oppose the status quo by the imperatives of the situation. If you are in a crack you must get out."

has been such unity of thought and such clearness as to the path we have to follow. It is not such luxuries as freedom of speech, but the control over his own body, the right to walk around and not be strung up to a tree, that concerns the negroes at this time and that gave rise to the association."

WILKINS further stated, "Some say we should let things go during the war period so there will be no disunity, in other words remain in a status quo. That we will not do because to make people free is why the war is being fought. No one can call us subversive if we refuse to remain in a status quo position."

A list of objectives outlined included: No segregation in the armed services; war jobs open to all; no bias against negroes in labor unions; removal of "the insulting and unscientific rule of the segregating of blood of negroes and white donors by the Red Cross in plasma banks" abolition of "Jim Crow" rules in voting, jury service, employment, edication, and housing.

At a mass meeting CHARLOTTA A. BASS, negress, editor of the California Eagle, leading Los Angeles negro weekly newspaper, addressed the assemblage in a stirring talk which followed the Communist Party line. It will be noted that in the July 16, 1942, issue of the California Eagle, an editorial by CH RIOTTA A. BASS describes her position regarding the Communist Party as follows:

This newspaper once Telt that no good could come from the infiltration of Communism in the American political scene. The changing of our views on this matter is reflected also in the change of policy of the great state of California and follows logically in the development of true national unity around the victory for the anti-Fascist world.

The "Los Angeles Sentinel" had the following to say regarding CH/RIOTTA A. BASS' speech:

She called for an ismediate opening of the second front, and delivered a scathing attack upon A. PHILIP RANDOLPH and his program for fighting "Jim Crow" segregation and discrimination in all phases of American life; she put across a rather different type of thought than was the general expression of the meeting.

The complete text of CHARLOTTA A. BASS' talk appears in the "California Eagle" issue of July 23, 1942, which is being retained in the subject file.

The July 23, 1942, issue of the "California Eagle" carries an article in which the resolutions adopted by the conference were discussed. The resolutions are as follows: A Pacific charter was urged, the capital march on Washington movement re-endorsed, the poll tax struck, a New Dies Committee asked, and a national youth executive committee of ten members demanded.

A resolution endorsing the immediate establishment of a second front in Europe was tabled, two recounts being necessary on the tabling motion.

The same paper carried an article concerning the youth parley of the N.A.A.C.P. and the resolutions and program endorsed by the Youth Conference are as follows: Resolution to set up a ten-man national youth executive committee; a firm and determined stand for the observance of the democratic rights of all people, campaign for a mixed volunteer unit in the army through cooperation in progressive white organizations and trade unions (many of which circulated petitions to that effect at the convention), and a resolution calling for the establishment of the second front. One of the prominent speakers at the youth convention was REVELSICATON. Negro, state vice-president of the C.I.O.



"The Los Angeles Sentinel", Negro newspaper, issue of July 23, 1962, shows a photograph of LAURINCE BAQUET, who stood up in the convention and objected rather loudly to A. PHILIPS RANDOLPH'S talk upon the Communist program for the negroes at this time of crisis, quoting BAQUET as follows: "I am a Communist at heart and anyone who says that the Communists have not helped the negro is all wrong".

One of the highlights of the convention was the presentation of the Spingarn medal, an award made annually for the highest achievement of an American negro, which was presented to A. PHILIPS RANDOLPH, International President of the Brotherhood of Sleeping Car Porters. This presentation was made because RANDOLPH was instrumental in securing the issuance of July 25, 1941, by the President of the United States of Executive Order banning discrimination because of race, breed, or color in national defense industries or Federal Government. RANDOLPH led a capital march of Eashington movement which was discussed at length during the convention. The issue of the "California Eagle", dated July 23, 1942, states that a local march on Washington committee has been planned.

Another highlight of the convention was a talk by WENDELL WILLKIE, who rapped race bias as importalism and who made a strong appeal to win the war.



The following article appears in the January 29, 1943 issue of "Current History" entitled Twenty Years of Negro Progress" by HERBERT J. SELLGMAN, Director of Publicity, NAACP:

"At the end of May 1909 the National Negro Congress was begun, among the conspicuous abservees being BOOKER T. WASHINGTON. At that conference race relations were discussed in the plan formed in the Cooper Union, New York, with a frankness and directness of statement that have since become familiar. Among the speakers were the late Professor JOHN SPENCER BASSETT, Professor FERRAND of Columbia University, Judge STAFFORD, and JENKIN LLOYL JONES. it was decided at that conference to form a permanent committee and to hold other conferences. Out of this beginning grew the National Association for the Advancement of Colored People, organized as permanent body in 1910, having for its President MOORFIELD STOREY of Boston, former President of the American Bar Association, whose activity and interest in the field of race relationshas dated back to his services as Secretary to Senator CHARLES SUMNER in the person of Dr. DU BOIS. The Niagara Movement and that new organization were merged. Dr. DU BOIS came from Atlanta to New York to assume the duty of Director of Research and ' \_ of the editor of the 'Crises' magazine which first \_\_\_eared in November of 1910."

According to an article appearing in the "Light" magazine on February 26, 1927, WILLIAM FICKENS, Field Representative of the NAACP toured Russia and wrote articles concerning his experiences there. The following article appeared in the Seattle enterprise on February 4, 1927 with a New York date line of February 3, 1927:

"Also have Jews been received by the NAACP, 69 Fifth Avenue from WILLIAM FICKENS, Field Secretary of the NAACP who has visited Russia on his European lecture tour.

"Among the Russian leaders Mr. PICKENS has conferred with are KALININ, sisters of Trotsky and Lenin, and prominent editors. He reports that the 'Fire in the Flint' by WALTER WHITE and 'Bursting Bonds' and 'The Vengeance of the Gods' by Mr. PICKENS himself are to be translated into Russian and perhaps put on the stage as well



as made into motion pictures. '

Mr. PICKENS has written a comprehensive article on lynching during the past forty years, details the campaign conducted over these peak forty years against this evil in America by the NAACP. This article is to be published in newspapers in Moscow, Berlin, and Paris whereas Mr. PICKENS has always written for hussian magazines on the American race problems."

The following information was obtained in "The Fourth National Convention" official report of Workers (Communist) Party of America held in Chicago, Illinois on America 21 to 30, 1925:

"In the NAACP, the negro bourgeoisie together with the middle class white reformists and under the partial leadership of the bourgeoisie (such as represented by Senator BURTON, Chairman last Republican National Convention) find the chief medium for its reformist operations. Yet it is a paradox and a reflection of the now passing period of the patronizing of the negro cause by the capitalist class, that this organization at its last convention, appeared in the role of championing, though in a timid and "respectable" way, negro worker's right to admittance in the trade unions.

In this organization, under present circumstances, it is permissable and necessary for selected Communists (not Party membership as a whole) to enter its conventions and to make proposals calculated to enlighten the negro masses under its influence as to the nature and necessity of the class strugg? In the identity of their exploiters and their leaders in the same persons and the treacherous nature of the reformist measures proposed.

However, it is only when the Communist work is so broadened and extended in the field of negro movements as to make our Party stand out as the only real champion of the negro against lynching, all discriminating and all oppression and exploitation that we can successfully combat the influence of such pourgeois movements.

The aim of our Party and our work among the negro masses is to create a powerful proletarian movement which will fight and lead the struggle of the negro race against exploitation and oppression in every form and which will be a militant part of the revolutionary movement of the whole American working class, to strengthen the American revolutionary movement by bringing it to the 11,500,00 negro workers and farmers in the United States, to broaden the struggles of the American negro workers and farmers, connect them with the struggles of the national minorities and colonial peoples of the world and thereby further the cause of the world revolution and the dictatorship of the proletariate. (adopted unanimously)."

"The NAACP was organized in 1909 upon a call written by OSWALD GARRISON VILLARD, signed by 54 persons including MARY WHITE OFINETON, W. E. B. QUIDOIS, BISHOP ALEXENDED THE CHARLES EDWARD RUSSELL, JOHN HAYNES ACCIMES, JOHN E FILHOLIAND, FRANCIS J. GRIMKE, RABBI STEPPEN S. WISE, and others.

In 1927 it had grown from this small committee to a nation-wide organization with branches in 'forty-four states and the District of Columbia with a gross expenditure of \$78,834.27 in 1927. Primary objectives on the organization are to fight against segregation, disfranchisement of colored voters in the south, lynching, to rullify anti-inter-marriage laws, segregation and other laws directed against social equality of negros with whites.

Official organ of the group is the "Crisis" edited by W. E. B. DU BOIS.

The following information was obtained from the book "The Red Network" written by Educate Filling, Communists William Z. FOSTER, BENJAMIN CETLOW, SCOP ARRING, ELIZABETH GURLEY ALYNN, ROBERT W. DUNN, and their fellow Director NORMAN FROMAS with generous appropriations of \$31,552, 1925-1928, \$7,365, 1923-1924, and \$5,000, 1929-1930 to the NAACP."

The official report of the Communist Party for the National Convention stated that the Party had penetrated the NAACP.

The "Chicago Lifender" in its issue of February 13, 1943, contained the information that the Chicago Branch of the NAACP will hold its third annual All-Chicago Victory Tea at the Paykway Ballroom on March 14, 1943. Serving as chairman is MRS. ETHEL BARRESON who will be assisted by Mrs. EFFIE R. FOSTER, and MRS. JEAN TO CRAY. The program outlined by the President, OSCAR C. AROWN, included a definite advancement into the Field of Transportation to obtain employment for colored workers as motormen, conductors, bus drivers, ticket sellers, or for any occupation in that industry.

It is also noted that WALTER WHITE, Executive Secretary of the NAACP has a regular column appearing in the "Chicago Defender" entitled "People and Places."

January 16, 1941 was National Defense Protest Day for persons of the colored race. The Chicago Branch of the the NAACP held its meeting at the Good Shepherd Congregational Church, 5700 Prairie Avenue. The chief complaint seems to be that the Army and Navy are not permitting negroes to obtain positions of importance; negroes are excluded from jobs in certain plants holding defense contracts. It was stated that the trouble is due to the Unions' refusal to permit negroes to membership.

### AD MASHIMODON, D. C.

On June 1, 1842, the Washington Bureau of the National Association for the Myancarent of Colored People was established at 100 Massachusetts Livenae, N. W., Washington, D. C. The establishment of the Washington Dureau was considered as the national association's most important new venture and its duties were as follows:

- (1) To mainthin a constant watch over all Congressional bills and resolutions affecting the welfare of the negroes;
- (2) To examine the policies of the Federal Departments and Agencies handling the armed services, employment, housing, etc;
- . (3) To prepare memoranda briefs to supply t good legistation or to oppose bad legislation;
  - (4) To inform the country on such measures; and
- (5) To coopera e with other organizations interested in the same or similar objectives.

TAYSON. WILLIAM ASSISTED is Dean of the Howard University Law School and was formerly civilian-aide to Secretary of Mar SILLSUM. Prior to his service in that capacity, he acted as a Federal Court Judge in the Virgin Islands.

The head of the legal staff is THURSON (LARSHALL, whose legal defense work in behalf of the NAACP corried him to all sections of the country during 1940. The national legal committee consists of 29 lawyers, white and colored, in 18 cities. The executive secretary of the national organization is MALTHA CHIED and the assistant secretary is RCY WIMMUS, who is also editor of "The Crisis", the official organ of the NAACP since 1910.

A chronological resume of the diversified activities of the Washington Bureau of the NAACP since its inception, are set forth as follows:

## Decomber, 1949;

The NAACP renewed the fight against the poll tex at the fall opening of the 73th Congress. The stand taken by the association was the abolition of the poll text in eight Southern states.

## <u>Irmury, 1945:</u>

The association directed Secretary of Mar SIII.SUL's attention to discrimination against negroes in armed forces.

#### Tebrunge, 1945;

Judge WILLIAM R. HASTIE, chairman of the adio committee of the local branch of the HAMP was appointed as the key worker in the 1940 no bership drive of the local branch. It is to be noted that on January 51, 1943, HASTIE resigned his position as civilian aid to the Secretary of War in protest against the unfair treatment of the negroes by the armed forces as alleged by him.

### <u> Merch, 1945:</u>

Local MACP requests larger representation of coloured people on public agencies. A resolution expressing opposition to the proposed

establishment of a second all colored fire department station house was unanimously adopted. .

## April, 1940;

Civic Rights Committee sponsored by the Hounrd University chapter of the TAAOP began an intensive campaign to urge passage of the BARDOUR-TOWN Ignal Rights Law for the District of Columbia. In line with this compaign, Howard University students picketed several local restaurants as a result of their refusal to serve colored persons.

## July, 1948:

The District of Columbia branch of the MAACP inaugurated a series of membership meetings simed at the organization of NIAOP clubs in Mashington schools, churches, and other institutions. There was continued pressure on Congressien for passage of the pending Civil . Rights Bill for the District of Columbia.

## Aurast, 1948:

The District branch of the MAACP viewed the opening of the Hearthstone Mar Morkers Club at 1703 - 11th Street, M. W. as a major defeat for Democracy in that it extended the pattern of segregation.

## January, 1944:

WALTER HIM of the WAAOP asserted that the increased efforts by Communists to sprend their doctrines chor; the cobred people should serve as a varning to the Derocratic and Republican parties who have been "using the negro as a political football". He pointed out that recently schools in New York, Chicago, and Loc Augel's had come under Communist control.

AIDRIG OSS was elected vice-president of the MAACP Youth Council in Vaskington, D. C. and BHATRICE HOLLONGH was elected assistant secretary. Intition, Youth Council President, named committee members who were to deal with problems facing the council and community.

AUGUSTA LOLDET, Vice-President; CAFFIRE LALY, Secretary; GLORIA TUSTER, Assistant Secretary; BLAUDYD TLLS, Treasurer; AUDRING HOSS, Reporter; and JOSEPP. DOLFD, Chairman of the Civil Rights Committee.

Four major objectives for the year were decided upon by the NAACP Youth Council as follows:

- (1) Demand by negro governmental clientele of respect and equal opportunities on the job;
- (2) Education of negro business men in respect demanded of and given to his customers;
- (3) Promote wholesome recreational activities for war workers and service people; and
- (4) Support logislation feworing the Civil Liberties Bill for the District of Columbia.

ENGRY DESCRIPTION of the 1944 Helbership Campaign of the Lychington HAACP. He was formerly administrator of the New Hegro Alliance and was then employed as assistant director of field operations of the Fair Employment Practices Committee.

## February, 1944:

It was asserted that the annual membership drive by the MAACP was offering Mashington tendhers an opportunity to help thousands of tenchers in the South and through them thousands of students.

#### <u>May, 1944:</u>

It was announced by Reverend ARIMUR D. MAY, president of the District of Columbia branch of the NAACP that the armual no bership compain which started on Pebracry 10, 1944, hid reached an enrollment of CO75, with contributions and membership fees totaling \$11,915.70 Dr. CRAY stated that the NAACP which is a bi-racial organization had enrolled more white

persons in 1944 than in any previous year. The membership goal was to secure 10,000 members in Mashington, D. C. in 1944.

Howard University students identified with the Civil Rights Committee of the Howard University chapter of the MAACP, picketed Thompson's Restaurant at 1109 Pennsylvania Avenue, N. W., in protest against a refusal of the restaurant to save regroes. Spokesnen for the group contended that they had no special grievance against that particular restaurant nor the Thompson firm, but that the protest was instituted because there are very few downtown restaurants in Washington, D. C. where regroes are allowed to eat.

THURGOOD LARSHALL, Special Counsel, and WILLIAM H. HASTIE, Chairman of the Mational Legal Committee of the MANOP, declared that all MANOP branches in the South had been advised to file complaints with United States Attorneys where negroes were barred from voting in the primaries.

It had been rumored that Dr. NCEDICAT CONTINUES. president of Howard University, and ordered the Civil Right's Committee, the student's branch of the NAIOP, distanced at the University because it would open the University to attack by reactionary Congressmen in whose lands Howard University's appropriations reat from year to year. However, the national negro press association reported that Dr. JOHNSON had expressed a sympathetic attitude for what the students had been endeavoring to accomplish with some success but he felt that the same results could be achieved without the students making use of the University's name in their operations.

## June, 1964:

Deverond ARTHER D. GRAY as president of the Mashington Eurecu of the MANOP, was succeeded in that capacity by MILLIA HAYRASHE, Dean of thouard University Law School. It was expected that as a result of the new leadership of IRLIMINA, MASHE the local group would become more militant in character. It was noted that the District of Columbia chapter of the organization had given its full support to the program started by the Howard University branch of the MAAOP in picketing restaurants in the downtown area demanding interracial service. It was understood that the majority of the Howard University faculty approved of the ideas expressed by the group but opposed the activity on the ground that it might bring the University is to disrepute among members of Congress. Reverend CRAY he igned his position as president in order to accept a pastorate in Chicago.

## - July 1944:

The MAACP pointed out that the Fair Employment Practices Committee fund was a very small part of the total amount that Congress voted this year for the war and operation of the covernment and the NAACP vigorously urged the Senate Appropriations Committee to vote favorably on the Fair Employment Practices Committee item in the National War Agencies appropriation bill for 1945.

of the HAACP, assumed such capacity to succeed LESLICIANY who was transferred to the New York office of the association to occupy a similar position. A graduate of Hampton Institute, Nr. REMICEDS did college work in New York University before studying theology at Eden Theological Seminary in Oberlin. He entered the United States Army Chaplain Corpor two years ago and served three consecutive terms as president of the Cleveland MAACP branch.

In a letter to Mr. PAUL V. McMUTT, Director of Mar Manpower of Commission, the discriminatory practices of the USES were assailed by the Washington Bureau of the MADP. The letter demanded that McMUTT order all of his field officers to cease requiring negro job seehers to use separate entrances or to be interviewed in segregated quarters or to fill requisitions of employers who seek workers by racial description.

## Au-ust, 1944:

EARL J. AMEDED, MAAOP Youth Council Delegate to the MAAOP war time conference in Chicago, stated that the Bist of Columbia groups resolution proposing the establishment of a national planning and advisory committee of local MAAOP Youth Councils, had been adopted by the war time conference. The resolution calls for a Youth Council Planning and Advisory Committee that would be composed of representatives of the local youth groups in college chapters.

## September, 1944:

The executive board of the NAACP decided to set up a permonent housing committee as a result of the public attention focused on the critical colored housing shortage in Mashington, D. C. The personnel of the consistee were to be chosen at the October meeting of the board

The Washington Branch of the MACP was one of the sponsors of

a mass meeting staged on September 4, 1944, at the Blood Donors Center, Acadia Emilding, 51 Louisiana Avenue, F. W., Washington, D. C. to protest the segregation of white and negro blood plasma. This was a peaceful meeting which, after about one hour, was disbursed by the Metropolitan Police but use the group had not obtained a license from the District for such demonstration. WILLIAM H. HASTID was the leader of this demonstration and in the October issue of "The Crisis", he assailed the deplorable spectacle of the use of the combined authority of the District of Columbia police and the Federal authority through the national park police in preventing a meeting which was particularly inspired for the purpose of increasing interest in blood donations for the armed services.

## October, 1944:

The NA40P, the ANA Mon-Partisan Council, and a group of prominent New York citizens were among those who protested to the president the anticipated plan of the Army for the est blishment of separate re-distribution stations for white and colored overseas veterans returning to the States. The negro press chried statements to the effect that Major General SOURDWILL was being blomed for the decision of segregation by the Army.

MALTIR UNITE, Executive Secretary of the MACP, revealed that in the near future he intended to go to India. This amnouncement came after a conference in which he and two other negroes participated with the President.

THURSCOD MARSHALL, Special MAACP Counsel, arrived by plane in San Francisco, California to assist in the civilian defense of the 20 negro sailors charged with nutiny for refusal to load around tion at the Lare Island Depot on August 9, 1944.

The Standard Gil Company, part of whose building in Mashington, D. C. is leased to governmen' amencies including the Lair Employment Practices Committee, was being unged to end discrimination in the canteen operated in the building by a private lessee who allegedly had refused to serve colored people or whites seen with them and the MAACP has exhibited an interest in the elimination of this discrimination.

FROM NOTE of Soldiers Home Hospital, and in that letter 1837II protested discrimination through segregation of negro veterans.

Accompanied by representatives of the Madington Lurenu of the NAACP, J. LECOMEN, one of the citizens of Mew Iberia, Louisiana who were

 allegedly beaten and driven from their houds on May 16, 1944, had two lengthy conversations with VICOUR M. RODELL, Chief of the divid Rights Section at the Department of Justice, in which it was urged that the Department begin immediate prosecution of white terrorists in New Ibgria.

Letters protesting the dismissal of Mrs. LIMITATE AM, white distician in charge of the 11 colored people from the Statler Hotel were sent to S. L. O. WAY. President of the American Civil Liberties Union, Mational Laurens Guild, Workers Defense League, and others. The local MACP requesting that the letters be sent following dismissal of Mrs. BERMAN carly in America for eating with the colored group, has demanded that Mrs. EMELAN be reinstated.

It was ennounced that GRAYT REMICEDS for two years a chaplain in the United States Army, and nore recently an administrative assistant in the Washington Eurequ of the NAACP, had resigned his post in order to participate more actively in the work of the Mon-Parties: Council for the Abolition of Discrimination in Military and Veteran Affairs. In his letter of resignation, he charged that the government continuously indicates its unvillingness to protect colored veterans and soldiers against humiliation, abuse, and outright mob violence.

Discriminatory practices by the proprietor of a restaurant and canteen in the building housing offices of the Fair Hylogment Practices Committee and other Federal arencies were vigorously notested during the last week of October, 1944, by the HAMP in a letter of the Standard Gil Company, owner of the premises at DEL Constitution Avenue, H. M. The NAADP urges that all patrons and interested citizens mail in protests now against the renewal of a lease to a tenant occupying said purmises participating in such un-American gractices.

The NAADP has issued a statement praising the recently aurounced policy of the Many to educt neare women into the NAVIS and empressed the hope that the neare NAVIS will be integrated into emisting units matter than into Jim Orow Units.

Addressing a meeting of the Americans United for Norld Imparisation in the State Department during the Intter with of Colorer, 1941, Dr. U. E. T. 13. Director of the MalDis Barcan of Receivable declared that the landerton Color Conference on the future would peace arounisation depressed him as a result of its passing over the ratter of colonies in its deliterations. Other regrees attending the meeting in the State Department were VILLIA. H. HASTIE of the MALOP, and has a large LETATIE President of the Mational Council of Vegro Women. In reference to the meeting, Nr. HASTIE observed that in inviting negro groups to participate, a shall and wholesome beginning had been undertoward recognition.

WILLIAN H. HASTIE denied the report that he had resigned from the National Citizens Political Action Committee.

Under the auspices of the District of Columbia branch of the MAACP and cooperating organizations, a mass meeting was held in Washington, D. C. on October 22, 1994, to unge support for the passage of a permanent Pair Employment Practices Committee act by Congress. There were several speakers at this meeting, all of whom unged the advisability of one necessity for such legislation. The meeting was attended by approximately 700 people and about 90% of those present were negroes. This constituted the most recent activity of the Mashington Eureau of the MAACP with a broad scope.

Inasmuch as investigation has not disclosed any activity on the part of this organization which is subversive in nature, this case is being closed subject to being respend after consideration of future activity of the organization.

The NAACP was born when MARY WHITE OVINGTON, its first member, met with WILLIAM LNGLISH WALLING, a columnist, during the first week of January, 1909, in a small room of a New York apartment.

The first conference was held on the evening of May 30, 1909, at Cooper Union, New York City. Over 1000 guests were invited and the initial conference was considered a success.

It was not until the second conference held in May, 1910, that the group organized a permanent body to be known as the National Association for the Advancement of Colored reople. Its first officers were listed as follows:

## Stated Aims and Objectives

A review of the Certificate of Incorporation at the Hall of Records, New York County, Clerk's Office, on May 11, 1954, revealed that the NAACP filed its Certificate for Incorporation under the New York State membership Corporation Laws on June 19, 1911.

The principal objects for which the Corporation was formed are:

To promote equality of rights and eradicate caste-or race prejudice among the citizens of the United States.

To advance the interest of colored citizens.

To secure for them impartial sufferage.

To increase their opportunities for securing justice in the courts, education for their children, employment according to their ability, and complete equality before the law.

To ascertain and publish all facts bearing upon these subjects and to take any lawful action



thereon; together with any and all mings which may lawfully be done by a membership corporation organized under the laws of the State of New York for the further advancement of these objects.

To take, receive, hold, convey, mortgage or assign all such real estate and personal property as may be necessary for the purposes of the corporation.

The territory in which the operations of the corporation are principally to be conducted, shall be the United States of America.

The principal office of the corporation and the center of its operations shall be in the city, Gounty, and State of New York; but the directors may establish branch or auxiliary offices elsewhere in the United States for the purpose of carrying on the work of the corporation, each to be managed by its local organization under such powers as lawfully may be prescribed in the by-laws of the corporation.





The November, 1953 issue of "Political Affairs" contained an article entitled "The NAACP Convention" by



one HUGH BRADLEY. The article is an extract from the report on Negro Work delivered at a National Conference of the CP.

ELIZABETH GURLEY FLYNN, testifying in the case "U.S. vs. ELIZABETH GURLEY FLYNN, et al", on October 20, 1952, stated that "Political Affairs" has been the theoretical organ of the CP since the publication's beginning in 1945.

The article pays tribute to the NACP as the most important Negro organization dedicated to the fight for Negro equality.

In the past, states the article, the NAACP has witnessed a consistent and steady growth in the influence not only among the Negro people, but in the labor movement and among other progressive strata of Americans. It is increasingly becoming a coordinating center for all major organizations among the Negro people and the pivot for the furtherance of the Negro-Labor Alliance. The NAACP has over 200,000 members, reflecting all classes among Negroes and representing the struggle towards unity of the Negro people. At the same time, it typifies the continued dominance of Negro life by the Negro petty bourgoisie.

According to the articlo, these factors were strongly revealed at the 44th National Convention of the NAACP held in St. Louis, Misscuri, in June of 1953. The convention was held against the background of a new political situation in the country, following closely upon the advent of the Eisenhower Administration. It convened at a time when the hope for peace was rising in the hearts of humanity everywhere, but when, at the same time, the pro-Fascist offensive of the Mc Carthyites had already marked menacing proportions, and when the reign of terror against the Negro people continued unabated. Manifestly, the Negro people were looking to this convention for clear leadership on the vital issues facing them, and expected a call for united and militant action in their behalf.





The convention lived up to this expectation by adopting a general progressive program on such questions as compulsory FEPC, housing, and an end to Jim Crow in education and in the railroad industry. The delegates associated themselves with the growing movement against Mc Carthyism, calling an end to the book-burning, taking a forthright stand in defense of academic freedom, and demanding a revision of the Mc Carran - Walter Immigration Act, as well as revision of the Loyalty Program. A positive stand was taken in defense of the labor movement; there was a call for Labor-Negro collaboration and the branches and their members were urged to work with the unions in their community.

In arguing persuasively for greater Negro-Labor cooperation, a resolution was adopted at the convention which pointed out:

"Organized labor is an important pioneer center in American life today. The support and cooperation of the American Labor Movement for the Civil Rights Program of the NAACP is extremely important and in certain situations perhaps even decisive. We urge our branches and state conferences whenever possible to seek the support of responsible trade unions for measures that we favor and in turn give our support to such measures supported by organized labor as are consistent with our policy and program."

The program on Foreign Policy adopted by the convention also showed an advance. While still weak in several respects, it represents an important departure from that of the 43rd Convention. In contrast to the almost 100% endorsement of the Truman Foreign Policy a year ago, this convention refused to give such blanket support to the Dulles-Eisenhower conduct of foreign affairs.

The 44th Convention urged the planning and execution of a Civil Rights mobilization in Washington, D.C., and voted to welcome "in the mobilization, the cooperation and support of bona fide organizations genuinally at one with us on our stated objective".



another important feature was the militant participation of the youth and the overwhelming support given to the Youth Program by the adult delegates. The convention launched a program to rid America of Jim Crow and to win the total integration of Negroes by 1963, the 100th anniversary of the issuance of the America of Proclamation.

The article revealed that there were serious weaknesses which evolved from the 44th Convention deliberations. Certain negative and harmful resolutions were adopted which run counter to the progressive and positive ones, and which can only be harmful to the Negro movement.

The article criticized the closing address to the Convention delivered by Mr. WALTER WHITE, Executive Secretary of the NAACP. The address was characterized throughout by a fawning attitude which called for complete confidence in and support for the Eisenhower Administration, an administration whose policies are generating further anti Negro measures in the country. WHITE stated that EISENHOWER is an unwilling prisoner of his own cabinet, his party and Congress, and, if the President has failed to do more on the Negro question, it is because he "has been so absorbed with war and foreign problems."

In addition to surrendering to the Eisenhower Administration on the Negro question, WALTER WHITE'S address included an orgy of Red-baiting and anti-Communist slander that is rare even for these times. According to the author, WHITE falsely proclaimed that war and Communism are the two factors which plague the modern world. WHITE stated, "We don't want the Communists running our affairs."

In addition, the article depicted that at no time did the convention approve of Mr. WHITE'S pro-Eisenhower speech, and it was the opinion of many observers that a majority of the delegates were definitely opposed to the Eisenhower Administration. The address by



WHITE was additionally characterized as "the major weakness and most negative feature of the 44th Convention of the NAACP". The capitulation by the top leadership to the Eisenhower Administration and the orgy of Red-baiting never before was equalled in any Negro gathering.

The author furnishes an explanation for the inconsistent and contradictory policy adopted by the convention - a policy which calls at the same time for struggle and surrender, for anti-Mc Carthyism and Red-baiting, for support to the National Independence Movement of Africans and Condemnation of Mau Mau "Violence". The answer is found in the composition of the convention and its leadership, made up of the Negro middle class and petty bourgoisie.

The article concludes by stating that the Negro workers in the main were absent; progressives and Communists, in the main, were absent. Therefore, the reformist leadership of WALTER WHITE was not basically challenged and he maintained an iron-fist control over every aspect of the deliberations. The negative features of the convention constituted a prime example of the vacillating role being played today by the Negro petty bourgoisic and of the continuing subordination of the Negro workers to the bourgoisie in the Negro Liberation Movement.

The programs adopted by the NAMCP and other major Negro organizations reflect the striving for unity on the part of the Negro people. The fight for jobs and FEPC, Negro representation and right-to-vote movement in the South are indicative of unification.

The February, 1954 edition of "Political Affairs" carried an article entitled "On The Slogan Free By '63" by ABNET W. BERRY.

The "Daily Worker" issue of March 7, 1952, page 2, column 5, reported that ABNER W. BERRY is a Negro affairs editor of the "Daily Worker".

It is to be noted the "Daily Worker" is an East Coast Communist daily newspaper.
