AT PONCA CITY:

Agents secured the address of Walter Collins who sold booze to Anna Brown on several occasions, agents were requested by Agent Frank Smith to secure the address of Walter Collins as he was a material witness. Walter Collins address is as follows: Ponca City, Oklahoma, Route 6, Box 85, Osage County, Oklahoma. Route 6 is handled out of Ponca City, Oklahoma. Mr. Kirby, Postmaster at Ponca City, Okla. advised us that Box 85 on Route 6 is in Osage County and that Walter Collins's home could be reached by going south on route 6 and inquire from O'Neil Bros., who conduct a grocery and filling station, just exact location of Walter Collins's home. Walter Collins's wife is named Ethel Collins.

AT KAW CITY:

Agents visited Kaw City and postmaster interviewed as to the whereabouts of Ralph Skenet, a witness in the case. Sept. 7th being a holiday and the clerk having the keys to the post office, the postmaster stated that he would check up the record on this party and forward same to Box 513 Guthrie, Okla., agents furnishing Post Master this address. Agents Parker, Wren and Davis will continue their under cover investigation and as facts develop a report will be forwarded. Pending. As you requested we are sending you a report covering our movements since we have been detailed on this case. we are sorry to state that this is all we have to report so far, we are doing everything in our power to locate witnesses, which Agent Frank Smith gave us a list of."

NOTES OF SPECIAL AGENT IN CHARGE T. B. WHITE.

Agents furnishing information herewith are especially assigned to investigation of Osage Murders and are operating in Osage County and vicinity under cover, ostensibly to obtain general information of interest to investigation, but incidentally to locate material witnesses, whose present whereabouts are questionable, so that service can be had on them for their presence before an anticipated Grand Jury and to familiarize themselves with the location of witnesses and defendants, who they will keep under surveillance until such time as their presence are required by the Government.

Dear Sir:

I am just in receipt of your letter of September 15th requesting advice as to when the four additional agents in the Osage Indian Murder Cases could be released from this assignment, and I am herewith replying to the same immediately.

Will say that when I requested these four additional agents for this assignment, August 5th, I fully expected the Federal Grand Jury to convene in Guthrie, Oklahoma on September 7th to hear this case and expected to have for presentation to the Grand Jury from fifty to one hundred witnesses. I anticipated that after the Grand Jury had duly considered the case that they would have returned indictments against at least twenty-five of the very worst criminals in Oklahoma. Circumstances, however, have brought about the postponement of the session of the Grand Jury at Guthrie until perhaps November 1st.

My plans at the time of making the request for these additional agents was to have three of them, who were especially fitted, Agents E. H. Parker, Charlie Davis, and John K. Wren, proceed to the Osage country and there work under-cover and ascertain especially the present addresses of the witnesses for the Government. Also, to meet and know personally all of the defendants in this case and ascertain any other information possible in an under-cover manner pertaining to this case; thus enabling us to know where to find the witnesses and at the proper time assist in the apprehension of those guilty of these crimes.

The other agent, F. G. Grimes, Jr., I wanted to assist Agent J. V. Murphy in preparing a record of this case so that a birds-eye view could be obtained as to the facts thus far developed, in order that it could be intelligently presented for prosecution.

Since having these four additional agents on these cases, they have made good progress. The three agents assigned under-

cover to obtain the addresses of witnesses and the names of the defendants have been of a great deal of benefit in the case. At the present time one of them, Agent John K. Wren, is on the premises of William K. Hale, the principal in all of these murder cases and I expect some results from Agent Wren's investigation. The other two agents in this under-cover work have also secured not only the addresses of witnesses but have succeeded in obtaining bits of information that are important in the case, and have made one report to you, while another is now being prepared setting forth the information they have obtained.

Agent Grimes has been able, together with the assistance of Agent Murphy, to have almost completed the preparation of the information already obtained in this case. As soon as it has been prepared, I am going to send you a copy of the same.

Now as to the releasing of these agents, I would like to keep the three that are doing the under-cover work, Agents Parker, Davis, and Wren, at least ten days longer on this case, for I am interested to see what developments grow out of their plan as above described. I believe that I can be able to release Agent Grimes at any time, for the record is now in such shape that I think Agent Murphy can handle it and be able to revise it as progress is made in the case.

In the event that Agents Parker, Davis, and Wren are released, I would like to get them back a short time before the convening of the Grand Jury that hears these cases. Our present plans are that shortly before the Grand Jury meets to file a complaint against all of the defendants implicated in these crimes and to place them under arrest and have them in custody during the time that the Grand Jury hears these cases. We will thus be serving two purposes; first, to be sure that they are under arrest, and next to prevent them from interfering in the presentation of their cases to the Grand Jury and to put confidence in the witnesses who testify for the Government that there is really going to be something done. This case has been carried on so long without prosecution that in reality few people believe that there is really going to be any prosecution had.

I might say in this connection that we are making good progress in the case and it will be interesting for you to know that we expect in a short time to secure a detailed statement from "Blackie" Thompson, who is now confined in the Oklahoma State Penitentiary for bank robbery and murder. We are told that he will have interesting information to give, as I am informed that he was a participant in one of the murders.

SYNOPSIS OF FACTS: INFORMATION OBTAINED BY CONFIDENTIAL INFORMANT, [REDACTED] **BTD**

Statement from E. C. Snyder involving one Copperfield in murder of Chas. Whitcomb; involving Alva McDonald in interfering with progress of Osage investigations, and fraudulently obtaining money from principles involved. Concerning Bill Hale in Osage murders; information from one Lon Williams involving U. S. Marshal, McDonald in interfering with Osage investigations; concerning Bill Hale, Al Spencer and Dick Gregg conspiring to kill Bill Smith; John Tillman, closely allied with Bill Hale and McDonald, admission of Tillman of having seen Government reports in Osage investigations. Information from E. J. McDurdy advancing theories concerning suspected murder of Bill Hays. Frank Mays quoting information he obtained from "Slats" Welch, connecting Kelsie Morrison with securing of nitro-glycerine to blow up Smith's house; registering in hotel to prove alibi; of "Slats" meeting Blackie Thompson, Dick Gregg and others and conversation concerning moneys due them by Bill Hale for murdering Smith family. Information from Cornet promising to co-operate with Government; of conspiracy by Hale et al to murder Henry Roan and others and promising to furnish name of witness, who was approached by persons hired to murder Indians and his assistance requested. Information received by Cornet concerning moneys paid Tillman and McDonald to strangle investigation of Osage murder cases. Cornet being approached by Kelsie Morrison and Morrison telling him of his murdering of Osage Indian, Billy Stetson, of marrying his widow and disposing of widow's estate to Bill Hale. Interview with one Flanery, information obtained relative to conversation between Flanery and Kelsie Morrison and Morrison's close alliance with Bill Hale. Interview with H. O. Brown, former Deputy U. S. Marshal, concerning details of Morrison, signing of Morrison's bond by Hale and of Morrison stating that he had it on Hale. Strictly confidential information, informant's name in possession of Bureau, involving Claude Parker in Osage murders with Bill Hale and others, and concerning meeting of Bill Hale, Al Spencer and Dick Gregg and others conspiring to murder W. E. (Bill) Smith. Promise of informant to co-operate with Government.

DETAILS:

I am submitting herewith results of my investigation covering period of my assignment as a confidential informant in the investigation of Osage Murder Cases.

AT PAWNEE, OKLA.

On September 5, in a confidential manner, I obtained from one E. C. (Ed) Snyder, the following information.

CONCERNING MURDER OF CHARLES WHITEHORN.STATEMENT FROM E. C. SNYDER.

That he, Snyder, was at one time Guardian for one Lewis Riddle, a half breed Osage Indian. That shortly after the murder of Charles Whitehorn, Lewis Riddle, his wife, and his, Riddle's half sister, Anna Riddle, a girl then about sixteen years of age, came to his, Snyder's house, and stated that they wanted some advice, and related the following story: "That Anna Riddle had given birth to a child and an ^{Indian} named Copperfield was the father" (Snyder did not recall whether it was Louis Copperfield or David Copperfield, but states he will determine which one it was in the near future); that they wanted to have the child enrolled as an Osage, and their plan was to force the parents of Copperfield to help them, stating that the brother of the child's father was the man who had killed Charles Whitehorn; that on the night of the killing an old Indian woman came to the place where Anna Riddle was living and told her she had better go up on the hill and get Copperfield and take care of him; that Anna Riddle started up the hill and met Copperfield who was very drunk and bloody; she asked him what was the trouble; that Copperfield told her that he had had a fight with Whitehorn and had shot him twice; that she returned with Copperfield to where he was staying, washed him up, and stayed with him until about 2 o'clock in the morning; that during this time Copperfield told her in detail just how he killed Whitehorn; that she then left Copperfield and went to her home; that the next morning Copperfield came to her house and asked her what he had told her concerning the Whitehorn murder; that she told him he had told her all; that he then cautioned her never to tell anybody.

Snyder then stated that he took Riddle, his wife, and Anna Riddle to a lawyer's office where they entered into a contract by which if they got the child on the Osage roll, that Snyder was to get part of the money that would come to the child; that they then took the contract to Anna Riddle's guardian, who refused to approve it. Snyder then dropped the matter, and had no further interest in it. Snyder stated that the Copperfield who was alleged to have been the father of the child, and the child, are both dead; that the Copperfield whom Anna Riddle alleged was the murderer of Whitehorn is alive and lives near Hominy, as does also Anna Riddle, who is now married. Snyder stated that he will go with a Government man to Anna Riddle and have her tell them the same story regarding the Whitehorn murder that she told him.

E. C. Snyder is a friend of Bill Hale, one of the principals in the Osage murders; he stated that Hale came to him in April, 1925, and stated that he expected to be arrested at any time in connection with the murder of some Indians, and Hale engaged Snyder's services to handle some of his business affairs in the event of his arrest; that Hale told him that Alva McDonald had sent a man to him, Hale, wanting \$8000.00 promising to fix things up for Hale in these murder cases; that Hale had sent McDonald word to go to hell; that Hale had his bondsmen and attorneys employed, and was ready in event of arrest.

CONCERNING MURDER OF W.E. (BILL) SMITH AND WIFE.

AT PAWUSKA OKLA.

On September 7, in a confidential manner, I obtained from one Lon Williams the following information: Williams stated that Alva McDonald had been in Pawhuska for two or three days previous, and had talked to him about the Osage cases, and had phoned the Tribal Attorney for the Osages and held quite a conversation; that he, Williams, understood from McDonald's conversation and other rumors, that McDonald was there trying to make some money out of the Osage murders; Williams stated further that he had heard from good authorities that at one time Bill Hale had arranged a meeting with Al Spencer and Dick Gregg and tried to get them to blow up W. E. Smith and his family, and that he had heard that Dick had either made an affidavit or would make an affidavit to that effect.

In a confidential manner, on September 7, at Pawhuska I obtained the following information from one E. C. (Clint) Hargis, an attorney: Mr. Hargis stated that it had come to him through different clients of his that one Claude Parker, Burley Johnson, Ace Kirby and Dick Gregg were the men who blew up the W. E. Smith home, and that Ace Kirby was the man who actually touched off the explosive; that he, Hargis, had heard of Alva McDonald's operations in trying to "shake down" various people in connection with the Osage murder cases. Hargis stated that he knew it to be a fact that there was a meeting between Bill Hale, Al Spencer and Dick Gregg at which time Hale propositioned them to blow up Smith's home, and that Al Spencer refused to participate in the murders. Hargis has lived in Pawhuska a long time, and has quite a clientele among the crooks of Osage County.

AT PAWUSKA OKLA.

On September 8, in a discreet and confidential manner, I talked with one John Tillman, member of the firm of Tillman & Tillman, attorneys, of Pawhuska, who is supposed to be a close friend of Bill Hale. Tillman asked me what McDonald was trying to do over there; that he, Tillman, had heard that McDonald was trying to make some money out of the Osage murder cases; Tillman stated that he had received a phone call from Oklahoma City that day to the effect that Blackie Thompson was to be released from the State Penitentiary at McAlester, and wanted to know if there was any truth in it;

Tillman stated "If the authorities would get hold of a man named Savage and one Bryan Griffin and put them in jail, that they would tell who killed Whitehorn". Tillman claimed to know nothing about any of the other Osage murders. Tillman stated that he had seen part of the reports made by the Bureau of Investigation's investigators in the Osage murder cases, and had an opportunity to see more of them but that he did not think the reports amounted to much.

AT PAWHUSKA OKLA.

On September 9, in a confidential and discreet manner, I talked with one K. J. McCurdy, of Pawhuska, and he gave me a long detailed history concerning the death of one Bill Vaughn, an attorney who was supposed to have been murdered and thrown from a Pullman car leaving Oklahoma City. I gained from my conversation with Mr. McCurdy that it is his impression that Bill Vaughn was in possession of material facts concerning Osage Indian murders, and that Vaughn had stated to McCurdy that he, Vaughn, had sufficient evidence to put Bill Hale in the electric chair; and that Vaughn had been to Oklahoma City and had obtained additional information concerning these murders, and was returning to Pawhuska, and was either murdered and thrown from a moving train, or was thrown alive from a train, which resulted in his death; that he, McCurdy, has a witness who will swear that shortly after the disappearance of Vaughn from the Pullman car that he examined the berth assigned to Vaughn, and which Vaughn was supposed to have occupied, and that it showed that no one had disturbed it in any manner. Mr. McCurdy related numerous other details to me, which may be of interest in the investigation.

AT PAWHUSKA OKLA.

On September 10, I interviewed Frank Mays, who in 1923 was a deputy sheriff of Osage County, but since is closely allied with the criminal element of that vicinity, to such an extent that he bears a questionable reputation, however, he impressed me as telling the truth. Mays stated to me that some time after the murder of W. E. Smith et al he arrested one "Slats" Welch, a notorious car thief; that on account of his fair treatment to Welch, Welch became confidential, and stated to him that Kelsie Morrison obtained the nitro-glycerine used to blow up Smith's house, at Red Rock, Okla., and to prove an alibi of his participation in this murder, put a man on the train, and sent him to Oklahoma City, and had this man register as Kelsie Morrison in some hotel in Oklahoma City, on the same night that Smith's house was blown up. Mays stated that another time "Slats" Welch told him that he was present at a place where Blackie Thompson, Dick Gregg and others were in hiding; that they all became intoxicated; that the conversation drifted to the murder of W. E. Smith; that Thompson, Gregg and others in this conversation stated that Bill Hale still owed them a balance for doing "that job", meaning the blowing up of Bill Smith's house, and discussed how they were going to collect this money from Hale.

AT ANADARKO OKLA.

During the period September 14 to 18 I gained the confidence of Henry

Cornett, confined in the County Jail, charged with bank robbery, and obtained from him the following information: Cornett stated to me that if he was released out of jail that he could furnish information that would clean up the Henry Roan murder case within ten days; that he knew parties in the Osage who knew all of the details concerning this murder and that he could make them tell the truth and would gladly assist the government in cleaning up these cases. He stated that a friend of his overheard a conversation in the Kingkade Hotel in Oklahoma City between Bill Hale and other parties in which they were plotting to kill Henry Roan and have the murder committed on his, Henry Cornett's, ranch in the Osage; that he could and would produce this man and make him tell the truth of what he had heard; that he, Cornett, could produce a man at Ponca City who could testify that parties who had been hired to kill some of the Osages came to him to get his services in pointing out some of the ones that they were to kill; that this man came to him, Cornett, at the time and asked his advice, and that he advised him not to have anything to do with it. Cornett stated that Bill Vaughn, who was murdered, told him that Bill Hale gave John Tillman, an attorney, \$5000. to block investigations of Osage murder cases, and that Tillman gave Alva McDonald, then U. S. Marshal, \$2500. of this money for his assistance in blocking the investigations. Cornett further stated that there were two or three men in the State Penitentiary at McAlester, who are in possession of all of the facts concerning some of the Osage murders, and that he, Cornett, is in a position to cause these men to divulge this information to the Government. Cornett stated that he was with one Kelsie Morrison on a drinking spree, and that Kelsie Morrison asked him, Cornett, why he didn't get him an Osage squaw and bump her off for her wealth like he, Morrison, did, then detailed how he, Morrison, had bumped off one Billy Stetson, the husband of an Osage woman, by giving him denatured alcohol, and how he, Morrison, later married Stetson's widow, who didn't live very long after their marriage, and how Morrison obtained her estate, and how Morrison later married another Osage woman named Catherine Cole, and that he, Morrison, disposed of the estate of Stetson's widow, to Bill Hale.

Cornett stated that he now has some bank robbery cases pending against him in the state courts, that he expects to defeat these cases, and until they are disposed of, he cannot afford to have it known that he is in any manner assisting the Government, but that just as soon as they are disposed of he will furnish me with all the details of information in his possession, and will locate and bring in all the witnesses who have information regarding these cases to me and cause them to make statements and testify to the true facts, promising me upon his word of honor to fulfill these promises. I am convinced that Cornett will do as he has stated, providing nothing occurs to interrupt.

AT ANADARKO OKLA.

On September 18, in a confidential and discreet manner, I talked with one Flannery, who lives in Ponca City, and who was in Anadarko assisting Henry Cornett in his cases. Flannery stated to me that on one occasion he met Kelsie Morrison in Tulsa, Okla., where both were drinking, and that Morrison in a conversation, stated to him that he had enough on Bill Hale to put him in the electric chair; that Bill Hale had to sign his bonds for any amount that he might want.

AT PAWUSKA OKLA.

On or about Sept. 10, in conversation with H. O. Brown, former Deputy U. S. Marshal under Alva McDonald at Pawuska, Brown stated to me that he arrested Kelsie Morrison some time last spring; that after the arrest Kelsie Morrison requested Brown to phone Bill Hale and tell him to come and sign his bond; that he, Brown, did not ring Hale, but asked another party to do so; that in a short time Bill Hale came, hunted him up, stating that he wanted to sign Morrison's bond, and did sign Morrison's bond for \$5000.00; that he, Brown, in a conversation with Kelsie Morrison later, remarked to Morrison 'you must have something on Hale that you can cause him to come to you when you call for him'; that Morrison replied that 'you bet I have, I can make Hale sign a \$100,000. bond for me, when I call for him he has got to come' or words to that effect.

AT PAWUSKA OKLA.

On September 21, I obtained from a confidential source, the name of which informant I would prefer not to disclose in this report, the following information; This informant stated to me that one Claude Parker knows all the details concerning the murder of W. E. Smith and family; that one occasion Bill Hale called Parker to Pawuska, and accompanied him in an automobile to Ponca City, where, Hale, Claude Parker, and two other men, whose names this informant did not divulge, discussed and planned blowing up the home of Bill Smith at Fairfax; that this informant is well acquainted with the two men whose names he did not mention; that they did not participate in the actual murder of Smith, but are in possession of all the details of the murder, and the planning of it, and that he can and will furnish me the names of these parties as soon as he is convinced that the Government really means to prosecute these cases. This informant states that there are numerous persons to his knowledge that have information concerning the Osage murder cases which they will divulge when they are convinced that the Government really means to prosecute these cases. Informant further stated that he also knows the names of parties who accompanied Bill Hale and were present when he met Al Spencer and Dick Gregg, and propositioned them to murder W. E. Smith and family. This informant states that for him to divulge this information at this time, and especially prior to his knowing positively that the Government is going into the cases, would place him in a rather delicate position; that should it leak out it would place him in a dangerous position, and would hurt his business; that he desires very much to help the Government in these matters, and stands ready, whenever the Government can convince him that it means business, and are actually going to proceed with these cases, to give the Government all the information in his possession.

The information that has already been obtained in the investigation of this case leads agent to believe that the facts set forth in this report of the information obtained by this informant is good information. The leads given will be immediately followed out and pursued vigorously and all information obtained will be included in a report to follow.

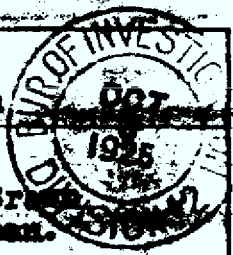

JOINT REPORT OF AGENTS JOHN WREN,
CHAS. R. DAVIS AND E. H. PARKER.

Summary of information obtained by these Agents giving names of confidential informants and results expected from their cooperation; anticipated information of the present whereabouts of material witnesses; and present addresses of numerous witnesses to be used before Grand Jury investigation.

DETAILS:

The following is a report of the activities of the above named Agents during the period September 9 to 16, 1925, at Pawhuska, Fairfax, Hominy, Grayhorse, Ralston and Skiatook, Okla.

Mr. R. H. Franks, who conducts the White Star Cafe at Fairfax, and who is willing to assist the Government provided his name is not divulged, furnished Agents the following information: that one TOM EASTMAN, a drug addict and dope peddler now residing at Bixby, Okla., lived at Fairfax at the time Anna Brown was murdered and when the county authorities were investigating Bryan Burkhart and Ernest Burkhart; that EASTMAN would gather with the crowds and get the feelings of the people and keep the two Burkhart boys and Bill Hale posted on every move made by the authorities, and that he acted as a spy for Bill Hale, advising him of the general talk and feeling of the people toward himself and the Burkhart boys, of any newspaper articles pertaining to the case, and of the arrival of Federal officers. Mr. Franks further stated

that at that time EASTMAN lived with a woman by the name of Lucile Boyce or Boyer who conducted a rooming house at Fairfax; that this woman was now conducting a rooming house at Bixby, Okla., under the name of Lucile Brown, and that EASTMAN was supposed to be living there with her.

Mr. Franks informed Agents that "Shorty" Morgan (a material witness in this case, and the person who sold liquor to Bryan Burkhardt and Anna Brown on the night Anna Brown was murdered) was released from jail about two months ago and returned to Fairfax; that on his arrival in Fairfax he learned he was wanted by the Federal authorities, and left, and is now somewhere in Florida. Mr. Franks stated that he did not know Morgan's present address, but would obtain it and furnish it to these Agents.

Mr. Franks also stated that he would try to obtain the addresses of Jim Boswell and Charlie Boswell, both of whom are material witnesses in this case.

Agents located Little John, or John Little, or John Star, in the Fairfax Jail, where he is being detained on account of being a dope addict. This man is an Osage Indian, and his correct name is John Little Star. Agents were advised by Agent Burger that this man is not wanted; that the witness wanted is a carpenter named Little Steve, or Steve Little. Mr. Franks will endeavor to locate Little Steve, or Steve Little, and furnish Agents his address, and any other information regarding this case he can obtain.

While in Fairfax, Agent Davis met Rev. A. E. Tuck, pastor of the Methodist Church, at his home. Agent Davis disclosed his identity and informed Rev. Tuck that he would like for him to assist in securing further evidence in regard to this case. Agent Davis found Rev. Tuck to be a true and fearless Christian gentleman and willing to assist the Government in any way, in bringing about the apprehension of the guilty parties. Rev. Tuck furnished the following information: That living in the home of Ernest Burkhardt, are Mr. and Mrs. W. G. Betts, who are members of Rev. Tuck's church, and good Christians; that Betts told him that he, Betts, had talked to Bill Hale on several occasions and told him he would get into serious trouble if he didn't cut out his crookedness; that he, Tuck, often visits the Betts in the Burkhardt home, and that no doubt Betts could give the Government some valuable information if properly interviewed by an Agent of this Department who is not working under cover. Rev. Tuck also stated that he had discussed this case with Mr. F. P. Glass, one of the members of his church, and proprietor of the G. & G. Store at

Fairfax, and found him willing to assist the Government in any manner possible; that Mr. Glass did not know anything about these murders except from hearsay, but might be able to furnish some information as to the whereabouts of missing witnesses if properly interviewed by an Agent of this Department who is not working under cover. Rev. Tuck requested that his name be kept strictly confidential, and stated that he would furnish any additional information he might obtain.

The following witnesses were located:

Mrs. Allie Richards is teaching in the public schools at Fairhuska, Okla.

Mandy Claremore, Mary Blackbird and Mamie Fletcher are at Fairfax, Okla.

Mary Starr is living near Hominy, Okla.

Roy Bunch (who married the widow of Henry Roan) is living with his wife on a farm near Fairfax. He was recently released from jail after serving a sentence on a bootlegging charge. Agents were informed that he has quit bootlegging and settled down since Snake Thompson, Prohibition Agent, has established his headquarters at Fairfax. Rev. Tuck informed Agent Davis that Snake Thompson is a member of his church and is an honest, fearless, Christian man, and can be trusted, and no doubt will be willing to assist Agents of this Department if called upon; that he is arresting bootleggers every day, and sooner or later will arrest some witnesses in this case, as it appears that most of them are bootleggers and law violators. Agents understand that Mr. Thompson wants "Shorty" Morgan, mentioned above in this report, on a bootlegging charge.

George James (who was with the Anna Brown party on the night Anna Brown was murdered) is a gambler, drives a red Buick touring car, and still lives in Fairfax.

Joe McGuire, who formerly lived at Ralston, has left Ralston and his present whereabouts are unknown. Mrs. Bob McSpadden, who runs the McSpadden Cafe at Ralston, informed Agents that McGuire and his wife and two children used to board with her; that McGuire and his wife had separated; that Mrs. McGuire had remarried and was living in Fairfax, but that she did not know the name of her present husband; and that McGuire took his oldest boy with him when he left Ralston.

Max Billings (who with Al Spencer and others met Bill Hale in his pasture, where Hale offered money to have W. E. Smith's house blown up) has a general merchandise store at Okesa, Okla., in partnership with a man named Wright. They are going to move this stock of merchandise to Tulsa, Okla., where Wright will run the business. Billings is guardian for two or three Osage Indian minors who own several farms in the vicinity of Okesa, and he will remain there managing these farms.

At Fairfax Agent Wren met A. W. Adams of El Paso, Texas, whom Agent Wren has known for a number of years, and who is a partner of Ed Timberlake, also of El Paso. They are pasturing some 2600 head of steers in Bill Hale's pasture. Agent Wren had a confidential talk with Mr. Adams, and was informed by him that he had had a number of steers stolen recently; that two cars of steers had been held up by the commission merchants at Kansas City, and among them were found some of his steers; that investigation showed that these steers were loaded on a train at Hominy, Okla.; that three men had been arrested for the theft of these cattle; and one of them had confessed that they had been stealing cattle since last April. Agents were unable to secure the names of the three men who were arrested. Agent Wren is now at Fairfax, and will be associated with Mr. Adams, going to the pasture with him and assisting him in checking up his stock, which will put Agent Wren in a position to meet Hale and the Burkhardt boys and the rest of the men working on the Hale ranch where Adams and Timberlake have cattle pastured.

Dr. D. A. Shoun, one of the physicians who examined the bodies of Anna Brown and Henry Roan, and who treated W. E. Smith before his death, has moved from Fairfax, Okla., to Denver, Colo., but is now at Fairfax visiting his brother, Dr. J. G. Shoun. Agents were unable to obtain Dr. D. A. Shoun's street address in Denver.

Dear Sir:

Re: Osage Indian Murder Cases.

Information has been coming to me from informants that I have working on the above case, as well as from agents working on the case, to the effect that former United States Marshal Alva McDonald has busied himself considerably in the above case, endeavoring, so I understand, to defraud those implicated in these murders out of money. Information comes to me from our confidential informant on this case, as reports that have been forwarded to you in the last few days will show, that McDonald made the proposition to William K. Hale, the principal figure in these murders that if Hale would give him \$25,000.00, he would "beat" these cases. Further, I have information that he has seen some of our witnesses and has been endeavoring to talk to them about the case. All of this information, together with other activities in this case charged to him, leads me to make the statement that it is my opinion that he is the man responsible for the disappearance of our file on this case from the United States attorney's office here.

With this information to you, I will say that it is my understanding that Mr. McDonald is preparing to go to Washington in the interests of this case and will eventually call at your office or the Interior Department; that he is, according to my understanding, going to pass the information he has to those that he has occasion to see there and to make a proposition to get charge of the case. I am certain that all that he is after is aid in his attempt to extort money out of those that are known to be guilty of the Indian murders. Knowing him to be very clever in his proposals, I am passing this information to you, as I thought that you would probably desire to have his movements covered while at Washington and get to the bottom of his activities there. I am

keeping him covered here and I am of the belief that before this matter is over with that he will be connected with it in some manner, although the information that we have now has come to us "second-handed". I am following up all the leads vigorously and will report results.


