Can testify that on February 6, 1923, he received word that an automobile was standing at the side of the road about three miles northwest of Fairfax in the direction of Burbank; that he suspected it was a whiskey car, and, in company with Jim Rhoades, went out to investigate; that they found the car standing about two hundred yards from the back road between Fairfax and Burbank, in a rocky swale, down which a dim trail ran; that the car was Henry Roan's touring car, had all the curtains up, and was pointing North and a little east; that Henry Roan's dead body was lying on the front seat, with a bullet hole through the head, that the bullet showed to have entered just back of the left ear, and emerged just over the right eye, breaking the windshield glass; that this broken glass was strewn for about twenty feet back along the car tracks and some pieces were still lying on the hood of the car; that Roan was lying on the front seat with his foot just off the pedals and his head, with his cap under it, resting on the right edge of the seat; that the position of the body plainly indicated that Roan had been driving when shot from the left rear; that the back curtain was shattered partly at the

She stated to Agents Weiss and Burger that a short time before her husband disappeared, and later found shot, Bill Hale came to their home at a child-time when she, her husband, and children were all ready to go to the country for dinner, and called her husband out and talked with him for some time, and her husband then told her to go ahead to dinner, that he was going with Bill Hale; that she went on to dinner in the country and returned late that day, and found her husband home drunk and he told her about Hale taking him to some bootlegger who had an old Dodge car with booze in it; that her husband told her this bootlegger had said he wanted to meet her, and her husband prevailed upon her to make the trip to see said bootlegger, but she never made the trip with him, and never met the bootlegger.

This witness, while an Agent for the Mutual Life Ins. Co., during the early part of 1921, made application for insurance to his company on the life of Henry Roan, in favor of W. K. Hale, in the sum of \$25,000, which was rejected.

Hale is alleged to have stated to H. W. Lake that he approached McLean to write a policy on Roan's life for \$25,000 payable to Hale as creditor; that McLean demurred on the ground that it was necessary for Roan to actually owe Hale before he could get the policy; that after discussion, McLean filled out a note with pen and ink for \$25,000 and gave it to Hale for him to obtain Roan's signature; that when the signed note was shown to McLean, that McLean wrote an application on Roan's life in favor of Hale, this application being later rejected.

E. F. Hall stated to H. W. Lake that this witness, McLean, remarked to him, Hall, that he drew up a note showing an indebtedness to a man, so that he could write a policy on this Indian, in favor of the man, for \$25,000; that after Henry Roan was murdered, McLean told Hall that Roan was that Indian.

Co., on a similar application made by Hale, due to Roan's physical unfitness. This witness admitted to H. K. Hale that Bill Hale had paid the premiums in cash when due on this policy to him, Reynolds.

Hale; that Hale then sued on the policy, which suit is now pending; that Hale claimed, as the basis for his insurable interest in Henry Roan's life, that Roan owed Hale, at Roan's death, on an open, unsecured account, undenied and unwitnessed, approximately the sum of \$25,000.; that Hale's deposition avers that at one time Hale sold and delivered to Henry Roan one hundred head of cattle at \$130. per head; that no writing of any kind was made or signed to evidence this deal, and no one was present to witness either the delivery or the agreement. Said Life Insurance Co. made an exhaustive investigation into this, and can furnish names of doctors at Fairfax who represented the company at that time, and show that Hale took Roan to Pawnee to other doctors to get the examination of Roan by, and that the regular doctors for the company would have certainly shown the true facts regarding Roan's physical condition, aside attempts, domestic trouble, etc.,

This witness, as attorney, is representing W. K. "Bill" Hale in Hale's suit against the Capital Life Insurance Company to recover a \$25,000 policy payable to Hale on the life of Henry Roan. H. W. Lake alleges that this witness displayed to him, Lake, a note purported to have been made by Roan in favor of Hale, covering an alleged indebtedness of \$25,000, which note Hale used as a basis for securing from the Capital Life Insurance Company a \$25,000 life insurance policy on Roan. This note, Lake alleges, was written on typewriter. Grinstead also stated to Lake that Hale had told him, Grinstead, that on a previous occasion he tried to get insurance on Roan in the Mutual Life Insurance Co., and that company's Agent drew up a note in the sum of \$25,000 for Roan to sign, to be used as a basis for securing the insurance; that Roan was rejected, and that he, Hale, destroyed this note. Lake also alleges that John McLean, Agent for the Mutual Life Insurance Co., told him, Lake, that he, McLean, had drawn up the note with pen and ink. It is alleged by Mr. Lake that this witness, Grinstead, stated to him that he did not believe Roan ever owed Hale any such amount of money, and that the whole transaction appeared irregular to him, but as Hale had given him the policy, he believed him, and gave him the note, and proved the same to the jury.

Cornett states that on account of criminal cases pending against him by the State, that it would do him untold harm should the Hale influences, prior to the termination of his cases, find that he was divulging information to the Government, but promised that he would at the opportune time, present a witness referred to and cause him to divulge the truth to the Government.

Cornett was residing in Osage County and was closely associated with all known suspects at the time of the murders, and should be in position to ascertain and divulge information of material value.
