Miss Buck had promised Campos to intervene in his behalf with persons in high positions as was necessary to secure his release.

On 10/10/44, Miss Buck, along with a group of Americans, organized the National Committee for the Independence of Puerto Rico in NYC. The group met sporadically and discussed the problems of Puerto Rico's urge for independence.
