WHAT YOU SEE. GM's latest ads brag about the company's "commitment to safety" and tout its "family" of test dummies.

CRUSHING BLOWS

No law requires cars to be tested for safety using animals, but GM continues to smash the skulls and break the necks of ferrets and pigs with pneumatic impactors like the ones used on baboons at the notorious University of Pennsylvania head injury laboratory exposed by animal rights activists in 1984. In fact, James Lighthall, the man who kills ferrets in GM's laboratory in Warren, Mich., cites Penn experimenter Thomas Gennarelli five times in his 13-page paper "Controlled Cortical Impact: A New Experimental Brain Injury Model." But even Gennarelli, in his own paper based on data from humans who died of brain injury, said of Lighthall's experiments with ferrets: "this type of damage is not the same as that seen in . . . man."

In a typical, current GM impact test on pigs, these intelligent, sensitive animals are restrained and hung in a cloth sling to await a crushing blow to the

stomach or chest from a pneumatically driven metal disk. In 1981, GM killed pigs who survived the test by electrocution, a crude and often painful procedure.

GM has operated a testing facility in Warren, Mich., since 1956. In the last decade the company has inflicted head, chest, and abdominal injuries on hundreds of monkeys, dogs, and rabbits, as well as pigs and ferrets. In 1988, 29 dogs were fed ethyl alcohol, had their chests and pericardiums cut open, and were hit directly on the exposed heart with an air-pressurized impactor. Pound seizure is legal in Michigan; these dogs may have been former companion animals.

GM AND AIR BAGS

GM Vice President Robert A. Frosch tells PETA: "Be assured, we believe that biomedical research should only be conducted when human lives may be saved or human suffering relieved." If the alleviation of suffering and death is important to GM, why hasn't the company installed air bags as standard equipment in its cars and trucks? University of Virginia School of Medicine researchers have concluded that, "if provided as standard equipment on both the driver and the passenger side, air bags could do
