



The following investigation was conducted by SA at Pittsburgh, Pa.:



Surveillances conducted in the vicinity of the Crystal Barber Shop, 1605 Centre Ave., on July 10, 1964, and July 22, 1964, disclosed no activity of interest to this investigation.

On July 13, 1964,

advised that the records of the Bureau of Motor Vehicles, Harrisburg, Pa., reflect that 1964 Pennsylvania license number 0C6396 is issued for a Gadillac coupe, the property of ROBERTO CLEMENTE, whose address is listed as Forbes Field Baseball Club, Pittsburgh 13, Pa.

ROBERTO CLEMENTE is a nationally known baseball player, and is presently playing as a right fielder for the Pittsburgh Pirates Baseball Team. Forbes Field, Pittsburgh, in the National League.

An item appeared in the "Pittsburgh Post-Gazette," a daily Pittsburgh newspaper, on July 11, 1964, reflecting that the mother, sister, and fiancee of ROBERTO CLEMENTE were visiting in Pittsburgh over the weekend.



further advised that ROBERTO CLEMENTE is currently in Puerto Rico.

On 11/7/72, the facts of this case were discussed with AUSA JAY WALDMAN at Pittsburgh, Pa. Mr. WALDMAN advised that inasmuch as the date of the threat against the life of ROBERTO CLEMENTE was passed, and since there were no follow up threats nor any clue as to possible suspects, the matter did not merit further investigation.

An eight-cent U. S. postage stamp, which came from a coil of stamps, is attached to Q1.


