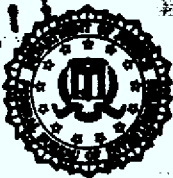

### I BACKGROUND

Roy Wilkins was born August 30, 1901 at St. Louis, Missouri. He is a Negro male, resides at 147-15 Village Road, Jamaica 35, New York, and is employed as Executive Secretary of the National Association for the Advancement of Colored People (N.A.A.C.P.), 20 West 40th Street, New York 18, New York, and is Editor of "The Crisis", official organ of the N.A.A.C.P.

### II SUBVERSIVE INFORMATION

The April 25, 1933 edition of the "Daily Worker", page 1, column 8, contained an article captioned "N.A.A.C.P. Crowd Line Up For Scottsboro Boys". This article reflected that Roy Wilkins, Assistant National Secretary of the N.A.A.C.P. attended a meeting of the N.A.A.C.P. and introduced one Frank Spector, Assistant National Secretary of the International Labor Defense, to that meeting.

The "Daily Worker" was an east coast Communist newspaper which suspended publication on January 13, 1958.

The International Labor Defense has been designated pursuant to Executive Order 10450.

Page 2 of the January 11, 1937 edition of the "Daily Worker" carried an article entitled "Call Anti-War Parley Hearing for Jan. 29". This article reflected that one Roy Wilkins, not further identified, was listed as a sponsor of the Fourth Annual New York City Conference Against War and Fascism. This article reflected that the conference was held under the auspices of the New York City Division of the American League Against War and Fascism.

The American League Against War and Fascism has been designated pursuant to Executive Order 10450.

On January 23, 1944, G-2, United States Army, made available information that Roy Wilkins, Editor of "The Crisis", a monthly magazine of the N.A.A.C.P., was one of the principal speakers at the Wartime Inter-Group Unity Conference held January 24, 1944, at the International Workers Order (IWO) Fraternal Clubhouse, New York City.

The IWO has been designated pursuant to Executive Order 10450.

Column 2, page 12 of the December 24, 1944 edition of the "Daily Worker" contained an article captioned "Back IWO Drive for Negro Members". This article reflected that 13 Negro and White leaders in the fields of education, art, letters religion and labor had endorsed the IWO campaign to enroll 6000 Negro Americans into its fraternal ranks by May 31, 1945. Among the names of leaders listed was Roy Wilkins, Editor of "The Crisis."

The June 11, 1944 edition of the "Daily Worker", page 7, Magazine Section, contained an article captioned "A Day With Councilman Davis". This article referred to the daily activities of New York Councilman Benjamin J. Davis, Jr. and stated that a letter from Roy Wilkins, Acting Secretary of the N.A.A.C.P. had been received by Davis. According to this article, Wilkins thanked Davis for offering his services as a lawyer in the fight in Georgia to enforce the Supreme Court's "white supremacy opinion".

Column 1, page 6, of the July 2, 1950, edition of "The Worker", an east coast Communist newspaper, contained an article captioned "N.A.A.C.P. Leaders Dumped Rights of Negroes". This article stated that it had been said that the 41st Annual N.A.A.C.P. Conference concluded the previous Sunday in Boston was the "best organized public gathering run by the United States State Department since the 1949, CIO anti-Communist bee in Cleveland...".

"Roy Wilkins, N.A.A.C.P., Administrator, was the main front man for the State Department's disastrous anti-Negro policies". The article went on to further abuse Wilkins for the manner in which he conducted the convention.

b7D [REDACTED] advised that Roy Wilkins was the National Executive Secretary of the N.A.A.C.P. It was this source's belief that Wilkins would not knowingly be used by the Communists; that Wilkins had fought Communism for many years and that he was then openly anti-Communist.

b7D [REDACTED] furnished information that a letter was sent by Roy Wilkins, Executive Secretary, N.A.A.C.P. to local branches of the N.A.A.C.P. According to the information furnished by this source, Wilkins was also Chairman of a Leadership Conference on Civil Rights, a group of 51 national organizations which was sponsoring a National Delegate Assembly for Civil Rights in Washington, D.C., March 4-6, 1956. According to this source, Wilkins stated that if the scheduled assembly were captured by left-wing!

individuals it would get very little attention from Congress. He further warned local N.A.A.C.P. branches to be very careful in selecting individuals to the nationwide conference in Washington, inasmuch as left-wingers were making a special effort to be selected as delegates by local branches of the N.A.A.C.P. Wilkins stated that the N.A.A.C.P. policy was not to cooperate with any Communist front or left-wing groups.

[REDACTED] advised that a regional conference of the N.A.A.C.P. held during the weekend of April 6, 1957, at Philadelphia, Pennsylvania, Roy Wilkins, National Secretary of the N.A.A.C.P. made an announcement regarding the march on Washington which was to be held in May, 1957. Wilkins stated that all delegates to this "pilgrimage" had to be closely screened in order that all "leftists" be definitely omitted. According to this source, Wilkins indicated he was aware of the potential propaganda medium this affair would afford to "leftists" if they were permitted to participate therein.

[REDACTED] advised that at the March on Washington held May 17, 1957, Roy Wilkins was one of the speakers at the Lincoln Memorial, Washington, D.C. According to this source, Wilkins stated that the CP was an evil force, that it attempted to use the N.A.A.C.P. as a front for CP activities and that the CP can only mean poverty, economic strain and slavery.

The "Daily Worker" issue of September 24, 1937, page 6, reflected one Roy H. Wilkins as a sponsor of a joint meeting of the American League Against War and Fascism and the American Friends of the Chinese People.

A characterization of the American Friends of the Chinese People appears in the Appendix attached hereto.

The "Daily Worker" issue of February 7, 1939, page 5, reflected one Roy Wilkins was a sponsor at the Workers Alliance Convention.

The Workers Alliance (since 1936) has been designated pursuant to Executive Order 10450.

as having said that the N.A.A.C.P. was on record against  
Communist infiltration and activity and would not support  
in any manner an effort to split the CIA--by communists  
especially--or look with favor or encourage in any way the  
setting up of separate Negro labor organizations.

APPENDIX

THE PHYSICIANS FORUM, INCORPORATED

Records in the office of the Clerk of New York State Supreme Court, Foley Square, New York, reflect that The Physicians' Forum, Inc. (PF) was issued a Certificate of Incorporation on April 27, 1944, under the laws of the State of New York, to operate as a non-profit, membership organization principally in the United States. The PF, under the name of the New York Physicians' Forum, had been in existence as an unincorporated association since about 1939.

A source, on September 13, 1954, furnished a folder of PF entitled "What is the Physicians' Forum?" which stated in part that to maintain freedom of thought and expression in medicine, the Forum opposes the imposition of "loyalty oaths" as a prerequisite for licensure, for hospital appointments or privileges, in medical schools, on hospital staffs and against patients; to re-establish the freedom of the medical press, the Forum urges medical society publications to open their volumes to diverse views on controversial subjects; and to provide a forum wherein socially liberal doctors may express their views in opposition to the policies of organized medicine.

The report of the Sub-Committee to Investigate the Administration of the Internal Security Act and other Security Laws of the Committee of the Judiciary, United States Senate, 82nd Congress, 1952 on "Subversive Influence in the Educational Process" on page 37 sets out the testimony of BELLA DODD, member of the National Committee of the Communist Party from 1944 to 1948. DODD testified that the PF was established primarily by the Communist Party (CP) and although not all members of the PF were Communists, the "initiative for organizing the PF came from the CP, came from the ninth floor (35 East 12th Street, New York City), where the National Committee of the CP existed."

On April 24, 1963, the above source advised that the PF is opposed to the resumption of nuclear testing and is against compulsory membership for physicians in the American Medical Association (AMA). It continues to be active in a program of supporting legislation which would provide medical care for the recipients of Social Security benefits, and provide for Social Security benefits for physicians.

The Physicians Forum is located at 510 Madison Avenue, New York, New York.

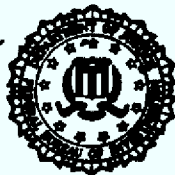

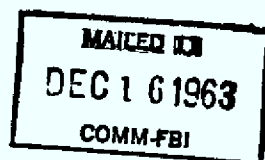

The 7/15/63 issue of "The Plain Dealer," Cleveland daily newspaper, contained an article which revealed that Roy Wilkins was one of the principal speakers at a rally sponsored by the United Freedom Movement (157-933) (UFM) which was held on 7/14/63 at the Cleveland Municipal Stadium in Cleveland, Ohio.

The UFM was reported to be an amalgamation of some thirty organizations interested in desegregation.

The 7/16/63 issue of the "New York Journal-American" contained an article entitled "The Negro View: 'Now or Never' - Leadership 'Disunity' Grows Graver." This article was the third in a series by Negro author Louis E. Lomax (62-102926) which disclosed the increasing friction among Roy Wilkins, James Farmer and Martin Luther King, leader of the NAACP, CORE and SCLC, respectively. Who would get the credit for holding mass demonstrations and to whom well-wishers should send their money, were at the root of the "current" crisis. In a speech in Virginia, Wilkins claimed the NAACP was doing all the work and footing the bills while other organizations including CORE and King, were making all the noise and grabbing the headlines. He advised the people not to send money to the CORE and Rev. King but to the NAACP.

On 8/22/63 AAG, Burke Marshall, Department of Justice, furnished copies of a telegram dated 7/25/63, and a letter dated 8/14/63, received by the Department from Roy Wilkins, Executive Secretary of the NAACP, regarding the arrest and prosecution of Rev. Harry Blake (44-23130), NAACP Branch President, in Shreveport, La., on a charge of breach of the peace. Wilkins said that Blake claimed he was warned by the city officials some months before that he would be held responsible for any demonstrations in Shreveport regardless of whether or not he participated. Wilkins also stated that a warrant was also issued for the arrest of Charles Evers, NAACP Field Secretary for Mississippi because he addressed a public meeting in Shreveport. Wilkins said that Federal presence and action was badly needed in Shreveport.

[REDACTED] furnished detailed information regarding the seventh annual National Convention of the SCLC (157-632) held Sept. 24-27, 1963 in Richmond. [REDACTED] advised the program of activity for 9/26/63 called for a public meeting to be held at the Belgian Building, Virginia Union University, at 8:00 p.m., to hear an address by Roy Wilkins, National Executive-Secretary, NAACP, NYC. According to [REDACTED] approximately 900 persons attended this meeting to hear Wilkins speak, and about 125 members of the Youth Chapter, NAACP, wore signs stating "Hi Roy, Virginia Union NAACP."

The 9/27/63 issue of the "Richmond Times Dispatch," a daily newspaper, in reporting on the SCLC convention stated that Wilkins, in his address, urged "caution and statesmanship" in the Negroes' civil rights campaign. He stated, among other things, "sometimes we must hit heavily, but at other times a light tap is just as effective to achieve the desired end."

The newspaper article further reported that in a press conference Wilkins was "cool to a Christmas boycott," stating "I find it difficult to go against the idea of Santa Claus" and added that a shopping ban would "disrupt" his organization's program, noting "we have a full schedule of activities which will be occupying our chapters until the end of the year."

The following references in the file captioned "Nation of Islam," (NOI) file 25-330971, contain information relative to the activities of Roy Wilkins during the period May, 1962 through June, 1963. NOI through the leadership of Elijah Muhammad, the Messenger of Allah, has affiliates throughout the US, and publishes a newspaper called "Muhammad Speaks." NOI's teachings stress separation of the black and white race, destruction of the white race, America, and Christianity by Allah, and non-participation in the white man's wars.

Members of NOI attended a rally at which Wilkins was a speaker, and at one time discussed asking Wilkins to speak at one of their outdoor rallies. Muhammad stated he would be glad to meet with Wilkins to discuss their working together on racial problems. On occasions officials of NOI thanked Wilkins and other officials of the NAACP for their love, sympathy and support of the black people and called for a united "Black Front to Fight Injustice." NOI leaders worked to undermine the prestige of Wilkins and other leaders of the Negro movement, and denounced Wilkins and the NAACP as an "Uncle Tom leader of an Uncle Tom Association which is led by white folk."

Wilkins said he did not anticipate any violence during the demonstration. In connection with his activities in civil rights matters Wilkins traveled in various states, including Connecticut, Alabama, North Carolina, South Carolina, Indiana, California, Pennsylvania, New York and Washington, D.C.

The NY Office had established liaison with individuals in a number of groups sponsoring integration, one of which was Roy Wilkins of the NAACP.
