On 11/28/65, Kathleen Crosby (9-44475), 915 Druid Circle, Charlotte, N.C., furnished information concerning an anonymous threatening letter received by her prior to a rally which was scheduled to be held at Ovens Auditorium, Charlotte, on that date, and in which she planned to participate as a guest speaker. Mrs. Crosby advised that the rally, which was to feature Roy Wilkins as the principal speaker, was organized to cement race relations and counteract violence.

During the course of an interview on 11/29/65, Mrs. Crosby indicated that she had addressed the above rally as planned. However, no mention was made as to Wilkins' presence at this affair.

The references disclosed, however, that some dissension existed among Wilkins, King and other Civil Rights leaders, in that each felt the other could not be trusted and only sought personal gain.





[REDACTED] advised that Roy Wilkins attended a memorial service for Medgar Evers, brother of Charles Evers (157-937), which was held on 6/12/66, at the Masonic Temple, 1072 Lynch Street, Jackson, Miss. During the service, Charles Evers announced that he would continue as NAACP Field Secretary for the State of Mississippi.

Informant stated that, in his opinion, the problems between Wilkins and Evers had been resolved and that Wilkins and the NAACP Board realized that Evers could be a political asset in the future.

The following references in the file captioned "Racial Matters" contain information concerning the numerous activities of Roy Wilkins from 3/29/64 to 6/12/66, relating to his position of leadership in the NAACP. During this period of time, Wilkins was active in the establishment and promotion of demonstrations of a peaceful nature and generally took a moderate stand on civil rights issues. Wilkins' speeches dealt primarily with voter registration, school segregation and Civil Rights legislation in Congress. Wilkins was observed at rallies, generally as a speaker, and at memorial services for civil rights participants who had met with violence.

Following the riots in the large northern cities in 1964, Wilkins requested the Department of Justice to initiate a full scale investigation of the riots, due to his suspicion that outside influences were involved.

In connection with his activities, Wilkins visited NYC; Charlotte, N.C.; Chicago, Ill.; Casper, Wyoming; Memphis and Nashville, Tenn.; and Hattiesburg and Jackson, Miss.

The following references in the file captioned "NAACP" contain information concerning the activities of Roy Wilkins, Executive Director, from 6/1/64 to 7/8/66. The references disclosed that prior to the early 1940's, Wilkins tended to adhere to the CP line. Since that time, however, he had endeavored to steer the NAACP from communist infiltration. During attempts to follow up the 8/28/63 March on Washington, D.C., Wilkins stepped in and prevented direct action programs.

On 1/4/65, during his annual report at NAACP headquarters, NYC, Wilkins stated that the enactment of the Civil Rights Act and achievement of voter registration were the highlights of the year. He indicated that concentrated efforts would be placed on the Anti-Poverty Act in the future.

Wilkins was scheduled to speak at NAACP functions at Birmingham, Ala., Raleigh, N.C., and Peoria, Ill., but no indication was given that these plans were executed. FBI protection was requested for the proposed Peoria visit. The references indicated that Wilkins spoke at an NAACP voter registration rally at Flint, Mich., on 7/26/64

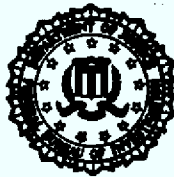

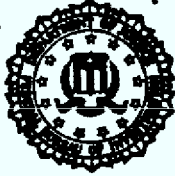

[REDACTED] advised that Roy Wilkins, Executive Director, National Association for the Advancement of Colored People (NAACP), arrived in Meridian, Mississippi, via Southern Airlines at about 2:50 p.m. on that date. He stated that Wilkins was met by a number of local NAACP members and they proceeded via automobile to the First Union Baptist Church, Davis Street, Meridian, Mississippi, where at 3:15 p.m. Wilkins spoke to a crowd of about 150 persons. During his talk he commented on the aims of the NAACP and stated that the NAACP was taking no active part in the "Poor People's March on Washington." He stated that as in the past the only assistance being given this program was some legal counsel, and where dire needs arise, some financial assistance.

[REDACTED] stated that at about 5:30 p.m. Wilkins and other NAACP Meridian officials proceeded to the Virginia Court Restaurant, Tom Bailey Drive, Meridian, where they had dinner. At about 7:30 p.m. Wilkins, in the company of Charles R. Barden, member of the National Board of Directors, NAACP, Meridian, Mississippi, left Meridian en route to Jackson, Mississippi, where Wilkins boarded an airlines for New York City. Gunn stated that there were no incidents

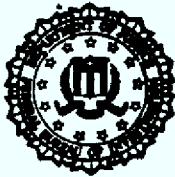

[REDACTED] advised on June 16, 1968, that Herman Ferguson and Arthur Harris, members of the JRPC, were found guilty by a New York, Queens County Supreme Court jury on June 15, 1968, charged with conspiracy to commit murder in the first degree in plotting to assassinate civil rights leaders Roy Wilkins, Executive Director of the National Association for the Advancement of Colored People (NAACP) and Whitney M. Young, Jr., Executive Director of the National Urban League. b7D

According to [REDACTED] Justice Paul Balsam, presiding, has not set a date for sentencing. The maximum penalty Justice Balsam could impose would be seven years imprisonment. b7D

The key witness for the prosecution was Edward Howlette, a Negro Detective, NYCPD, who infiltrated the Revolutionary Action Movement (RAM), a subgroup organized by Ferguson, state [REDACTED]

[REDACTED] advised [REDACTED] that JRPC is a subsidiary of RAM. b7D

A characterization of RAM is attached.

According to [REDACTED] Defense Attorney Gene Ann Condon failed to put Ferguson or Harris on the witness stand or call other witnesses after she heard in private, tape recordings obtained by the NYCPD containing conversations between Ferguson, Harris and others dealing with the conspiracy to assassinate Roy Wilkins and Whitney M. Young, Jr. b7D

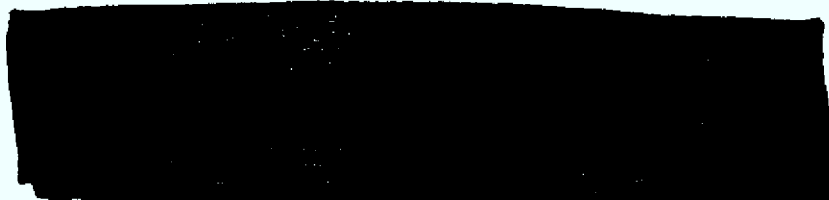

REVOLUTIONARY ACTION MOVEMENT

On November 3, 1964, a source made available a document entitled, "The Revolutionary Action Movement Manifesto", the document having been obtained by the source from an individual known to be a member of the Revolutionary Action Movement (RAM).

This document stated, in part, that RAM was officially organized in the Winter of 1963 by Afro-Americans who support the revolutionary objectives of ROBERT F. WILLIAMS, then residing in Cuba, and his concept of organized violence to achieve the liberation of the Afro-American people in the United States. This Manifesto disclosed that RAM had oriented its program to one of education and political revolution and the organization of a "black" political party with revolutionary objectives, having recognized the need for a "black revolution" that could and would seize power. RAM philosophy is described in this document as one of revolutionary nationalism, that is, one involving the struggles of the non-white races of the world against exploitation and enslavement by the white capitalist and imperialist nations.

Regarding WILLIAMS, it should be noted that on August 28, 1961, a Federal warrant was issued at Charlotte, North Carolina, charging him with Unlawful Flight to Avoid Prosecution for the crime of kidnaping. Subsequent to the issuance of this warrant, WILLIAMS fled the United States to Cuba, where he published a monthly newsletter entitled, "The Crusader" from Havana. As of December, 1966, WILLIAMS was residing in Peking, China.

This source, in September, 1964, advised RAM is dedicated to the overthrow of the capitalist system in the United States, by violence, if necessary, and to its replacement by a socialistic system oriented toward the Chinese Communist interpretation of Marxism-Leninism. RAM is entirely non-white in membership, clandestine in nature, and owes its primary allegiance to the "Bandung World", that is, the non-white races of the world rather than to any national entity, as such.

2.

REVOLUTIONARY ACTION MOVEMENT (CONTINUED)

On November 16, 1964, a second source advised he learned recently from a RAM member that the organization began in Detroit, Michigan, largely under the impetus of DON FREEMAN, described as the "Father" of RAM and referred to as RAM's "Black Stalin". FREEMAN served as RAM Chairman, with MAXWELL STANFORD (now of Philadelphia, Pennsylvania) serving as RAM Field Chairman.

On May 12, 1967, a third source advised that the RAM still remains active; however, there is no formal headquarters, as such, for the RAM. The source advised that MAXWELL STANFORD of Philadelphia, Pennsylvania, is considered the leader of RAM and if a RAM headquarters ever existed, it will most likely be where STANFORD resides.

ROY WILKINS - Summary
Born: August 30, 1901
St. Louis, Missouri

Roy Wilkins has never been the subject of an investigation conducted by the FBI. He has been associated with the National Association for Advancement of Colored People (NAACP) since approximately 1931. His name, therefore, has appeared frequently in the public press as he has endeavored to further the publicly known aims and purposes of this nationally known organization.

During the 1930's and 1940's various communist publications contained articles concerning Wilkins's activities when those activities coincided in purpose with programs sponsored by the Communist Party (CP). No information has been received, however, that Wilkins has ever been a CP member.

An article captioned "NAACP Leaders Dumped Rights on Negroes" appeared in the July 2, 1950, edition of "The Worker." This article stated that it had been remarked that the Forty-first Annual NAACP Conference, concluded on the previous Sunday in Boston, was the "best-organized public gathering run by the United States State Department since the 1949 CIO Anti-communist bee in Cleveland..."

Roy Wilkins

"Roy Wilkins, NAACP Administrator, was the main front man for the State Department's disastrous Anti-Negro policies." The article criticized Wilkins for the manner in which he conducted the convention.

A source, who has furnished reliable information in the past, on March 1, 1951, expressed his belief that Roy Wilkins, the "National Administrative Secretary" of the NAACP, would not knowingly be used by the communists; that Wilkins had fought communism for "many years" and that he was then openly anticommunist.

A National Conference of the NAACP was held during the weekend of April 6, 1957, in Philadelphia, Pennsylvania. At this conference, Roy Wilkins, National Secretary, NAACP, announced that all delegates to the March on Washington to be held in May, 1957, would be closely screened in order that all "leftists" be definitely omitted.

A source, who has furnished reliable information in the past, advised that Roy Wilkins was one of the speakers who spoke at the Lincoln Memorial, Washington, D. C., on May 17, 1957, in connection with the above-mentioned March on Washington. Mr. Wilkins stated that the CP was an evil force, that it attempted to use the NAACP as a front for CP activities, and that the CP can only mean poverty, economic strain and slavery. (62-78270-8)

In recent years Wilkins has been active in the establishment and promotion of demonstrations of a peaceful nature and has seemingly taken a moderate stand on civil rights issues. His speeches have dealt primarily with voter registration, school segregation and civil rights legislation in Congress. He has been observed at rallies, mainly as a speaker, and at memorial services for civil rights participants who have met with violence.

Following the riots in the large ^{urban} modern cities in 1964, Wilkins requested the Department of Justice to initiate a full scale investigation of the riots due to his suspicions that outside influences were involved.

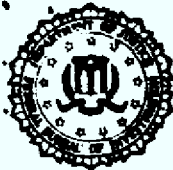

REVOLUTIONARY ACTION MOVEMENT

On November 3, 1964, a source made available a document entitled, "The Revolutionary Action Movement Manifesto," the document having been obtained by the source from an individual known to be a member of the Revolutionary Action Movement (RAM).

This document stated, in part, that RAM was officially organized in the Winter of 1963 by Afro-Americans who support the revolutionary objectives of ROBERT F. WILLIAMS, then residing in Cuba, and his concept of organized violence to achieve the liberation of the Afro-American people in the United States. This Manifesto disclosed that RAM had oriented its program to one of education and political revolution and the organization of a "black" political party with revolutionary objectives, having recognized the need for a "black revolution" that could and would seize power. RAM philosophy is described in this document as one of revolutionary nationalism, that is, one involving the struggles of the non-white races of the world against exploitation and enslavement by the white capitalist and imperialist nations.

Regarding WILLIAMS, it should be noted that on August 28 1961, a Federal warrant was issued at Charlotte, North Carolina, charging him with Unlawful Flight to Avoid Prosecution for the crime of kidnaping. Subsequent to the issuance of this warrant, WILLIAMS fled the United States to Cuba, where he published a monthly newsletter entitled "The Crusader" from Havana. As of December, 1966, WILLIAMS was residing in Peking, China.

This source, in September 1964, advised RAM is dedicated to the overthrow of the capitalist system in the United States, by violence, if necessary, and to its replacement by a socialistic system oriented toward the Chinese Communist interpretation of Marxism-Leninism. RAM is entirely non-white in membership, clandestine in nature, and owes its primary allegiance to the "Bandung World," that is, the non-white races of the world rather than to any national entity, as such.

On November 16, 1964, a second source advised he learned recently from a RAM member that the organization began in Detroit, Michigan, largely under the impetus of DON FREEMAN, described as the "Father" of RAM and referred to as RAM's "Black Stalin." FREEMAN served as RAM Chairman, with MAXWELL STANFORD (now of Philadelphia, Pennsylvania) serving as RAM Field Chairman.

On May 12, 1967, a third source advised that the RAM still remains active; however, there is no formal headquarters, as such, for the RAM. The source advised that MAXWELL STANFORD of Philadelphia, Pennsylvania, is considered the leader of RAM and if a RAM headquarters ever existed, it will most likely be where STANFORD resides.

NATION OF ISLAM

CONFIDENTIAL

A source advised on May 3, 1968, that the Nation of Islam (NOI) is an all Negro organization originating in Detroit, Michigan, in the early 1930s. ELIJAH MUHAMMAD is the leader of the NOI and self-styled "Messenger of Allah" in that he claims Allah (God) selected him to lead the so-called Negro out of slavery in the wilderness of North America by establishing an independent black nation within the United States. Headquarters of the NOI is located at Muhammad's Temple (or Mosque) Number 2, 5335 South Greenwood Avenue, Chicago, Illinois.

MUHAMMAD teaches there is no such thing as a Negro; that the so-called Negroes are slaves of the white race, referred to as "devils," in the United States; and that the white race because of its exploitation of the so-called Negro will be destroyed by Allah in an approaching "War of Armageddon, a war between God and the devil.

Officials and members of the NOI, including MUHAMMAD, have refused to comply with provisions of the Selective Service Act, stating that they respect laws of the United States as long as they do not conflict with the laws of the NOI, but do not believe the government should force them to participate in wars from which they have nothing to gain.

In the late 1950s MUHAMMAD, acting on legal advice, tempered NOI teachings against the white man and the government to avoid possible prosecution; however, basic tenets remain the same. He de-emphasized religious teachings in the NOI and emphasized economic benefits derived by so-called Negroes who join the NOI. MUHAMMAD believed this would create more interest in his programs and, of course, new followers.

Hits Rights 'Pussyfooting'

Civil rights leader Roy Wilkins accused the Nixon administration yesterday of "pussyfooting" on the problems of racial conflict and urban ills.

Wilkins, executive director of the National Association for Advancement of Colored People, said the administration "frightens me by its attitude on the civil rights question."

The fact that it is easing up on school desegregation, that it

has no cease-and-desist order for enforcement of employment discrimination, and that it cuts the housing appropriations below the minimum so we can't rebuild our cities—all of these things frighten me," Wilkins said.

Charging that the Nixon administration has not indicated how it intends to solve racial and urban problems, Wilkins said: "This is what holds everybody up in the air."
