Result of examination:

Q1 and Q2 were searched through the appropriate sections of the Anonymous Letter File but no identification was effected. Representative photographs of these specimens are being added to this file.

Q1 is described as a white bond envelope measuring approximately 6.25 by 4.29 by .0054 inches containing the watermark "KRETONA." This is a watermark of the S. S. Kresge Company, Detroit, Michigan, indicating this product is sold exclusively by the S. S. Kresge five- and ten-cent stores. Q2 is a piece of white bond blue ruled paper which has been cut from a larger sheet of paper, possibly loose leaf paper. Q2 measures approximately 7.30 by 6.67 by .0033 inches and bears a red stain of undetermined origin on the back. No watermark was noted in Q2 and no indented writing of significance was noted in Q1 or Q2.

The questioned handwriting on Q1 and Q2 was prepared with the use of a pencil and the stamp on Q1 comes from a sheet of stamps.

Q1 and Q2 are enclosed with copies of this report to the Baltimore Office as requested. Photographs of Q1 and Q2 are retained.

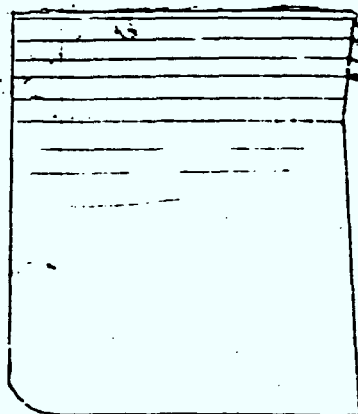

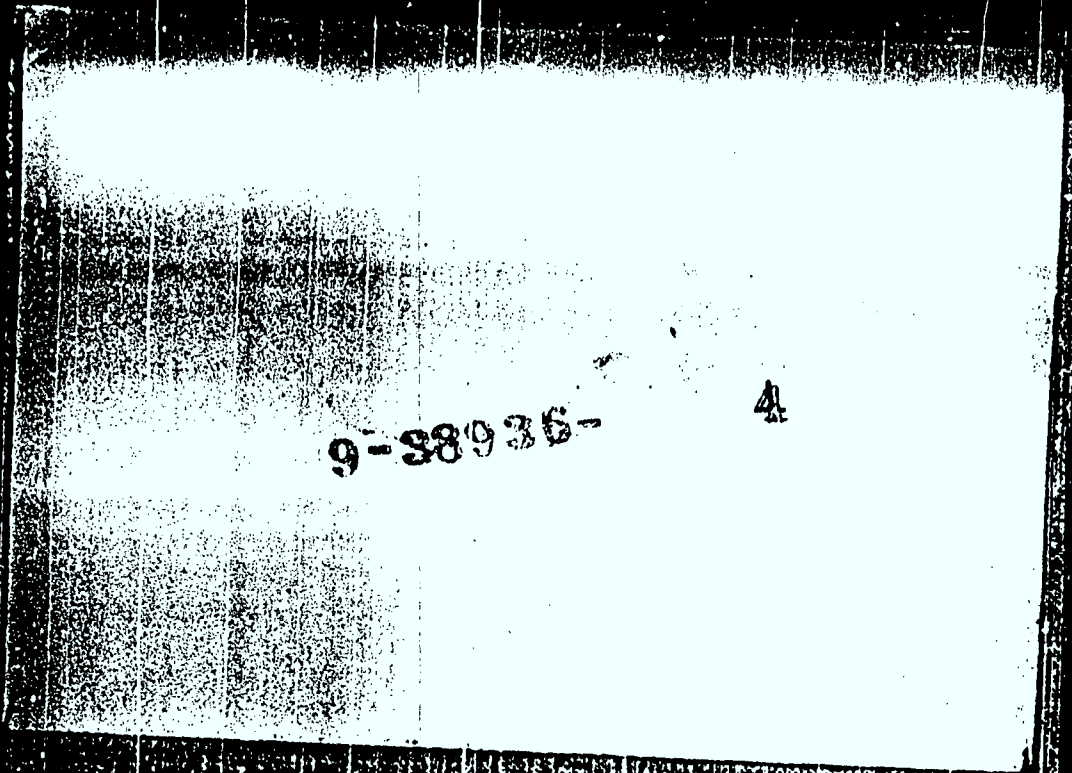

Q1 is described as a white bond envelope measuring approximately 6.25 by 4.29 by .0054 inches containing the watermark "KRETONE." This is a watermark of the S. S. Kresge Company, Detroit, Michigan, indicating this product is sold exclusively by the S. S. Kresge five- and ten-cent stores. Q2 is a piece of white bond blue ruled paper which has been cut from a larger sheet of paper, possibly loose leaf paper. Q2 measures approximately 7.30 by 6.67 by .0033 inches and bears a red stain of undetermined origin on the back. No watermark was noted in Q2 and no indented writing of significance was noted in Q1 or Q2.
