The letter was written on the reverse side of a billing invoice dated 10/31/71, from the Monterrey Pharmacy, 12901 Riverside Drive. Sherman Oaks. California, and is addressed to California.

The above letter was contained in a red and white U. S. Postal Service postage free envelope. A return mailing label glued on the front of the envelope bore the handprinted name "Sammy Davis, Jr., Harrah's, Reno, Nevada." No postmarks were noted on the envelope.

Also found inside the envelope was a small card bearing the name "Institute for Family Neurosis Research." Beneath this appears the handprinted name The other side of the card bears the handprinting "KGIL, (213) 894-9191."

Reportedly KGIL is a radio station located in San Fernando (Los Angeles County), California, and is a disc jockey affiliated with this station.

Another item contained in the envelope was a memographed sheet dated 12/4/73, bearing numerous well-known names and accusations. The bottom of the sheet lists the name of the editor as and the sheet is signed by "Der Fuhrer."

On 1/31/74, this case was discussed with AUSA E. PIERRE GEZELIN at Reno, Nevada. GEZELIN was of the opinion that this matter constituted a violation of the Federal extortion statute.

Also on 1/31/74, SAMMY DAVIS, JR. was interviewed by SAS of the FBI and acknowledge receipt of the above items. DAVIS, however, was unable to furnish any information concerning the identity of the sender. He was of the opinion that the person who prepared the letter and other items was a "nut."

The FBI Laboratory is requested to compare the handwriting on the enclosed letter with the letter submitted in referenced Las Vegas airtel. It is further requested that this letter be searched through the anonymous letter file.

The Latent Fingerprint Section of the Laboratory is requested to examine all of the enclosed items for fingerprint impressions. In this connection it should be noted that the contents of the envelope were handled by numerous people before being turned over to the FBI including SAMIN DAVIS, JR. and his staff.


