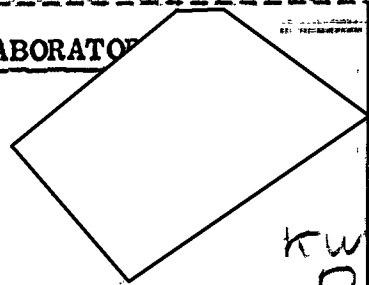

I just received a letter from Captain of the U. S. Supreme Court Police which enclosed a Xerox copy of a letter forwarded to the Chief Justice of the United States and postmarked November 23, 1970; at Pittsburgh, Pennsylvania. The letter which is signed "A Sticker For Holy Justice," bears a return address of North American Insurance Institute, Pittsburgh, Pennsylvania, states that the author is going to bomb Supreme Court when all nine Justices are in session unless new laws banning "pornographic junk" are passed. The author of this letter complains of permissive nudity in movies, stage plays and books. A Xerox copy of the letter is attached. A name check of the anonymous letter file in the FBI Laboratory failed to reflect any previous correspondence. Captain Coble's letter is attached.

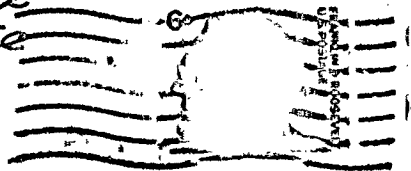

NOTE: Unknown subject directed an undated obscene, threatening letter to the U. S. Supreme Court, postmarked November 23, 1970, Pittsburgh, Pa., criticizing the Court unless new laws banning "pornographic junk" are passed the Supreme Court would be bombed. Unsub has now directed a letter to the Director dated 12/8/70, in an effort to have the Director influence the Supreme Court Justices to change the permissive, lewd pornographic movies, stage plays, and books which they have allowed in this country. He again threatens the Supreme Court because of their failure to change the pornography laws. Pittsburgh Office is currently attempting to identify the author of these letters, and the United States Attorney, Pittsburgh, is of the opinion the letter to the U. S. Supreme Court is a possible violation of the Federal Extortion Statute.
