BEATRICE MERKEN'S address was listed as 2314 28th Street, Astoria, Long Island, New York, her birth place as Fall River, Massachusetts, and her age as 24 years old. Her parents were listed as ABRAHAM BEAMERKEN and PAULINE SCHWARTZ, both born in Russia.

The application for marriage license indicated that LEVISON'S first marriage had been annulled on June 21, 1942 in Westchester County, New York, and that this was the first marriage for BELTRICE MERKEN. The name of LEVISON'S first wife did not appear on these records. The couple were married by Rabbi NAPHTALITISHBERG, 25-10 30th Road, Long Island City, New York, and witnesses to the marriage were JELNETTE KAUFMAN and ESTHER SCHWARTZ.

The Marriage License Bureau records for the Borough of Manhattan, as checked on July 21, 1953 by SE reflect the following information on certificate number 7160, for the year 1939:



The records of another government agency of known reliability, were examined on June 24, 1953 by SE and indicate that STANLEY DAVID LEVISON has not had any military experience.


C. Health

The records of when examined on June 24, 1953, indicated that STANLEY LEVISON allegedly had a hemorrhoid condition as of 1943.




