trial for murder and get down to the
real facts! We have no doubt he

"This never could have happened to the Conspiracy 8, or some poor father, stealing a cheap, but beautiful doll, at Christmastime for his sick daughter. No in this great America the poor are always punished severely while the rich never get punished at all like the Lindbergh's who killed their deaf baby and planted the evidence on an innocent man later killed. Are you going to correct this terrible trial of Ted's?"

3. Postal card postmarked "CHICAGO, ILL. 11B PM 23 APR 1970," addressed to Most Esteemed Judges, bearing handwritten message as follows:

"Please show this nation and the world that there is justice and law in this country for everyone rich or poor by reopening the Ted Kennedy case, exhume Mary Jo's body, get to the truth, to the bottom of all Ted's lies and deceptions. Why all the lies? Why is he so evasive when questioned? Why all the secrecy? The Conspiracy 8 could not have had all this secrecy. Why Ted? Because he is rich! I hope God punishes him soon if you judges don't. He deserves death.

4. Postal card postmarked "CHICAGO, ILL. 14 B PM 16 APR 1970," addressed to The Honorable Judges, bearing handwritten message as follows:

"Our family wants to know the truth behind the Ted Kennedy murder of Mary Jo Kopechne and object to the sudden closing down of the case as was done by that lousy Mass. lawyer and judge of Dukes County Court. It is a disgrace to our nation to handle justice in such a fashion. Sure Ted is glad the case is over so he, the murderer, can go free. That awful, good-for-nothing Ted should be barred from being a senator any longer. I hope somebody kills him in justice to Mary Jo, if the courts cannot or more likely, will not do anything in the name of justice.

be anything but moral decay. So Roman

a moral rebirth starts at the top of the land.
Now let's see what you can do in this grave
matter!"

6. Postal card postmarked "CHICAGO, ILL.
14B PM 15 APR 1970," addressed to United
States Judges, bearing handwritten message
as follows:

"Now what are you judges going to do
about the Ted Kennedy murder case? Is it in the
name of justice to close the Mary Jo Kopechne
case, have the jury quit, to have a secret
inquiry, to leave the public still in doubt, to
have the case suddenly ended by Judge Wilfred J.
Paquet, to have transcripts missing, news media
state the FBI found a bullet in Mary Jo's head,
state Kennedy's son killed her? What the hell
is going on in our country when the scales of
justice do not function to punish the rich!
The poor Conspiracy 8 got 4 years just for
outbursts in court! What about murder?
Damn Mass.! Damn Ted!"

The United States Secret Service has shown that the printing and handwriting have been associated with letters previously sent to the Supreme Court in February, 1968, from an individual who signed the letter R. Rathbone, Chicago, Illinois 60630. Investigation conducted by the United States Secret Service failed to identify R. Rathbone.

The United States Capitol Police, the Intelligence Division of the Metropolitan Police Department, both Washington, D.C. and the Intelligence Unit, Chicago Police Department, Chicago, Illinois have been advised of the receipt of this material.

By communication dated May 28, 1970, the FBI Laboratory furnished the following report of their examination of described postal cards:

Result of examination:

Specimens Q1 through Q6 were searched in the Anonymous Letter File without effecting an identification. Appropriate copies are being added thereto.

The conclusion was reached that the hand printing on Q1 and Q5 were prepared by one person. Farther, the conclusion was reached that the handwriting on Q2 through Q4 and Q6 were prepared by one person.

Specimens Q1 through Q6 were prepared on United States Post Office five-cent postal cards. No indented writing of significance or other identifying characteristics were noted on these items.

Specimens Q1 through Q6 are being returned separately. Photographs are retained.

By communication dated June 8, 1970, the FBI Identification Division, Latent Fingerprint Section, advised that on examination of the postal cards as described in preceding laboratory report, eleven latent fingerprints and two latent palm prints were developed on subject cards.

On May 25, 1970, Assistant United States Attorney William P. Cagney, III, advised that following his review of the postcards in question, he would decline prosecution based on the following considerations:

1. The postcards in question contain no precatory language.
2. There is no immediacy indicated by the language utilized in the postcards in question.
3. Threats, if any, contained in the postcards are veiled and make reference to a third person.
4. There are no threats contained in the postcards in question which are directed to the recipients themselves.

1) Postal Card postmarked Chicago, Illinois, p.m. 15 June 1972, addressed to Senator McGovern, The Senate - U.S., Washington, D.C. This card reads as follows:

"Dear Mr. McGovern. You must not go along with Mr. Ted Kennedy on the nomination tickets of the Democratic convention.

"We have no use for Kennedy as he is a murderer or shielding a murderer which makes him an accomplice to a murder--and he should be electrocuted like other men are for their foul deeds. This rotten country of America where justice is only dealt out to the poor. Phooey on it."

2) Postal Card postmarked Chicago, Illinois, p.m., 15 June 1972, addressed to Mr. George McGovern, Senator from North Dakota, Senate of America, Washington, D.C. This card read as follows:

This document contains neither recommendations nor conclusions of the Federal Bureau of Investigation. It is the property of the Federal Bureau of Investigation and is loaned to your agency; it and its contents are not to be distributed outside your agency.

"He should be brought to trial for the murder he committed. The Statue of Liberty balances scales of justice but there is no justice for rich mens' sons--justice is only dealt out to the poor boys. Well, God works in mysterious ways and America is praying every day for her injustice through the moral breakdown of its people. Kill Kennedy!"

The United States Secret Service has made a check of their name files and visual files of previously submitted letters with negative results.

The United States Capitol Police, The Intelligence Unit, Metropolitan Police Department both of Washington, D.C. and the Intelligence Unit, Chicago, Illinois, Police Department have been advised of the receipt of this material.

NOTE: Unknown subject directed an undated obscene, threatening letter to the U. S. Supreme Court, postmarked November 23, 1970, Pittsburgh, Pa., criticizing the Court unless new laws banning "pornographic junk" are passed the Supreme Court would be bombed. Unsub has now directed a letter to the Director dated 12/8/70, in an effort to have the Director influence the Supreme Court Justices to change the permissive, lewd pornographic movies, stage plays, and books which they have allowed in this country. 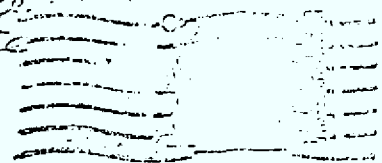

cancelling machine at this post office. The envelope could
have been mailed anywhere in a mailbox in the City of Pitts-
burgh. It was also determined that no box has been returned
by the North American Insurance Institute, and the Polk
Directory also failed to disclose the identity of this
institution.

The following undated letter was directed to the Chief Justice of the U. S. Supreme Court, Washington, D. C., in an envelope postmarked Pittsburgh, Pa., November 23, 1970, and bearing the return address, "North American Insurance Institute, Pittsburgh, Pa.?"

"Dear Chief Justice of the United States Supreme Court

"I'm going to throw a bomb on the Supreme Court of the United States of America, and destroy it, because it's no good and evil, I'll throw it while you nine Justices are in session, its occupants are no good either

"I ain't telling you when, what day, or, hour just then when you are in session, just beware and be on the alert for this action. Unless you pass new laws banning all this pornographic junk which you are allowing now in this good old country of the U.S.A.

On December 7, 1970, this matter was discussed with Assistant U. S. Attorney THOMAS A. DALEY at Pittsburgh, Pa., by SA [REDACTED] of the Federal Bureau of Investigation, who advised contents of the letters involved would constitute a Federal violation of the Extortion Statute and that he would consider prosecution if the writer could be identified.

A check of the 1969 and 1970 Pittsburgh, Pa., Telephone Directories and the 1969 Pittsburgh City Directory failed to disclose an institute by the name of North American Insurance Institute.

Assistant Superintendent for the U. S. Post Office at Pittsburgh, Pa., advised that the envelopes containing the letters involved were received at the main post office at 7th Avenue and Grant Streets, Pittsburgh, Pa., as the numbers 4B and 3B appearing in the cancellation indicate the envelope was run through the automatic cancelling machines located at the main office. It was his opinion that the envelopes could have been mailed anywhere in the City of Pittsburgh, and thereafter transported to the main post office.

It was also determined that no Post Office Box was retained by an institute known as the North American Insurance Institute and that the Polk Directory also failed to disclose an institute under this name.

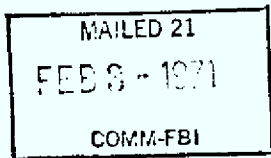
