



He stated that he had been informed by William Gardner of the Civil Rights Division that Gardner intended to go back as far as 1940 and intended to learn of any and all possible violations of citizens' civil rights by FBI Agents advised he was concerned regarding the inquiry and desired to know if the FBI was aware of the extent of this inquiry since we had only mentioned surreptitious entries to his client was advised that we were under the impression this inquiry was limited to surreptitious entires and then only those of recent years. He was informed this would be boought to the attention of the Director and he was thanked for bringing this to our attention.

Of course, an Agent who is the subject of this inquiry and freely chooses to initiate a conversation with a colleague or other Bureau personnel, may do so and is not subject to this rule.

According to Mr. Pottinger, because we are dealing with very sensitive matters involving right to counsel, their concern and what they are trying to avoid is a situation in which an Agent receives a directive, an order, or advice or any other communication, formally or informally, which could cause him act to feel free to cooperate in this investigation consistent with his constitutional antegrands.

SURREPTITIOUS ENTRY INVESTIGATION PROTECTION OF NATIONAL SECURITY INFORMATION

In view of our mutual concern as expressed in Departmental memorandum to the Director, Federal Bureau of Investigation, "Re: Surreptitious Entry Investigation," dated 19 July 1976, regarding appropriate protection of classified national security information, with your concurrence, it is my intention to brief the FBI personnel assigned to the Task Force who will be handling such classified information.

As you know, the Agent personnel assigned to this Task Force, by design, were drawn from our complement of Agents who have had little or no experience in security-Type investigations. Since these gents have had little or no experience in matters involving classified national security information, the briefing will be in compliance with Executive Order 11652 which requires that employees handling such classified information must be familiar with the provisions of this Order. The Executive Order requires that agencies handling such classified information establish and maintain active training and an ongoing program for employees having access to classified national security information or material. Such training shall include as a minimum the briefing of new employees and periodic reorientation during employment to impress upon -each individual his responsibility for exercising vigilance

fied national security information, with your concurrence, such a briefing will be afforded the Task Force FBI personnel.

This proposed briefing will be conducted by personnel of the Intelligence Division who are familiar with the provisions of Executive Order 11652.

Your concurrence and/or suggestions regarding this proposed briefing will be appreciated.

NOTE:

In connection with the investigation currently underway by a Task Force consisting of FBI Agents in support of the Civil Rights Division criminal surreptitious entry investigation, the matter of the handling of classified national security information has been a concern of both the FBI and the Department. Since the FBI personnel assigned to this Task Force have not previously been engaged in security investigations which would familiarize them with the provisions of EO 11652, it is felt that an appropriate briefing regarding the provisions of this EO should be afforded the Agent personnel assigned to the Task Force. This matter was discussed at a conference in Mr. J.B. Adams' Office on 7/23/76, at which time it was the consensus of opinion that the AAG, Civil Rights Division, who is in charge of this inquiry, should be advised of our intention to conduct such a briefing and that his concurrence should be sought.

In addition, Gardner stated he desired to learn what level of authority approved the above activities and what levels of authority were aware of such activities and acquiesced in their being conducted.





Dear Mr. Kelley:

Reference is made to your letter, dated July 27, 1976, which was delivered to me on August 3, 1976.

As you may be aware, on June 18, 1976, an individual, identifying himself as William L. Gardner, Chief, Criminal Section, Civil Rights Division, United States Department of Justice (USDJ), Washington, D.C., advised me on the telephone that his Division had the responsibility for an investigation being conducted concerning surreptitious entries made without judicial approval in residences and other buildings which could be violations of Title 18, Sections 241, 242, and 2236, United States Code. Gardner stated that he was in possession of information that I may have had a role in such entries on one or more occasions. Therefore, I was being considered a potential subject of this investigation. In short, Gardner requested that I travel to Washington, D.C., to be interviewed by him in this matter, at which time I would be advised of my Constitutional rights as a subject. He advised that he desired to have this interview conducted as quickly as possible and would appreciate it if I or someone acting on my behalf contact him to arrange for the interview and the conditions under which I would be interviewed.

I told Gardner that at this point, I was undecided as to whether or not I was in need of counsel. Furthermore, I had been instructed not to discuss classified information at this time with an attorney who did not have an appropriate



MILED clearance and therefore if I did decide to obtain legal counsel, I could not proceed in selecting an attorney and advising him of possibly pertinent facts. I told him that other matters and problems of a similar nature were still being resolved at the Federal Bureau of Investigation Headquarters (FBIHQ) and USDJ level which would have a bearing upon my decisions as to choice of counsel.

Gardner advised me that he had on that very day learned of the problem concerned with divulging classified information to independent counsel.

Other similar matters concerning the possibility of my interview were discussed, notably the possible use of a Grand Jury proceeding in New York City in order to obtain a statement from me in this matter. I was also left with the impression that Gardner would recontact me at an unspecified date in the near future. I have not been recontacted by him since our discussion on June 18, 1976.

Concerning your July 27, 1976 letter to me, I can only regard it as a reiteration and confirmation of your previous instructions as set forth in your teletype message of June 17, 1976. In regard to providing information to counsel of my choice, there has never been any doubt in my mind that such information would be of a highly classified nature pertaining to national security matters.

Due to the fact that I have never been advised by the USDJ as to the specific facts which have led the USDJ to consider me a potential subject, I have been put in the potential position of necessarily having to be as liberal as possible in providing information to counsel in an attempt to anticipate the scope of an interview with Mr. Gardner. Therefore, the probability of divulging classified information to counsel, becomes proportionally greater with the amount of information furnished.

As a result of your letter to me, I have initiated contact with an attorney in order to determine his willingness to represent me in this matter. In order to assist me in this regard, I hereby respectfully request that I be furnished a copy of the Employment Agreement (FD-291) executed by me.

Additionally, I hereby request that I be furnished copies of any documents furnished from FBI files to the USDJ which appear to specifically implicate me in any surreptitious entry matter.

Additionally, I hereby request that I be furnished, when available, a copy of the document presently being prepared by the Chicago Division of the FBI relating to the foreign connections of the Weatherman Underground Organization (WUO). This document may provide sufficient evidence that the WUO is properly described as a foreign organization as distinguished from a domestic organization.

Additionally, I hereby request copies of any documents disseminated to the USDJ in the normal course of business during the period that I was a member of Section 47, at the New York Division, which could reasonably indicate to the reader that a surreptitious entry technique was involved. It is requested that the specific identities of personnel of the USDJ receiving such documents be determined and furnished to me.

Your favorable response to my above-stated requests would indeed be appreciated since I naturally desire to afford the attorney of my choice every advantage in his efforts to provide excellent representation on my behalf.



Counsel stated their client had been contacted by representatives of the Civil Rights Division concerning captioned inquiry. Their client was not advised that he was a subject of the investigation, but was informed that he would be asked to sign a waiver of rights. They said SA was visibly upset and emotionally disturbed by this whole incident, particularly as it pertains to his future in the FBI. Their contact with LCD was to obtain a blanket commitment from the Bureau that no administrative action would be taken against their client regardless of the position he took with the Department. They advised that at this time they had not made a final decision as to whether or not they would permit their client to cooperate with the Department or to invoke his constitutional rights. In either event, they desired some commitment from the Bureau that whatever aution their elient took his future in the Bureau would not be jeoperassed.

Both attorneys were fully briefed concerning this investigation and the fact that it is being directed by the Civil Rights Division. They were informed that the official position of the Bureau was that of cooperation with the Department, and that the Director had advised our field divisions that no Agent would be subject to administrative action if he chose to exercise his constitutional rights.* It was further pointed out that since the Bureau was not in possession of all facts concerning this investigation no commitment could be made other than that set out above. Both attorneys stated they understood that we were not in possession of the facts concerning this inquiry.

*This means that no action would be based on the fact constitutional rights were exercised. No broader commitment could be given.



We concur in the suggestion that your response be cleared through Mr. Pottinger because, as a practical matter, such a response could have the effect of lessening an Agent's willingness to discuss fully and candidly his activities. We certainly wish to avoid any possibility of the Civil Rights Division incorrectly construing our response as an intentional effort to lessen cooperation from our employees in the captioned investigation.





You also agreed that for the purpose of communicating your instructions to those memployees involved, we should only notify those field offices to which the subject agents are currently assigned and FBI Headquarters personnel. Attached is a copy of such communication which was telephonically read to you by Mr. Farrington on July 16th and which you approved for transmittal as indicated above.

With regard to paragraph 3 of your July 9th memorandum, you were assured that we would not tolerate any employee hampering or interfering with this inquiry in any manner. In addition you were also assured that another agent would handle, as far as possible, any classification broblems arising in connection with this inquiry and Arise Dir. particularly in confiection with classification questions arising as to Dep. AD Inc. documents or information involving the Weather Underground. However it was also noted that we reserved the right to consult with from time to time in his capacity as the Bureau's Classification Officer,

I advised all Special Agents in Charge by teletype of June 15, 1976, that the Bureau was ω operating with the CRD in this inquiry and encouraged those employees contacted and informed that they are subjects of this investigation to also cooperate. In furtherance of the information set forth in the above referenced teletype, the CRD has requested me to advise and encourage you to consult counsel, if you have not already done so. 

Mr. Gardner requested that Special Agents and travel at Government expense to Washington, D.C., for the purpose of being interviewed by Government officials. Mr. Gardner also suggested that Special Agents and consider obtaining private counsel in this matter. and have both obtained private counsel to represent their interests in this matter.

Special Agents and were both formerly assigned to the New York Division, Special Agent having been assigned there from July 1968 until January 1973, and Special Agent assigned there from February 1971 until August 1975. Due to the period of time that has transpired since their initial assignment to the New York Division and due to the voluminous amount of material handled by them during this period, many facts pertaining to their investigative activities while assigned to New York have become uncertain. Both of these Agents feel that in order to properly discuss this matter with Departmental attorneys, other Governmental officials or their own attorneys, it is necessary that they review the files contained in the New York Division so as to refresh their recollections as to the events and circumstances out of which the current allegations arose.

Therefore, Special Agents and have requested that they be permitted to travel to New York City in an official business status at Government expense, for the purpose of reviewing files maintained there, these files being otherwise unavailable to them.

It would appear to the Special Agent in Charge, Detroit Division, that such travel should be authorized in the interest of justice and so that all of the facts surrounding these allegations can be brought to light. Due to the varied investigative assignments and cases that Agents work during the span of a five year period, it is understandable that recollections become clouded and uncertain. Prior to these Agents answering any inquiries that the Government might have concerning the allegations against them, they should be permitted to review the files in the New York Division pertaining to their investigative activities while assigned there. Special Agents, currently assigned to the New York Division and against whom similar allegations have been made, have been afforded the opportunity to review these files. In addition, at least one other Special Agent has been permitted to travel at Government expense from one field division to another for the purpose of reviewing files to refresh his recollection in this matter. To deny Special Agents and this same opportunity to refresh their recollection would be grossly unfair and unjust.



The Special Agent in Charge, Detroit Division, strongly recommends that Special Agents and and be authorized to travel at Government expense from Detroit, Michigan, to New York City, for the purpose of reviewing files maintained by the New York Division.





I know you would want to know in connection with the current investigation being conducted by the Civil Rights Division (CRD) concerning surreptitious entries, I advised all Special Agents in Charge by teletype dated June 15, 1976, that the Bureau was cooperating with the CRD in this inquiry and encouraged those employees contacted to also cooperate.

In my communication of June 15, 1976, referred to above, I did not suppose that information and material to d be provided to counsel in connection with this investigation are necessarily classified or subject to the nondisclosure requirements of Title 18, Code of Federal Regulations, TPart 17. However, in the event that information you propose to provide to counsel is so classified, you ishould inform him of that belief and advise him that he may contact the CRD for guidance as to whether a security clearance of counsel is necessary and, also, by what process the clearance can be sought and obtained.

In response to your request, you are hereby released from the provisions of your Employment Agreement (FD-291) subject only to the possible need for security clearance of your counsel as discussed above.

DETAILS: When the CRD's investigation into surreptitious entries was initiated, we were furnished a list of Agents who were considered subjects of the inquiry. Many of these Agents contacted FBIHQ advising they were consulting private counsel and were desirous of being released from their employment agreement. At this time, a letter was prepared by Legal Counsel Division which it was felt would suffice for this purpose.

On 7/29/76.

telephoned Legal Counsel Division to report a contact by a representative of the CRD. This representative stated that he desired to speak to concerning the CRD's inquiry stated that he informed the Department representative that he desired to consult with private counsel, and that he was contacting the Legal Counsel Division to request a release from the provisions of his employment agreement. On 8/9/76, we forwarded the above-mentioned letter. This letter uses the sentence, "The CRD has requested me to advise and encourage you to consult counsel, if you have not already done so." This sentence was based on discussions between representatives of the Legal Counsel Division and the Department.

This was based on the fact that many of the Agents contacted by CRD are no more than witnesses in this investigation. The Department has advised, however, that people interviewed can subsequently become subjects as the result of additional investigation.

In view of the above, Legal Counsel Division will no longer notify Agents who retain private counsel that they are being released from their employment agreement unless we determine that they have been designated a subject of the investigation, or unless they specifically request to be released. In line with this, it is recommended that attached letter to be approved and sent. We recommend that letter and our answer be retained in files as evidence of our intentions.







SYNOPSIS AND DETAILS:

Attached is a memorandum I received from the Assistant Attorney General, Civil Rights Division, and its enclosures, a letter dated September 7. 1976, from the Attorney General to the Assistant Attorney General, Civil Rights Division, and a copy of a memorandum from the Director to the Attorney General dated September 3, 1976, captioned "Surreptitious Entries Classification Matter."

The Director's memorandum to the Attorney General of September 3 requested advice concerning the appearance of Special Agent before a grand jury pursuant to a subpoena and the possible conflict between his potential testimony and restrictions imposed by the Code of Federal Regulations and Executive Order 11652. The Attorney General's letter to Mr. Pottinger dated September 7 appears to provide the resolution of the problem described in the Director's memorandum.

RECOMMENDATION:

That Special Agent be advised that the letter from the Attorney General to Mr. Pottinger appears to have resolved the potential conflict between his testimony and the restrictions imposed by the Code of Federal Regulations and Executive Order 11652.



SURREPTITIOUS ENTRIES CLASSIFICATION MATTER



In connection with the Civil Rights Division investigation into surreptitious entries, certain Agents were subpoensed to appear before a grand jury impaneled in the Southern District of New York and the attorney for these Agents is altempting to quash the subpoenss for various reasons, including the fact that members of the grand jury have not been cleared to receive classified information and the Agents are not able to reveal such classified information pursuant to national security regulations.

Special Agent has been subpossed to appear before a grand jury in Washington, D. C., on September 3, 1976, and although his attorney attempted to defer his appearance pending resolution of the motion in New York such action was not agreed to by the Civil Rights Division.

has advised that because the Weatherman investigation has been held by the Department Review Committee to be a national security investigation, and sources and methods of intelligence related thereto are classifiable, he is requesting that you be asked to resolve the conflict between his subpoena to testify and restrictions imposed by Title 28, CFR, Sections 17.3 and 17.64 and Executive Order 11652. In view of the dilemma and after discussing the matter with his attorney, he has advised he intends to decline to testify and has furnished a copy of the statement he intends to make as the reasons for his declination.

In order that this Bureau may appropriately advise and other employees confronted with this situation, I respectfully request your early consideration of this matter.




