SURREPTITIOUS ENTRIES

Reference is made to your memorandum of April 20, 1976, captioned: "Socialist Workers Party et al. v. Attorney General, et al. (S.D.N.Y.) 73 CIV 2149," in which you ask whether any public or executive session statements, memoranda, surreptitious entries, were made by Department personnel (including Bureau personnel) which may need to be retracted and/or clarified.

We have reviewed public and executive session statements made by Bureau personnel concerning surreptitious entries and have concluded that, on the basis of information available to FBI Headquarters (FBIHQ) at the time of such remarks, those statements were accurate and do not require retraction. Further, we believe that in view of recent statements by the Bureau to the press, in connection with surreptitious entries, there is no need to clarify past statements in this regard.

As you know, our inquiries in response to Departmental and Senate and House Select Committees' requests have, from time to time, shown newly discovered information relating to entries performed by Bureau personnel. We have promptly advised the Department on the occasion of each discovery.

We have made an effort to be as accurate as possible in our statements concerning surreptitious entries. Unfortunately, procedures followed with respect to recording information relating to entries were such that it has been most difficult to identify the activity in our files. Further, documents pertaining to surreptitious entries were not maintained in normal record channels, thereby hampering our efforts to respond accurately to questions posed to us.

## PURPOSE:

To advise of receipt of information indicating the Department is expanding the scope of its investigation into surreptitious entries.

## SYNOPSIS:

Authority obtained to notify present and former Agents who are subjects of above inquiry they are released from their employment agreement in order to discuss this with their counsel. Attorney representing a former Special Agent advised he was informed by Department that they intend to go back to 1940 and look into all possible violations of civil rights by Bureau Agents.

## RECOMMENDATION:

That this matter be discussed with Assistant Attorney General, Civil Rights Division, to clearly establish the extent of their inquiry into this matter.

Legal Counsel to Mr. Adams memo of 7/15/76, captioned as above, obtained authority to telephonically notify present and former Agents who are subjects of Civil Rights Division surreptitious entries investigation they are released from their employment agreement so they could discuss this matter with their counsel. This telephonic notice was to be followed by letter from the Director. Legal Counsel Division has been handling this matter and on 7/26/76, former SA [REDACTED] Vernon, Connecticut, was contacted and advised he was released from his employment agreement for the purpose of discussing the matter of surreptitious entries with his attorney.

At 4:30 p. m. , Legal Counsel Division was contacted by [REDACTED] attorney, a [REDACTED] of Hartford, Connecticut, who advised he represented former Agent [REDACTED] and that he had been informed of our call notifying [REDACTED] he was released from his employment agreement. [REDACTED] pointed out that our telephonic notice mentioned surreptitious entries. He stated that he had been informed by William Gardner of the Civil Rights Division that Gardner intended to go back as far as 1940 and intended to learn of any and all possible violations of citizens' civil rights by FBI Agents. [REDACTED] advised he was concerned regarding the inquiry and desired to know if the FBI was aware of the extent of this inquiry since we had only mentioned surreptitious entries to his client. [REDACTED] was advised that we were under the impression this inquiry was limited to surreptitious entries and then only those of recent years. He was informed this would be brought to the attention of the Director and he was thanked for bringing this to our attention.

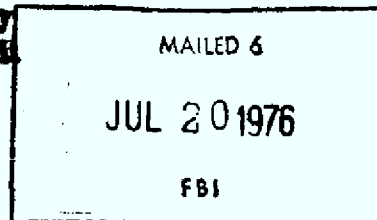

Pursuant to instructions received from Assistant Attorney General J. Stanley Pottinger, Civil Rights Division, no one in your office should communicate or discuss with any Agent who is the subject of captioned inquiry any matter concerning this investigation unless a written communication to these Agents has been approved beforehand by Mr. Pottinger. Of course, an Agent who is the subject of this inquiry and freely chooses to initiate a conversation with a colleague or other Bureau personnel, may do so and is not subject to this rule.

According to Mr. Pottinger, because we are dealing with very sensitive matters involving right to counsel, their concern and what they are trying to avoid is a situation in which an Agent receives a directive, an order, or advice or any other communication, formally or informally, which could cause him not to feel free to cooperate in this investigation consistent with his constitutional safeguards.

In view of our mutual concern as expressed in Departmental memorandum to the Director, Federal Bureau of Investigation, "Re: Surreptitious Entry Investigation," dated 19 July 1976, regarding appropriate protection of classified national security information, with your concurrence, it is my intention to brief the FBI personnel assigned to the Task Force who will be handling such classified information.

As you know, the Agent personnel assigned to this Task Force, by design, were drawn from our complement of Agents who have had little or no experience in security-type investigations. Since these Agents have had little or no experience in matters involving classified national security information, the briefing will be in compliance with Executive Order 11652 which requires that employees handling such classified information must be familiar with the provisions of this Order. The Executive Order requires that agencies handling such classified information establish and maintain active training and an ongoing program for employees having access to classified national security information or material. Such training shall include as a minimum the briefing of new employees and periodic reorientation during employment to impress upon each individual his responsibility for exercising vigilance and care in complying with the provisions of the Executive Order.

Since the FBI personnel assigned to this Task Force have not previously been engaged in security investigations which would familiarize them with the provisions of EO 11652, it is felt that an appropriate briefing regarding the provisions of this EO should be afforded the Agent personnel assigned to the Task Force. This matter was discussed at a conference in Mr. J.B. Adams' Office on 7/23/76, at which time it was the consensus of opinion that the AAG, Civil Rights Division, who is in charge of this inquiry, should be advised of our intention to conduct such a briefing and that his concurrence should be sought.

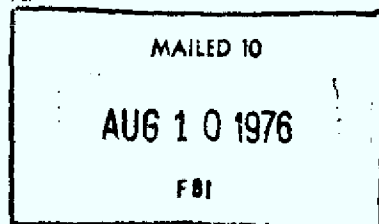

In furtherance of the information set forth in the above-referenced teletype, the CRD has requested me to advise and encourage you to consult counsel, if you have not already done so. For that purpose, you are hereby released from the provisions of your Employment Agreement (FD-291) subject only to the possible need for security clearances of your counsel as discussed below.

My prior communication of June 15, 1976, did not suppose that information and material to be provided to your counsel in connection with this investigation are necessarily classified or subject to the nondisclosure requirements of Title 28, Code of Federal Regulations, Part 17. However, in the event that you believe that material or information provided to counsel is so classified, you should inform your counsel of that belief and advise him that he may contact the CRD for guidance as to whether a security clearance of counsel is necessary and, if so, by what process the clearance can be sought and obtained.

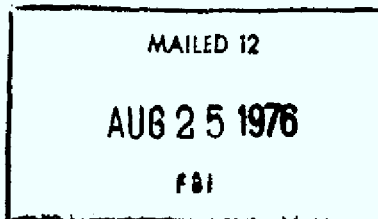

[REDACTED] was contacted by William Gardner of the Civil Rights Division and desired to interview [REDACTED]. Gardner informed [REDACTED] he intended to learn of any and all possible violations of citizens' civil rights by FBI Agents and intended to go back as far as 1940. This was the first indication we have received that the Department's inquiry is not to be limited to surreptitious entries.

On 7-29-76 [REDACTED] Atlanta, advised Assistant Director Leavitt he had been contacted by Gardner concerning surreptitious entries investigation.

[REDACTED] later contacted by a representative of Legal Counsel Division who informed him that he was released from his employment agreement for the purpose of consulting with private counsel if he desired to retain same. [REDACTED] stated that he had retained counsel and upon his advice had declined to be interviewed by Gardner at this time.

During the conversation [REDACTED] stated that Gardner stated he intended to cover the following subjects. The interview was to cover all investigative techniques utilized by Squad 43 and the entire Division 4 of the New York Office. This would include surreptitious entries, wiretappings, COINTELPRO activities, and the identity of Agents participating in above activities. In addition, Gardner stated he desired to learn what level of authority approved the above activities and what levels of authority were aware of such activities and acquiesced in their being conducted.

Dear Mr. Kelley:

Reference is made to your letter, dated July 27, 1976, which was delivered to me on August 3, 1976.

As you may be aware, on June 18, 1976, an individual, identifying himself as William L. Gardner, Chief, Criminal Section, Civil Rights Division, United States Department of Justice (USDJ), Washington, D.C., advised me on the telephone that his Division had the responsibility for an investigation being conducted concerning surreptitious entries made without judicial approval in residences and other buildings which could be violations of Title 18, Sections 241, 242, and 2236, United States Code. Gardner stated that he was in possession of information that I may have had a role in such entries on one or more occasions. Therefore, I was being considered a potential subject of this investigation. In short, Gardner requested that I travel to Washington, D.C., to be interviewed by him in this matter, at which time I would be advised of my Constitutional rights as a subject. He advised that he desired to have this interview conducted as quickly as possible and would appreciate it if I or someone acting on my behalf contact him to arrange for the interview and the conditions under which I would be interviewed.

I told Gardner that at this point, I was undecided as to whether or not I was in need of counsel. Furthermore, I had been instructed not to discuss classified information at this time with an attorney who did not have an appropriate

clearance and therefore if I did decide to obtain legal counsel, I could not proceed in selecting an attorney and advising him of possibly pertinent facts. I told him that other matters and problems of a similar nature were still being resolved at the Federal Bureau of Investigation Headquarters (FBIHQ) and USDJ level which would have a bearing upon my decisions as to choice of counsel.

Gardner advised me that he had on that very day learned of the problem concerned with divulging classified information to independent counsel.

Other similar matters concerning the possibility of my interview were discussed, notably the possible use of a Grand Jury proceeding in New York City in order to obtain a statement from me in this matter. I was also left with the impression that Gardner would recontact me at an unspecified date in the near future. I have not been recontacted by him since our discussion on June 18, 1976.

Concerning your July 27, 1976 letter to me, I can only regard it as a reiteration and confirmation of your previous instructions as set forth in your teletype message of June 17, 1976. In regard to providing information to counsel of my choice, there has never been any doubt in my mind that such information would be of a highly classified nature pertaining to national security matters.

Due to the fact that I have never been advised by the USDJ as to the specific facts which have led the USDJ to consider me a potential subject, I have been put in the potential position of necessarily having to be as liberal as possible in providing information to counsel in an attempt to anticipate the scope of an interview with Mr. Gardner. Therefore, the probability of divulging classified information to counsel, becomes proportionally greater with the amount of information furnished.

As a result of your letter to me, I have initiated contact with an attorney in order to determine his willingness to represent me in this matter. In order to assist me in this regard, I hereby respectfully request that I be furnished a copy of the Employment Agreement (FD-291) executed by me.

Additionally, I hereby request that I be furnished copies of any documents furnished from FBI files to the USDJ which appear to specifically implicate me in any surreptitious entry matter.

Additionally, I hereby request that I be furnished, when available, a copy of the document presently being prepared by the Chicago Division of the FBI relating to the foreign connections of the Weatherman Underground Organization (WUO). This document may provide sufficient evidence that the WUO is properly described as a foreign organization as distinguished from a domestic organization.

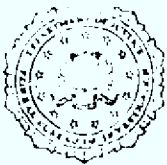
Additionally, I hereby request copies of any documents disseminated to the USDJ in the normal course of business during the period that I was a member of Section 47, at the New York Division, which could reasonably indicate to the reader that a surreptitious entry technique was involved. It is requested that the specific identities of personnel of the USDJ receiving such documents be determined and furnished to me.

Your favorable response to my above-stated requests would indeed be appreciated since I naturally desire to afford the attorney of my choice every advantage in his efforts to provide excellent representation on my behalf.

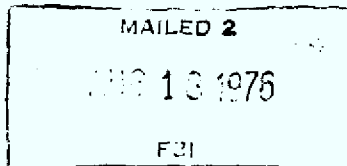

You also stated it was your understanding that a written memorandum confirming the above would be placed in [Redacted] personnel folder for future reference.

My understanding of your telephone call of August 20, 1976, was that you wanted assurances that this Bureau is desirous of Agents cooperating in the surreptitious entry investigation consistent with their Fifth Amendment rights and that the fact of their cooperation would not be held against them at a later date. I did so assure you, but it is not proper to interpret my assurances as any sort of grant of immunity from administrative action as outlined in your letter. DETAILS:

On 8/20/76 [REDACTED] former Special Agent, and [REDACTED] former Assistant United States Attorney, New York, visited LCD and conferred with SA [REDACTED] concerning their client SA [REDACTED] New York Division. Counsel stated their client had been contacted by representatives of the Civil Rights Division concerning captioned inquiry. Their client was not advised that he was a subject of the investigation, but was informed that he would be asked to sign a waiver of rights. They said SA [REDACTED] was visibly upset and emotionally disturbed by this whole incident, particularly as it pertains to his future in the FBI. Their contact with LCD was to obtain a blanket commitment from the Bureau that no administrative action would be taken against their client regardless of the position he took with the Department. They advised that at this time they had not made a final decision as to whether or not they would permit their client to cooperate with the Department or to invoke his constitutional rights. In either event, they desired some commitment from the Bureau that whatever action their client took his future in the Bureau would not be jeopardized.

Both attorneys were fully briefed concerning this investigation and the fact that it is being directed by the Civil Rights Division. They were informed that the official position of the Bureau was that of cooperation with the Department, and that the Director had advised our field divisions that no Agent would be subject to administrative action if he chose to exercise his constitutional rights.\* It was further pointed out that since the Bureau was not in possession of all facts concerning this investigation no commitment could be made other than that set out above. Both attorneys stated they understood that we were not in possession of the facts concerning this inquiry.

\*This means that no action would be based on the fact constitutional rights were exercised. No broader commitment could be given.

By memorandum 8/20/76 I advised that on that date I received a call from [REDACTED] attorney for SA [REDACTED] New York, in connection with surreptitious entries. He said that SA [REDACTED] is desirous of cooperating in the investigation, has been offered immunity, and would appreciate a memorandum being placed in his file to the effect that the Bureau does desire for Agents to cooperate in this investigation consistent with exercising their Fifth Amendment rights. I advised him that this is consistent with our instructions to all offices and, accordingly, a memorandum would be placed in SA [REDACTED] personnel file. A copy of that memorandum was designated for SA [REDACTED] file.

By letter 8/24/76 [REDACTED] referred to our telephone conversation and stated it is his understanding, based upon his conversation with me, that SA [REDACTED] would suffer no sanction, reprimand or administrative action of any kind in connection with his testimony and the facts which he may reveal. It was his further understanding that a written memorandum confirming the above would be placed in SA [REDACTED] personnel folder for future reference.

[REDACTED] letter indicates a conclusion of immunity from administrative action which I did not intend, as I feel there is no basis for granting such immunity. My understanding was that [REDACTED] wanted assurances that the Bureau is desirous of Agents cooperating in the surreptitious entry investigation consistent with their Fifth Amendment rights and that the fact of their cooperation would not be held against them at a later date. It is my understanding that once immunity from prosecution is granted, we are then in a position to require Agents to answer concerning their activities without any assurances that their answers would not be used against them for administrative purposes. You are correct in your understanding that there is no legal bar to our taking administrative action against a Special Agent (SA) based upon information he reveals after being granted immunity from criminal prosecution by the Department. This assumes, of course, that the facts he discloses indicate that he has acted in an unauthorized or otherwise improper manner in connection with his employment.

As you note in the attached memorandum, it would be improper to take administrative action against an SA because of the fact of his cooperation and, of course, we would not wish to do so as the Bureau has indicated it desires to have our employees cooperate fully in this matter, consistent with their own Fifth Amendment rights.

We concur in the suggestion that your response be cleared through Mr. Pottinger because, as a practical matter, such a response could have the effect of lessening an Agent's willingness to discuss fully and candidly his activities. We certainly wish to avoid any possibility of the Civil Rights Division incorrectly construing our response as an intentional effort to lessen cooperation from our employees in the captioned investigation.

This memorandum will confirm conversations held during a meeting on July 13, 1976, with you, Mr. William L. Gardner, Deputy Associate Director James B. Adams and Inspector - Deputy Assistant Director James C. Farrington relative to your memorandum of July 9th, captioned as above, a copy of which is enclosed for your convenience.

In connection with the restrictions set forth in paragraph 2 of your memorandum that no one in the Bureau should communicate or discuss with any subject agent any matter concerning this investigation, unless a written communication to them has been approved beforehand by you, your memorandum to me of July 12th, a copy of which is also enclosed, modifies those instructions to the degree that a subject agent who freely chooses to initiate a conversation with a colleague or other Bureau personnel may do so, and is not subject to this rule. You also agreed that for the purpose of communicating your instructions to those employees involved, we should only notify those field offices to which the subject agents are currently assigned and FBI Headquarters personnel. Attached is a copy of such communication which was telephonically read to you by Mr. Farrington on July 16th and which you approved for transmittal as indicated above.

With regard to paragraph 3 of your July 9th memorandum, you were assured that we would not tolerate any employee hampering or interfering with this inquiry in any manner. In addition you were also assured that another agent would handle, as far as possible, any classification problems arising in connection with this inquiry and particularly in connection with classification questions arising as to documents or information involving the Weather Underground. However, it was also noted that we reserved the right to consult with [redacted] from time to time in his capacity as the Bureau's Classification Officer.

In connection with the current investigation being conducted by the Civil Rights Division (CRD) concerning surreptitious entries, I advised all Special Agents in Charge by teletype of June 15, 1976, that the Bureau was cooperating with the CRD in this inquiry and encouraged those employees contacted and informed that they are subjects of this investigation to also cooperate. In furtherance of the information set forth in the above referenced teletype, the CRD has requested me to advise and encourage you to consult counsel, if you have not already done so. For that purpose, you are hereby released from the provisions of your Employment Agreement (FD-291) subject only to the possible need for security clearances of your counsel as discussed below.

My prior communication of June 15, 1976, did not suppose that information and material to be provided to your counsel in connection with this investigation is necessarily classified or subject to the nondisclosure requirements of 28 C. ## PURPOSE:

On June 16, 1976, and June 13, 1976, William Gardner, Departmental Attorney, Civil Rights Division, Washington, D.C., advised Special Agents [REDACTED] and [REDACTED] respectively, that the Justice Department is currently conducting an inquiry concerning allegations that FBI Agents surreptitiously entered private premises in New York, New York, within the last five years and stated that Special Agents [REDACTED] and [REDACTED] are both considered subjects of this inquiry. Mr. Gardner requested that Special Agents [REDACTED] and [REDACTED] travel at Government expense to Washington, D.C., for the purpose of being interviewed by Government officials. Mr. Gardner also suggested that Special Agents [REDACTED] and [REDACTED] might consider obtaining private counsel in this matter. Special Agents [REDACTED] and [REDACTED] have both obtained private counsel to represent their interests in this matter.

Special Agents [REDACTED] and [REDACTED] were both formerly assigned to the New York Division, Special Agent [REDACTED] having been assigned there from July 1968 until January 1973, and Special Agent [REDACTED] assigned there from February 1971 until August 1975. Due to the period of time that has transpired since their initial assignment to the New York Division and due to the voluminous amount of material handled by them during this period, many facts pertaining to their investigative activities while assigned to New York have become uncertain. Both of these Agents feel that in order to properly discuss this matter with Departmental attorneys, other Governmental officials or their own attorneys, it is necessary that they review the files contained in the New York Division so as to refresh their recollections as to the events and circumstances out of which the current allegations arose.

Therefore, Special Agents [redacted] and [redacted] have requested that they be permitted to travel to New York City in an official business status at Government expense, for the purpose of reviewing files maintained there, these files being otherwise unavailable to them.

It would appear to the Special Agent in Charge, Detroit Division, that such travel should be authorized in the interest of justice and so that all of the facts surrounding these allegations can be brought to light. Due to the varied investigative assignments and cases that Agents work during the span of a five year period, it is understandable that recollections become clouded and uncertain. Prior to these Agents answering any inquiries that the Government might have concerning the allegations against them, they should be permitted to review the files in the New York Division pertaining to their investigative activities while assigned there. Special Agents, currently assigned to the New York Division and against whom similar allegations have been made, have been afforded the opportunity to review these files. In addition, at least one other Special Agent has been permitted to travel at Government expense from one field division to another for the purpose of reviewing files to refresh his recollection in this matter. To deny Special Agents [redacted] and [redacted] this same opportunity to refresh their recollection would be grossly unfair and unjust.

The Special Agent in Charge, Detroit Division, strongly recommends that Special Agents [redacted] and [redacted] be authorized to travel at Government expense from Detroit, Michigan, to New York City, for the purpose of reviewing files maintained by the New York Division.

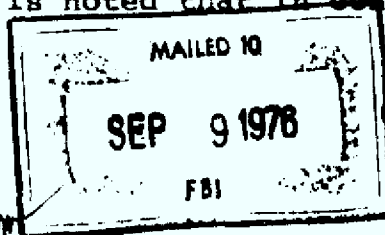

In connection with the Civil Rights Division investigation into surreptitious entries, certain Agents were subpoenaed to appear before a grand jury impaneled in the Southern District of New York and the attorney for these Agents is attempting to quash the subpoenas for various reasons, including the fact that members of the grand jury have not been cleared to receive classified information and the Agents are not able to reveal such classified information pursuant to national security regulations.

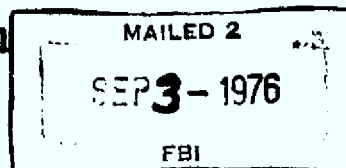
Special Agent [REDACTED] has been subpoenaed to appear before a grand jury in Washington, D. C., on September 3, 1976, and although his attorney attempted to defer his appearance pending resolution of the motion in New York such action was not agreed to by the Civil Rights Division.

[REDACTED] has advised that because the Weatherman investigation has been held by the Department Review Committee to be a national security investigation, and sources and methods of intelligence related thereto are classifiable, he is requesting that you be asked to resolve the conflict between his subpoena to testify and restrictions imposed by Title 28, CFR, Sections 17.3 and 17.64 and Executive Order 11652. In view of the dilemma and after discussing the matter with his attorney, he has advised he intends to decline to testify and has furnished a copy of the statement he intends to make as the reasons for his declination.

In order that this Bureau may appropriately advise [REDACTED] and other employees confronted with this situation, I respectfully request your early consideration of this matter.

I have received the copy of your letter to Attorney General Levi dated August 26, 1976.

I know you would want to know in connection with the current investigation being conducted by the Civil Rights Division (CRD) concerning surreptitious entries, I advised all Special Agents in Charge by teletype dated June 15, 1976, that the Bureau was cooperating with the CRD in this inquiry and encouraged those employees contacted to also cooperate.

In my communication of June 15, 1976, referred to above, I did not suppose that information and material to be provided to counsel in connection with this investigation are necessarily classified or subject to the nondisclosure requirements of Title 18, Code of Federal Regulations, Part 17. However, in the event that information you propose to provide to counsel is so classified, you should inform him of that belief and advise him that he may contact the CRD for guidance as to whether a security clearance of counsel is necessary and, also, by what process the clearance can be sought and obtained.

In response to your request, you are hereby released from the provisions of your Employment Agreement (FD-291) subject only to the possible need for security clearance of your counsel as discussed above.

DETAILS: When the CRD's investigation into surreptitious entries was initiated, we were furnished a list of Agents who were considered subjects of the inquiry. Many of these Agents contacted FBIHQ advising they were consulting private counsel and were desirous of being released from their employment agreement. At this time, a letter was prepared by Legal Counsel Division which it was felt would suffice for this purpose.

On 7/29/76 [REDACTED] Atlanta Division, telephoned Legal Counsel Division to report a contact by a representative of the CRD. This representative stated that he desired to speak to [REDACTED] concerning the CRD's inquiry. [REDACTED] stated that he informed the Department representative that he desired to consult with private counsel, and that he was contacting the Legal Counsel Division to request a release from the provisions of his employment agreement. On 8/ 9/76, we forwarded the above-mentioned letter. This letter uses the sentence, "The CRD has requested me to advise and encourage you to consult counsel, if you have not already done so." This sentence was based on discussions between representatives of the Legal Counsel Division and the Department.

By letter dated 8/13/76 [REDACTED] took exception to this sentence and stated that he believes it prejudicial, as it implies that he is being investigated as a subject. He requested that our letter be removed from his personnel file and the record be made clear that he was contacted by the Department for interview only.

The letter which was prepared by Legal Counsel Division for submission to Agents who have requested release from their employment agreements was designed to fit all categories, i.e., subject or witness, and was not intended to infer that anyone was a "subject," "suspect,"

This was based on the fact that many of the Agents contacted by CRD are no more than witnesses in this investigation. The Department has advised, however, that people interviewed can subsequently become subjects as the result of additional investigation.

In view of the above, Legal Counsel Division will no longer notify Agents who retain private counsel that they are being released from their employment agreement unless we determine that they have been designated a subject of the investigation, or unless they specifically request to be released. In line with this, it is recommended that attached letter to [REDACTED] be approved and sent. We recommend that [REDACTED] letter and our answer be retained in files as evidence of our intentions.

## SYNOPSIS AND DETAILS:

Attached is a memorandum I received from the Assistant Attorney General, Civil Rights Division, and its enclosures, a letter dated September 7, 1976, from the Attorney General to the Assistant Attorney General, Civil Rights Division, and a copy of a memorandum from the Director to the Attorney General dated September 3, 1976, captioned "Surreptitious Entries Classification Matter."

The Director's memorandum to the Attorney General of September 3 requested advice concerning the appearance of Special Agent [REDACTED] before a grand jury pursuant to a subpoena and the possible conflict between his potential testimony and restrictions imposed by the Code of Federal Regulations and Executive Order 11652. The Attorney General's letter to Mr. Pottinger dated September 7 appears to provide the resolution of the problem described in the Director's memorandum.

## RECOMMENDATION:

That Special Agent [REDACTED] be advised that the letter from the Attorney General to Mr. Pottinger appears to have resolved the potential conflict between his testimony and the restrictions imposed by the Code of Federal Regulations and Executive Order 11652.

In connection with the Civil Rights Division investigation into surreptitious entries, certain Agents were subpoenaed to appear before a grand jury impaneled in the Southern District of New York and the attorney for these Agents is attempting to quash the subpoenas for various reasons, including the fact that members of the grand jury have not been cleared to receive classified information and the Agents are not able to reveal such classified information pursuant to national security regulations.

Special Agent [REDACTED] has been subpoenaed to appear before a grand jury in Washington, D. C., on September 3, 1976, and although his attorney attempted to defer his appearance pending resolution of the motion in New York such action was not agreed to by the Civil Rights Division.

[REDACTED] has advised that because the Weatherman investigation has been held by the Department Review Committee to be a national security investigation, and sources and methods of intelligence related thereto are classifiable, he is requesting that you be asked to resolve the conflict between his subpoena to testify and restrictions imposed by Title 28, CFR, Sections 17.3 and 17.04 and Executive Order 11652. In view of the dilemma and after discussing the matter with his attorney, he has advised he intends to decline to testify and has furnished a copy of the statement he intends to make as the reasons for his declination.

In order that this Bureau may appropriately advise [REDACTED] and other employees confronted with this situation, I respectfully request your early consideration of this matter.
