I. BACK TROUND

The CHLA was chartered in 1933 to render legal and protective services to its members who operate laundries in the New York City area.

advised on June 20, 1957 that the CPIA was infiltrated and controlled by Communists during the 1930's and most of the Communists who gained control of the CPIA are still in control of it at the present time.

A confidential informant who has furnished reliable information in the past on March 25, 1955 advised that when he was last conversant with such activity in 1952, a group of persons within the CHLA, whom he described as Communists, had as their purpose the furtherance of Chinese Communist interests in the New York City area by operating through the CHLA.

The October 12, 1949 issue of the "China Paily News" (CDN) reflected that at a meeting held at CPLA headquarters in New York City on October 9, 1949 to celebrate the founding of the "Peoples Republic of China" as well as to celebrate the Chinese National holiday the five star flag of the "New Government" was flown and expressions of loyalty and support thereto were voiced by speakers.

II. LOCATION

The CHLA is located at 191 Canal Street, New York City, and utilizes the entire second floor of that loft building.

The highly confidential and anonymous source will be contacted at that address.

III. SECURITY ASPECTS

The building at 191 Canal Street is a six story brick loft building structure. The CHLA occupies the entire second floor. The other occupants of the building are as follows:

The fourth, fifth, and sixth floors are vacant.

CO., have burgler alarm systems; however, they are individual systems and operate seperately and individually. There is no alarm system for the CYLA or for the building itself. The street door of the building has a lock on it; however, a key is available.

It has been determined through surveys that all business activity ceases at 191 Canal Street no later 9:00 pm. The only maintenance personnel on the premises is the elevator operator who ceases work and leaves the building at approximately 5:00 pm. The main business activity in the area ceases at approximately 6:00 pm, and virtually all business activity terminates at about 2:00 am in the surrounding area. Surveys have indicated that traffic, both vehicular and pedestrian, is at its lowest ebb between 2:30 am and 5:00 am.

From June 13, 1956 through June 26, 1956, pretext telephone calls were made to the CPLA at various times in the early morning hours between 1:00 and 6:00 am and no answers were received.

The main activity of the CHLA is centered on the weekend periods, mainly on Sundays. Surveys have indicated there is usually no one in the main rooms of the CHLA after 9:00 pm at night and a source has advised that the CHLA usually opens around 11:00 am on weekdays.

A survey conducted on the night of August 1-2, 1957 from 9:00 pm on August 1 to 8:30 am on August 2, 1957 indicated that the CFLA was unoccuppied during that period. No activity at all was noted.

A survey of the CHLA was conducted on the evening of August 5-6, 1957 and it was conducted from 8:30 pm on August 5 to 8:00 am on August 6, 1957. At the beginning of the survey it was noted that

a light was on in the back of the CHLA and the windows were open.

At 10:40 pm a Chinese male was observed closing the win-dows. He did not close them completely but left them slightly open.

A minute or so later, the light went out and at 10:45 pm three Chinese males emerged from the street entrance at 191 canal Street and walked west along Canal Street.

From then until the end of the survey the CHLA was in complete darkness and no further activity was noted.

It is contemplated that physical surveillances will be placed on the CHIA from 9:00 pm until 8:00 am for two days prior to the development of the contemplated source, and from 9:00 pm on the evening before up through the development of the source. Spot telephone calls will be made to the CHIA at various times in the early morning hours in order to determine if anyone is in there.

It is believed that the best for the assignment to take place is between the hours of 2:30 am and 4:00 am, on a weekday morning.

Security will be assured prior to entry on this operation.

IV. PURPOSE OF THIS ASSIGNMENT

It is expected that the highly confidential and anonymous source will make available both membership and financial statements of the CPLA. It is also expected that the official relationship between the CPLA and CDN as well as the general Chinese Communist activity in the New York area, will be established. It is also felt that this source will establish that liaison exists between the "Peoples Republic of China", and the pro-Communist element in the United States. This source may also disclose any official connection between the CPUSA and the pro-Communist Chinese groups in the United States.
