





on 28/76, a comprehensive review of the material contained in this volume was conducted by me. There is no question in my mind that each and every item, with the exception of the top serial which is a memorandum from dated 7/14/72 which should remain unclassified, contained in this volume requires classification of at least "Confidential", exemption category 20, (intelligence sources and methods) with an imperior declassification.

Departmental attorneys assigned to the Civil Rights Division who recently conducted investigation in the NYO, had access to this volume and made xerox copies of six memoranda covering the period from 4/3/70 to 7/14/72. Five of these memoranda, in my opinion, warrant classification of "Confidential", have been individually so stamped, and the Bureau will be requested by teletype to handle appropriate classification at the Department.

The classifying officer is myself, #6392, and the date of the classification affixed as \$/28/76.
