Buffalo is making no local dissemination of instant LHM, and whether or not any dissemination should be made at SOG is being left to discretion of the Bureau.

The information set forth in instant LHM is being furnished to the Bureau and interested offices principally because of the serious nature of the alleged information furnished and Miss CALDWELL's prominent position as a world-famous hovelist, although previous experience with Miss CALDWELL demonstrates she has a penchant for intermingling fact and fiction indiscriminately, and has, in the past, published an article bearing on the internal security of the Completely fictional.

Miss CALDWELL is now attempting to twist information recently furnished by her as evidencing advance information concerning the death of Senator KENNEDY, despite available facts as set forth in referenced LHM definitely indicating otherwise.

Specific attention is directed to the fact as set forth in instant LHM that when telephoned Miss CALDWELL on June 4, 1968, she said she was unavailable for interview because she was hurrying to go to the hospital to see her husband who was on the brink of death. On June 6, 1968, she told that after talking with him on June 4, 1968, she had gone out to the front of her home to plant flowers.

Because of Miss CALDWELL's known unreliability, no action is recommended on the information being furnished by her, other than possible dissemination by the Bureau of this information because it is very possible Miss CALDWELL may proceed to furnish the same information to other governmental agencies, or may proceed to publish the information she has furnished.

At 3:45 P. M., on June 6,1968, a telephone call was received at the Buffalo Office of the Federal Bureau of Investigation from TAYLOR CALDWELL, an authoress, whose true name is Mrs. JANET T. C. REBACK, and who resides at 34 Audley End, Buffalo (26), New York.

Miss CALDWELL immediately referred to a letter she had recently mailed to the Buffalo Office of the Federal Bureau of Investigation predicting "that something terrible was going to happen," to the fact that on June 4, 1968, a Special Agent of the Federal Bureau of Investigation had telephonically discussed this letter with her, and she stated she now wished to furnish additional developments.

She said that on the afternoon of June 4, 1968, shortly after discussing her letter with a Special Agent of

the Federal Bureau of Investigation, she had gone outside to plant some flowers in front of her home. While so engaged, she noticed a young man on a motor bike ride by in the street in front of her home several times. Finally, this young man stopped directly in front of her home and commenced speaking with her. She states she was surprised to see on close observation that this young man was a Negro, whereas when she had seen him from a slight distance, he appeared to be Caucasian.

According to Miss CALDWELL, the first thing this young Negro said to her was, "Do you know DONALD JACKSON?"

Miss CALDWELL said she replied, "I know him well." (Miss CALDWELL explained at this point that she knows a Negro in Buffalo named DONALD JACKSON, who is head of the Donald Jackson Foundation, the purpose of which is to raise money to provide educational scholarships for meritorious and needy Negro students. She stated that she has given financial and other assistance to DONALD JACKSON, and immediately assumed that this is the DONALD JACKSON the young man was inquiring about.)

Miss CALDWELL went on to state that the next thing the young Negro said to her was "Did you tell Secret Service what our friend in New York wanted you to tell them?"

Miss CALDWELL said she replied, "You mean about the Negro woman?"

The young man allegedly said, "No! No! You've got that mixed up."

Miss CALDWELL allegedly replied, "I told the FBI."

The young Negro then allegedly replied, "You should have told the Secret Service. Anyway, it's too late now."

Miss CALDWELL stated that almost immediately thereafter, the young Negro drove away on his motor bike, the entire conversation having lasted about one or two minutes. She stated that she had never seen this young Negro before, and described him as about 19 years of age, wearing a dark sleeveless shirt, blue jean trousers, and as being very well spoken. She conjectured he is a student because strapped on the back seat of his motor bike had been two or three text books.

Miss CALDWELL stated she had been completely startled when she had heard the young Negro refer to "our friend in New York," but had immediately assumed that the reference made was to the Negro businessman in New York City who had recently written to her that "something terrible is going to happen."

Miss CALDWELL then made reference to the recent assassination in Los Angeles of Senator ROBERT F. KENNEDY and proceeded to speculate that perhaps this was the "terrible thing about to happen" that her Negro friend from New York City had written to her about, and which information she in turn had forwarded to the Federal Bureau of Investigation. She acknowledged that in her letter to the Federal Bureau of Investigation, she had described the incident about to occur as involving an unknown Negro woman, but now wondered whether she may possibly have misinterpreted the Negro businessman's letter. She speculated that perhaps what the Negro businessman had been trying to tell her was that a Negro woman was to be involved in the incident in some way, but not necessarily as the victim.

Miss CALDWELL concluded by stating she felt Senator KENNEDY's death was more than just a mere coincidence, that she is "not a believer in coincidence," and that there must definitely be some connection between the information she had previously received and Senator KENNEDY's death.

Attention is directed to the fact that Miss CALDWELL in her telephone call of June 6, 1968, to the Federal Bureau of Investigation, stated that her conversation with the unidentified young Negro occurred while

she was planting flowers in front of her home on the afternoon of June 4, 1968, and that she also stated she had gone outside to plant these flowers shortly following a telephone conversation with a Special Agent of the Federal Bureau of Investigation, on June 4, 1968.

It is noted that a Special Agent of the Federal Bureau of Investigation did, in fact, have a telephone conversation with Miss CALDWELL from about 4:35 P. M. to 4:50 P. M., on June 4, 1968. During an earlier telephone call to the CALDWELL residence on June 4, 1968, the Special Agent was told by a housekeeper, who answered the telephone, that Miss CALDWELL was asleep, that it is Miss CALDWELL's practice work through the night and sleep during the day, and that about 4:30 P. M.

When the Special Agent of the Federal Bureau of Investigation did telephonically contact Miss CALDWELL at about 4:35 P. M., on June 4, 1968, he requested a personal interview with Miss CALDWELL concerning a letter which had been received from her earlier that day. Miss CALDWELL replied she was not available for interview then because she was hurrying to get ready to visit her husband, who is in the hospital on the brink of death, and that because of her busy schedule, she would have no time for a personal interview for at least two weeks or perhaps longer.

This office is in receipt of a letter dated 10/16/57 signed by JANET M. REBACK (pen name Taylor Caldwell) of 34 Audley End, Eggertsville, N. Y. The letter has been appropriately acknowledged.

In this letter REBACK referred to one HERBERT HARRIS whom she met in 1928 at Hornell, N. Y. At that time, HARRIS was a young man and a graduate of the University of Syracuse.

REBACK alleged in her letter that in 1928 HARRIS "attempted to convert me to the Communist viewpoint."

Subsequent to 1928, REBACK had occasional contact with HARRIS. In 1941 or 1942, he "called" her from Washington and stated he had been appointed to a position in Washington "to help fight the Nezis and save our noble Ally, Russia."

REBACK had no further contact with HARRIS until recently when "someone" informed her that HARRIS for years has been holding an important position in the State Department; "writes text books and other propaganda for that Department" and guides opinions of State Department officials.

Dear Mr. Roche:

A long time ago, 1928, in fact, I met one Herbert Harris in Hornell, N. Y. He is a graduate of the University of Syracuse. I and numerous talks with Mr. Harris, who was quite a young man then, and it was my first encounter with the Communist jargon, in its purest and most uncompromising form. He attempted to "convert" me to the Communist viewpoint, but it was repugnant to me. I was 27 years old at the time, and knew nothing of Communism - but its doctrines as expounded by Herbert Harris, were particularly distasteful to the. I was with the U. S. Immigration Service in Buffalo, then, and after my return from Hornell I talked over the Communist doctrines with my present husband, Marcus Reback, who was with the Service until he retired in 1950. He told me then that it was his opinion that Mr. Harris had been infected by Communism.

Mr. Harris came to see me in Buffalo several times thereafter, but our friendship dwindled, if there had ever been a friendship. In 1941 or 1942, he called me from Washington, very jubilant, and told me he had been appointed to a position there, "to help fight the Nazis and save our noble Ally, Russia." I am not certain of the Department to which he was appointed then, but I remarked to my husband, at the time, that I could not understand why a man of his convictions had been chosen by Washington to Help in the War Effort, "as the jargon was in those days.

I forgot all about Mr. Harris until recently, when someone informed me that he now held a most important position in the State Department - a position he has been holding for years - and writes text books and other propaganda for that Department, and "guides opinions of State Department officials." To say that I was shocked is an understatement. Of course, we all know that Communists have done, and still do, a great deal of pro-Communist work in the State Department, but Mr. Harris is the only one I know personally.

When Mr. Harris called me from Washington, in 1942, it was because he wished me to write material in behalf of "democracy," heavily weighted with good feeling towards Russia. I declined. - For a number of years, from about 1941 to 1947, the Government would buy at least 2,000 copies of my books for the armed forces and for our overseas libraries. Then, from 1947 on the State Department ceased to buy my books. When my book, THE DEVIL'S ADVOCATE, was published in 1952, (an out-right attack on Communism abroad and particularly in the United States,) the State Department wrote, prior to publication, and asked for galleys on the book, as my publisher had done a great deal of prepublication publicity on the theme of the The ostensible reason, as the State Department wrote me, "was to get you foreign publishers. " This was absurd, as the Government, until 1947, had not only been buying thousands of copies of each of my books, but had been sending them to our overseas libraries and for the armed services, and knew very well that we had always had foreign publishers. In fact, the Government had been buying foreign translations of them.

My husband, who is my collaborator and business manager, wrote to the State Department, informing them we had always had foreign publishers; he named them. Before the publication of the book in the United States, all our foreign publishers had cabled us for galleys, which were duly sent. At no time had any of them refused a book; they were particularly enthusiastic about the galleys of THE DEVIL'S ADVOCATE. Then, all at once, our English, Swedish, Norwegian, Dutch and Danish publishers rejected the book, with lame excuses. Only France, Italy and Spain took it; our French publisher said, "No matter who brings pressure to bear on me not to publish it, I am going to publish it!" He made no other comment.

I know coincidences happen, but I am now wondering if Herbert Harris, in his high position in the State Department, has not had a hand in this, and if he has not been behind the sudden decision of the Government not to buy any more of our books for overseas libraries and the armed services, and the pressure which was put on our foreign publishers not to publish THE DEVIL'S ADVOCATE.

I am the only major best-selling novelist in the United States who is not tainted by "liberalism" and Communism, and who has never belonged to a Communist front. As a result the press, which is mainly "liberal," has been furiously attacking me for years in their alleged "reviews." It seems, according to a raft of reviews now coming in about our new book, 'THE SOUND OF THUNDER, " that, because I state over and over again in this book, and in nation-wide talks, that a man's first duty is to God and his country, and that Communism is a vile heresy against the nature of God and man, that my ideas are "anachronistic" and "edectic," One major review was particularly abusive, stating that the book was "unaccountably weighted on the side of religion. " Apparently the American Communists, and their fellow-traveling liberals, having scored such triumphs against Joe McCarthy, the House an-American Committee, and the FBI, feel strong enough now to attack religion in accordance with their directives from Moscow. - The New York Times, who used to give us marvelous reviews until 1946 when they discovered we were not "liberals," always reviewed our books, though abusive since 1946. They have not reviewed THE SOUND OF THUNDER, which is unprecedented. As one of their editors wrote me in February, 1951, "If you wrote WAR AND PEACE tomorrow, we'd give you no credit for it. (Our) critics are laying for you. " In our bitterness, we are beginning to wonder what protection an antiCommunist has in the United States now, had we been Communists we'd have had the enthusiastic support of the press and would now be very wealthy! for, as liberal writers told me in New York, with contempt, that had we been "liberals" we'd not have had to pay any taxes, or only token payments. Perhaps if my husband had fought with the Spanish Communists, as did Hemingway, we'd now be the darlings of the American press and the Government.

I had always had my suspicions of a psychiatrist in Buffalo, one Dr. Samuel Yochelson, of whom I wrote you before. We broke off friendly relations with him several years ago, as his proCommunist remarks angered us. He bragged to us that he had three agents of the Internal Revenue Service "in the palm of my hand," and that he was treating these men. At one time he was so angered, in 1949, by my condemnations of Communism, that he warned me I would "get into trouble." I have just heard, through a friend, that he has been openly boasting that he "set" the Internal Revenue Service on us, to "put us out of business," "with their fascist ideas." I knew the man was a fool, but this has gone beyond folly. He laughed to me, in 1952, that people write to the FBI, accusing him of Communism, and that the agents immediately run to him to tell him of this, and laugh with him. I cannot believe this, though. If we

lose the FBI America will be lost. Sincer

Dear Sir:

This will be my very last letter to the Department of Justice before turning to the East German Government, and asking the help of the Communists. I am NOT a Communist, but the Department of Justice is FORCING me to turn to the Communists in East Germany to ask them to bring my cry for help to the attention of the whole world and to let the people in foreign countries know about the inhuman treatment which I have received as a Nazi victim in the United States, and that for more than four years I have had to flee from one part of the country to another in fear of my life, because the authorities in Washington have refused to give me any help.

For six years I have written numerous letters to the Department of Justice, asking them to make an investigation in my case, asking them to let me prove that am the helpless victim of my former husband and a group of dangerous criminals and leading politicians -- among them two murderers -- all of whom have the protection of the authorities in Washington D.C. But nothing has changed my fate. On August or to force my former husband to return my passport and my other identification papers, so that I can leave the country. Up to date I have not received any answer. Being born in East Germany and left without identification papers, the Department is FORCING me to turn to the Communists.

To get the true idea of what is going on among high officials in the present government of the United States, I shall give the manuscript of my book, "What is Going On Behind the Iron Curtain in the U.S." with all the details of my long suffering into the hands of the Communists, together with numerous items of evidence to prove to the world that the present government is the biggest law-violator in the United States, and that the government itself has no respect for the Constitution and the laws of the U.S.

I shall not keep secret from the Communists that I have been denied citizenship papers, because I was not willing to sell my body to other men to whom my exhaust a wanted to hire me out for money, and that I was denied citizenship papers because I wanted to live a clean and honest life, and refused to continue my life as a tool of a criminal and murderer, who has the protection of the highest officials in Washington.

I shall report to the East German government that income tax evasion is a crime in the U.S., and will be prosecuted, but NOT when the income tax evader has the protection of the top officials in Washington, or when his daughter is working as a secretary in the White House. With the evidence in my possession I SHALL PROVE THESE FACTS to the East German government. I shall prove still other facts, not only in my case, facts which would shock the newspapers in the United States, when they learn the truth about a case when the truth was never learned. I am going to reveal this to the East German Government.

I shall prove to the Communists that for a gambler, swindler, tax evader and murderer in the U.S. it is only a question of money to win a law suit, and that I was not even allowed to appear in court for my divorce hearing (after I filed for divorce), and was threatened by the District Attorney with being committed to a mental institution for the rest of my life, should I appear in court for the divorce hearing. I was sentenced as the guilty one, because I wanted to remain honest and live a clean life, and refused to continue my life as a tool for a criminal.

I shall report to the Communists that I - being a Nazi victim with a very har fate, and with prison and concentration camp already behind me before I came to the United States (my first husband was murdered in a Nazi concentration camp), was robbed in the United States of my very last belongings, even my passport and identification papers, and was NOT allowed to have my papers back.

I am able to PROVE every statement made in my book about the inhuman treatment which I have received as a foreign woman and a Nazi victim in the United States, and I have not only named the individuals and top officials involved, regardless of rank or position, but I also shall give the copies of my letters, which I have sent to these individuals and top officials, asking for help and protection. I received no help. Since I sent all my letters by registered mail, these noble Americans will not be able to deny it when their names come to the attention of the people in the world, revealed through the East German government.

ment of Justice, I shall prove to the East German Government, that the Department knew that I am left without any papers, and being born in East Germany, the West German government is unable to give me a new passport so that I can leave the country and ask for asylum in another country until the people of the United States have elected a government which will respect the Constitution and the laws of the United States. The Department has done nothing in the matter.

I shall also prove to the Communists that the Department KNEW that I have been forced to flee continuously from one part of the country to another in fear for my life, and instead of doing something for me to give me the chance to prove that I am a helpless victim of a group of dangerous criminals, the Department has threatened that I will be put in jail, if I do not surrender.

I shall prove to the Communists that I wouldn't have to live in hiding and flee continuously, if the Department itself didn't violate the laws and protect those criminals and individuals who are involved in my case.

In my book which will be given into the hands of the East German government, I will prove that a foreign woman in the United States can be hired out to other men like a slave, with the knowledge and consent of the authorities.

I shall report to the Communists in East Germany, that in the past 6 years I have written many thousands of letters, not only to all top officials, Congressmen, Supreme Court Justices, all Committees on Un-American activities, ALL Church Leaders in the U.S., ALL leading Churches in the U.S., many times to all leading newspapers but also twice to President Eisenhower, from whom I received no acknowledgement of my letters. Nothing has changed my pitiful life, and I have to continue to flee and move around, to work with all sorts of tricks, as I don't possess any identification papers, and can not even prove that I am born. I have not found ONE SINGLE true American in the whole United States WITH THE POWER AND THE COURAGE to help me. I shall tell the East German Government that this is the reason, that I -- who am not a Communist -- am forced to ask the East German Government to help me to get out of the hands of those criminal elements, all of whom are leading politicians, by publishing my true story about my horrible experiences in the U.S., in as many languages as possible, to make the people in the whole world know how the present U. S. Government is working officially with the criminal elements so that no honest and true American can do anything to stop it.

A copy of this letter will be sent to all members of the United Nations, all foreign Embassies and Consulates in the U.S., and all leading newspapers in Europe, to prepare the people and the governments of European countries for the things ahead, and to let them know that the authorities in Washington are responsible for the events which might develop.

I am giving herewith the Department of Justice one very last chance, either to make an investigation in my case, as soon as possible, in open court, and in the presence of newspaper reporters, as I want to leave the United States as soon as government for help.

If you should want to contact me, you may notify the West German Government in Bonn, as they know where I am in hiding. Should I not hear from the West German government by March 3, 1958, I shall charge my co-workers abroad to hand over the manuscript of my book, with the originals of my documents of evidence, to Messrs. Ulbricht and Grotewohl, of the East German Government.

Again I want to repeat that I am NOT a Communist. If I were, I would not have lived for more than four years as a fractive, as if I had been the criminal, but would have asked the East German Government long ago to bring my case to the attention of the whole world.

Should I be forced to ask the Communists for help, I want to remind the Department that the present U. S. Government will be responsible for the consequences, not only toward their own people, but also toward their Allies, and not the least, toward the people in their Allies' countries.
