The Lowndes County, Alabama, Grand Jury on 4-22-65 returned an indictment against subjects William Eaton, Collie Leroy Wilkins and Eugene Thomas, charging them with the murder of Mrs. Viola Liuzzo in Lowndes County on the night of 3-25-65. They were arrested on the indictments on 4-22-65 and released on \$10,000 bond each. The three subjects are represented by Klan Attorney, Matt Murphy of Birmingham, Alabama, and according to press reports, Murphy has stated that he would subpoena FBI Director, John Edgar Hoover and President Lyndon Johnson for the trial scheduled for 5-3-65.

The possibility of the issuance of a state subpoena for the Director and President Johnson was discussed with Departmental Attorney, John Murphy, 4-23-65, and Murphy advised that such a subpoena would have absolutely no force and effect outside of the boundaries of the State of Alabama. The law on this point in general states that the subpoena of one state has no extra territorial effect and cannot compel the attendance of witnesses not within the state. He stated that there exists between some states an agreement concerning the production of witnesses. However, the persons involved here reside in the District of Columbia and the District of Columbia has no such agreement with any state.

It is noted that since the presence of the Director and the President cannot be commanded at the trial of this matter in Alabama, any appearance made in answer to the subpoenas would of necessity be voluntary and appropriate only if their appearance could serve the ends of justice. Neither the Director nor the President could testify to the direct facts of the case from a personal observation or participation, and therefore, their appearance would not in any way enhance the ends of justice and would be irrelevant to the trial issue.

## Rowe Hides Face At Birmingham Hearing

AN ATTORNEY Matt H. Murphy Jr. of Birmingham, who represented all four of the defendants, confirmed yesterday that he had been unable to locate Rowe since the charges were dropped.

Murphy said it "may have been true" that Rowe was an informant prior to the Luzzo case, but he warned that Rowe may backfire in more than one. There are such cases as counterspies."

The attorney, predicting that Rowe will be "tremendously embarrassing to the federal government," said he plans to file a writ of habeas corpus to force the FBI to reveal "where they are detaining my client."

Murphy was listed as attorney for all four Klansmen when they were arrested on March 27, the day after the killing. Dismissal of the complaint against Rowe apparently came as a surprise to Murphy.

ABELIEB, Murphy had accused the FBI of trying to bribe Rowe to give information.

The four Klansmen were charged with violating Mrs. Luzzo's civil rights. The Justice Department declined to explain why it withdrew the complaint against Rowe.

Eugene Thomas, 42, steel worker of Fairfield; William Orville Eaton, 41, former steelworker of Bessemer, and Collie Leroy Wilkins Jr., 21, auto mechanic of Fairfield, are free under \$50,000 bond each on the charges.

When Rowe was arrested federal officials told the press the Klansman was "unemployed."

Alabama Atty. Gen. Richmond Flowers has said he will ask the Lowndes County grand jury, which convenes Monday, to return murder indictments in the case. He indicated only three indictments would be sought.

ANY LINKS between Rowe and the FBI prior to the Luzzo killing would add another strange twist to an already unusual and controversial case.

The day after the murder, President Johnson, in an unprecedented television address, announced the four arrests, identified the defendants as Klansmen, and bitterly denounced the "hooded society of bigots."

To some this sounded like the President had prejudged the guilt of the defendants before an audience of millions. Klan leaders complained bitterly and the American Civil Liberties Union said the President's announcement was incompatible with a system of justice that presumes the defendant innocent until proven guilty.

# Charges Against One of Four Accused Ku Kluxers Dropped

MONTGOMERY, Ala. (AP) — Justice Department dropped charges yesterday against a Birmingham man who was arrested within hours after a March 25 civil rights slaying of a Detroit housewife.

The order dismissing a conspiracy charge against Gary James Rowe Jr., 35, was issued by U.S. Commissioner James M. Guttery.

The motion to dismiss the charge came from Asst. U.S. Attorney J. O. Sentell.

Washington, a Justice Department spokesman said dismissal of the charge was a tactical action since the grand jury failed to indict Rowe. The spokesman did not comment

Rowe was arrested with three other Birmingham area men—described by President Johnson as being members of the Ku Klux Klan—by FBI agents the day after Mrs. Viola Liuzzo, 39, was shot to death from ambush near Lowndesboro, Ala.

The shooting occurred on the highway being used by civil rights marchers for their Selma-to-Montgomery march to dramatize a voter registration campaign.

Mrs. Liuzzo, one of many out-of-state volunteers drawn to the march, had been shuttling demonstrators from Selma to the state capital. She was slain shortly after she had left a Selma church by car. A Negro

youth in the vehicle escaped injury.

The other men arrested after her death were Eugene Thomas, 42, an employe of U.S. Steel at Bessemer; Collie Leroy Wilkins Jr., 21, a self-employed mechanic of Fairfield; and William Orville Eaton, 41, a retired steel worker, also of Bessemer.

A federal grand jury indicted Thomas, Eaton and Wilkins April 6 on charges of violating the constitutional rights of civil rights demonstrators. Rowe was not indicted, and dismissal of the original charges against him thus came as no surprise.

The three indicted men are free on bonds of \$50,000 each.

With reference to the receipt of a subpoena by SAC Ingram to testify as a witness for the defendant Collie Wilkins in this matter, Departmental Attorney Robert Owen called to verify the fact that SAC Ingram had actually been served. I advised Owen that Ingram had been served with a subpoena yesterday afternoon by the Deputy Sheriff of the Jefferson County Sheriff's Office and that the subpoena called for him to appear at Wilkins' trial on Monday, 5/3/65. Owen inquired as to whether the subpoena stated a definite time for Ingram's appearance, and I advised him that it did not. It simply called for his appearance on 5/3/65.

Owen stated that the matter is still under discussion at the Department, that he has been in conference with Assistant Attorney General Doar concerning the matter and that a final decision had not yet been reached. Owen indicated that the Department's present feeling in the matter is that they will file a motion to quash the subpoena on the basis that Ingram, from personal knowledge, cannot testify to information pertinent to the trial.

Owen stated that as soon as a definite decision is reached he will advise us.

# Man Accused in Liuzzo Death Apparently Spy for FBI

HAYNESVILLE, Ala. — Gary T. Rowe, one of the four men originally accused by federal officers in the slaying of Mrs. Viola Liuzzo, emerged today as an apparent undercover agent of the Federal Bureau of Investigation.

Rowe, 34, testified for about 90 hours yesterday afternoon

before a Lowndes County grand jury which is investigating the killing of the Detroit civil rights worker on March 25.

The grand jury is expected to report its decision today.

Under elaborate cloak-and-dagger security measures by the FBI, Rowe slipped into the grand jury room in the Lowndes County courthouse at 7 p.m.

Two hours later, reporters

spotted him as he and two FBI special agents dashed for the back door of the courthouse.

An FBI man blocked the door as the sunburned, red-haired Birmingham man sped away in the back seat of a light green car, accompanied by two FBI men.

Rowe was said to have worn what appeared to be a .38-caliber revolver in a hip holster as he

entered the grand jury room, and was seen wearing it as he climbed into the car.

It was later learned from reliable sources here that Rowe has been a paid informant of the FBI for the past six years.

It was reported that Rowe said he had been paid by the FBI since 1959 for reporting on Ku Klux Klan activities.

On March 26, Rowe and Eu-

gene Thomas, 43, and William D. Eaton, 41, both of Bessemer, Ala., and Collie Le Roy Wilkins Jr., 21, of Fairfield, Ala., were arrested by FBI agents and charged with conspiring to violate Mrs. Liuzzo's civil rights in the killing. Since murder is not a federal crime, this was the only charge that could be placed against the men.

Last week, when a federal

grand jury indicted the other three men but did not indict Rowe, reports began to circulate that he was an undercover informant. Federal charges against Rowe were dropped and he was freed.

It is reported that Rowe telephoned the FBI before he left for Selma the night of the killing, and that he called them after he returned to Birmingham.

Indications are that Rowe was in the assailants' car when Mrs. Liuzzo was killed, but could not prevent the shooting.

Rowe's testimony was not disclosed.

After President Johnson announced the arrests in a telecast on March 26, it had been speculated that FBI agents had been able to make such speed-

arrests because cars of all known Ku Klux Klansmen in the area had been under surveillance.

The state grand jury of 18 white men heard evidence on the Liuzzo case during the entire day yesterday.

Testimony was also given by Leroy Moton, 19, the Negro civil rights worker for the Southern Christian Leadership Conference who was in the car with Mrs. Liuzzo when she was shot.

FBI agents were conspicuous for their absence during the morning, as state and county prosecutors apparently hoped to make a case without associating the federal government with the charges against the accused persons.

The first indication that Rowe might be an informant came when he was unexplainedly brought to the federal arraignment by FBI agents three hours after the other three defendants had arrived.

# Klansman Released in Liuzzo Slaying Apparently Worked Secretly for FBI

MOBILE, Ala., April 4 — A Ku Klux Klansman who apparently witnessed the slaying of Viola Liuzzo of Detroit while he was working undercover for the FBI, testified before the Lowndes County grand jury today.

Henry T. Rowe Jr., 34, brought before the jury under a heavy FBI guard, testified for two hours before the jury, and then was whisked out of the County by agents who used force to keep a reporter from trying to interview him.

Rowe was armed with a pistol in a holster.

He and three other Klansmen were arrested in the March 25 killing and booked on Federal charges of violating Mrs. Liuzzo's civil rights. The Justice Department later dropped the charges against Rowe. It has declined to say why.

Eugene Thomas, 42, Fairfield steelworker; William O. Ston, 41, a former steelworker from Bessemer, and Willie Leroy Wilkins Jr., 21, a Fairfield auto mechanic, are each under \$50,000 bond each on the Federal charges.

Mrs. Liuzzo, a white civil rights demonstrator, was killed by bullets fired from a

passing car as she drove from Selma to Montgomery a few hours after the March 25 march to the State Capitol.

With her was a 19-year-old Negro, Leroy Moton, who works for the Rev. Dr. Martin Luther King Jr.'s Southern Christian Leadership Conference. Moton, who escaped injury, also testified before the jury today.

The arrest of the Klansmen was announced the day after the slaying. Rowe's role as an undercover informant apparently accounted for the speed. He reportedly called the FBI within four hours as soon as he could slip away.

Rowe reportedly told the FBI he was sitting in the back seat of the car from which the

bullets were fired. A reliable source said Rowe contended the shooting happened quickly and on the spur of the moment and he was helpless to interfere.

Rowe has been supplying the FBI with information on Klan activities since 1960, according to the source.

Rowe and the three defendants were listed as members of the United Klans of America, the Nation's largest Klan with an estimated membership of 5000.

As Rowe emerged from the jury room today, a reporter tried to follow him but was shouldered to the wall by an FBI agent. The reporter continued down the hallway, but another agent blocked the exit.

# KKK Men: 'Harassed And Innocent'

BIRMINGHAM, Ala. (AP) — Three Ku Klux Klan members were freed on \$10,000 bail each in Birmingham, Ala., today after a trial on first degree murder charges in the ambush death of a Democratic leader who marched for civil rights.

The three said they were innocent and had been subject to almost continuous harassment by telephone calls and letters in recent weeks.

Their attorney, Matt H. Murphy Jr., defended President Johnson for his remarks in connection with the arrest of the members. Murphy said he would appeal to subpoena the President "if I hope to represent these men."

There were these other developments on the racial scene:

—Tear gas and smoke bombs were used by police to stop a demonstration by more than 300 Negroes in the west Alabama city of Demopolis. Five demonstrators were arrested. Fourteen persons were treated for tear gas burns at a hospital.

—The Senate began debate on the voting rights bill in Washington. Members of the Senate Judiciary Committee which sent the bill to the floor said the nation must have "new, strong legislation to protect voting rights." Twelve Southern senators organized forces to oppose the measure.

—Civil rights movement officials said

their organizations planned quieter campaigns in Mississippi this summer because the state has experienced marked changes. The appraisals were made at a meeting of the Mississippi Council on Human Relations in Jackson.

—Paul Beliesen, the missing Nampa, Idaho, Negro who briefly held membership in the Ku Klux Klan last February, has turned up in San Francisco and apparently dropped from sight again.

—Some 300 University of Mississippi students demonstrated last night outside a campus dormitory where several Negroes — here for the Southern Literary Festival — were staying. Campus police reportedly had the demonstrators under control shortly after midnight.

WASHINGTON (AP) — Money. It is a dirty job. A favor in court. It is the persuasions that are the tools of the trade. The men who work with Ku Klux Klans, Communists and gangsters when it needs information come only from the in-

formation — and usually only for the jobs — do FBI agents sometimes become members of the Klan, the party, or the syndicate — and not only for the jobs but often for years of in-coming information — in-formation already in the organ-ization are tapped.

But the term also is loosely applied to informers — men and women who are not in the FBI but who, for some inducement, regularly supply information to the government men.

FBI DIRECTOR J. Edgar Hoover has often said the bureau has the Klan virtually wired for sound with informants.

"At times," Attorney General Nicholas Katzenbach quipped recently, "I think we know more about what the Klan is doing than we know about what some divisions in the Justice Department are doing."

The FBI refused to discuss any aspect of the Liuzzo case and issued a terse "no comment" when asked about a New York Times report that Rowe had been its undercover man in the case.

It is commonly known, however, that the FBI will pay for information, strictly on a cash-on-delivery basis. One Justice Department source says as much as \$5,000 or \$10,000 may be paid for a particularly important piece of information.

But in the day-to-day routine of law enforcement, it's more likely that the payment will only cover a man's expenses or give him a little extra pocket money.

THE AMOUNT SPENT BY Hoover's men for information each year does not appear in the FBI appropriation chart. But experts describe it as "pretty small potatoes."

Money is not the only inducement offered by FBI men seeking information. Much has been gained from a private, discreet discussion of a man's duty to his country and the need for law and order.

And while the FBI won't talk

# FBI Informer No Surprise To Klan

 ANTA, Ga. (AP) — Top Klan members say they are surprised by FBI claims the orders have been infiltrated but they say government should spend more time on Communists.

In Craig, Georgia grand wizard of the United Klans of America, Knights of the Ku Klux Klan, said the case of Garmonas Rowe Jr. of Brimingham was nothing new.

"He's one of the men who have been playing a dual role long," said Craig, 36, Friday night.

"I was talking to Shelton that over the weekend," he said. "Shelton told me he has done it for several years."

Craig referred to Robert M. Gandy of Tuscaloosa, Ala., imperial wizard of the United Klans of America and, as such, the head of several state chapters. Shelton could not be reached for comment.

**Reported Tipster**  
 Gandy was reported to be the man who provided the FBI information which resulted in night arrests in the slaying of Dr. Martin Luther King Jr. in Detroit of five killed March 25 during the civil rights march from Selma to Montgomery.

Both federal and Alabama authorities have declined comment on the Rowe report.

"Usually," said Craig, "we find that some of the crimes charged to the KKK have been done by FBI informers to create an atmosphere of hatred against the organization when true klans were not involved."

Craig suggested the House Un-American Activities Committee investigate what he called the "narcissistic element" involved in the Selma to Montgomery march rather than starting a search of the KKK.

James R. Venable of Stone Mountain, Ga., imperial wizard of the National Knights of the Ku Klux Klan Inc., said the FBI ought to be using its agents "in the Communist field rather than trying to catch KKKs."

At the same time, Venable said, "there has never been any member of the KKK charged with selling any secrets of the U.S. government or with insurrection nor has there been one who hesitated when asked to serve in the military."

Just to be on the safe side, Venable said, "we are setting traps for pimps and infiltrators. We are setting more traps than the FBI."

**Nothing To Hide**  
 Asked if he knew of federal agents in his organizations, he said, "I don't know of any, but I'm sure we've got them. We have nothing secret to hide. Our tactics are to use the ballot box to win this race war."

Craig said he would welcome FBI agents to his organization "if they could qualify. But we don't want them coming in as druggists or mechanics or imposters of any kind."

"E. McDaniel, grand dragon of the United Klans of America in Mississippi, declined comment about the FBI when reached at his home in Natchez.

NEVILLE, Ala. (AP) — A grand jury reports its findings in the investigation of the

slaying of a 39-year-old civil rights worker. Lowndes County jury of

men completed its investigation yesterday into the slaying of Mrs. Viola

of Detroit and of several cases. It reportedly returned some indictments, but nature will not be known after the formal report and those indicted have been into custody.

Those questioned by the jury was Gary Thomas Rowe

34-year-old Birmingham who was arrested by federal authorities after the slaying but later released.

Rowe was one of four Ku Klux Klansmen arrested on federal civil rights charges March 1 day after Mrs. Liuzzo shot to death in her car Lowndesboro. A federal

grand jury meeting in Montgomery earlier this month indicted the other three men on charges of conspiring to injure blacks in the exercise of their constitutional rights.

The indicted were Eugene Thomas, 42, an employe of U.S. Steel at Bessemer; Collie Leroy Thomas Jr., 21, of Fairfield, a employe mechanic; and Orville Eaton, 41, also Bessemer, a retired steel

Rowe was not indicted and the charges against him subsequently dismissed. The New York Times said Rowe had been working as an undercover agent for federal authorities, including the FBI, and state officials refused to comment on the report.

Meanwhile, the president of Bogalusa, La., Civic and League—which claims it is for the town's Negroes

was arrested on a charge of issuing a worthless \$15 check.

A. Z. Young was accused in a warrant of signing a check dated April 10 issued to Ward's Repair Chop, a Bogalusa television store owned by a white man.

City Judge A. J. Jones signed the warrant and set an April 26 hearings. Young was released on \$500 bail.

In Nampa, Idaho, the Negro who served a one-day term as Grand Titan of the Idaho Ku Klux Klan in February was reported missing. His wife, Mrs. Emmaline Bellesen, told Nampa police her husband, Paul Bellesen, left home in the family

car and had not returned.

Later, one of Bellesen's former employes in a janitor service, Larry Brennan, told police he saw Bellesen in San Francisco International Airport. He said Bellesen told him, "I'm just sort of taking a vacation and I don't want anybody to know you saw me."

In Boston, civil rights leaders went ahead with plans for a massive parade and rally Friday with Dr. Martin Luther King Jr. as the chief speaker. The parade and rally are to protest racial imbalance in schools and sub-standard housing.

Mayor John F. Collins took issue with a statement by the Rev. Virgil Wood, head of the

Boston branch of King's Southern Christian Leadership Conference, that the marchers would demonstrate in front of city hall.

Wood said Selma officials didn't want demonstrations either, but they were held nevertheless. "Boston is no different from Selma," he said. "If

we choose to do it, we will do it."

Collins said that was unreasonable after the city had freely granted permits for the parade through the principal downtown business streets, plus the use of Parkman bandstand on Boston Common for the rally.

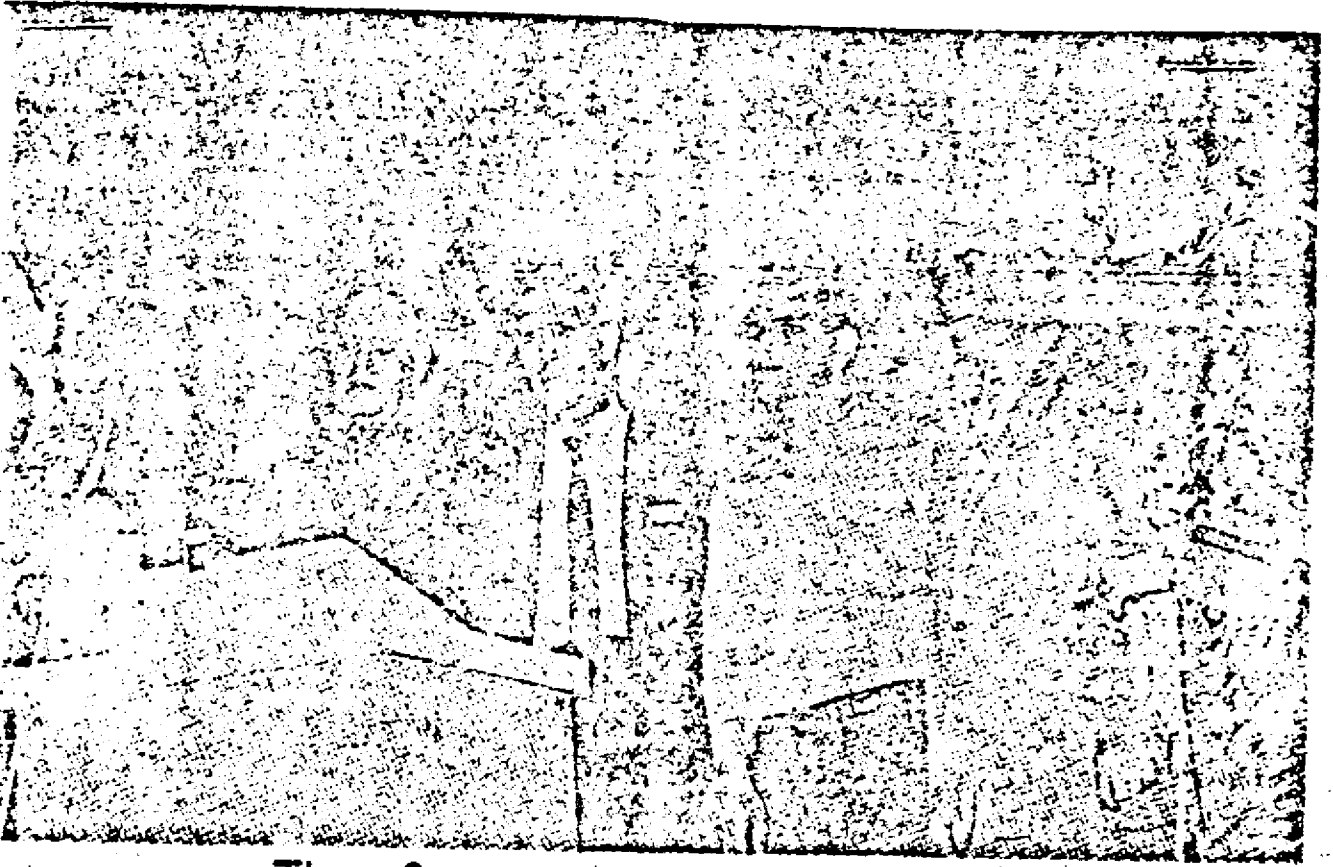

On the afternoon of 4/29/65, SAC Ingram of the Birmingham Office was served with a subpoena to appear for the defense at the trial of Collie Wilkins on 5/3/65. Wilkins is charged with the murder of Viola Liuzzo. The subpoena is for Ingram's personal appearance and it is not requested that he bring any records.

The receipt of the subpoena by SAC Ingram was discussed with Mr. Robert Owen of the Civil Rights Division on 4/29/65. Owen advised that the Department would take the matter under consideration and would take action with regard to the subpoena.

On 4/30/65, Mr. Owen of the Department advised that he had taken the matter of the subpoena of SAC Ingram up with Assistant Attorney General Doar and with attorneys of the Civil Division of the Department and it was the opinion of the Department that there was no basis for filing a motion to quash the subpoena.

Owen advised that the Attorney General has directed a telegram to SAC Ingram advising him that he should appear in answer to the subpoena and testify. It states that Ingram cannot testify to anything contained in the records or files of the Bureau and the Department of Justice pursuant to Order of the Attorney General number 324-64 dated 10/8/64. His testimony is to be limited only to matters of personal knowledge that are relevant to the issue of the trial.

Mr. Owen is furnishing a copy of the Attorney General's telegram and he stated that an attorney from the Civil Division of the Department who is experienced in handling matters of subpoena is proceeding to Hayneville, Alabama, and will be present to protect the Government interest when SAC Ingram is called to testify.



With the forthcoming trial in state court of subject Collie LeRoy Wilkins for the murder of Mrs. Liuzzo, which is scheduled to begin Monday, May 3, 1965, at Hayneville, Alabama, the question arises as to the desirability of an Agent being present in the courtroom during the proceedings.

It will be necessary that Agents be available to insure complete protection of our informant during the period that he is in Hayneville for the purpose of testifying. Following the completion of his testimony, he should depart from the area, and it should not be necessary for Agents to remain.

The state prosecutor has indicated to Inspector Joseph Sullivan that he desired to have as few "Federal Agents" as possible at the trial. It is realized that several FBI Agents will necessarily be used as witnesses by the prosecutor. Other FBI Agents may be necessary as rebuttal witnesses following the testimony given by the defense. It is also known that the Department plans to have an attorney at Hayneville during the trial.

## RECOMMENDATION

Since Inspector Sullivan will be in close touch with the state prosecutor and can follow the proceedings through him, and as the prosecutor has indicated that he does not desire "Federal Agents" around, it is recommended that we do not have an Agent sitting in the courtroom observing the proceedings. The presence of Agents if known would, of course, be the subject of considerable comment by Alabama news media

According to Sullivan, the Solicitor desires to have some written record if possible to support testimony of Agents that payments had been made to this informant for a substantial period of time.

It should be noted that the Department had previously instructed SAC Ingram of the Birmingham Office that he was not to furnish any information whatsoever from the official files or records of the office in connection with his appearance at the trial.

This matter is being taken up with the Civil Rights Division of the Department for a determination as to what action they desire be pursued concerning the request of the Circuit Solicitor to support the testimony of the Agents that payments have been made to this informant for a substantial period of time.

On April 2, 1965, the Memphis Division advised that they had interviewed [REDACTED] at Nashville, Tennessee and he advised as follows: b7c

He first met Victim LIUZZO in Selma, Alabama, about March 17 or 18, 1965, where he and LIUZZO had arrived for Civil Rights work. LIUZZO volunteered her 1963 Oldsmobile for use in transportation of Civil Rights workers, including [REDACTED]. Victim stayed in a Selma housing project apartment with a Negro family and during the march from Selma to Montgomery, March 21 - 25, 1965, LIUZZO walked in the march while her car was used extensively on the march route by several integrated groups of Civil Rights workers. [REDACTED] also said that LEROY MOTON, Negro male victim, was with LIUZZO the night of the slaying and that MOTON had used LIUZZO's car extensively.

LIUZZO was last seen by [REDACTED] in Montgomery, Alabama, on March 25, 1965, about 3:30 p.m. to 4:00 p.m. upstairs in the Dexter Avenue Baptist Church where fainting and ill victims of the march were resting.

He does not recall if LIUZZO was ill at the time nor does he know if LIUZZO was ever treated by a doctor while she was in Alabama.

LIUZZO planned to return to Detroit, Michigan, with [REDACTED] in her car, stopping en route at [REDACTED] home in Nashville, however, after victim's slaying in Alabama, [REDACTED] made other travel arrangements.

[REDACTED] stated he joined the Klan approximately five or six years ago and only attended two meetings at Selma. He voluntarily left the Klan as he became disillusioned. He initially joined thinking it was primarily a social organization; however, after attending two meetings he learned that they preached white supremacy and he felt they were a somewhat radical group.

[REDACTED] advised that to the best of his knowledge the Klan has not been active in Selma, Alabama, area for the past four years. He has not received any information that they intend to reactivate.

At the time [REDACTED] joined the Klan [REDACTED] at Selma, the leader of the Klavern No. 47 was [REDACTED] [REDACTED] does not know if [REDACTED] is presently active in any Klan organization. The initiation fee was \$12.50 and [REDACTED] is unable to recall the amount of monthly dues. The Klavern at that time met in office space above the Tillman Drug Company, Selma. [REDACTED] was unable to state who occupied or rented the space used by the Klan at that time for their meetings.

After attending one meeting at Selma, [REDACTED] was initiated into the Klan at Prattville, Alabama. He was unable to recall the exact location. He advised he took the initiation at Prattville as he was told there was no Klan member or members in Selma capable of performing the initiating ceremony. [REDACTED] is unable to recall any of the details of the initiating ceremony, due to the lapse of time. He also stated that inasmuch as he only attended two meetings, he is unable to recall any other members of Klavern No. 47 at that time.

[REDACTED] stated that at the two meetings he attended, he did not hear any member discuss any plans for violent action against any individual or group. [REDACTED] stated should he learn of the Klan reactivating in the Selma, Alabama, area, or uncover any plans for violent action, he will immediately notify the FBI, Selma.

He joined the Ku Klux Klan in 1957 when [redacted] was the head of the Klan in Selma, Alabama. [redacted] was Grand Dragon of the State of Alabama, and he described the local Klan as being very disorganized during time he belonged. A friend, [redacted] was instrumental in getting him to join and the reason for joining was because he understood the Klan was for segregation of the races and was organized to protect segregationists. He said his main objection to integration was intermarriage. During his stay in the Klan, he participated in burning a few crosses and wore the sheets of the Klan members but denied participating in or knowing of any beatings by Klan members.

He got fed up with talking about wanting to beat someone that was brought up at the meetings, but said the leaders were not for this either and all the leaders wanted to do was to things to scare or intimidate the Negro but some in the Klan wanted to knock heads. At various meetings he attended there were from 25 to 30 individuals present but he only attended about 15 or 20 meetings during his 6 months stay in the Klan. The meetings were usually held at Old Odd-Fellows Meeting Hall.

The Prattville Klan helped organize the Klan in Selma, and he described a man he believed to be named [redacted] as one of them, and said this man was an expert on Klan Kraft. All this man's speeches stressed non-violence.

He quit going to Klan meetings after about [redacted] because there was too much arguing among the members about what they were going to do. He said in addition to participating in a few cross burnings, he and other Klansmen had talked to a few white and Negro drunks who they heard beat their wives in order to try to straighten them out.

He denied knowing anything about a Klan motorcade in

The policy of the White Citizens Council is non-violence and obedience to all laws, but to fight for segregation in the courts of the land. He stressed that the White Citizens Council stays out of church affairs and has no policy in trying to influence church decisions as to segregation and integration. The White Citizens Council attempts to direct those informing the public concerning matters that are believed by the White Citizens Council to be the best interest of all people. They encourage people to send news clippings favorable to their views to other sections of the country.

He said there is no connection whatsoever between the White Citizens Council and the Ku Klux Klan aboveboard or below. He knows of no present members of the White Citizens Council of Selma, Alabama, who has ever had any connection with any Klan, however, he said it is entirely possible that some former Klan members are members of the White Citizens Council. He also stated that he knew nothing about any motorcade organized by the Klan in Montgomery, Alabama, on Sunday, March 21, 1965. He is positive that none of his executive committee or no person holding responsible position in White Citizens Council had any connection with this motorcade or encouraged anyone to join it. He said if any member of the White Citizens Council asked anyone to join this motorcade, they had done so as an individual and not as a White Citizen Council member and he has heard nothing of it.

He said to his knowledge he has had no contact with any Ku Klux Klan officers at any time.

[redacted] advised that during the period of time he belonged to Klavern No. 47 he believes that the Exalted Cyclops was [redacted] but that he could not be certain of this. [redacted] advised that he does not recall who any of the other members were during this period of time. [redacted] advised that at the meetings he attended there were only about ten or fifteen members present.

[redacted] advised that he could not recall where these meetings were held but stated that they were in the downtown area of Selma, Alabama, and that they were on the second floor of a building in this area. [redacted] advised he did not know who held ownership of this hall nor any of the details concerning its rental.

[redacted] advised that he was initiated into the Klan at a meeting which was convened in [redacted] Alabama, the time and place he does not recall.

[redacted] advised that while he held membership in Klavern No. 47 he does not recall any mention of violence or any plans having been made by the members to conduct violence of any type. [redacted] advised he does not now have any knowledge that Klavern No. 47 is still in existence and stated he would be willing to notify the FBI should he receive any information regarding the reactivation of Klavern No. 47 or any contemplated violence by any individuals in Selma, Alabama.

[redacted] was contacted and advised he was formerly a member of Klavern No. 47 of the KKKK. [redacted] further advised he has not been active in the Klavern in over five years, and he has no plans of reactivating in the Klan.

[redacted] further stated he knows of no present activity of Klavern No. 47 and could furnish no information as to any activities now being engaged in by any Klavern.

APPENDIX

U. S. KLANS, KNIGHTS OF THE KU KLUX KLAN, INC.,  
ALSO KNOWN AS THE U. S. KLANS (USK)

A source advised on October 12, 1956, that ELDON LEE EDWARDS organized a new klan group in Atlanta, Georgia, in 1953. This organization received a corporate charter in Georgia in October, 1955, under the name U.S. Klans. The same source, and a second source, advised in May, 1960, that U. S. Klans has no direct affiliation with any previous klan group, but utilizes, with only minor changes, the klan kloran or ritual written in about 1915 by WILLIAM JOSEPH SIMMONS for use by the old Knights of the Ku Klux Klan (1915-1944).

These sources advised that the U.S. Klans has as its principal aims and objectives the promotion of Americanism, white supremacy and segregation of the races. On numerous occasions EDWARDS announced that these objectives would be attained by legal means and without violence.

The first source and a third source advised in February, 1961, that at that time a split occurred in U.S. Klans, which resulted in a great majority of the officers and members pulling out and forming a new klan group known as United Klans, Knights of the Ku Klux Klan of America, Inc.

These sources advised in May, 1962, that U. S. Klans is almost out of existence and only a few units remain.
