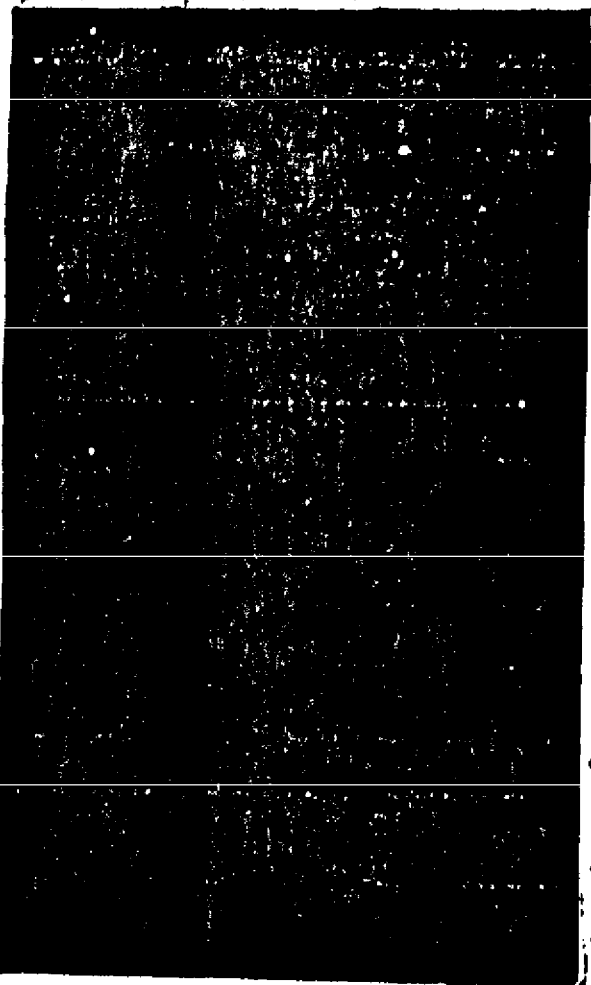

At 5:30 a.m., the White House operator called stating he received a telephone call from a person who said he was Mr. Anthony J. Liuzzo, 19375 Marlow, Detroit, Michigan, and stated he was the husband of Mrs. Liuzzo who was killed in Alabama last night and wanted to speak to the President. The White House operator wanted to verify whether or not the caller actually is the victim's husband since if it is the victim's husband the President probably will call him this morning.

The operator was advised that, of course, we had no means of identifying the person who called the White House. However, Mrs. Liuzzo's driver's license shows that she resided at the above address in Detroit and the Detroit City Directory shows that one Anthony J. Liuzzo, whose wife is Viola Liuzzo, resides at the same address.

Marlowe, Detroit. The license described Viola Liuzzo as  
female, blond hair, gray eyes, 5'2", 127 pounds. b7c

[REDACTED] Identification Division,  
Detroit Police Department, advised that Viola Liuzzo, 19375  
Marlowe, Detroit, Michigan, born on April 11, 1925, was  
arrested June 16, 1964, charged with "failing to send children  
to school." The arrest card indicated that Viola Fauver  
Liuzzo, of 19375 Marlowe, a resident of Detroit for 13 years  
prior to June 16, 1964, had been arrested by officers of the  
Detroit Police Department on June 16, 1964, at 8:45 a.m. at  
13365 Schaefer, Detroit, Michigan. Viola Fauver Liuzzo was  
arrested on warrant 208967 on the complaint of Mr. William  
Lakin, 5057 Woodward, Detroit, Michigan, the latter being  
associated with the Detroit Board of Education. The disposition  
of the arrest was shown as one year probation and \$50.00 fine. b7c

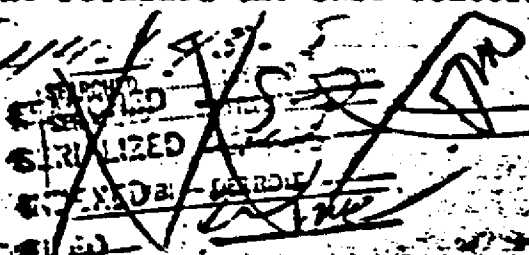

Viola Liuzzo, and stated that he was of the opinion that Viola Liuzzo was a professional crusader. Her complaint at the time she was brought before him on a charge of failure to send children to school, was the fact that in Detroit children are permitted to drop out of school at the age of 16 and Viola Liuzzo felt that the children should not be permitted to drop out of school until reaching the age of 18, and for that reason she refused to send her own children to school.

Judge Joseph Gillis stated that he adjourned the case from June 16, 1964, to September, 1964, hoping that Viola Liuzzo would be able to adjust this matter without his aid and that during that period he received a letter from the Detroit Board of Education advising that they did not desire to prosecute. Judge Gillis stated that he was willing to drop the matter but that Viola Liuzzo insisted on being tried and entered a plea of guilty, and that he then placed her on one year's probation with a fine of \$50.00. Judge Gillis stated that after the trial he received information from the Probation Department of the Detroit Records Court that Viola Liuzzo was emotionally disturbed and appeared to be on the verge of a nervous breakdown.

The records of the Detroit Division indicate that one Viola Liuzzo had addressed a letter to the "Detroit Free Press," a newspaper published daily at Detroit, Michigan, in which Viola Liuzzo belittled the United States Government's charges against James R. Hoffa, President of the International Brotherhood of Teamsters

On March 29, 1968, [REDACTED] b7c  
[REDACTED] Special Investigations Bureau, Detroit, Michigan,  
Police Department, advised that funeral services for Mrs.  
Viola Liuzzo were scheduled to be held tomorrow morning  
at Detroit, Michigan. [REDACTED] pointed out b7c  
that Mrs. Liuzzo is the person who was fatally wounded  
recently in Alabama where she was engaged in transporting  
persons in her automobile who had participated in the  
recent civil rights march between Selma and Montgomery,  
Alabama. [REDACTED] advised that a number of  
individuals from various labor, civil rights organizations,  
church organizations and local city and state officials  
were scheduled to attend the services.

He advised that President James Hoffa of the  
Teamsters Union; President Walter Reuther of the United  
Auto Workers - Congress of Industrial Workers; Roy Wilkins,  
National Association for the Advancement of Colored People  
National Official and Reverend Martin Luther King, Nobel  
Prize Winner are expected to attend the funeral services  
for Mrs. Liuzzo.

In addition, [REDACTED] b7c  
advised that local National Association for the Advancement of Colored  
People and Congress Of Racial Equality officials were  
expected to attend the services.

The following informants were contacted by Special Agents [redacted] and [redacted] on March 19, 1965: b7c

[redacted] advised the United Klans of America, Incorporated, Knights of Ku Klux Klan (United Klans), are not active in Lowndes County, Alabama. Informant stated at one time there was a chapter in Lowndes County, but this chapter was broken up. b7D

[redacted] advised he has spoken to a number of former Klansmen and other persons prone to violence who reside in the Lowndes County, Alabama, area and it is the general opinion of these people that they wanted no violence to occur in Lowndes County in connection with the Selma to Montgomery march. [redacted] advised that if any violence occurred, it would be caused by persons other than persons from Lowndes County. b7D

[redacted] advised [redacted] and no mention has been made of any action to protest the Selma to Montgomery civil rights march. [redacted] stated that although individual Klansmen are upset about this march, these Klansmen stated they would follow Imperial Wizard ROBERT SHELTON's orders that nothing was to be done to interfere with this march. b7D

[redacted] advised ROBERT CRKEL, Grand Dragon, State of Alabama, United Klans, has placed a call for all Klansmen in Alabama, South Carolina, North Carolina, and Georgia to join a motorcade from Patterson Field, Montgomery to Selma, Alabama, which was scheduled to leave Montgomery at 2:00 p.m., March 21, 1965. [redacted] advised Klansmen in the motorcade were not to be armed and that the motorcade would disperse at Selma, Alabama, and the Klansmen were to take various routes home. b7D

[REDACTED] advised Klansmen were gathering at Patterson Field at approximately 12:30 p.m. March 21, 1965. Informant advised ROBERT SHELTON, Imperial Wizard, and BOB CREEL, Grand Dragon, State of Alabama, were in town for the motorcade and that approximately 50 cars had already gathered for the motorcade. b7D

[REDACTED] advised that there were still some out-of-town Klansmen in Montgomery, Alabama. Informant advised he had heard of no planned activity on the part of Klansmen to do anything in regard to the Selma to Montgomery, Alabama, march. b7D

[REDACTED] advised [REDACTED] United Klans, met on March 4, 1965, and denounced any political support for L. B. SULLIVAN, Montgomery Police Commissioner, because SULLIVAN had allowed permits to be granted for Negroes to demonstrate in Montgomery. Informant advised that on March 11, 1965, the regularly scheduled meeting of Den 11, United Klans, Montgomery, Alabama, had met and that Klansmen were angry about civil rights agitators from outside the State of Alabama coming to Montgomery and causing civil rights demonstrations. b7D

[REDACTED] GENE VANN, Exalted Cyclops, Lawrenceville Lodge 610, United Klans, Montgomery, Alabama, had telephoned Klansmen who belonged to Confederate Den 11, United Klans, and asked them to participate in the demonstration by white people to be held on March 21, 1965, to protest outside agitators being in Montgomery, Alabama. This march was to originate in the Square in Montgomery and go to the State Capitol where speeches were to be made. VANN did not indicate the organizations which were to participate in the demonstration, but merely referred to them as white people. Informant observed this march and observed several persons in the march that he recognized as belonging to Lawrenceville Lodge 610, United Klans, but was unable to identify them. b7D

[REDACTED] advised groups of white persons had met at Crampton Bowl, Montgomery, Alabama, and had paraded to the Federal Building to protest the United States Government's assistance to outside agitators. This march was held on March 20, 1965.

[REDACTED] advised that on March 20, 1965, CHARLES WILKINSON, Exalted Cyclops, Den 11, United Klans, Montgomery, Alabama, had made a statement that the United States Government had issued an order permitting the Negroes to march and that the Negroes will march. WILKINSON stated the best thing to do was to stay away from the Selma to Montgomery civil rights march and to follow the instructions of Imperial Wizard ROBERT SHELTON by having nothing to do with this march.

Synopsis: Investigation at Detroit disclosed VIOLA LIUZZO had been involved in an arrest under Warrant #208967, in Detroit, on a charge of failing to send children to school. She was fined \$50 and placed on one year's probation. The sentencing judge stated in his opinion VIOLA LIUZZO was a professional crusader; that she was convicted only because she insisted on being convicted. Several unmailed letters found in Mrs. LIUZZO's automobile after death describe her feelings over the demonstration in which she was participating indicating she was deeply involved emotionally in the movement. [REDACTED] b7C

Interviews with habitués of the Silver Moon Cafe, Selma, failed to disclose any further corroboration of the presence of the subjects there. Two Craig AFB students describe an incident on the highway wherein they placed an individual near the crime scene who answers Victim MOTON's description.

The results of the post-mortem investigation conducted by the State of Alabama, Department of Toxicology and Criminal Investigation, assessed the cause of the Victim's death as the bullet wound which almost completely severed the spinal cord at the base of the brain. No other significant findings were noted in the post-mortem report.

A certified copy of the birth record for the Victim LIUZZO has been secured.

DETAILS:

I. BACKGROUND OF VIOLA GREGG LIUZZO

By communication of March 27, 1965, the Detroit Office advised as follows:

[REDACTED] Records Division, Michigan Secretary of State's Office, Lansing, Michigan, on March 26, 1965, advised that 1963 Oldsmobile coupe, with 1965 Michigan license EJ 9177, is registered to ANTHONY J. LIUZZO at 19375 Marlowe, Detroit, Michigan. This vehicle has Vehicle Identification Number 632M60486. b7c

[REDACTED] Drivers' Service Division, Michigan Secretary of State's Office, advised that operator's license number L200-847-015-283 was issued April 16, 1963, to a VIOLA LIUZZO, born April 11, 1925, residing at 19375 Marlowe, Detroit. The license described VIOLA LIUZZO as female, blond hair, gray eyes, 5'2 $\frac{1}{2}$ ", 127 pounds. b7c

[REDACTED] Identification Division, Detroit Police Department, advised that a VIOLA LIUZZO, 19375 Marlowe, Detroit, Michigan, born on April 11, 1925, was arrested June 16, 1964, charged with "failing to send children to school." The arrest card indicated that a VIOLA FAUVER LIUZZO, of 19375 Marlowe, a resident of Detroit for 13 years prior to June 16, 1964, had been arrested by officers of the Detroit Police Department on June 16, 1964, at 8:45 a.m. at 13365 Schaefer, Detroit, Michigan. VIOLA FAUVER LIUZZO was arrested on warrant 208967 on the complaint of Mr. WILLIAM LAKIN, 5057 Woodward, Detroit, Michigan, the latter being associated with the Detroit Board of Education. The disposition of the arrest was shown as one year probation and \$50.00 fine. b7c

The court file was Detroit Recorders Court file number 208967.

Detroit Recorders Court Judge JOSEPH GILLIS, on March 26, 1965, advised that he recalled the case concerning VIOLA LIUZZO, and stated that he was of the opinion that VIOLA LIUZZO was a professional crusader. Her complaint at the time she was brought before him on a charge of failure to send children to school, was the fact that in Detroit children are permitted to drop out of school at the age of 16 and VIOLA LIUZZO felt that the children should not be

permitted to drop out of school until reaching the age of 18, and for that reason she refused to send her own children to school.

Judge JOSEPH GILLIS stated that he adjourned the case from June 16, 1964, to September, 1964, hoping that VIOLA LIUZZO would be able to adjust this matter without his aid and that during that period he received a letter from the Detroit Board of Education advising that they did not desire to prosecute. Judge GILLIS stated that he was willing to drop the matter but that VIOLA LIUZZO insisted on being tried and entered a plea of guilty, and that he then placed her on one year's probation with a fine of \$50.00. Judge GILLIS stated that after the trial he received information from the Probation Department of the Detroit Records Court that VIOLA LIUZZO was emotionally disturbed and appeared to be on the verge of a nervous breakdown.

The records of the Detroit Division indicate that one VIOLA LIUZZO had addressed a letter to the "Detroit Free Press," a newspaper published daily at Detroit, Michigan, in which VIOLA LIUZZO belittled the United States Government's charges against JAMES R. HOFFA, President of the International Brotherhood of Teamsters.

III. INVESTIGATION REGARDING SUBJECTS AT MONTGOMERY, ALABAMA

Date March 9, 19651

Mr. JOHN STOLECKI, General Manager, Bama Department Store, 810 Southern By-Pass, Montgomery, advised he was in the store on March 25, 1965, when four men, all well-dressed in business suits, came into the store at approximately five or six P.M.

He said two men were larger in frame than the other two and that all four appeared rough looking.

STOLECKI said that GEORGE LEONARD, a salesman in the store, waited on the four men in the Sporting Goods Department. He said that one of these men had a scar from his eye to the lower portion of his nose. He stated that he could not remember on which side of the face this scar appeared.

STOLECKI was shown photographs of WILKINS, ROWE, THOMAS and EATON. He said that he could not identify the photographs as being the same four men that were in the store on March 25, 1965.

RICHARD McDANIEL, Department Manager, Bama Department Store, Montgomery, Alabama, advised that on Thursday, March 25, 1965, 4 men inquired about high powered rifle ammunition. He said they were dressed in suits and sport coats and all were wearing neck ties.

McDANIEL said it was about 1 PM when the 4 men were in the store inasmuch as he went to lunch from 12:30 to 1:00 PM that day, and the 4 men were at the sporting goods counter as he returned from lunch.

He said one individual did inquire about .357 caliber ammunition. He said he told them about the Gun Shop which is close by on the Southern By Pass Highway to the East. McDANIEL was shown photographs of EUGENE THOMAS, WILLIAM ORVILLE EATON, GARY THOMAS ROWE, JR., and COLLIE LEROY WILKINS, and stated he could not identify the photographs as being identical with the 4 individuals in the store.

FRED LOUIS DALETT, Manager, Milner Graystone Hotel, Montgomery, Alabama, advised that to his knowledge VIOLA GREGG LIEZZO was not registered in the hotel on March 24 or 25, 1965, and that no medical doctor had been called to the hotel to treat a civil rights worker or guest in the hotel on March 24 or 25, 1965. DALETT further advised that there were many instances of persons other than registered guests bringing sleeping bags into the hotel and sleeping on the floor in rooms of registered civil rights workers.

DALETT stated he observed a woman in the lobby on several occasions on the 24th and 25th of March, 1965, who he believed to be associated with the demonstrators and from conversations he overheard and telephone calls she made from the desk, believed that she was involved with the arranging of transportation and transporting civil rights demonstrators between Selma and Montgomery.

DALETT furnished the following description of this unknown woman:

Mr. FREEMAN stated he is the owner and operator of Freeman's Amoco Station, and remains at the station until closing time each night. He stated he can think of no one else who was at the station, other than himself, on March 25, 1965, between the hours of 8:30 and 9:00 PM.

Mr. WELCH stated he is the manager of Taylor's American Station and was the only employee there during the evening of March 25, 1965. Mr. WELCH further stated that on March 25, 1965, Taylor's American Station was closed at about 8:00 PM, which is the normal closing time for each Thursday.

It is to be noted that the above-described American Service Stations were the only ones observed on Highway #31, North, from the North City Limits of Montgomery, Alabama, to within fifty miles of Birmingham, Alabama.

IV. INVESTIGATION REGARDING SUBJECTS AT SELMA, ALABAMA

SPENCER EUGENE COONER, home address, Route #1, Townley, Alabama, employed as lineman, Alabama Power Company, advised that he has been in Selma since January 25, 1965, working on cross-country power lines to the Dan River Project.

He related that he eats dinner regularly at three or four restaurants in Selma, one of which is the Silver Moon Cafe.

COONER recalls eating at the Silver Moon Cafe on Thursday evening, March 25, 1965. He estimates that he arrived at the cafe at approximately 7:00 PM and stayed from 45 minutes to an hour.

COONER does not recall observing any well-dressed individuals in the cafe. He was shown photographs of subjects WILLIAM ORVILLE EATON, EUGENE THOMAS, COLLIE LEROY WILKINS, and GARY THOMAS ROWE, JR., but he could not identify them as being individuals he had ever seen. He was also shown a photograph of a 1962 Chevrolet, white over red, and advised that he could not recall having seen this vehicle in the area of the Silver Moon Cafe at any time.

COONER explained that he always goes to dinner with a group of four or five other Alabama Power Company employees who work on the same crew that he does. Whenever this group goes into a restaurant for dinner, they always sit at the same table, converse among themselves, and generally do not associate, pay any attention to, or converse with local citizens who may be in the restaurant.

He advised that he could not furnish any information in connection with this killing nor did he hear of anyone who may have been involved in the killing of VIOLA LIUZZO the night of March 25, 1965.

Mr. MORRIS PERRY, 2520 Water Street, advised that he recalls being in the Silver Moon Cafe on Thursday, March 25, 1965, at approximately 3:00 PM for a little while after which he left. He said later on that evening between 6:00 and 6:30 PM, he came back to the Silver Moon Cafe where he met HUGHIE CLAY NICHOLS, a fellow employee at Baggett Transfer Company who was already in the cafe. He said that they had a cup of coffee together, during which NICHOLS told him about a trip he was making for the company hauling material to various nearby cities and also to Birmingham, Alabama. PERRY stated that he was on vacation and had planned to take a ride with NICHOLS on this trip, and after approximately 30 minutes in the cafe, he went across the street to the Coffee Pot Cafe to call his mother to tell her he was going on this trip and would be away from home over night, whereupon they departed in a company truck and returned to Selma the next day.

PERRY recalled that PETE LACKEOS and OUIDA LARSON were the only two people he can specifically remember who were working at the Silver Moon but could not recall what other customers, if any, were in there at that time. He stated that he and NICHOLS sat at a table in front of the juke box, and he did not notice any strangers, particularly four men dressed in suits.

PERRY stated he was unable to identify photographs of COLLIE LEROY WILKINS, EUGENE THOMAS, WILLIAM ORVILLE EATON, and GARY THOMAS ROWE as anyone he has ever seen and stated he did not notice a 1962 Chevrolet, white over red, parked anywhere around the Silver Moon that evening.

He stated that he recalls seeing photographs in the newspapers of the four men arrested in Birmingham, Alabama, for killing some white woman on the highway between Selma and Montgomery, Alabama, and at that time looked them over carefully and did not recognize any of them as people he knew.

She further stated that she has worked at the Silver Moon Cafe, 138 Washington Street, Selma, Alabama, for about 14 years, but has not worked at this cafe during the past two years. Mrs. LANGSTON was unable to furnish any names of people who might patronize the Silver Moon Cafe.

He was also unable to identify photographs of COLLIE LEROY WILKINS, GARY THOMAS ROWE, JR., EUGENE THOMAS, and WILLIAM ORVILLE EATON, as any persons he saw around the Silver Moon Cafe and was also unable to identify photographs showing a 1962 Chevrolet, white over red, as any vehicle he noticed in that area.

He stated that he does not recall if he even ate at the Silver Moon Cafe during the evening of March 9 and March 25, 1965, and did not witness any assault on three men in that area.

Mr. CUNNINGHAM said since he had learned that two of his men had been contacted by the FBI, he has questioned his entire crew of seventeen and they all have stated that they knew nothing about any assault or other incidents around the Silver Moon Cafe.

The details of this report are as follows:

**SUBJECT: Post-Mortem Examination**

At the request of Major W. R. Jones, State Investigator, and with authorization of Circuit Solicitor Arthur E. Gamble, Jr., a post-mortem examination was conducted on the body of Viola Gregg Liuzzo, white female, at the White Chapel Funeral Home, Montgomery, Alabama. Time of examination was 12 midnight on March 25, 1965. Body was identified by State Investigator [REDACTED]. State and Federal Officers and funeral home personnel were present part of the time during the post-mortem examination. Guy V. Purnell, Toxicologist, of this Department assisted with the examination. b7c

**EXTERNAL EXAMINATION:**

This is the unembalmed body of a moderately obese, white female, measured height 5 feet 2 inches and estimated weight 150 pounds, resembling the reported age of 39 years. Scalp hair is reddish-blonde. Teeth are natural with three upper left, two upper right, three lower left, and four lower right missing but not of recent extraction. After photographs are made, bloodstained clothing consisting of a girdle, torso brassiere, slip and dress is removed from body. Two rings on ring finger on left hand, one ring on right finger of right hand, and wrist watch on left wrist are delivered to State Investigator Lt. [REDACTED] b7c

Bloodstains cover the major portion of the head, neck, and face; especially, the left side. Bloodstains are also on hands and smaller stains are on lower extremities below the knees. Feet are soiled. Soiled areas also appear on the

back of right hand. Body is washed and additional photographs are made. On lateral surface of upper arms are small dark areas. Fingernails are short with no free edge present. An old linear scar of the lower mid-abdomen is judged to be surgical. Lower abdomen is marked with white lines (striae atrophicae).

**THORACIC-ABDOMINAL;**

The thoracic and abdominal cavities are opened with a Y incision. There is appreciable fat in the abdominal wall. No evidence of physical trauma is observed to organs of these cavities. Lungs possess the typical mottled, glistening outer surface with a crepitant feel. Heart is not remarkable in size. Coronaries are patent in the large observed sections. There is evidence of minimal atherosclerosis of the aorta in the area of the coronary orifices. An appreciable quantity of fat is around the kidneys. Capsules of kidneys peel easily revealing a smooth, slightly congested surface. A small quantity of a white milky liquid is observed in pelvis of each sectioned kidney. Stomach contains an estimated 5 ounces of a brownish, thick semiliquid. The appendix is not located. Uterus is non-pregnant. Adrenals, spleen, liver, and pancreas are not remarkable grossly.

UNITED KLANS OF AMERICA, INCORPORATED  
KNIGHTS OF THE KU KLUX KLAN (UNITED KLANS)

Records of Superior Court of Fulton County, Georgia, reflect that this Klan organization was granted a corporate charter on February 21, 1961, at Atlanta, Georgia, under the name United Klans, Knights of the Ku Klux Klan of America, Inc.

A source advised on February 27, 1961, that United Klans was formed as a result of a split in U. S. Klans, Knights of the Ku Klux Klans, Inc. According to the source, the split resulted from a leadership dispute and United Klans has the same aims and objectives as the parent group. These are the promotion of Americanism, white supremacy and segregation of the races.

The first source and a second source advised in July, 1961, that United Klans, Knights of the Ku Klux Klan of America, Inc., merged with Alabama Knights, Knights of the Ku Klux Klan. The merged organization established headquarters in Suite 401, The Alston Building, Tuscaloosa, Alabama. The organization is directed by ROBERT SHELTON, Imperial Wizard, and is the dominant Klan group in the South with units in several southern states.

Second source advised that at a meeting at Prattville, Alabama, on October 22, 1961, the U. S. Klans, Knights of the Ku Klux Klan, merged with the United Klans of America, Inc., Knights of the Ku Klux Klan,
