Inspector Sullivan in Montgomery, Alabama, has advised that the Grand Jury is considering instant case. Sullivan reported at 4 p. m. Washington time that the informant had been on the stand since the lunch recess and was still testifying. He had been before the Grand Jury approximately two hours at the time of the conversation with Inspector Sullivan.

Sullivan advised that he personally had appeared before the Grand Jury at the outset. He stated this Grand Jury had been considered to be "a good Grand Jury" by the Departmental attorneys and the U. S. Attorney. He stated the Grand Jurors were most noncommittal while he was in there and did very little talking except for one juror who asked several questions.

Sullivan advised that the corridors in the Federal Building were very clear. There have been very few spectators gathering around the Courthouse. There are a number of witnesses, including several Agents from Birmingham who participated in the arrests and searches as well as the FBI Laboratory examiner, yet to appear before the Jury.

Sullivan advised that he did not know how long the jurors would be questioning the informant. There had been no report from the jury room as to the type of testimony or questions being asked by members of the jury. They did not know whether there had been a favorable or antagonistic reaction on the part of members of the Grand Jury to the informant's testimony regarding the Klan.





McGovern advised that an attorney by the name of Matt Murphy has called the Birmingham Office to state he is representing all of the subjects. Murphy was told that the subjects would be arraigned in the immediate future. McGovern said he was going to call Inspector Sullivan in Selma in order to get the informant back to Birmingham as soon as possible in order that he might be arraigned.



At 2:00 p.m. SAC Ingram called from Birmingham to advise that he thought there might be a problem in the arraignment of the three subjects without the fourth, namely, the informant. He said a Klan attorney, Matt Murphy, has told the office he represents all four men and will be present at the arraignment. Ingram thinks questions will be raised as to the whereabouts of the fourth man at the arraignment and also there may be a question as to why the fourth man (the informant) was not arraigned before the nearest Commissioner



ADVISED THAT HE TALKED TO MOTON THIS DATE CONCERNING HIS SECURITY. 

The President called at approximately 1 a.m. this morning to inquire concerning the shooting of Mrs. Viola Liuzzo in Lowndes County, Alabama. SA Harold C. Swanson, a supervisor in the Civil Rights Section who was on duty handling the Alabama situation last night, advised the President of the basic facts of the killing and that upon receiving information that this crime had occurred, the FBI immediately instituted a full investigation.

The President called back at 1:16 a.m. to state that the Bureau should do everything possible around the clock until we find the perpetrators of this heinous crime. He requested that he be kept informed and that any significant news be brought to his attention immediately. He also requested that he be kept informed of the progress of the investigation and requested that Deputy Attorney General Ramsey Clark be advised of the killing.

The President was advised that his observations would be brought to the Director's attention and he was assured that we were already doing everything humanly possible to break this case and that our entire facilities are fully committed to this end.

Immediately thereafter, Deputy Attorney General Ramsey Clark was advised of the killing. He was informed that this was being done at the request of the President and that we had already instituted a full investigation.

According to Rowe, who is a member of the Eastview Klavern of the United Klans of America (UKA), Thomas, Eaton and Wilkins are members of the Bessemer Klavern of the UKA. Bureau files contain no additional information concerning Eaton. Bureau files contain the following additional information concerning Thomas, Wilkins and Rowe. Information in files being furnished to the Department.

EUGENE THOMAS:

On August 6, 1959, information was received that several individuals participated in an automobile caravan at which time crosses were burned in the Cahaba Heights section near Birmingham, Alabama. Thomas was identified as one of the individuals who was wearing a white hood and robe.

At a meeting of the UKA held November 17, 1961, Thomas was elected as an Assistant Klavan Chief of the Bessemer, Alabama, Klavern.

An informant advised that at a UKA meeting held in Fort Payne, Alabama, on 11/14/64, Thomas, Exalted Cyclops, Bessemer Klavern, UKA, announced from the chair that he had received information that a splinter Klan group in Jacksonville did not want the UKA to hold a rally in Jacksonville and that if UKA did this and if Robert Shelton, Imperial Wizard, spoke his life would be in danger.

On October 6, 1964, Thomas, in company with Robert Shelton, Imperial Wizard, UKA, was in attendance at the Alabama State Fair in Birmingham, Alabama, where the Klan had a booth.

**Memorandum to Mr. Belmont
RE: EUGENE THOMAS, ET AL.;**

After a regular meeting of the Bessemer Klavern on August 14, 1964, one of the Klansmen mentioned that an FBI Agent had proposed that the Klan help themselves and the country by assisting to solve the Sixteenth Street Baptist Church bombing in Birmingham. Thomas made the comment that he did not feel the proposal was a bad idea.

On September 26, 1964, following a Klan rally, Thomas and other Klansmen drove to the Flame Club, Fairfield, Alabama, to investigate allegations that both Negro and white people were in attendance at the club. At the club, they observed Negro and white people intermingling. They left the club and started back to Bessemer stopping at a phone booth on the highway where Thomas made a call to [REDACTED] asking him to meet them. When they met, Thomas explained to [REDACTED] what they had observed and the necessity for the Klan's taking immediate action to stamp out this "race mixing." [REDACTED] asked what he would need and Thomas explained that he would need dynamite, automatic weapons and hand grenades. In about 25 minutes, [REDACTED] returned and gave Thomas one Thompson submachine gun, eight sticks of dynamite and five or six hand grenades. Thomas and the other Klansmen returned to the Bessemer Klavern where they were joined by approximately 35 other Klansmen. They then drove to a park within two blocks of the Flame Club where they parked. When police cars were observed in the area of the Flame Club, the plan to bomb the club was abandoned. Plans were later made to bomb the club on October 3, 1964, but were vetoed by Robert Shelton, Imperial Wizard, UKA. Pertinent information concerning this matter was furnished to local law enforcement agencies and appropriate military and Government agencies. In order to protect the identity of the informant, [REDACTED] was not mentioned in the dissemination. B 7c

Thomas was interviewed by Agents of the FBI on 1/17/64. Thomas denied any knowledge of the bombing of the Sixteenth Street Baptist Church, Birmingham, Alabama. He denied being a Klan member, however, advised that he was personally acquainted with Robert Shelton. He admitted being arrested in 1947, 1949, 1950 and 1957. He claimed he had no knowledge of the use of explosives and would not know where or how to buy dynamite and further stated he had never seen any dynamite used.

Memorandum to Mr. Belmont
RE: EUGENE THOMAS, ET AL.;

On June 8, 1963, the UKA held a rally near Tuscaloosa, Alabama, with Robert Shelton presiding. Thomas was one of the several persons arrested and charged with carrying concealed weapons.

An informant furnished information on November 19, 1964, concerning acquisition of weapons by Klansmen. The informant advised that Thomas had acquired the following weapons: a .38 caliber pistol, a .45 caliber pistol, an automatic shotgun, three 303 Enfield rifles, a 30-30 Winchester rifle, hand grenades, blasting caps, two M-1 rifles, a Browning automatic rifle, a Japanese rifle and a German automatic pistol. This information was disseminated locally to the Alcohol, Tobacco and Tax Division of the Treasury Department, Bureau of Customs and Secret Service. This information was disseminated at the Bureau to the Army, Secret Service and the Internal Security and the Civil Rights Divisions of the Department.

COLLIE LEROY WILKINS:

On 3/11/64, Wilkins was arrested by Hueytown, Alabama, Police Department and charged with "driving while drunk." A revolver was observed under Wilkins' feet and the car was searched. A sawed-off shotgun, a small baseball bat, a slingshot, a Kloran and a Klan robe were located in the car. The Kloran is the booklet setting forth the ritual of the Klan. Wilkins denied Klan membership and declined to discuss Klan matters.

Wilkins was interviewed by Agents of the FBI on 3/11/64. Wilkins stated he was not a member of any Klan organization and denied knowing any prominent members of the Bessemer Klavern. He stated he attended a Klan rally on 5/11/63, and had left meeting at its close and gone home. Wilkins denied owning the Klan robe that was found in his automobile but admitted owning the shotgun. He stated he felt he needed the gun to protect himself against Negroes.

In May, 1964, the Chief of Police, Hueytown, Alabama, advised that he had been contacted by a Klansman in attempts to recover the Kloran and Klan robe found in Wilkins' car. The chief stated that although there was nothing specifically stated by this person as to Wilkins membership in the Klan, there were statements made which left no doubt in his mind that Wilkins was a member of the Klan.

FBI IDENTIFICATION RECORDS:

Thomas' FBI Identification Record reflects he was first arrested in 1945 on the charge of "drunk." He has five subsequent arrests for assault and battery, reckless driving and carrying concealed weapon.

Eaton's FBI Identification Record reflects he was arrested on 4/22/54, by the Alcohol Tobacco and Tax Division, Treasury Department, Birmingham, Alabama, for "VPL" distilling (probably violation of prohibition laws). He pleaded guilty and was sentenced to two years, suspended and placed on probation for two years.

Wilkins' FBI Identification Record indicates he was arrested in 1961 for "MP of P" (probably malicious destruction of property); was arrested in March, 1964, under the National Firearms Act for possession of a sawed-off shotgun and arrested in December, 1964, for "AIM" (probably assault with intent to maim). Johnson Declares War On KKK After Killing

FBI Arrests 4 Alabamans; Wallace 'Sorry

Editorial, 12-A.

WASHINGTON — An aroused and grim President Johnson declared war on the Ku Klux Klan yesterday, calling it "a hooded society of bigots" disloyal to the United States.

He said he will ask new laws to curb what he described as the Klan's "vicious work," suggested Congress investigate its activities and warned Klansmen to quit and "return to a decent society — before it is too late."

THE PRESIDENTIAL denunciation was coupled with his disclosure that the FBI had just arrested four Alabama klansmen in connection with Thursday night's murder of a white woman civil rights worker near Lowndesboro, Ala.

Speaking on nationwide television and radio with FBI Director J. Edgar Hoover at his side, Johnson said, "I cannot express myself too strongly in praising" Hoover and his men for swift action after the slaying of Mrs. Viola Gregg Liuzzo, 39-year-old Detroit mother of five.

OF THE KILLING of Mrs. Liuzzo as she drove along Highway 80 on the route of the Selma-Montgomery civil rights march, Johnson said:

"Mrs. Liuzzo went to Alabama to serve the struggle for justice. She was murdered by the enemies of justice, who for decades have used the rope and the gun, the tar and the feathers to terrorize their neighbors.

"They struck at night, as they generally do, for their purposes can not stand the light of day."

OF KU KLUX KLANSMEN, he said, "My father fought them many long years ago in Texas and I have fought them all my life because I believe them to threaten the peace of every community where they exist. I shall continue to fight them be-



'What Kind Of People Are They?'

DETROIT — "There were 25,000 people down there and she had to be the one. She had to be the one. My God, it's unbelievable."

Those were the anguished words of Anthony J. Liuzzo, 51, minutes after he learned his wife Viola, 39 had been shot to death while driving back to Selma, Ala., from Thursday's racial demonstration in Montgomery.

Liuzzo, a big husky Teamster official wept openly and cried:

"The dirty rats, the dirty rats. What kind of people are living down here? What kind of people can they be?"

Liuzzo later got a call from President Johnson. Liuzzo said the President agreed with him that the slain woman "did not die in vain."

"BEING AN Italian and a member of the Teamsters Union," Liuzzo told the President, "I know what it is to be pushed around and kicked around."


Liuzzo said the President expressed sympathy on the part of Mrs. Johnson and himself, and then agreed when Liuzzo said: "I don't think she died in vain."

A husky man, Liuzzo had blinked back tears a short time earlier and declared:

"They should put a 90-foot fence around the state of Alabama and let those segregationists live with themselves. They don't deserve to live with human beings."

MRS. LIUZZO, A white Roman Catholic mother of five, had gone to Selma to join the march because "there are too many people who just stand around talking" about what Negroes contend are specifically

[redacted] by tomorrow morning, 4-3-65. Mr. Ingram stated Departmental attorneys said these four individuals have been subpoenaed to appear before a grand jury in the captioned case and that they need the information in our files tomorrow morning. Ingram said this poses a tremendous task for his office and that he wanted to know whether he should work his people all night in order to get this information ready. Four subjects have been arrested and charged with violation of Title 18, Section 241, (conspiracy to injure and intimidate persons in the exercise of their rights under the Constitution and laws of the U. S.) in connection with this shooting. The initial reports of the Mobile and Birmingham Divisions were received at the Bureau 3/30/65. They have been reviewed and disseminated to the appropriate U. S. Attorneys and to the Department. The Bureau is now in receipt of two subsequent reports of the Mobile Division dated 4/1/65 and 4/3/65 and two reports from the Detroit Division dated 3/31/65 and 4/1/65. As you know, United Press International (UPI) has quoted captioned individual as saying, on 3/27/65, that Mrs. Viola Liuzzo might not have been murdered if FBI Agents had advised local officers they had a carload of Ku Klux Klansmen under surveillance. According to a teletype from Selma, received in the Bureau at 1:11 a. m. today, Clark telephonically advised the Selma Resident Agency yesterday that he had had a conference with a newsman during the morning of 3/27/65. He said he told the newsman the FBI had never told him about the car bearing the Liuzzo murderers being in the Selma area. He stated he did not know anything about the car and, if he did by an outside chance, he might have picked them up. Clark further stated that he presumed the FBI had the vehicle under observation. He continued, "I've been getting so much heat from the newspapers on this I had to tell them something. I don't recall receiving any information about the car."

After consultation with Messrs. Belmont and Joseph A. Sullivan, and approval by Mr. Tolson, the attached statement was released at 9:45 p. m., 3/27/65, to Associated Press and UPI.

Since this statement was released, there have been several news reports alleging Sheriff Clark has issued a rebuttal. He has been quoted as saying this is not the first time the Department of Justice has called him a liar. Inspector Sullivan is checking these reports out to ascertain whether Clark has been talking to reporters again, and will report his findings to the Bureau later today. If Clark has been talking, however, I feel we should not attempt to answer any additional remarks he may make regarding this matter. To do so will only feed him more material with which to keep a "feud" going with the Bureau, and I believe we should discourage the development of such a situation, if at all possible.

DeLoach to Mohr memo 3/28/65

Re: Sheriff James Clark

Additional developments in the Liuzzo murder include a statement made by the Grand Wizard of the United Klans of America, Robert Shelton, that one of the subjects in this matter had been offered a bribe by the FBI for a confession. This bribe is supposed to consist of several hundred acres of land located in Minnesota. A telephonic contact at 11:35 a.m. today with J. L. McGovern, of the Inspection Division, who is in Birmingham, disclosed that absolutely no promises nor offers were made to any of the subjects. Mr. McGovern said this may have originated with the informant in this case since the latter is telling a variety of stories to his attorney, Matt Murphy, in an attempt to divert suspicion from himself.

Shelton has been making a number of wild claims to the press in the past few hours. He has called the President a "damned liar," and he has said that Reverend James J. Reeb was dying of cancer before he was clubbed to death in Selma. The latter has been labeled as "hokum" by John Sullivan, New England Chairman of the American Friends Service Committee, who said Mr. Reeb had undergone a physical examination shortly before joining the Committee on 9/1/64. This examination disclosed Reeb was "in the pink of health," according to Sullivan.

The Director has also received a telegram from Martin Luther King which reads as follows:

"Let me congratulate you and the FBI for this speedy arrest of the accused assassins of Mrs. Luizzo. The Agents assigned to Alabama have done an outstanding job of containing the tremendous violences and savagery which runs rampant under this surface of Alabama life. There is still much work to be done before Alabama is rid of the racist sickness which pollutes her body politic, I am sure that we can continue to count on four efficient services."

I do not believe this wire should be acknowledged because a reply would only help build up this character and a communication from Mr. Hoover, which King would undoubtedly publicize, will tie us in with him, and put us under an obligation to him. I likewise feel that King's telegram to the Director should not be released to the press for the same reasons. Mr. Belmont concurs in these recommendations.

Page 6055. Congressman Gathings, (D) Arkansas, spoke concerning the economic boycott of Alabama suggested by Dr. Martin Luther King. Gathings stated "I implore Dr. King to please permit the schoolchildren of Alabama to participate in the school lunch program by the utilization of surplus food commodities, - - - . At this point, Congressman Andrews, (D) Alabama, stated "I hope the gentleman will remember and that the Members of this House will remember that last December Mr. J. Edgar Hoover, one of the greatest Americans of all time, said that this Martin Luther King was the most notorious liar in this country, and Mr. Hoover until this day has not retracted that statement."

Pages 6055-6056. Congressman Gross, (R) Iowa, spoke concerning the Bobby Baker investigation. He included the article written by Paul Eope which was set forth with remarks of Senator Williams earlier in this memorandum.

Pages 6066-6067. Congressman Cleveland, (R) New Hampshire, spoke concerning use of certain materials in construction of public buildings, referring to the substitution of concrete for stone exteriors of new Federal buildings. He stated "Four structures which would have concrete exteriors have recently been authorized for construction in Washington, at a total cost of \$126 million. These four buildings are the Federal Office Building No. 5, the National Air and Space Museum of the Smithsonian Institution, the Federal Bureau of Investigation Building, and a new headquarters for the Housing and Home Finance Agency." Mr. Cleveland included a brochure entitled "Our Beautiful Capital, Will It Be Marred by the New Trend in Federal Building?" (It is to be noted the General Services Administration advised the architects have not yet presented their recommendations to the Fine Arts Commission as to the exterior treatment for our building.)

Page 6074. The House received a letter from the Attorney General transmitting a draft of proposed legislation entitled "A bill to amend section 4082 of title 18, United States Code, to facilitate the rehabilitation of persons convicted of offenses against the United States." This was referred to the Judiciary Committee.

With reference to Mobile teletype 3-27-65, referring to the "five-day arrest rule," the following is set forth:

This case involves the arrest of four subjects on Federal charges by Bureau Agents on 3-26-65, in connection with the fatal shooting of Viola Liuzzo in Lowndes County, Alabama, on the night of 3-25-65. Mobile, in stating that a report would be submitted within the five-day arrest rule, was referring to the rule set forth in the Manual of Rules and Regulations, Part II, Section 4B, Page 2c, which states, "A report must be sent to the U. S. Attorney within five working days of the taking of a subject into Federal custody." The report will, of course, contain the facts developed upon which the arrest was made in order that the U. S. Attorney may proceed with prosecution without delay.

The purpose of the rule is to insure that any delay in the handling of prosecution of subjects arrested by Bureau Agents cannot be attributed by the U. S. Attorney or the Department to delayed reporting on the part of the Bureau. With respect to this case due to its importance, Mobile Division, where the shooting occurred, and the Birmingham Division, where the arrests were made, have both been instructed that the investigation of this matter must be handled on an expeditious basis and the report of the arrests submitted no later than 3-30-65, to the Bureau for clearance before being furnished to Departmental attorneys.


