SPECIAL NEWS RELEASE

Five television shows, THE WEB, BRIDE & GROOM, LOVE OF LIFE, SEARCH FOR TOMORROW, and GUIDING LIGHT were rated objectionable in the current findings of the National Television Review Board announced during March.

The board, an independent organization surveying TV shows since 1950, also named four variable programs, WALTER WINCHELL, NAMES THE GAME, MR. & MRS. NORTH, and SUPERMAN.

THE WEB was rated objectionable because of an "excess of crime and violence at an hour that precedes bedtime for children." BRIDE & GROOM, it was reported, "depreciates the sanctity of the Holy vows....makes sacred ritual too commercial." The three soap operas, SEARCH FOR TOMORROW, GUIDING LIGHT, and LOVE OF LIFE were objectionable because of "sordid situations....no value placed on family life....vulgarity displayed....excess of adultery and drinking."

WALTER WINCHELL, the report continued, was variable because his TV program "peddles distrust and possible hatred." The "double meanings" of NAMES THE GAME and MR. & MRS. NORTH were observed, and SUPERMAN was variable due to an "excess of violence."

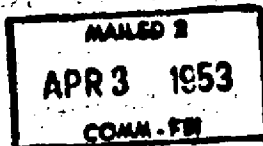

TELECAST 6:45 PM EST

WINCHELL: "Havana, Cuba. Batista has smashed another revolutionary plot. Over 40 persons have been arrested, one is believed to be a New Yorker."

COMMENT: None. For your information.

WINCHELL: "New York City. War veterans groups will picket the opening of pro-Nazi Walter Kieseking on April 22 at Carnegie Hall. This pro-Nazi punk is having the next to the last laugh."

COMMENT: None. For your information.

WINCHELL: "Chicago. Heads were crushed and chairs were thrown in a free-for-all between members of the American Soviet Friendship League and the American Friends of the Anti-Bolsheviks organization out there in Chicago."

COMMENT: This apparently refers to a memorial meeting held at Peoples Auditorium in West Chicago, Illinois, on April 12, 1953. This meeting was a memorial to Joseph Stalin and F. D. Roosevelt and was sponsored by the National Council of American Soviet Friendship, which organization has been cited by the Attorney General as coming within the purview of Executive Order 9835. During this meeting a riot broke out between anti-Communists and persons sponsoring the meeting. The Chicago Office has advised that no one was seriously injured and only minor damage was caused to the hall before police gained control. Several persons were arrested but none were held.

WINCHELL: "East Berlin. Churches of the Protestant faith especially Sunday school classes have been charged with criminal resistance to the Soviet Republic."

COMMENT: None. For your information.

WINCHELL: "Rio. The Communist are capitalizing on the terrible Brazilian inflation. A wave of strikes is paralyzing Brazil."

COMMENT: None. For your information.

WINCHELL: "'New York Daily Mirror.' Ray Russell Davioni (?) who told the court that he was a press agent which he never was will be sentenced on the 17th. He was Mickey Jake's partner in the vice case. Davioni (?) will get one year from Judge Goldstein in the New York penitentiary."

COMMENT: None. For your information.

WINCHELL: "'The Los Angeles Herald Express.' The Department of Justice, this or next week, will start denaturalization action against two dozen Hollywood figures. Some are nationally known. All will be targets for immediate deportation."

COMMENT: [REDACTED] Immigration and Naturalization Service, has advised the Bureau's liaison representative that he has no knowledge concerning this matter.

WINCHELL: "'Crestline, California, Courier.' The Crestline Chamber of Commerce has named a day after me for my recent scoop about a Red school for spies near Crestline. There were no Crestline people involved, I'm glad to say. 'Walter Winchell Day' is August 31 at the three-day Hillbilly Jamboree at Crestline, California. How's that for a coast to coast plug?"

COMMENT: As you know, this matter has received many comments by Winchell on his past programs and in his columns.

WINCHELL: "To all editors in Danville, Virginia, Norfolk, Virgin and all Virginia newspapers. Commie pamphlet called 'The Southern Peoples Common Program for Democracy' is being mailed to Virginia editors and educators. The FBI knows that I know what I'm talking about."

COMMENT: This information was disseminated in the FBI Current Intelligence Summary dated April 8, 1953.

WINCHELL: "Attention: International News Service. The hottest scandal in Paris. French Communist leader, ~~Thorez~~, is back in Paris with a new lady friend. Thorez introduces this woman everywhere as a Russian brain surgeon which has Allied Intelligence in stitches and you'd be in stitches too if some very fussy editors on this network would leave me alone." FRANCE

COMMENT: The April 10, 1953, issue of the "Washington Daily New page 4, carried an article captioned, "Crippled Thorez Bypasses Welcome." This article states, in part: "Traveling with Thorez was a Russian doctor, Valeria ~~Dazedova~~, 42, a short, stocky woman

FRANCE

WINCHELL: "'New York Journal.' Narcotic agents are taking moving pictures with hidden cameras of known marijuana sellers and smokers all over New York."

COMMENT: None. For your information.

WINCHELL: "Washington. Two more Communist spies, Otto Verber and Kurt Ponger, arrested in Vienna will be tried next month. The Government has witnesses and motion pictures which allegedly link these spies to Russian Embassy clerk, Yuri Novikov." ALST

COMMENT: The trial of Verber and Ponger is presently scheduled for next Monday, April 20, 1953. Novikov, who was the second secretary of the Russian Embassy, was declared persona non grata after Verber and Ponger were arrested in Austria in January 1953.

WINCHELL: "Washington, D. C. The United States Senate Committee investigating Commies and strange 'Red fellows' will subpoena former executives of the Young Communist League. First to be subpoenaed is James Wechsler, editor of the 'New York Post.'"

COMMENT: Wechsler had admitted his YCL membership. As you know, Wechsler has been the target of Winchell in many of his broadcast and columns.

WINCHELL: "Detroit, Michigan. It's a baby girl for Marjorie Douce, daughter of orchestra leader Frankie Carle and the wife of a G-man in Detroit."

COMMENT: Marjorie Douce is the wife of Special Agent Richard G. Douce, presently assigned to the Detroit Office, his first office of assignment.

BROADCAST 9:00 PM EST

WINCHELL: "Washington. The President's courageous act in repudiating Mr. Dulles for his leak on the Korean situation has received the quiet and complete support of the United States Senate. Mr. Dulles fled from the capital to rest his kicked shins in the Thousand Islands. The newspapers are still pretty sore."

COMMENT: None. For your information.

WINCHELL: "United States Combat Intelligence warns that this week in Korea, the bloodiest of the war, gives every indication that the high Red command is probing for a break through offensive all the way to Seoul."

COMMENT: None. For your information.

WINCHELL: "Washington Post." The next atomic explosion will take place on the floor of the United States Senate over the big oil tanker deal."

COMMENT: This apparently refers to the actions of Senator Joseph McCarthy in connection with his recently announced treaty with a group of Greek ship operators to discontinue shipments to Communist China.

WINCHELL:

"Hollywood, California. Mexican authorities have been alerted to the plans of Hollywood Communists now in disguise trying to cross the Mexican border."

COMMENT:

This undoubtedly refers to the production of the motion picture, "Salt of the Earth," being produced by the Independent Productions Corporation in conjunction with the International Union of Mine, Mill and Smelter Workers.

WINCHELL:

"Havana, Cuba. The President of the Student Body has closed all Havana schools following three riots between students and police. Professor Garcia Barcena tells me he was tortured by the Cuban soldiers."

COMMENT:

Professor Rafael Garcia Barcena, University Professor, arrested along with many others approximately two weeks ago for a alleged revolutionary attempt against the Batista Regime.

WINCHELL:

"New York City. Senator Hickenlooper and his special committee will start a two-weeks' investigation of the Voice of America in New York City on May 4."

COMMENT:

As you know, the Voice of America has been under investigation recently by United States Senate investigating committees

WINCHELL:

"U. S. Intelligence is very hep to the so-called mystery a very large mess, behind the big Greek interest in shipping. One big Greek ship owner is turning state's evidence for our Government."

On April 3, 1953, the Civil Division of the Department advised that it was considering sending an Attorney to New York to obtain a formal deposition from [REDACTED]. To date no information has been received from the Department whether [REDACTED] has furnished any information or a deposition.

WINCHELL:

"John P. Flynn's new book, 'The Lattimore Story,' is a walloping answer to the smear gang. 'The Lattimore Story' is now in your book stores. Read it and be enlightened."

COMMENT:

Flynn's source material are the McCarran Committee Hearings on the Institute of Pacific Relations.

WINCHELL:

"Attention: Congressman Edward P. Boland. Regarding your telegram, Congressman, on my last Sunday night's hit that the Communist over here are sending pamphlets to Virginia editors and Virginia educators, I said the FBI knows about it. Why don't you contact John Edgar Hoover, Congressman?"

COMMENT:

Congressman Edward P. Boland is a member of Congress from Springfield, Massachusetts. As you know, the item referred to above regarding the Communist pamphlets was mentioned by Winchell on his programs last week. "Mr. and Mrs. United States. The President's declaration has received more attention in world capitals than any American document since FDR announced the Four Freedoms, but the big questi

our President asked and left unanswered shows that world peace has more hope than comment. That question is 'What is the Soviet Union ready to do for peace?' I can't hear what you are saying Mr. Malenko with all that shooting. Vichinsky talks peace in New York but they haven't changed their textbooks behind the Iron Curtain and their textbooks teach four hundred million Russian and satellite children that they must kill Americans or be killed by Americans. Marx, Lenin Engels and Stalin said it over and over again that the world is much too small for Capitalism and Communism and they have never taken back one comma. What our President did not mention was the colonial problem. The reason is that the colonial problem is much too touchy for the Allies. Paris for instance is most sensitive about the fact that the French have no more right to be in Morocco and Tunis than the Russians had to be in Czechoslovakia. Mr. Eisenhower also avoided the question on the future of China. This is because London, which claims Chiang Kai-shek has no right to be in Formosa, becomes very irritable and angry at the mere mention of the fact that the British have very little right to be in Hong Kong. The Red leaders want no peace, they merely need more time to get ready to ~~shoot~~<sup>knock</sup> us out. They want atomic weapons neutralized only because they have none to compare with ours. In my opinion even world disarmament would not bring peace because the roots of the trouble are not the weapons they carry in their hands but the murder they carry in their hearts."

COMMENT:

WINCHELL:

"The Washington Post: Cedric Belfrage, a British subject, is a radio commentator and editor of a pro-Commie sheet over here. He is quietly trying to become an American citizen. His paper, I mean his rag, defends Alger Hiss, the atomic spies, the Rosenbergs and it blames the Korean War on us. Contact Elizabeth Bentley who helped expose many American Reds and ask Miss Bentley about her sworn testimony regarding Cedric Belfrage."

COMMENT:

As you know, the Bureau is fully aware of Belfrage and his background. He is the editor of "The National Guardian" which is published in New York City.

"Attention 'New York Mirror.' There will be a front page explosion tomorrow night at the New York Academy of Medicine at a meeting of the New York County Medical Society at 105th Street and 5th Avenue, New York. A fight over admitting a Vienna doctor allegedly leading Nazi."

COMMENT:

WINCHELL:

"United Nations, New York. A moving picture made by a top moving picture company for the United Nations just completed will be blasted by a Senate Committee as Communist propaganda."

"Another top UN official will be charged with Communist affiliation before the Jenner Committee on Tuesday. His initials are J. D."

"Berlin, Germany. Another big Russian spy ring has been uncovered. It numbers many friends of Germany's Adenauer, who has just visited the President at the White House."

COMMENT:

This may refer to the Institute for Economic Study. On April 10, 1953, it was reported that 35 spys were arrested in Western Germany. The Bureau has received no information that this spy ring had any activities coming within the Bureau's jurisdiction.

WINCHELL:

"Washington. The House Un-American Activities Committee will start hearings May 4. Nearly 100 witnesses from the theater, television and radio have already been served with several subpoenas.

COMMENT:

As you know, this is a resumption of the hearings of the House Un-American Activities Committee which has been investigating Communist infiltration into the motion picture, television and radio industries. The Committee recently conducted hearings in Los Angeles, California.

WINCHELL:

"The New York Journal American.' The FBI is on the tail of a munitions manufacturer for possible violations of the MammAct. His parties are notorious. The wife of a prominent Wall Streeter will be involved."

COMMENT:

WINCHELL:

"Washington Post.' A group of mysterious Chinese trying to organize a third force in China are now in the United States. One was trained at Moscow. He has big business connections over here. London knows more about him than Washington does. His initials are P. C."

COMMENT:

The Third Force is a movement which is neither pro-Communist nor pro-Nationalist. The Chinese Third Force, an uncohesive grouping of organizations and individuals, has existed in Hong Kong since the Communist occupation of mainland China. Under pressure from British authorities and motivated by a desire for personal safety, some Third Force adherents are now to be found in Japan, the United States and Southeast Asia. However, Hong Kong remains the focal point of the movement according to information received from the State Department. There is no identifiable information regarding the individual referred to as P. C.

WINCHELL:

"New York Daily Mirror.' The FBI knows about a group in New York trying to bring over Heinz Neuhaus, a German boxer, and his Manager Joe Besselman (2) both allegedly were SS men for Hitler."

COMMENT:

None. For your information. The Bureau's files fail to reflect any reference regarding Heinz Neuhaus.

BROADCAST 9:00 PM EST

WINCHELL:

"Barcelona. Pity the innocent children of Spain. They are being taught early how to be good Fascists. Today a group of them circulated leaflets praising Mussolini, calling him 'that great Italian without a tomb.'"

COMMENT:

The Monday, April 27, 1953, issue of "The Washington Post," page 14, column 4, contains an article dated Barcelona, Spain, April 26, captioned "Mass for Mussolini." This article states that "a memorial funeral mass was celebrated in the Sacred Heart Church today for Benito Mussolini. Clergymen refused to say who paid for it. Children distributed leaflets praising 'Mussolini, that great Italian without a tomb.'"

WINCHELL:

"Washington. Three top State Department officials in Germany and Austria will be ordered home to face charges for Communist affiliation before the Senate Committee headed by Joseph McCarthy. One of the very first bomb shells resulting from the recent flying trip to Europe of Roy Cohn and David Schine of McCarthy's staff of 'red killers.'"

COMMENT:

One of the State Department officials in Germany to be recalled for questioning by Senator McCarthy's Committee is [REDACTED]

[REDACTED] The other two officials are unidentifiable.

WINCHELL:

"Ladies and gentlemen. Using the standard smear technique James Wechsler, the 'New York Post' Editor, tried to explain away the fact that he appeared before the Senate Investigating Committee the other day by hiding behind the freedom of the press and attacking the probers. Wechsler, former top executive of the Young Communist League, once had to admit under oath in another examination before trial, that the 'New York Post,' his paper, followed the red party line for over a year and he argued that Senator McCarthy

questioned him this week because his 'rag,' the Post, had crittized McCarthy. McCarthy who is more violently attacked by many other leading editors has not sent for any of them and no other editors are likely to be sent for. Wechsler's fury is thoroughly understandable. He would like to change the subject to the future of Joe McCarthy instead of James Wechsler's pro-Moscow past."

**COMMENT:**

As you know, Wechsler has admitted his YCL membership in the past. He has been the target of Winchell in many of his broadcasts and columns.

## WINCHELL:

"The Free Cuba Party has an army to overthrow President Batista. They are waiting for the signal to invade Cuba at a secret spot along the Yucatan coast."

## COMMENT:

This refers to the revolutionary forces headed by the deposed president of Cuba, Carlos Prío Socarras, and his former minister, Aureliano Sanchez Arango. This group has been active since they were ousted in March, 1952, in trying to organize a revolutionary group to attack Cuba. Various dates have been set for the actual invasion.

## WINCHELL:

"Bolivia is expected to be the very first big South American nation to fall under actual Communist rule."

## COMMENT:

Victor Paz Estenssoro is the president of Bolivia. His party is the MNR (Movimiento Nacionalista Revolucionario) which is made up of two factions, the right wing called the Paz, and the left wing which is under the leadership of Juan Lechin who is the head of the miners union. Although Lechin is considered to be a leftist, there is no indication that he is a Communist.

## WINCHELL:

"Another big batch of indictments against well known New York gamblers over income tax evasions will soon make big news in New York."

Hammett has been described by Louis Budenz as a "concealed Communist."

A number of press agents handling the legit shows will be summoned by a committee investigating Communists. At least four well known men, press agents for the big Broadway shows, will be named, not accused, named as dues paying members of the Communist Party."

Josephine Baker is American-born but has French citizenship by virtue of her marriage. She has been away from the United States for some time but came to this country on an entertainment tour during 1952 when she made unfavorable speeches about the United States. She alleged that she was refused service at the Stork Club which received considerable newspaper publicity. She went to South America from the United States where she continued to make unfavorable speeches about the United States. She then returned to Europe.

## (1) WINCHELL:

Said executives, of a disreputable New York union long suspected of serving the Communists, will be subpoenaed by a Congressional committee.

## COMMENT:

Possibly refers to officials of the International Fur and Leather Workers Union (IFLWU). The Jenner Committee requested information on this Union on June 25, 1953, and a memorandum is in the process of being prepared. The IFLWU was expelled from the CIO on the charge of Communist domination and is subject of an FBI pending security matter case.

## (2) WINCHELL:

Said that the New York labor movement will demonstrate this evening, June 29, in front of the Soviet United Nations Headquarters and the "Russian Embassy" on New York's Park Avenue, from 4:30 P.M. to 6:00 P.M.

## COMMENT:

From the nature of Winchell's remarks it presumably is an anti-Communist demonstration.

## (3) WINCHELL:

Announced that Radio Commentator Johannes Steel will be subpoenaed by the McCarthy Committee this week.

Said that the man who "pulled the switch" on the Rosenbergs is the latest to be threatened with death.

(8) WINCHELL:

Said that two FBI Agents still are guarding Federal Judge Kaufman who sentenced the Rosenbergs.

(9) WINCHELL:

Said Fyke Farmer of Nashville, Tennessee, who secured the stay for the Rosenbergs from Supreme Court Judge Douglas, is known as a "red fronter" to Congressional committees.

COMMENT:

[REDACTED] Much of his time has been devoted to agitating for a world government. Has been described as an impractical idealist.

(10) WINCHELL:

Said that Guatemala "gun runners" were supplying secret "red" arsenals in South America and many of the rifles involved were Russian made. Remarked that United States intelligence is of the opinion that the smuggling may be by fishing fleets or "red" submarines.

COMMENT:

COMMENT:

J. B. Matthews was appointed as Executive Director of the Senate Permanent Investigating Committee by Senator McCarthy last month. An article by Matthews entitled "Reds And Our Churches" appears in the current issue of the "American Mercury." Matthews in his article alleged that "The largest single group supporting the Communist apparatus in the United States today is composed of Protestant clergymen."

(4) WINCHELL:

Stated that the Grievance Committee of the New York Bar Association was investigating Emanuel Bloch, attorney for Julius and Ethel Rosenberg.

COMMENT:

At the funeral services for the Rosenbergs, Bloch alleged that the officials of the United States Government had "murdered" the Rosenbergs.

(5) WINCHELL:

Stated that Attorney General Herbert Brownell had ordered Assistant Attorney General Warren Olney III to continue the Justice Department's efforts to have Harry Bridges deported.

COMMENT:

Bridges is the President of the International Longshoremen's and Warehousemen's Union, which has been expelled from the CIO for following the Communist Party line. The U. S. Supreme Court recently reversed Bridges' conviction for perjury in connection with his application for U. S. citizenship on the grounds that the statute of limitations had expired. The Communist activities of Bridges are well known to the Bureau.

(6) WINCHELL:

Stated that the "Red underground" in the United States was wondering about the recall of the Russian Ambassador to the United States to Moscow and was wearing a "pained expression."



COMMENT:

It is noted that on June 30, 1953, Georgi Zarubin, Soviet Ambassador in Washington, flew to Moscow, and that on July 1, 1953, Jacob Malik, Soviet Ambassador in London, also returned to Moscow.

(7) WINCHELL:

Stated that he testified last week in a pretrial hearing in connection with a libel suit which had been brought against him by James Weschler, editor of the "New York Post."

COMMENT:

Weschler is a self-admitted former member of the Young Communist League during the 1930's and his activities in this connection have been given considerable publicity by Senator McCarthy.

(8) WINCHELL:

Stated that the disappearance of a "Canadian spy list" was a "major scandal" in U. S. Intelligence circles. Winchell stated that former Prime Minister of Canada Mackenzie King considered this list so secret that he had copies of it flown directly to Winston Churchill and former President Harry S. Truman. Winchell claimed, however, that the Russians gained possession of this list through "counterespionage" and as a result were able to recall their "top agents" before the FBI could "trap" them. Winchell also stated that United States intelligence officials have complained that political influence was used to assist these spies in escaping.

COMMENT:

As you are aware, the Bureau has no information indicating that any "Canadian spy list" was ever furnished to former President Harry S. Truman. It is also noted that former President Truman has specifically denied the receipt of any such list from Prime Minister Mackenzie King.

(9) WINCHELL:

Stated that Istvan Kossa, prominent Hungarian Communist, has been missing since the early part of April, 1953.

COMMENT:

None. For your information.

RADIO BROADCAST

In addition to the above, Winchell made the following comments of interest to the Bureau during the course of his radio broadcast at 9:00 p. m., July 5, 1953:

(1) WINCHELL:

Stated that the son of Max Lowenthal and the daughter of Harry Dexter White had been subpoenaed to appear before the Senate Internal Security Committee.

COMMENT:

You will recall that Lowenthal was the author of the book "The Federal Bureau of Investigation" which presents a distorted history of the Bureau and its activities. Harry Dexter White, now deceased, was former Undersecretary of the Treasury of the United States. He has been implicated in Soviet espionage by both Whittaker Chambers and Elizabeth Bentley.

(2) WINCHELL:

*D'USSEAU*  
Stated that Arnold Deusau (phonetic), "an author and playwright," had been subpoenaed to appear before the Senate Permanent Investigating Committee this week.

COMMENT:

Deusau's appearance is probably in connection with the investigation being conducted by Senator McCarthy regarding the books which are being

maintained in the State Department's overseas libraries. It was not possible to definitely identify Deusau on the basis of the information furnished by Winchell during the course of this broadcast.

(3) WINCHELL:

Stated that the radio and television broadcasts of July 5, 1953, were the last broadcasts in this series and that he would not return to the air until September 6, 1953.

COMMENT:

Dear Mr. Winchell:

I saw you on television last night and enjoyed listening to your broadcast. I was glad to hear you back up Mr. J. Edgar Hoover in regards to civil rights.

However, there was one thing that I didn't like about your broadcast and that was when you mentioned the date of the report to be issued by Senator Jenner or one of his committees. You mentioned the date of its release as being September 23. I think it is a mistake to let this information get out and here's why.

If you will recall, there also was advance notice given to the realse of the Senate Judiciary Committee report on traitors and Communists in our Government. What happened? By almost perfect timing the Dr. Kinsey report was RELEASED and his report held the attention of the American people and press at just the same time that the report of the Senate Judiciary Committee was released. What was the result? Almost everybody was talking and arguing about Dr. Kinsey's report and practically nobody was talking or arguing about the report issued by the Senate Judiciary Committee.

It will be very interesting to see if a trumped up sensational news story will be sprung on the American press and the American people timed just so as to take the edge off the report which is according to plan going to be released on September 23rd. If another sensational news story (phony, of course) is timed for September 23 so as to divide the attention of the American people, I think there might be more to it than just mere COINCIDENCE.

If anything smells fishy around September 23 perhaps it would be a good idea to get in touch with Senator William E. Jenner and have him postpone the issuance of his report until such a time as the complete and undivided attention of the American people can be centered on any report he or his committees has to make.

I think you are one of the leaders of this country of ours in the fight against Communism and I believe there is no higher tribute that can be paid to any American than to call him a leader in our country's fight against Communism.

No reports have been received indicating that any Communists or other individuals with subversive backgrounds have been assigned by the Foundation to positions which would enable them to direct or control any of the activities of the organization. Owing to the rapid expansion of the Foundation since 1950 it appeared possible that individuals with subversive backgrounds may have been employed in some instances but no specific cases are known.

Winchell said:

The International Workers Order, whose case is on appeal, will hold a demonstration in Washington, D. C., on October 4, 1953, for the benefit of the Supreme Court which reconvenes October 5, 1953.
