MEMORANDUM of Telephone Call.

Mr. Fay advised from New York that yesterday he had a call from [redacted] of the New York Times advising he had received a tip from a confidential source (and requested that his name be disclosed under any circumstances) to the effect that there was a plot to kidnap one of the Hearst family; that a gangster had gone into the office of either the editor of the New York American or New York Journal last Friday and stated that there was a plan on hand to kidnap one of the family; that he understood that three were on the west coast and the rest here; that Mr. Fay had gotten in touch with Connelley who did some checking, and advised that he had contacted a Mr. Berlin, in charge of the International Magazine Company, and holds the same position on magazines published by Hearst as Connelley does on the news. Mr. Fay advised he had been to see Morris who advised that his sales manager had obtained confidential information that there was a plot on hand to kidnap one of the Hearst family and that he immediately gave this information to Bill Carley, the editor of the New York Journal, who had a guard put around the family. Mr. Fay further advised that when Connelley called today he said he went to the sales manager and advised he had to know the source of this information, which was very important and very vital, and ascertained that the source was a man employed in their own organization in an advertising capacity, [redacted] that when he, Mr. Fay, went in this afternoon he called [redacted] in and told him that Connelley had advised that he had the confidential information and that the Bureau would handle it in the right way, and [redacted] advised that on Thursday, July 13th (probably meant 17th) about 3 p.m. he had received a telephone call from a man with a Jewish accent and talked like a East Side, and called [redacted] by the name of Edie (everyone in the office calls him Ed), and [redacted] advised that he presented the gambling place conducted by Doyle, and advised that there was a plot to kidnap one of the Hearst family. [redacted] stated that he reviewed the information that it was one of the sons of Hearst. [redacted] further stated that the only place he is referred to as "Daddy" is at Doyle's, but that he has not been to Doyle's but has at other times in the last three or four years, and that only about ten people there have his name, and he is getting a kick at the people at Doyle's who have been in contact with Doyle and any other possibilities. Mr. Fay stated he was [redacted] during this evening in this regard.

Mr. Fay advised by telephone, with regard to the alleged plot to kidnap a member of the Hearst family, that he last night contacted Curley and Carley knew nothing about the matter except that they are guarding the Hearst boys; that he, Curley, thought the Nassau County police had been working on the case but that Pinkertons had taken it over; that Berlin advised this morning he had been in touch with Bill Hearst, one of the sons, and said that detectives and police in New York City are handling it, and that he knows that Sullivan (supposedly the Assistant Chief) and two detectives are working on the case, and that Detective Broderick left last night with the twins for the coast. Mr. Fay inquired whether it would be satisfactory to let them know we are on the case, and I advised that I thought this would be alright.

On April 25, 1944, Mr. EDWARD L. COMPTON, who is a member of the legal firm of Flint & McElroy, Los Angeles, California, counsel for WILLIAM RANDOLPH HEARST, advised that Mr. HEARST had recently received a threatening letter from the Subject.

After a perusal of the contents of this letter, Mr. COMPTON was advised to contact the local post office authorities inasmuch as this matter came within their jurisdiction. This matter was also discussed with Assistant United States Attorney Charles Veale, Los Angeles, who stated that he believed this was a matter for the postal authorities.

For the information of the Detroit Field Division, a reference is also made to VERA BROWN of the Detroit Times in the letter to Mr. HEARST. A copy of the threatening letter is being enclosed for the Detroit Field Office.

A check of the Los Angeles Field Division indices reflected no derogatory information concerning the Subject and no investigation is being conducted by this field division.

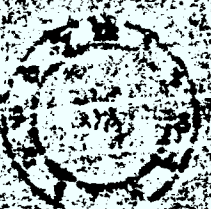

great power when Hearst took hold of him, and the men seen were fighting, Ince was getting the better of the encounter, whereupon Hearst drew out a pistol and shot Ince, the bullet lodging in Ince's stomach.

Surgical aid was immediately given Ince by Hearst's physician on the yacht, Dr. Gordon Graham, and then, several hours later, Ince was brought ashore, the boat landing at the foot of Broadway in San Diego. This was early in the morning of Nov. 27. Ince was then slowly dying. He was carried on board of a Santa Fe railroad train, to convey him to his home in Hollywood, but when the train had arrived at Del Mar, 15 miles north of San Diego, his condition was so alarming that his attendants took him off the train and carried him to a room in the Hotel Del Mar. Ince remained there Monday night and on Tuesday evening he again was placed on a train and taken to his Hollywood residence, where he died early Wednesday morning, about 70 hours after Hearst shot him.

The death certificate was signed by a woman physician of Los Angeles, who saying Ince had died from heart failure. The body soon was cremated. Ugly reports were whispered thruout Hollywood circles. Everyone who had been with the party on the yacht was pledged to secrecy. Hearst employed a veritable army of those gentry known as private detectives and who for cash will bargain to commit any and all crimes in the calendar and whose business is so brisk that there are more than one hundred and fifty private detective agencies in the state of California. Hearst has expended over a million dollars as bribes thru these private detective crime merchants in blocking any and all moves that might bring about an investigation by law officers concerning the murder.

The foregoing facts relative to the killing of Ince were communicated to Mrs. Anne Sample Matherson around the first of December two years ago, and then she, in the terrible straits of legal prosecution for her perjuries, sent word to Hearst that if he did not at once come to her rescue and get her free she would tell the world about the murder and his connivance with Marion Davies.

Hearst was seized with fright, and here is what quickly happened:

Hearst reported went from Chicago to Springfield, Penn., and from there out of hiding through Canada, to the residence of the



Mrs. McPherson immediately made these statements: "I was walking in L.A. several days ago but now I'm sitting pretty on top of the world," and

pointing to the Hearstian reporters who were near her she said: "These are my deliverers." She quickly made changes in her staff of attorneys. She soon

got a postponement of her trial. She announced to reporters that she was thinking of starting a daily or weekly newspaper of her own for, she said, "I want to have out hold of some real news to print."

Will Hays, the semi-annual director of Hollywood strikes, has spent about a half-million dollars in helping Hearst to keep up the barrier of James A. Hayes, former district attorney of Los Angeles county, is now in jail en route to the penitentiary for taking big bribes to free criminals. It is said he got one hundred thousand dollars from Hearst to free Mrs. McPherson.

The California State Legislature is now preparing to open a rigid inquiry into all of the criminal charges made against Mrs. McPherson and her aide, a superior court judge, Carlos Hardy, who has been impeached for taking a \$2,500 bribe from Mrs. McPherson for his work in hiring and managing a crew of private detectives who worked to blockade law officers and defeat justice.

As the tragedy occurred in United States naval waters, on board a yacht in federal registry, it appears incumbent on the Department of Justice in Washington and in California to use all the powers of the government in bringing Hearst, the murderer and briber and hell-fiend, to the bar of justice. The blood of Thomas H. Ince cries out for vengeance. Murder will out.

Scores of noted men and women in the eastern part of the United States know that Hearst murdered Ince, and these leaders are patiently waiting to see what the California State Legislature and The District Attorney of Los Angeles County may do in prosecuting Hearst, Mrs. McPherson and the private detectives.

I, the writer of the foregoing facts, strive always to be

100 % a God-fearing, patriotic citizen of the United States.

I know very well that all the foregoing truths will

be brought out before the world. I also realize that

those who covered up the facts will be exposed. Yours truly,

To Whomever The Following Facts May Concern :

My name is Frank Wiltonwood, my wife and I have been married 27 years and we live at 224 South Figueroa Street. For 25 years I was a newspaper reporter in the East and the West, and during 4 years I was a photoplay writer in the largest film studios of Hollywood. I hereby declare that I positively know that Willie Earl Leigh murdered Thomas M. Ince.

On Sunday night, November 19th, 1934, Hearst gave a party on board of his large steam yacht, "Quail," in San Diego Bay, the guests being mainly motion picture people. Thomas M. Ince, a noted producer of film dramas, was one of Hearst's guests at the party. Another guest was Miss Marion Davies, a film star and who for years has been one of Hearst's mistresses, he being the father of two children born to Miss Davies.

There was much liquor drunk by Hearst and his guests, Ince playfully made love to Miss Davies, Hearst became wildly jealous and angrily attacked Ince, Hearst finally shooting Ince in the stomach. Ince was brought ashore at the foot of Broadway in San Diego several hours after the shooting, and Ince then was slowly dying. Ince later was removed to his home in Hollywood where he died about 5 o'clock Wednesday morning Nov. 19th, Ince thus living only 2 days after he had been cowardly murdered by that blacking traitor W.E. Hearst.

Hearst already has spent more than one million dollars in bribes paid to San Diego officials to suppress the murder facts and prevent prosecution, and these bribe-taking chiefs include many men in the federal, state, county and city offices, and several editors of San Diego newspapers, and other leaders.

Ince once was my employer and true friend. Several months after he was murdered I began investigating the tragedy and I quickly found that I was being trailed and persecuted by a gang of Hearst's private detectives, these crooks continually spreading infamous lies about me, blackmailing me in every way possible and incessantly striving to put me completely out of existence. I therefore write this statement of undeniable facts about the murder and if anyone doubts these truths PLEASE GET BURY AND ARK HEARST TO HAVE ME ARRESTED.

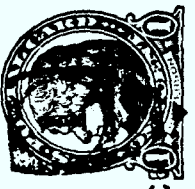
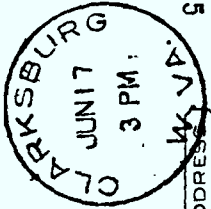

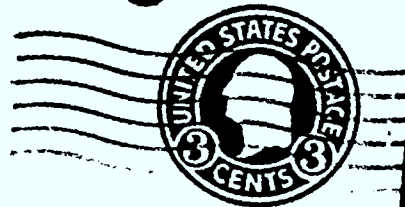

No action is being taken in this division, and the matter is brought to your attention for record purposes.

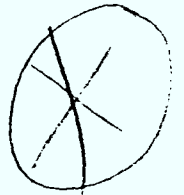

Of course Finland and Latvia and Esthonia and Lithuania all had PROMISES from England and the United States—all had pledges of undying friendship.

These devoted European republics all had many words of encouragement from England and the United States,—words of consecration to the sublime cause of democracy, words of insistence that the republics of Finland and Esthonia and Lithuania battle bravely for independence and sacrifice all for liberty.

INSPIRING WORDS these brave little republics got in their heroic fight for freedom, but NO EFFECTIVE AID.

At least no effective aid from the great imperialistic democracies.

Amazingly enough, the only actual aid the republics of Eastern Europe got was from Germany.

England and the United States reserved their aid for Russia, the destroyer of democracy; for Stalin, the cruel conqueror of republics, the oppressor of all free men everywhere.

But Finland does not need the aid of the capitalistic imperialism and the democratic despotism.

She is doing very well without them, thank you.

She is even doing very well despite the disgraceful aid to Russian tyranny rendered by these self-styled great democracies.

The Finns have driven the Russians back off of much of that part of her homeland which the Russians stole from them in 1940.

WE IN AMERICA condemned Russia and denounced the Butcher Stalin then ~~for~~ the bloody rape of Finland.

The Russia that we are aiding today is the same Russia ~~that we condemned~~ a year ago.

The Stalin that we now revere as a benevolent ruler and praise as a gentle and guileless patriot is the same ruthless murderer and torturer of his own people that we but lately recoiled from in horror,—the same bloody tyrant who ravished Finland and destroyed the democracy of Esthonia, Latvia and Lithuania.

Russia has not changed.

Stalin has not changed.

Democratic Finland has not changed.

The liberty loving people of Esthonia, Latvia and Lithuania have not changed.

But the great imperialistic democracies have very drastically changed in their professed high ideals and altruistic purposes, and in their declared devotion to freedom and the democratic cause.

ON FEBRUARY 10, 1940, President Roosevelt, expressing the sympathy of the people of America for Finland in her struggle against the aggressions of Russia, said:

"Here is a small republic in Northern Europe which, without any question whatever, wishes solely to maintain its own territorial and governmental integrity.

"Nobody with any pretense of common sense believes that Finland had any ulterior design on the integrity or the safety of the Soviet Union.

"That American sympathy is 98 per cent with the Finns in their effort to STAVE OFF INVASION OF THEIR OWN SOIL is now aximatic."

AND WINSTON Churchill, in one of his soaring flights of oratory, speaking for the English people, said:

"Only Finland. superb, nay, sublime—sublime in

the jaws of peril, Finland shows what free men can do. The service rendered by Finland to mankind is magnificent."

"Everyone can see how Communism robs the soul of a nation, how it makes it abject and hungry in peace and proves it base and abominable in war."

"We cannot tell what the fate of Finland may be, but no more mournful spectacle could be presented to what is left to civilized mankind than that this splendid Northern race should be at last worn down and reduced to servitude worse than death by the dull, brutish force of overwhelming numbers."

**BEAUTIFUL WORDS,** friends, entrancing words, rhetorical words, meaningless words.

England voiced her vacant devotion to the cause of liberty and democracy, but sent to aid Finland not a soldier nor a plane.

Finland got no more help than Poland.

England was lavish with praise, but miserly of men and guns.

She was very selfishly, but very wisely, no doubt, looking out for her own.

We can understand her abandoning Poland and Finland and Greece and Yugoslavia and Esthonia and Latvia and Lithuania and Belgium

and France, but **WHY AID RUSSIA?**

Why support that "Communism" which "robs the soul of a nation" and "makes it abject and hungry in peace and proves it base and abominable in war?"

Why should the democratic imperialism of England present the "mournful spectacle" to "civilized mankind" of aid and abetting the reduction of the Finns, "this splendid Northern race," to "servitude worse than death by the dull, brutish force" of Russia's (and its ally England's) "overwhelming numbers?"

Why betray a democracy which "had rendered such magnificent service to mankind?"

**AND FURTHERMORE—** coming nearer home and considering a domestic problem of decency and democracy—why should liberty loving America want to aid despotic Russia in subduing this "small republic in Northern Europe which—without any question whatever—wishes **SOLELY TO MAINTAIN ITS OWN TERRITORIAL AND GOVERNMENTAL INTEGRITY**" and "to stave off invasion of their own soil," as President Roosevelt **ONCE**

truthfully said? But, thank Heaven, Finland is succeeding in spite of betrayal.

Ours is the loss of honor and opportunity, ours is the sacrifice of sincerity and dignity and veracity, ours is the abandonment of democracy

and liberty, ours is the folly and infamy of collaborating with aggression and oppression.

Finland is winning without the wordy warriors of the pretended idealistic and altruistic democracies.

She is winning back her "own soil that Russia robbed her of."

The "small republic in Northern Europe" is regaining its "territorial integrity."

**MONDAY** THE Finnish Army captured the strategic town of Pitkaeranta on the Eastern shores of Lake Ladoga (which was Finnish territory before the Russian invasion), and annihilated 3000 Russian troops.

The Finns are advancing victoriously to recapture all their land lost to Russian greed and aggression.

And to our shame and sorrow they are achieving victory not because of England and America, but in spite of them.

They are succeeding by their own noble efforts and through the aid and opportunity furnished by the Huns, by those base, those evil, those barbarous, those infamous, despotic, state Socialistic Germans.

What a humiliation that these unworthy people should take the place in the battle for liberty and democracy in the world that we should have occupied, and that we would have occupied—if we only had meant what we so eloquently said.

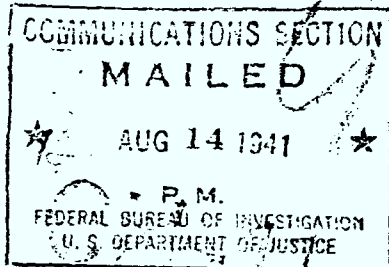

Dear Sir:

While Americans are fighting and dying in defense of our nation, shall "Stab in the Back, Hearst", be permitted to attack our ally, Russia, as he did in today's Examiner?

Whether Nazism or Communism is worse, who shall say, but we know that communistic bullet is as effective against the common enemy as the American or English one. It may be, perhap, that Russia is fighting mainly for Russia, overly-suspicious of our motives in this war, but should not this be all the more reason for discretion, and Hearst not be allowed to add fuel to the fire of distrust, particularly, when Russia's aid is so welcome in our fight with Japan? These attacks of Hearst against Communism, alias Russia, should be prohibited for the "duration".

Up to the very hour of Japan's attack, Hearst was daily supporting the Nazi cause, but now when we private citizens are admonished to do nothing to prevent our efforts in winning the war, under penalty of the law, upon what meat does this Great Caesar feed, that he defies the law and continues to sow seeds of strife and distrust amongst our Allies?

If the many Laura Ingalls, were found to have been in the pay of the Nazis, when shall we uncover the arch-conspirator, Hearst? If the Lindbergs, Wheelers, and other foolish ones, had not had the support of Hearst's great newspaper chain in all of our large cities, along with the Chicago Tribune and a few others, they would have desisted long ago, a quicker unity of the nation resulted, our war preparations farther advanced - a present saving of lives of our soldiers resulting.

Hearst and his satellites in Congress, fought and prevented our joining the League of Nations, which, without our entry could not maintain itself, and which was gotten up to prevent just such a holocaust now existing. Preventive steps should be taken now against his actions being repeated, after the peace is declared.

Be this as it may - the safety of the lives of our boys, demands that we promptly squelch Hearst's present efforts to sow disunity amongst our Allies!

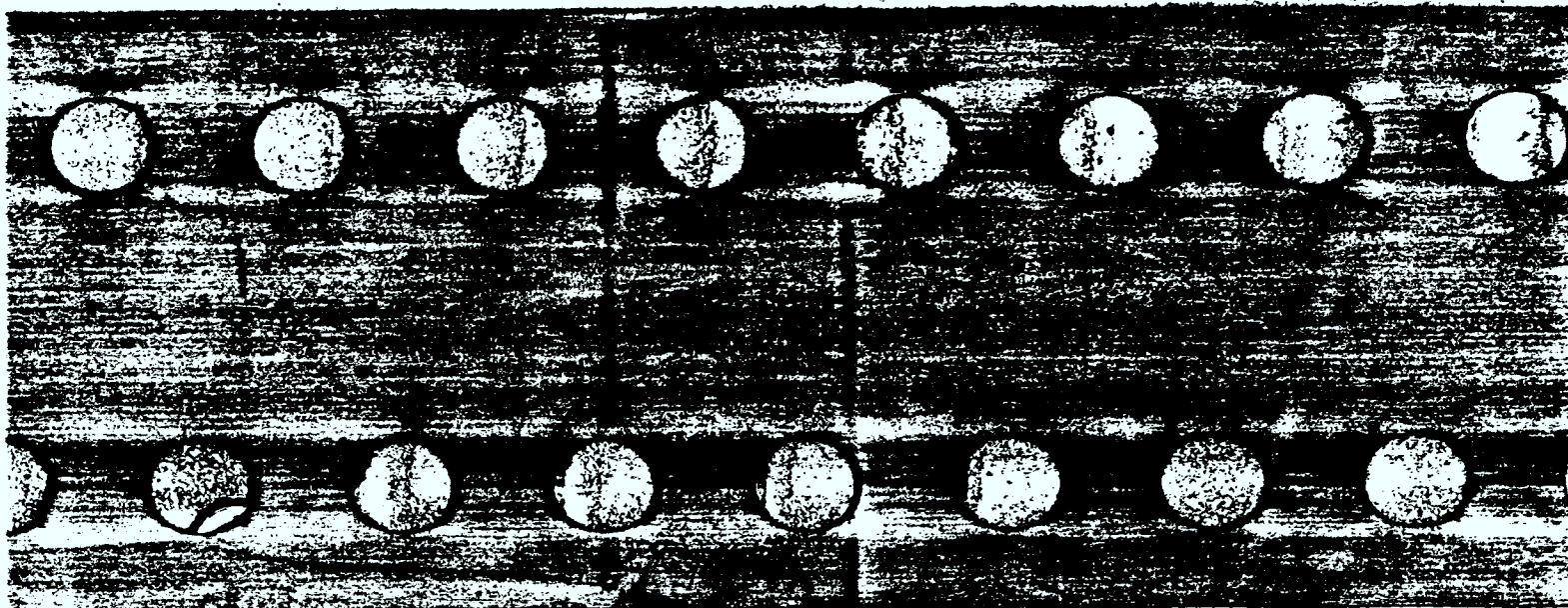

Dear Sir:

It was a general rumor many years ago that William Randolph Hearst was not permitted to land in England, or if he landed that he was requested to leave England, because the British Government considered him an undesirable person. This action, I believe, took place during the last war, during which time, by the way, I was an official in Washington.

Perhaps on account of that but definitely regardless of that, Mr. Hearst and his newspapers have at all opportunities shown animosity toward the British Empire and particularly toward England, which, generally, may be immaterial, and as he owns the papers I believe that he may have a right generally to express his personal viewpoints, but at a time like this when the British Empire, and particularly England, and the United States and its allies are fighting a common enemy, it appears to me that any venomous public attack upon England with an attempt to create in the mind of the readers of his papers that England is shirking its duty and that other nations and that parts of the British Commonwealth are taking a similar viewpoint comes pretty near being a fifth columnist activity in that it is obviously designed to create discontent and if it should succeed too greatly in doing so and therefore injure the welfare of the United States of America, it might almost, it would appear to me, be considered treasonable.

I enclose, hoping that you will have the opportunity of reading it, the article to which I particularly refer, this article appearing in the Boston Sunday Advertiser of January 25, 1942 and, no doubt, in all other papers in which Mr. Hearst has an interest.

## IN THE NEWS

THE WAR in the Pacific is not only the most serious situation that confronts the Allies, but it is the only phase of the war which is now vital.

Hong Kong, of course has fallen to the Japanese.

Singapore is being more menaced every day.

The Malayan peninsula is being absorbed by the constant advance of the Japanese armies, even as the prey of an anaconda is steadily drawn into the python's distended jaws.

The Dutch East Indies are being attacked on many fronts by the advancing tide of Japanese invasion.

Footholds of Japanese occupation have been obtained on Sumatra, on Borneo, and now on strategic islands off the coast of New Guinea.

The Japanese flood has reached the very doors of Australia.

The Japanese advance toward the complete conquest of the Pacific is proceeding not only on schedule, but ahead of schedule.

THE INTEGRITY of the British Empire is being threatened, but the English government is not concerned about the situation.

Yesterday's discussion in the British parliament centered on the defense of purely English airports, and over the invasion of any English airport by "hunters, members of Parliament and small boys."

Meanwhile, Australian troops are marching over the sand dunes of Libya in a manner greatly gratifying to the English government and "William C. Bullitt, President Roosevelt's special representative in this area" expresses himself as "more cheerful than he had been since the fall of Paris."

But Australia is not cheerful. The Australian press, in leading editorials, demands "immediate and substantial aid from the nations united with the commonwealth in the anti-Axis front."

Australian Army Minister Francis Forde, in a public statement, declared that "never before in history has Australia faced so serious a predicament."

The air minister, Arthur D. Brackford, positively states that the Japanese are expected to launch a full scale attack on New Guinea in an effort to obtain bases for an assault on the Australian mainland.

NOR IS CANADA OVERJOYED at the narrow English conduct of the war in disregard of the interests of the British Empire.

A secret session of the Canadian Parliament is to be held to discuss the failure of mechanical equipment for the Canadian troops at Hong Kong to reach that imperial port.

Canadian National Defense Minister Leighton Ralston declares that Canadian troops who fought at Hong Kong did so without a single piece of the mechanical transport equipment which they needed, and which had been promised them and assigned to them.

IN OUR OWN AMERICA, a somewhat similar indifference to—or at least neglect of—the essential situation exists. We have completely failed adequately to support MacArthur's heroic Army in the Philippines.

We are neglectful of the opportunity which China offers us to strike at Japan's flank and rear.

We have talked of some belated assistance to the Dutch East Indies and Australasia.

but we are still singularly disposed to wet nurse England, and to consider the Atlantic as the only important theater of war.

**THIS IS PARTLY** due to the influence of the refugees—royal, noble plebian and proletarian—who cannot see farther than their own noses—partly to the fact that the centers of American population are on the Atlantic side of the continent—and partly due to just plain dumb lack of vision.

As a matter of obvious fact, there is nothing that can happen to America or to England on the Atlantic beyond the blowing up of a few cargo ships.

Germany is being completely engaged, and defeated too, by Russia.

England never has been in any real danger of actual invasion, and the Atlantic coast of America, even with the smallest defenses, is safe from any kind of attack.

Germany possesses only an extremely inferior navy, and Italy a practically negligible one.

But Japan, on the Pacific side, has a powerful navy, an overwhelming air force, and a mighty well disciplined, and well seasoned army.

It is advancing steadily and rapidly to occupy all the islands of the Pacific, and to separate Australia from the British Empire.

**WHAT WILL BE THE RESULT** of such a dramatic coup?

Let us consider calmly present conditions in the Orient, and conservatively exercise our imagination.

The Orient has been dominated by the white races because of our superior technical knowledge and our SUPPOSED superior military power.

The Oriental races have in the meantime been acquiring our technical knowledge and are now proving their own superior military power.

There is a natural disposition on the part of these Oriental races to be free from Occidental domination and what they consider Occidental exploitation.

Now if the Japanese are allowed to succeed in driving the

occidental races out of the Pacific, ALL the Oriental races will surely declare themselves free from Occidental domination.

Thailand has already done so. Burma has tried to do so through the disaffection of Burmese Premier U Saw.

The English prevented that alliance with Japan—that rejection of the British yoke.

But the armies of Japan are marching to the aid of Burma, and that country might still be able to join its forces with Japan.

Japan is occupying Indo-China.

China proper is dissatisfied with the meager and ineffective aid it is receiving from the occidental powers.

China is demanding that the United States and Britain institute a convoy system to China, which needs war materials to be a useful and formidable ally, instead of to England, which does not need them.

China is intimating very broadly that otherwise she may throw in her lot with the other oriental nations and add her three hundred millions of population to the man power of Japan.

If this occurs, India is exceedingly likely to join the general movement and declare her independence of Occidental rule, and that will mean not only the disruption of the British Empire but a united Oriental continent and a dominated Oriental ocean at our Golden Gates.

**WE WILL HAVE NO TIME** then to dispute the possession of the Libyan sand hills.

We would have but little time to pursue a quarrel, and prosecute a war among the European nations.

The Yellow Peril would be on our front porch—and even perhaps breaking in our doors.

Hidiki Tojo, premier of Japan, lately addressing the Japanese Diet, declared that Japan intends to fight until the United States and the British Empire are "brought to their knees."

Perhaps, friends and fellow citizens, we would better prevent that happening by realizing the importance of the Pacific situation before it is too late.

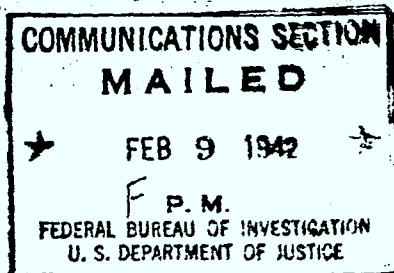

vorice suits during which Judge Rudolph Desort remarked: "If Mrs. Dilling doesn't answer everybody else will begin to talk and I'll have a nervous breakdown."
