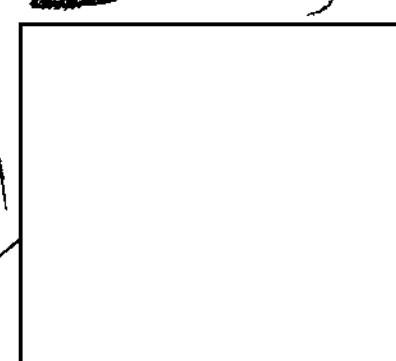

CONN.
AFENI SHAKER, a BPP member from New York City, stated that she was currently out on \$1,000.00 bail, after having been in jail for the past 18 months.

[redacted] an individual who identified himself as a member of the New Haven Chapter of the BPP, made the following speech which was duly recorded:

"You're not going to stop those tanks by running out in the streets, playing through a yard. Only thing that's going to stop that tank is a Molotov cocktail or some other type of explosive instrument. And that's what it falls down to.

"When we look at America today, we find that facist repressive and facist brutality is not only being efflicted upon black people, it's always been efflicted upon black people. What's todays date? August the 19th? August the 19th? 'Right on.' Well let me tell you something, tomorrow's August the 20th, and that will make the 353rd year the black people who have been in this country being subjected to unmitigated pure hell. Three hundred and fifty-three years tomorrow. Think about that, that's a long time, 1619 to 1970 to receive the dis-brutality in this mindless murder that black people have always suffered is now also being applied and efflicted upon every man, woman, and child who have stood up and said that, 'I will not submit to my human rights and to my Constitutional rights being deprived and being trampled upon.' I think Kent State pointed that out; and that was a very profound lesson because the Kent Sate resaw that the 'pig' of America give less than a dam now to what the color of your skin is. All they concerned with is whether

A check of the Criss-Cross Directory for the San Francisco area indicates that there is no address as 1435 Golden Gate, San Francisco, California. A spot check was conducted in the 1400 block of Golden Gate and no 1435 could be found.

A check was conducted of the San Francisco indices which revealed that Afeni Shakur with a true name of Alice Faye Williams with additional alias of Mrs. Lumumba Shakur have been the subject of San Francisco file #157-3988, New York file #157-3477, Bureau file #157-13328.

Afeni Shakur is described as follows:

Race	Negro
Sex	Female - adult
DOB	January 10, 1947
POB	Lumberton, North Carolina

A check of file, indicates that Shakur was indicted on April 2, 1969, for Conspiracy to Commit Arson and Murder with 21 others known as the Panther 21, by the New York County Grand Jury and was arrested on April 4, 1969, and held on \$100,000 bond until January 30, 1970, when bond was raised by a coalition of Christian Churches. File also indicates that she had been listed in the past as being the wife of Lumumba Shakur, true name of Anthony Costan.

Department of Motor Vehicle Records, Sacramento, California were examined and revealed that Afeni Shakur was issued California Driver's License N7012440 with an effective date of October 15, 1979.

The DMV check described Afeni Shakur as follows:

It is to be noted that 1219 Second Avenue, San Francisco, California is currently the address of Alan Mark Shafer who has been associated in the past with Marilyn Jane Buck, has been a member of the Prairie Fire Organizing Committee (PFOC). Shafer was a Seattle Weatherman who was known to have obtained several birth certificates for dead infants and had a map of a commune known as "Footbridge Farms" located in Oregon. Bureau fugitive Marilyn Buck was believed to have frequented this commune in the past when it was still active.
