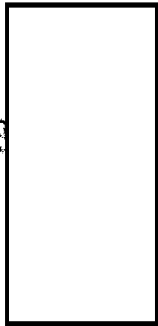

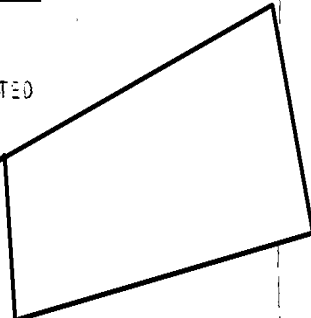

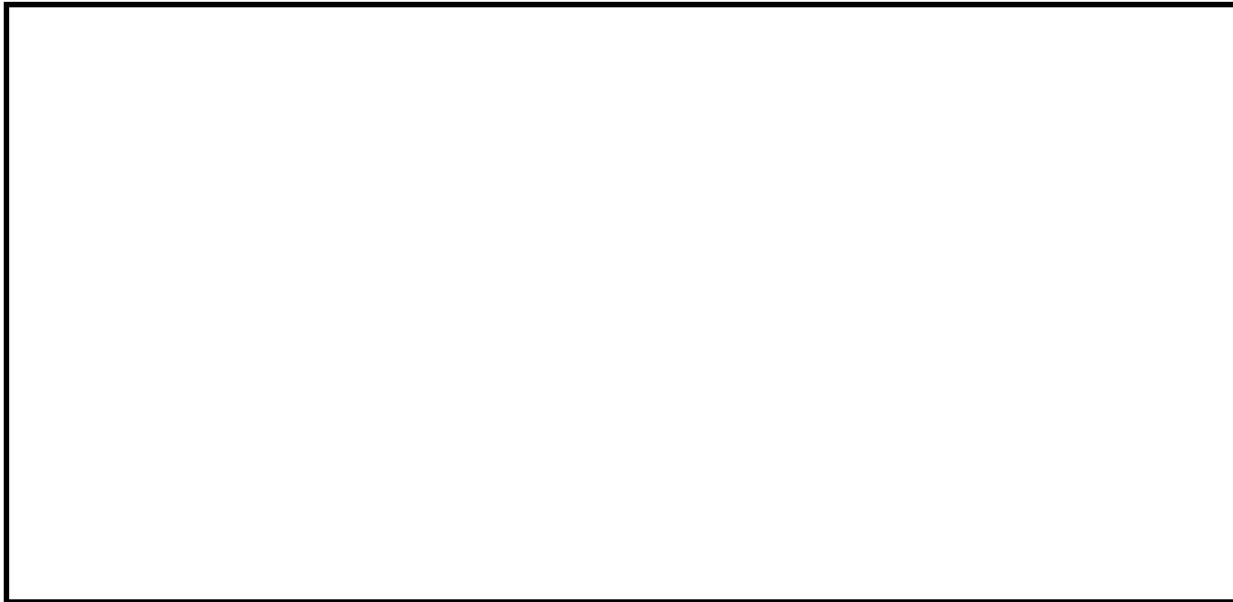

TO INVESTIGATE SUSPECTED GANG ACTIVITY IN RHODE ISLAND AND TO DETERMINE THE EXTENT OF ACTIVITIES AND CONNECTIONS BETWEEN RHODE ISLAND BASED KINGS AND THEIR CONNECTICUT COUNTERPARTS. TO THIS END, FBI PROVIDENCE HAS INITIATED AN INFORMAL JOINT MULTI AGENCY LATIN KING TASK FORCE WHICH INCLUDES REPRESENTATIVES OF ATF, USSS, RISP, HJD, PROVIDENCE POLICE DEPARTMENT, AND THE RHODE ISLAND NATIONAL GUARD.

SINCE SEPTEMBER 1994 THE PROVIDENCE LATIN KINGS HAVE PARTICIPATED IN THE BUYING AND SELLING OF FIREARMS, AND NARCOTICS, EXTORTION, AND MURDER. INVESTIGATION HAS REVEALED THAT THERE ARE APPROXIMATELY 100 LATIN KINGS AND ASSOCIATES IN THE PROVIDENCE AREA.

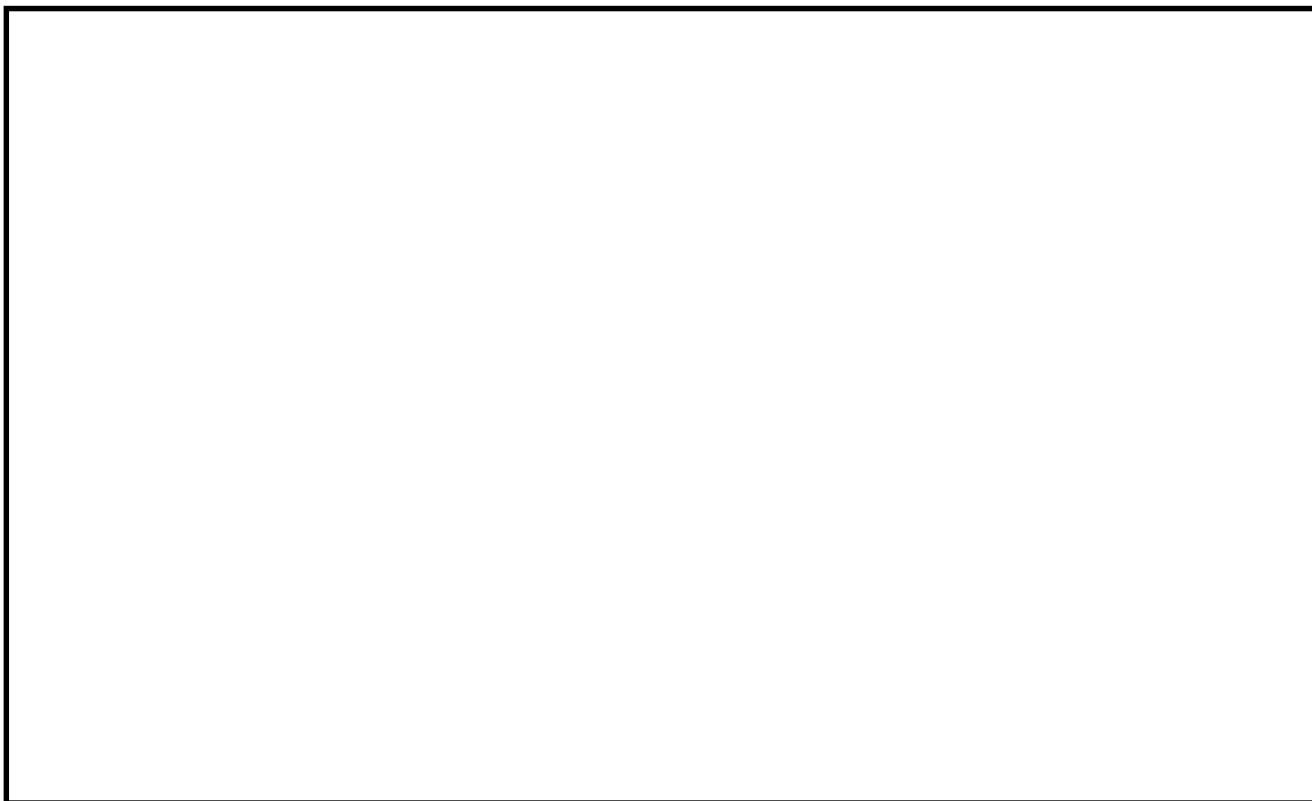
