SUBJECT: THREAT AGAINST SENATOR EDWARD KENNEDY, CONGRESSIONAL ASSASSINATION STATUTE, (OO:LOS ANGELES)

FOR INFORMATION OF THE BUREAU AND LOS ANGELES, ON NOVEMBER 13, 1979, A LETTER WAS RECEIVED IN THE OFFICE OF SENATOR EDWARD KENNEDY, WASHINGTON, D.C., STATING THAT KENNEDY WOULD BE ASSASSINATED BY AN ORGANIZATION KNOWN AS "ALL", WHICH STANDS FOR THE AMERICAN LIBERTY LEAGUE. THE LETTER ADVISED THAT THE ORGANIZATION WAS BASED IN CALIFORNIA, HOWEVER, HAD MEMBERS IN WASHINGTON, D.C., AND ALL ALONG THE EAST COAST. THE LETTER CONSISTED OF ONE HAND WRITTEN PAGE. THE LETTER WAS DATED NOVEMBER 7, 1979. THE ENVELOPE CONTAINING THE LETTER WAS POST-MARKED NOVEMBER 9, 1979, SANTA ANA, CALIFORNIA, AND CARRIED THE RETURN ADDRESS OF 4565 CEDAR AVENUE, LOS ANGELES, CALIFORNIA.

who are ready to go into action when you travel
throughout the country making speeches etc.

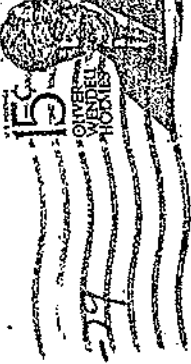
There is no way for you to escape assassination,

INVESTIGATION BY THE LOS ANGELES DIVISION DETERMINED THERE IS NO SUCH ADDRESS IN LOS ANGELES OR SURROUNDING AREAS.

AN INDICES CHECK REGARDING (ALL) REVEAL LOS ANGELES FILE 9-5928 (BUFILE 9-54978, SAN DIEGO 9-1063) ENTITLED CLARENCE FUNK STAUFFER; MAYOR TOM BRADLEY - VICTIM; [REDACTED] - VICTIM; SENATOR EDWARD M. KENNEDY - VICTIM; [REDACTED] - VICTIM.

THIS INVESTIGATION PREDICATED UPON THREATENING LETTERS RECEIVED BY ABOVE VICTIMS IN WHICH ALL CONTAINED THREATS ON BEHALF OF THE AMERICAN LIBERTY LEAGUE. THE FBI LABORATORY IDENTIFIED CLARENCE FUNK STAUFFER AS THE WRITER OF THE KENNEDY, [REDACTED] AND [REDACTED] LETTERS. A COMPLAINT CHARGING STAUFFER WITH THE VIOLATION OF TITLE 18, USC, SECTION 876, WAS FILED ON MARCH 3, 1977, AT LOS ANGELES AS A RESULT OF THE KENNEDY LETTER. STAUFFER WAS ARRESTED ON THAT SAME DATE, HOWEVER, PROSECUTION WAS SUBSEQUENTLY DECLINED BY AUSA [REDACTED] [REDACTED] LOS ANGELES, BASED ON INSUFFICIENT EVIDENCE TO WARRANT

STAUFFER UPON INTERVIEW DENIED HE HAD EVER HEARD OF THE AMERICAN LIBERTY LEAGUE OR WRITING ANY LETTERS TO THE ABOVE VICTIMS.

A REVIEW OF THE LOS ANGELES FILE REFLECTS THAT THE AMERICAN LIBERTY LEAGUE WAS FIRST KNOWN IN THE LOS ANGELES AREA BETWEEN 1936 AND 1939. THE LEAGUES OBJECTIVE WAS TO "PROTECT THE CONSTITUTION" AND CLAIMED TO HAVE 2,000 MEMBERS.

LOS ANGELES AS YET IS NOT IN RECEIPT OF LETTER IN CAPTIONED CASE, HOWEVER, SUSPECTS THAT STAUFFER COULD BE THE WRITER DUE TO SIMILARITIES IN THIS MATTER AND HIS PAST ACTIVITIES AS WELL AS THE LETTERS REFERENCE TO THE AMERICAN LIBERTY LEAGUE ORGANIZATION. LOS ANGELES IS ALSO UNAWARE OF ANY OTHER INDIVIDUAL ASSOCIATED WITH THIS ORGANIZATION OTHER THAN STAUFFER.

A SPECIAL NOTE IS THAT SENATOR KENNEDY WILL TENTATIVELY BE IN LOS ANGELES ON NOVEMBER 30, 1979, THROUGH DECEMBER 2, 1979.

WASHINGTON FIELD IS REQUESTED TO FACSIMILE A COPY OF THE LETTER TO THE SAN DIEGO DIVISION.

SAN DIEGO AT VISTA, CALIFORNIA, UPON RECEIPT OF THE FACSIMILE COPY WILL INTERVIEW STAUFFER AND DETERMINE IF HE OR ANY OTHER PERSON KNOWN TO HIM WROTE LETTER IN CAPTIONED MATTER.

LOS ANGELES AT LOS ANGELES, CALIFORNIA, WILL MAINTAIN CONTACT WITH U.S. SECRET SERVICE AND IN ADDITION WILL PRESENT MATTER TO U.S. ATTORNEY, LOS ANGELES, REGARDING A VIOLATION OF THE EXTORTION STATUTE.

Re Washington Field teletype to the Bureau dated 11/15/79, Washington Field airtel to the Bureau dated 11/21/79, Los Angeles teletype to the Bureau dated 11/23/79, and San Diego airtel to Los Angeles dated 12/11/79.

For information of the Bureau and Washington Field investigation conducted at Los Angeles regarding CLARENCE FUNK STAUFFER determined the letter in question received by Senator KENNEDY's office on 11/13/79, is identical in nature, content and in reference to the American Liberty League as previously set forth in referenced Los Angeles teletype.

STAUFFER was interviewed by the San Diego Division on 12/6/79, at Vista, California. He stated he had no information regarding this letter. It should be noted STAUFFER has been interviewed at least three times in the past regarding threatening letters and the FBI Laboratory

has positively identified STAUFFER as the writer of the previous extortion letter to Senator KENNEDY on 6/15/76. STAUFFER is an elderly individual who has never exhibited any signs of violence or outward hostility which would tend to make one feel he is dangerous.

United States Secret Service, Los Angeles and San Diego, have been advised of circumstances surrounding this letter and are well aware of STAUFFER's activities in the past.

Based on the belief that STAUFFER is the perpetrator of the letter in captioned matter, this matter was presented to Assistant United States Attorney (AUSA) [redacted] Los Angeles, on 1/9/80. After hearing the facts in this matter, AUSA [redacted] stated he would decline prosecution on the basis of insufficient evidence at this time. [redacted] stated it appears STAUFFER is an elderly man without violent tendencies to warrant any further action in this matter.
