The informant added that LOMBARDI deliberately avoids publicity and desires to remain in the background even in his dealings with the underworld element.

The files of the New York Office of the Federal Bureau of Investigation (FBI) reflect that MICHAEL GIORANO, also known as Nick Jerome, FBI Number 217633B, is well known in Miami, Florida. These files reflected that GIORANO associates with nationally known hoodlum figures in Miami.

The files of the New York Office of the FBI reflect that one BEN LOMBARDI, also known as "Cross-Eyed Benny" was registered at the Cromwell Hotel, 110 20th Street, Miami Beach, Florida, from February 2, 1953 to February 14, 1953. These files further reflect that one [REDACTED] acted as [REDACTED] of LOMBARDI during LOMBARDI's stay at the Cromwell. *FLA*

It is not known at this time whether the JEROME referred to by NY T-1 above is identical to MICHAEL GIORANO as described above.

On August 3, 1962, NY T-2 advised that subject frequents the Sea Gull Hotel, Miami Beach, Florida, and was recently observed in conversation with [redacted] and NICK JEROME. The nature of this conversation was unknown to NY T-2.

On August 24, 1962, NY T-3 advised that he had learned that an individual, believed to be [redacted] FBI Number [redacted] had a conversation with RAYMOND L. S. PATRIARCA, FBI Number 191775, about some land at Cape Canaveral. He learned that [redacted] had loaned some money in connection with the Cape Canaveral venture and had a chance to make additional money and indicated that PATRIARCA was his partner in the venture. Informant also learned that another one of the individuals who owned land is connected with JOE STRETCH, who is believed to be JOSEPH ANTHONY STRACI.

NY T-3 learned that [redacted] mentioned to PATRIARCA that a discussion with JOE STRETCH might be very helpful in connection with their making some money with the Cape Canaveral land. PATRIARCA said that "FAT TONY," who is believed to be ANTHONY SALERNO, and JOE STRETCH would probably tell "FAT TONY" about the conversation with PATRIARCA. BARBORIAN added that if there was a chance to make some money, JOE STRETCH and "FAT TONY" would do it themselves.

NY T-3 learned that PATRIARCA told [redacted] that he was going to meet an individual named "PATTY" at one o'clock Saturday, August 25, 1962, and that maybe "PATTY" could get in touch with JOE STRETCH and give them the necessary assistance they needed in straightening out the Cape Canaveral land before selling it. NY T-3 was unable to further identify "PATTY".

NY T-4 advised that during the Kefauver hearings RAYMOND L. S. PATRIARCA was identified as one of the three racket chiefs in the New England states.

JOSEPH ANTHONY STRACI, also known as JOE STRETCH, FBI Number 72208, was born January 1, 1906, Sicily, Italy, and naturalized on November 7, 1945, in New York City. He resided at 200 East End Avenue, New York City.

On May 31, 1955, NY T-5 advised that JOSEPH STRACI is one of the top men in the East Harlem Italian mob. He stated that STRACI also became a power in the garment district.

On September 25, 1962, NY T-6 advised that he observed an individual who he believed to be the subject at the Stage Barber Shop, 55th Street and 7th Avenue, at 4:00 P.M. This informant was under the impression that SALERNO was residing at the Americana Hotel which is located across the street from this barber shop.

On September 28, 1962, NY T-6 stated that he observed an individual who he believed to be the subject in conversation with [redacted] in the lobby of the Americana Hotel.

[redacted] stated that they crossed 7th Avenue and 53rd Street, at which time this individual produced a man's gold ring with a diamond inset which he stated was quite valuable but would sell it for \$80.00. [redacted] bought the ring for \$60.00.

[redacted] exhibited this ring to interviewing agents and is described as a gold Gypsy setting with a single faceted diamond in the center of the ring.

[redacted] stated he regretted the purchase and expressed a desire for the return of his money.

He furnished the following description of the individual who sold him the ring:

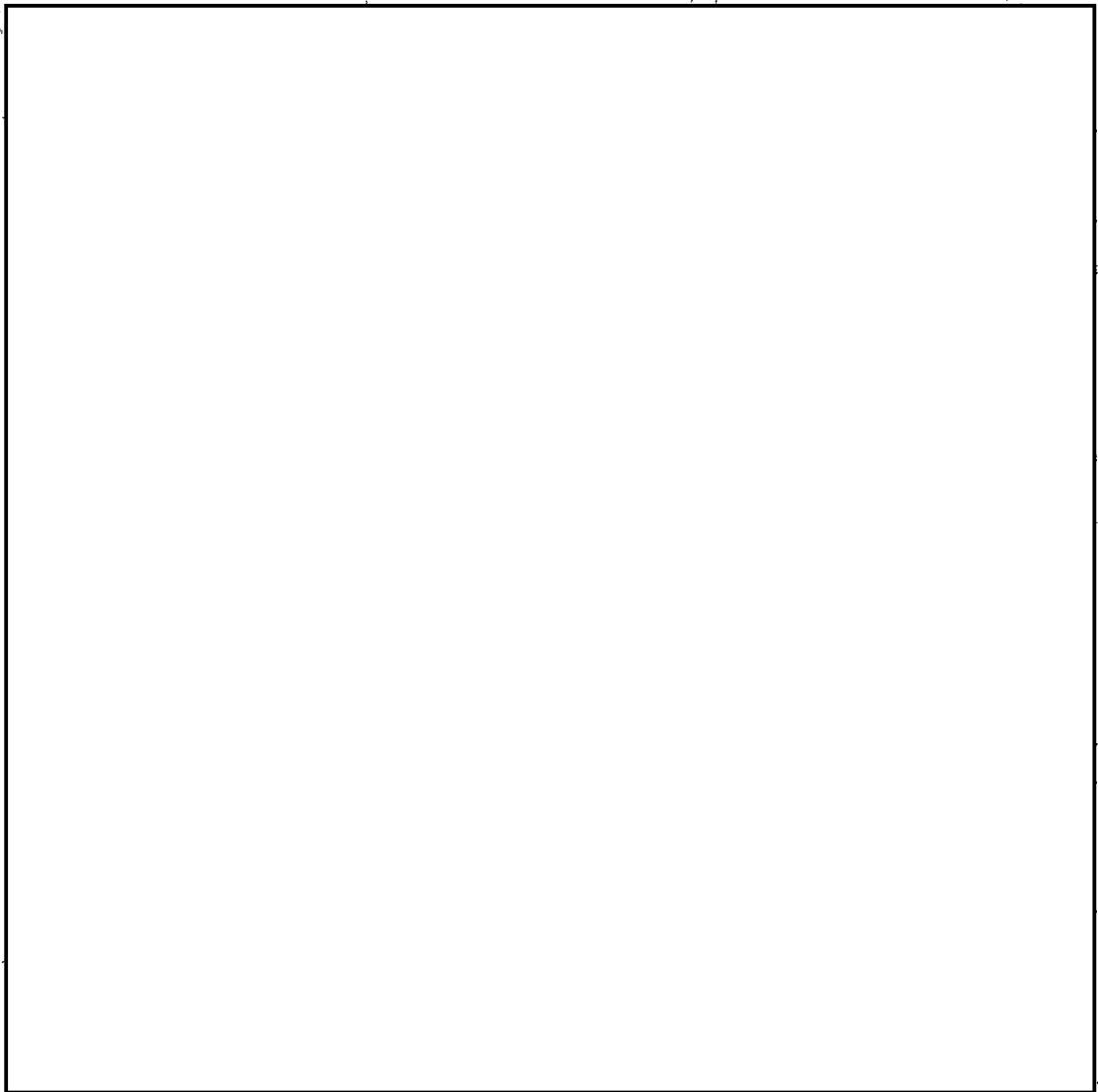

He said that his activities in Miami consisted of playing cards at the Amvets Post mentioned above and visiting the race tracks. He said that while in Miami, he usually goes to the Tropical Park Race Track as he is not allowed on the track at Hialeah. He said; however, that he occasionally sneaks on the track at Hialeah on big days when there is a large crowd in attendance.

Concerning himself, Mr. JOSEPH advised that for approximately the past 40 years, he has made his living through bookmaking, touting horses and placing his own bets. He denied that he is presently engaged in bookmaking and said he has not been so engaged for approximately 15 years. He said he presently makes his living on placing his own bets at the track and an occasional touting of horses. He said that several years ago he had operated a horse book in the Chicago area with one JOE GLEASON and one NELLIS GOLDSMITH, both of whom are now deceased. He claimed several arrests for gambling and bookmaking in the Chicago area prior to 15 years ago, but stated that he had never served any time in connection with these arrests.

Concerning the Chicago hoodlum element, Mr. JOSEPH advised that he has always tried to avoid any contact with these individuals because he prefers to operate on his own. He said that he knows of GUS ALEX only by reputation and through what he has read in local newspapers. He stated that he has never operated a horse book or engaged in any other activities in an association with the hoodlum element in Chicago.

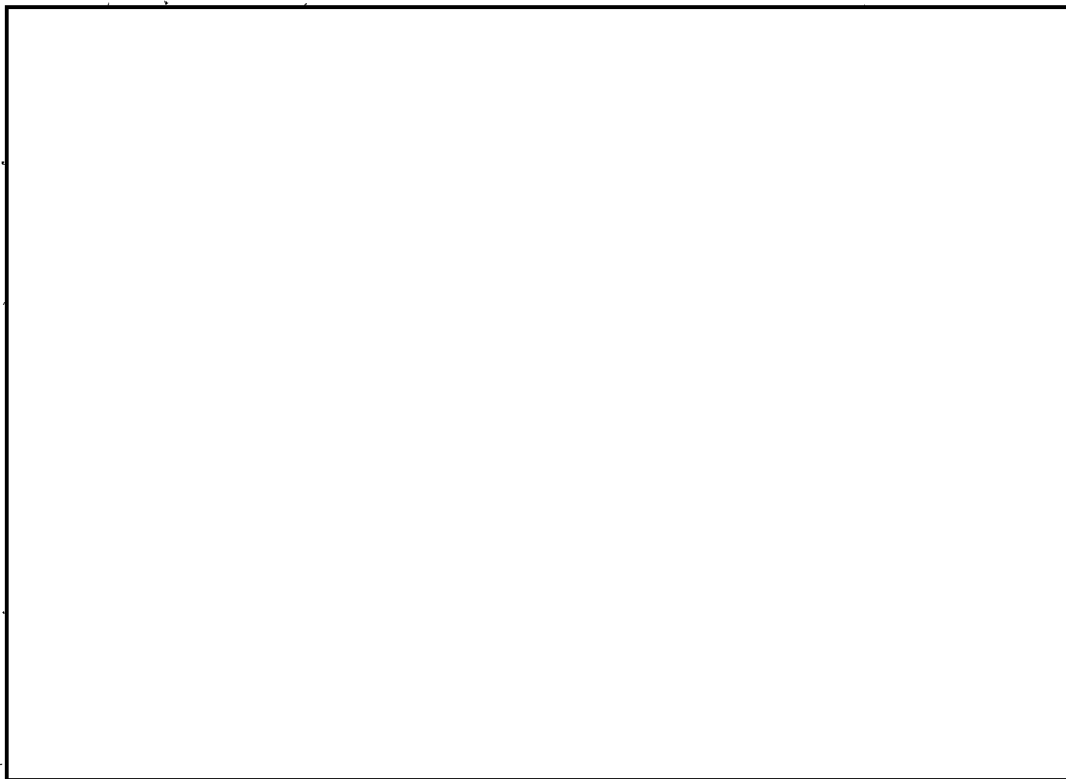

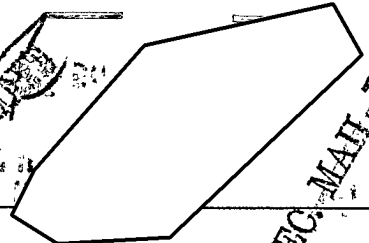
