DANIEL DEUTSCH AND FAMILY MEMBERS ABA CRISTINA DEUTSCH, NEE CLERICO, ERICA DEUTSCH, AND TOMAS ALEJANDRO DEUTSCH, PLAN TO DEPART MONTEVIDEO SETEMBER 19 VIA LAN CHILE FLIGHT 122 AT 1950 ARRIVING SANTIAGO 2100 AND DEPART SEPTEMBER 20 FROM SANTIAGO ON LAN CHILE FLIGHT 140 AT 2100, ARRIVING NEW YORK 1145 SEPTEMBER 21.

3. FOR SANTIAGO: DANIEL DEUTSCH'S PARENTS AND THREE SISTERS HAVE BEEN IMPRISONED BY ARGENTINE MILITARY OF CORDOBA REGION SINCE AUGUST 27. AT DEPARTMENT'S REQUEST EMBASSIES BEUNOS AIRES AND MONTEVIDEO HAVE BEEN WORKING FOR PAST TWO WEEKS TO UNITE DANIEL AND HIS WIFE (WHO FLED TO URUGUAY) WITH THEIR CHILDREN AND TO ARRANGE FAMILY'S SAFE AND EXPEDITIOUS TRAVEL TO THE U.S. THERE HAS BEEN CONSIDERABLE WHITE HOUSE, CONGRESSIONAL AND U.S. PUBLIC INTEREST IN FAMILY'S PLIGHT. LENGTHY STOPOVER SANTIAGO NECESSARY TO AVOID TRANSITING BUENOS AIRES. WOULD THEREFORE APPRECIATE YOUR ASSISTING DEUTSCH FAMILY TO EXTENT POSSIBLE AND CABLING INS NEW YORK AND DEPARTMENT TO CONFIRM THEIR DEPARTURE SANTIAGO.
